**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Extends air quality provisions relating to emissions from woodstoves to solid fuel burning devices. Modifies provisions relating to sale of solid fuel burning devices. Defines "solid fuel burning device." Prohibits burning of certain materials in solid fuel burning devices, masonry *[fireplaces]* **heaters, pellet stoves** or trash burners.

Renames Residential Wood Heating Air Quality Improvement Fund to Residential Solid Fuel Heating Air Quality Improvement Fund. Modifies certain aspects of fund.

Modifies prohibition on installation of used solid fuel burning devices. Modifies prohibition on sale of used solid fuel burning devices. Modifies provisions relating to removal of solid fuel burning devices. Modifies requirements for solid fuel heating curtailment program.

Adds questions regarding woodstoves and fireplace inserts to seller's property disclosure statement.

**A BILL FOR AN ACT**

2 Relating to solid fuel burning devices; creating new provisions; amending ORS 105.464, 468A.005,  
3 468A.020, 468A.300, 468A.460, 468A.465, 468A.485, 468A.490, 468A.495, 468A.500, 468A.505 and  
4 468A.515; and repealing ORS 468A.470, 468A.475, 468A.480, 468A.510 and 468A.520.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 468A.460 is amended to read:

7 468A.460. In the interest of the public health and welfare it is *[declared to be the public]* **the**  
8 policy of the State **of Oregon** to control, reduce and prevent air pollution caused by *[woodstove*  
9 *emissions]* **solid fuel burning devices**. The Legislative Assembly declares *[it to be the public]* **that**  
10 **it is also the** policy of the State **of Oregon** to reduce *[woodstove]* **solid fuel burning device** emis-  
11 sions by encouraging the Department of Environmental Quality to continue efforts to educate the  
12 public about the **air quality** effects of *[woodstove]* **those** emissions *[and the desirability of achieving*  
13 *better woodstove]*, **by ensuring that solid fuel burning devices used in Oregon meet** emission  
14 performance *[and heating efficiency]* **standards established under ORS 468A.465 and by ensuring**  
15 **compliance with ORS 468A.460 to 468A.480.**

16 **SECTION 2.** ORS 468A.465 is amended to read:

17 468A.465. (1) *[On and after July 1, 1986,]* A person may not advertise to sell, offer to sell or sell  
18 a new *[woodstove]* **solid fuel burning device** in Oregon unless $[:]$ , **pursuant to rules adopted by**  
19 **the Environmental Quality Commission, the Department of Environmental Quality certifies**  
20 **that the device meets emission performance standards, certification labeling standards and**  
21 **all other requirements set forth in rules adopted by the commission. Before adopting emis-**  
22 **sion performance standards under this section, the commission shall consider any emission**

1 performance standards proposed or adopted by the United States Environmental Protection  
2 Agency.

3 (2) In addition to devices certified under subsection (1) of this section, the department  
4 may certify new solid fuel burning devices that have been certified by the United States  
5 Environmental Protection Agency pursuant to:

6 (a) 40 C.F.R. part 60, subpart AAA, as in effect on the date the commission first adopts  
7 rules under subsection (1) of this section; or

8 (b) Any equivalent or more stringent standard adopted by the United States Environ-  
9 mental Protection Agency subsequent to such date.

10 [(1) The woodstove has been tested to determine its emission performance and heating efficiency;]

11 [(2) The woodstove is certified by the Department of Environmental Quality under the program  
12 established under ORS 468A.480 (1); and]

13 [(3) An emission performance and heating efficiency label is attached to the woodstove.]

14 **SECTION 2a.** Notwithstanding ORS 468A.465 (1), until December 31, 2010, the Environ-  
15 mental Quality Commission may not adopt an emission performance standard for any solid  
16 fuel burning device that is more stringent than the emission performance standard adopted  
17 by the United States Environmental Protection Agency for the same device.

18 **SECTION 3.** Until the Environmental Quality Commission first adopts rules pursuant to  
19 ORS 468A.465 as amended by section 2 of this 2009 Act, a person may advertise to sell, offer  
20 to sell or sell a new solid fuel burning device in Oregon that has been certified to meet  
21 emission performance standards adopted by the commission pursuant to ORS chapter 468A  
22 that are in effect on the effective date of this 2009 Act.

23 **SECTION 4.** ORS 468A.485 is amended to read:

24 468A.485. As used in ORS [468A.490] 468A.460 to 468A.480:

25 [(1) "Area that exceeds the PM10 standard" means an area of the state that exceeds, on or after  
26 January 1, 1990, the air quality standard for PM10 as established by the Environmental Quality  
27 Commission under ORS 468A.025.]

28 [(2) "Western interior valleys" means the area of the state encompassed by the borders of the States  
29 of Washington and California and the crests of the Cascade Mountain Range on the east and the Coast  
30 Range on the west.]

31 (1) "Masonry heater" has the meaning given that term in the American Society for  
32 Testing and Materials (ASTM) E1602-03, Standard Guide for Construction of Solid Fuel  
33 Burning Masonry Heaters, as in effect on the effective date of this 2009 Act, or the meaning  
34 given that term by rule of the Environmental Quality Commission.

35 (2) "Pellet stove" means a heating device that uses wood pellets, or other biomass fuels  
36 designed for use in pellet stoves, as its primary source of fuel.

37 (3) "Residential structure" has the meaning given that term in ORS 701.005.

38 (4)(a) "Solid fuel burning device" means any device that burns wood, coal or other  
39 nongaseous or nonliquid fuels for aesthetic, space-heating or water-heating purposes in a  
40 private residential structure or a commercial establishment and that has a heat output of  
41 less than one million British thermal units per hour.

42 (b) "Solid fuel burning device" does not include:

43 (A) Masonry fireplaces built on homesites, or factory-built fireplaces, that are designed  
44 to be used with an open combustion chamber, that are without features to control air-to-fuel  
45 ratios and that meet minimum emission performance standards adopted by the commission,

1 or all masonry fireplaces and factory-built fireplaces if the commission does not adopt any  
2 standards;

3 (B) Woodstoves built before 1940 that have an ornate construction and a current market  
4 value substantially higher than a common woodstove manufactured during the same period;

5 (C) Pellet stoves that meet minimum emission performance standards adopted by the  
6 commission, or all pellet stoves if the commission does not adopt any standards;

7 (D) Masonry heaters that meet minimum emission performance standards adopted by the  
8 commission, or all masonry heaters if the commission does not adopt any standards;

9 (E) Central, wood-fired furnaces that are indoors, ducted and thermostatically controlled,  
10 that have a dedicated cold air inlet and a dedicated hot air outlet that connect to the heating  
11 ductwork for the entire residential structure and that meet minimum emission performance  
12 standards adopted by the commission, or all central, wood-fired furnaces if the commission  
13 does not adopt any standards; and

14 (F) Other solid fuel burning devices identified in rules adopted by the commission.

15 (5)(a) "Trash burner" means any equipment that is used to dispose of waste by burning.

16 (b) "Trash burner" does not include an air contamination source that has been issued  
17 an air quality permit as described in ORS 468A.040.

18 (6) "Treated wood" means wood of any species that has been chemically impregnated,  
19 painted or similarly modified to prevent weathering and deterioration.

20 **SECTION 5.** Section 6 of this 2009 Act is added to and made a part of ORS 468A.460 to  
21 468A.480.

22 **SECTION 6.** A person may not cause or allow any of the following materials to be burned  
23 in a solid fuel burning device, a masonry heater, a pellet stove, a trash burner or any device  
24 described in ORS 468A.485 (4)(b):

25 (1) Garbage;

26 (2) Treated wood;

27 (3) Plastic or plastic products;

28 (4) Rubber or rubber products;

29 (5) Animal carcasses;

30 (6) Products that contain asphalt;

31 (7) Waste petroleum products;

32 (8) Paint;

33 (9) Chemicals;

34 (10) Paper or paper products, except for paper used to kindle a fire; or

35 (11) Any other materials described in rules adopted by the commission.

36 **SECTION 7.** ORS 468A.490 is amended to read:

37 468A.490. (1) There is [*created*] **established** within the State Treasury a fund known as the  
38 Residential [*Wood*] **Solid Fuel** Heating Air Quality Improvement Fund, separate and distinct from  
39 the General Fund.

40 (2) All moneys appropriated or received as gifts or grants for the purposes of this section shall  
41 be credited to the Residential [*Wood*] **Solid Fuel** Heating Air Quality Improvement Fund.

42 (3) The State Treasurer may invest and reinvest the moneys in the fund as provided in ORS  
43 293.701 to 293.820. Interest from the moneys deposited in the fund and earnings from investment of  
44 the moneys in the fund shall accrue to the fund.

45 (4) All moneys in the [*Residential Wood Heating Air Quality Improvement*] fund are continuously

1 appropriated to the Department of Environmental Quality to:

2 *[(a) Pay all costs incurred by the department in maintaining residential wood heating emissions*  
3 *inventories, analyzing projects and programs proposed for funding in accordance with this section,*  
4 *administering projects and programs selected for funding in accordance with this section and imple-*  
5 *menting the requirements of ORS 468A.475 (2) and 468A.480 (1)(g).]*

6 *[(b) Pay all reasonable costs as determined by the Environmental Quality Commission for local*  
7 *government and regional authority public education, emission inventory maintenance, curtailment and*  
8 *opacity programs to reduce residential wood heating emission in an area that exceeds the PM10*  
9 *standard or an area that is at risk of becoming an area that exceeds the PM10 standard.]*

10 *[(c) To the extent moneys remain in the fund after paying the costs under paragraphs (a) and (b)*  
11 *of this subsection, to fund programs established under subsections (5) and (6) of this section in a*  
12 *manner designed to achieve cost-beneficial reductions in emission of air contaminants from woodstoves,*  
13 *attain federal ambient air quality standards before deadlines specified in the Clean Air Act and*  
14 *maintain compliance with such standards after the deadlines established in the Clean Air Act.]*

15 *[(d) Not more than 15 percent of the total amount of moneys received under this section shall be*  
16 *expended for costs under paragraphs (a) and (b) of this subsection.]*

17 *[(5) A portion of the moneys available under subsection (4) of this section shall be used by the*  
18 *Environmental Quality Commission to fund a low or no interest loan program for wood heated house-*  
19 *holds located in the western interior valleys or in any other county containing an area that exceeds the*  
20 *PM10 standard to replace woodstoves that were not certified under ORS 468A.480 for sale as new on*  
21 *or after July 1, 1986. The program shall include the following elements:]*

22 **(a) Pay all costs incurred by the department for evaluating projects and programs, in-**  
23 **cluding projects and programs proposed by local communities or qualifying organizations, for**  
24 **project management and oversight of funds awarded for projects and programs selected in**  
25 **accordance with this section and for documenting the benefit to air quality from such**  
26 **projects;**

27 **(b) Fund the program established under subsection (5) of this section;**

28 **(c) Fund activities to enhance enforcement of ORS 468A.460 to 468A.480;**

29 **(d) Fund public education programs related to compliance with ORS 468A.460 to 468A.480;**  
30 **and**

31 **(e) Fund public education programs related to the benefits of the use of solid fuel burning**  
32 **devices certified pursuant to ORS 468A.460 to 468A.480.**

33 **(5) The department shall use moneys available under subsection (4) of this section to**  
34 **establish a program designed to reduce the emission of air contaminants by providing grants,**  
35 **loans or other subsidies for the replacement or removal of solid fuel burning devices that**  
36 **were not certified by the department pursuant to ORS 468A.465. In addition to any other**  
37 **requirements established by rules adopted by the Environmental Quality Commission, the**  
38 **program shall provide that:**

39 **(a) All forms of new high-efficiency, low air contaminant-emitting heating systems are allowed,**  
40 **except vent-free heating appliances;**

41 **(b) Any [removed woodstove] solid fuel burning device removed under the program must be**  
42 **destroyed;**

43 **(c) Any replacement [woodstoves] device selected under the program must be installed in con-**  
44 **formance with building code requirements and the manufacturer's specifications including but not**  
45 **limited to [chimney] venting specifications; and**

1 (d) To be eligible, program participants shall participate in any home energy audit program  
2 provided at no charge to the homeowner and shall obtain all information available regarding subsi-  
3 dies for cost-effective weatherization. The department shall make the information required in this  
4 subsection readily available to program participants.

5 **(6) The department may enter into an agreement with a local government or a regional**  
6 **authority in order to implement the program established under subsection (5) of this section.**

7 *[(6) A portion of the moneys available under subsection (4) of this section shall be used by the*  
8 *commission to fund local government or regional authority programs to provide subsidies for replace-*  
9 *ment of woodstoves that were not certified under ORS 468A.480 for sale as new on or after July 1,*  
10 *1986, to low income persons in wood heated households in an area that exceeds the PM10 standard.*  
11 *The local government or regional authority programs must include the following elements to be eligible*  
12 *for funding:]*

13 *[(a) All forms of new high-efficiency, low emitting heating systems are allowed.]*

14 *[(b) All woodstoves removed are destroyed.]*

15 *[(c) The local government or regional authority adopts and enforces an ordinance that limits*  
16 *emissions from woodstoves to no visible smoke, except for steam and heat waves, during periods of air*  
17 *stagnation and to an average of 20 percent opacity at all other times except during start up and refu-*  
18 *eling as determined by the commission. This requirement shall not be in lieu of any final stage of*  
19 *woodstove curtailment required during air stagnation if the final stage of curtailment is necessary to*  
20 *prevent exceeding air quality standards established under ORS 468A.025 by the latest date allowed*  
21 *under the Clean Air Act to reach attainment of such standards.]*

22 *[(d) In an airshed requiring more than a 50 percent reduction in woodheating emissions as speci-*  
23 *fied in the State Implementation Plan control strategy for PM10 emissions, program participants shall*  
24 *have a backup heat source if a certified woodstove is selected.]*

25 *[(e) Any replacement woodstove selected under the program must be installed in conformance with*  
26 *building code requirements and the manufacturer's specifications including but not limited to chimney*  
27 *specifications.]*

28 *[(f) To be eligible, program participants shall participate in any home energy audit program pro-*  
29 *vided at no charge to the homeowner and shall obtain all information available regarding subsidies for*  
30 *cost-effective weatherization. The local government or regional air quality authority shall make the in-*  
31 *formation required in this subsection readily available to program participants.]*

32 **SECTION 8.** ORS 468A.495 is amended to read:

33 468A.495. (1) *[On and after September 29, 1991,]* The state building code under ORS 455.010 shall  
34 prohibit installations of used *[woodstoves that were not certified for sale as new on or after July 1,*  
35 *1986, under ORS 468A.480 (1).]* **solid fuel burning devices, except devices that were certified for**  
36 **sale as new:**

37 **(a) By the United States Environmental Protection Agency pursuant to 40 C.F.R. part**  
38 **60, subpart AAA; or**

39 **(b) By the Department of Environmental Quality pursuant to ORS 468A.465.**

40 **(2) Notwithstanding subsection (1) of this section, if pursuant to ORS 468A.465 the Envi-**  
41 **ronmental Quality Commission adopts more stringent standards than those described in**  
42 **subsection (1) of this section for the certification of new solid fuel burning devices, the**  
43 **commission by rule may prohibit the installation of some or all used solid fuel burning de-**  
44 **vices certified for sale as new under less stringent standards if:**

45 **(a) The used solid fuel burning devices were manufactured at least 15 years prior to the**

1 **date on which the commission adopts more stringent standards; or**

2 **(b) The used solid fuel burning devices are located in a nonattainment area in this state**  
3 **that does not attain compliance with standards for particulate matter established by the**  
4 **commission pursuant to ORS 468A.025.**

5 **SECTION 9.** ORS 468A.500 is amended to read:

6 468A.500. (1) *[On and after September 29, 1991, no person shall]* **A person may not** advertise for  
7 sale, offer to sell or sell, within this state, a used *[woodstove that was not certified under ORS*  
8 *468A.480 (1) for sale as new on or after July 1, 1986.]* **solid fuel burning device unless the device**  
9 **was certified for sale as new:**

10 **(a) By the United States Environmental Protection Agency pursuant to 40 C.F.R. part**  
11 **60, subpart AAA; or**

12 **(b) By the Department of Environmental Quality pursuant to ORS 468A.465.**

13 **(2) Notwithstanding subsection (1) of this section, if pursuant to ORS 468A.465 the Envi-**  
14 **ronmental Quality Commission adopts more stringent standards than those described in**  
15 **subsection (1) of this section for the certification of new solid fuel burning devices, the**  
16 **commission by rule may prohibit the advertisement for sale, offer to sell or sale of some or**  
17 **all used solid fuel burning devices certified for sale as new under less stringent standards if:**

18 **(a) The used solid fuel burning devices were manufactured at least 15 years prior to the**  
19 **date on which the commission adopts more stringent standards; or**

20 **(b) The used solid fuel burning devices are located in a nonattainment area in this state**  
21 **that does not attain compliance with standards for particulate matter established by the**  
22 **commission pursuant to ORS 468A.025.**

23 **SECTION 10.** ORS 468A.505 is amended to read:

24 468A.505. *[After December 31, 1994, all woodstoves, other than cookstoves, not certified for sale*  
25 *as new on or after July 1, 1986, under ORS 468A.480 (1) shall be removed and destroyed upon sale*  
26 *of a home in any PM10 nonattainment area in the state that does not attain compliance with the PM10*  
27 *standard established by the Environmental Quality Commission under ORS 468A.025 by December 31,*  
28 *1994.]*

29 **(1) In connection with the sale of a residential structure, all used solid fuel burning de-**  
30 **VICES, other than cookstoves, in the residential structure or on the real property sold with**  
31 **the residential structure, must be removed and destroyed unless the solid fuel burning de-**  
32 **VICES were certified for sale as new:**

33 **(a) By the United States Environmental Protection Agency pursuant to 40 C.F.R. part**  
34 **60, subpart AAA; or**

35 **(b) By the Department of Environmental Quality pursuant to ORS 468A.465.**

36 **(2) Notwithstanding subsection (1) of this section, if pursuant to ORS 468A.465 the Envi-**  
37 **ronmental Quality Commission adopts more stringent standards than those described in**  
38 **subsection (1) of this section for the certification of new solid fuel burning devices, the**  
39 **commission by rule may require the removal and destruction of some or all used solid fuel**  
40 **burning devices certified for sale as new under less stringent standards if:**

41 **(a) The used solid fuel burning devices were manufactured at least 15 years prior to the**  
42 **date on which the commission adopts more stringent standards; or**

43 **(b) The used solid fuel burning devices are located in a nonattainment area in this state**  
44 **that does not attain compliance with standards for particulate matter established by the**  
45 **commission pursuant to ORS 468A.025.**

1       **(3) This section does not apply to:**

2       **(a) Masonry heaters;**

3       **(b) Masonry fireplaces described in ORS 468A.485 (4)(b)(A); and**

4       **(c) Central, wood-fired furnaces described in ORS 468A.485 (4)(b)(E).**

5       **(4) The removal and destruction of a used solid fuel burning device under this section is**  
6 **the responsibility of the seller of the residential structure, unless the seller and buyer agree**  
7 **in writing that it is the buyer's responsibility. If the seller retains responsibility, the seller**  
8 **shall remove and destroy the device prior to the closing date of the sale of the residential**  
9 **structure. If the buyer accepts responsibility, the buyer shall remove and destroy the device**  
10 **within 30 days after the closing date of the sale of the residential structure.**

11       **(5) The person responsible for removal and destruction of a used solid fuel burning device**  
12 **under this section shall provide to the department written confirmation of the removal and**  
13 **destruction, pursuant to rules adopted by the commission.**

14       **(6) The failure of a seller or buyer of a residential structure to comply with this section**  
15 **does not invalidate an instrument of conveyance executed in the sale.**

16       **SECTION 11. (1) Except as provided in subsection (2) of this section, the amendments to**  
17 **ORS 468A.505 by section 10 of this 2009 Act become operative on August 1, 2010.**

18       **(2) The amendments to ORS 468A.505 by section 10 of this 2009 Act become operative on**  
19 **the effective date of this 2009 Act for the purpose of adopting rules under ORS 468A.505.**

20       **SECTION 12. ORS 468A.515 is amended to read:**

21       **468A.515. (1) If a local government or regional authority has not adopted or is not ade-**  
22 **quately implementing a curtailment program in any area of the state where such a program**  
23 **is required under the Clean Air Act, the Environmental Quality Commission may adopt by**  
24 **rule, and the Department of Environmental Quality may operate and enforce, a program to**  
25 **curtail residential solid fuel heating during periods of air stagnation as described in sub-**  
26 **section (2) of this section. The department shall suspend operation and enforcement of a**  
27 **program adopted under this subsection upon a determination by the department that the**  
28 **local government or regional authority has adopted and is adequately implementing the re-**  
29 **quired curtailment program.**

30       **[(1)] (2) Any programs adopted by the [Environmental Quality] commission pursuant to sub-**  
31 **section (1) of this section to curtail residential [wood] solid fuel heating during periods of air**  
32 **stagnation shall provide for two stages of curtailment based on the severity of projected air quality**  
33 **conditions. Except as provided in subsection [(2)] (4) of this section, the programs shall apply to all**  
34 **[woodburning fireplaces, woodstoves and appliances] heating by means of solid fuel, including but**  
35 **not limited to solid fuel burning devices, masonry heaters, pellet stoves, trash burners and**  
36 **all devices described in ORS 468A.485 (4)(b). The programs shall provide that [woodstoves that**  
37 **were certified for sale as new on or after July 1, 1986, under ORS 468A.480 (1) shall be curtailed only**  
38 **at the second stage to insure attainment of air quality standards.] use of a solid fuel burning device,**  
39 **masonry fireplace or other solid fuel burning device identified in rules adopted by the com-**  
40 **mission be curtailed only at the more severe stage of projected air quality if the solid fuel**  
41 **burning device, masonry fireplace or other solid fuel burning device identified in rules**  
42 **adopted by the commission was certified for sale as new:**

43       **(a) By the United States Environmental Protection Agency pursuant to 40 C.F.R. part**  
44 **60, subpart AAA; or**

45       **(b) By the department pursuant to ORS 468A.465.**

1       **(3) Notwithstanding subsection (2) of this section, if pursuant to ORS 468A.465 the com-**  
2 **mission adopts more stringent standards than those described in subsection (2) of this sec-**  
3 **tion for the certification of new solid fuel burning devices, the commission by rule may**  
4 **require curtailment during the less severe stage of projected air quality of some or all solid**  
5 **fuel burning devices certified for sale as new under less stringent standards if:**

6       **(a) The solid fuel burning devices were manufactured at least 15 years prior to the date**  
7 **on which the commission adopts more stringent standards; or**

8       **(b) The solid fuel burning devices are located in a nonattainment area in this state that**  
9 **does not attain compliance with standards for particulate matter established by the com-**  
10 **mission pursuant to ORS 468A.025.**

11       [(2)] **(4) Programs adopted by the commission to curtail residential [wood] solid fuel heating**  
12 **during periods of air stagnation [shall] do not apply to:**

13       **(a) A person who is classified at less than or equal to 125 percent of poverty level pursuant to**  
14 **guidelines established by the commission taking into account federal poverty [income] guide-**  
15 **lines [adopted under the Omnibus Budget Reconciliation Act of 1981 (P.L. 97-35)];**

16       **(b) A person whose residence is equipped [only with wood heating until such time as funding**  
17 **becomes available for replacement or woodstoves that were not certified under ORS 468A.480 for sale**  
18 **as new on or after July 1, 1986, and for the period of time between application for such funds and**  
19 **completion of the replacement] solely with a solid fuel burning device that meets any additional**  
20 **requirements as described in rules adopted by the commission; and**

21       **(c) [Wood burning] Pellet stoves, unless the pellet stove is located in a nonattainment area**  
22 **in this state that does not attain compliance with standards for particulate matter estab-**  
23 **lished by the commission pursuant to ORS 468A.025.**

24       [(3) *If a local government or regional authority has not adopted or is not adequately implementing*  
25 *the required curtailment program, the Environmental Quality Commission may adopt by rule and the*  
26 *Department of Environmental Quality may operate and enforce a program to curtail residential wood*
