

Senate Bill 109

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor Theodore R. Kulongoski for Department of Consumer and Business Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Repeals statutes governing sellers of travel. Transfers unexpended balance of funds used in administering repealed statutes to General Fund.

2 Relating to sellers of travel; creating new provisions; amending ORS 646.608 and 646A.110; and re-
3 pealing ORS 646A.010, 646A.012, 646A.014, 646A.016, 646A.018 and 646A.020.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 646.608, as amended by section 8, chapter 19, Oregon Laws 2008, and section
6 5, chapter 31, Oregon Laws 2008, is amended to read:

7 646.608. (1) A person engages in an unlawful practice when in the course of the person's busi-
8 ness, vocation or occupation the person does any of the following:

9 (a) Passes off real estate, goods or services as those of another.

10 (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-
11 proval, or certification of real estate, goods or services.

12 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-
13 ciation with, or certification by, another.

14 (d) Uses deceptive representations or designations of geographic origin in connection with real
15 estate, goods or services.

16 (e) Represents that real estate, goods or services have sponsorship, approval, characteristics,
17 ingredients, uses, benefits, quantities or qualities that they do not have or that a person has a
18 sponsorship, approval, status, qualification, affiliation, or connection that the person does not have.

19 (f) Represents that real estate or goods are original or new if they are deteriorated, altered,
20 reconditioned, reclaimed, used or secondhand.

21 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade,
22 or that real estate or goods are of a particular style or model, if they are of another.

23 (h) Disparages the real estate, goods, services, property or business of a customer or another
24 by false or misleading representations of fact.

25 (i) Advertises real estate, goods or services with intent not to provide them as advertised, or
26 with intent not to supply reasonably expectable public demand, unless the advertisement discloses
27 a limitation of quantity.

28 (j) Makes false or misleading representations of fact concerning the reasons for, existence of,
29 or amounts of price reductions.

30 (k) Makes false or misleading representations concerning credit availability or the nature of the

1 transaction or obligation incurred.

2 (L) Makes false or misleading representations relating to commissions or other compensation to
 3 be paid in exchange for permitting real estate, goods or services to be used for model or demon-
 4 stration purposes or in exchange for submitting names of potential customers.

5 (m) Performs service on or dismantles any goods or real estate when not authorized by the
 6 owner or apparent owner thereof.

7 (n) Solicits potential customers by telephone or door to door as a seller unless the person pro-
 8 vides the information required under ORS 646.611.

9 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give
 10 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of
 11 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or
 12 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,
 13 discount or other value is contingent upon occurrence of an event subsequent to the time the cus-
 14 tomer enters into the transaction.

15 (p) Makes any false or misleading statement about a prize, contest or promotion used to publi-
 16 cize a product, business or service.

17 (q) Promises to deliver real estate, goods or services within a certain period of time with intent
 18 not to deliver them as promised.

19 (r) Organizes or induces or attempts to induce membership in a pyramid club.

20 (s) Makes false or misleading representations of fact concerning the offering price of, or the
 21 person's cost for real estate, goods or services.

22 (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any
 23 known material defect or material nonconformity.

24 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

25 (v) Violates any of the provisions relating to auction sales, auctioneers or auction marts under
 26 ORS 698.640, whether in a commercial or noncommercial situation.

27 (w) Manufactures mercury fever thermometers.

28 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal
 29 law, or is:

30 (A) Prescribed by a person licensed under ORS chapter 677; and

31 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and
 32 on the proper cleanup of mercury should breakage occur.

33 (y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to
 34 inform the purchaser that mercury is present in the thermostat and that the thermostat may not be
 35 disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the
 36 mercury does not become part of the solid waste stream or wastewater. For purposes of this para-
 37 graph, "thermostat" means a device commonly used to sense and, through electrical communication
 38 with heating, cooling or ventilation equipment, control room temperature.

39 (z) Sells or offers for sale a motor vehicle manufactured after January 1, 2006, that contains
 40 mercury light switches.

41 (aa) Violates the provisions of ORS 803.375, 803.385 or 815.410 to 815.430.

42 (bb) Violates ORS 646A.070 (1).

43 (cc) Violates any requirement of ORS 646A.030 to 646A.040.

44 (dd) Violates the provisions of ORS 128.801 to 128.898.

45 (ee) Violates ORS 646.883 or 646.885.

 36 *the children’s product, as defined in section 1, chapter 31, Oregon Laws 2008, that is the subject of*
 37 *the violation.*
- 38 (2) A representation under subsection (1) of this section or ORS 646.607 may be any manifesta-
 39 tion of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact.
- 40 (3) In order to prevail in an action or suit under ORS 646.605 to 646.652, a prosecuting attorney
 41 need not prove competition between the parties or actual confusion or misunderstanding.
- 42 (4) An action or suit may not be brought under subsection (1)(u) of this section unless the At-
 43 torney General has first established a rule in accordance with the provisions of ORS chapter 183
 44 declaring the conduct to be unfair or deceptive in trade or commerce.
- 45 (5) Notwithstanding any other provision of ORS 646.605 to 646.652, if an action or suit is brought

1 under subsection [(1)(zz)] (1)(yy) of this section by a person other than a prosecuting attorney, relief
2 is limited to an injunction and the prevailing party may be awarded reasonable attorney fees.

3 **SECTION 2.** ORS 646A.110 is amended to read:

4 646A.110. (1) ORS 646.608 [(1)(fff)] (1)(eee), 646A.100 to 646A.110 and 646A.112 apply only to
5 persons who engage in the retail sale of merchandise in the regular course of their business.

6 (2) ORS 646.608 [(1)(fff)] (1)(eee), 646A.100 to 646A.110 and 646A.112 do not apply to public of-
7 ficials acting within the scope of their duties as public officials.

8 **SECTION 3. The unexpended balances of amounts authorized to be expended by the De-**
9 **partment of Consumer and Business Services for the biennium beginning July 1, 2009, from**
10 **revenues dedicated, continuously appropriated, appropriated or otherwise made available for**
11 **the purpose of administering and enforcing the provisions of ORS 646A.010 to 646A.020 are**
12 **transferred to the General Fund and made available for general governmental expenditures.**

13 **SECTION 4. ORS 646A.010, 646A.012, 646A.014, 646A.016, 646A.018 and 646A.020 are re-**
14 **pealed.**
