

## HOUSE AMENDMENTS TO SENATE BILL 125

1 On page 1 of the printed bill, line 3, after “336.805” insert “, 336.810”.

2 On page 2, after line 22, insert:

3 **“SECTION 3. Section 4 of this 2009 Act is added to and made a part of ORS 336.790 to**  
4 **336.815.**

5 **“SECTION 4. (1) The Department of Transportation shall reimburse the Department of**  
6 **Human Services for the cost of providing a course of traffic safety education that is:**

7 **“(a) Certified by the Department of Transportation; and**

8 **“(b) Provided to children in the legal custody of the Department of Human Services under**  
9 **ORS 419B.337 and in foster homes as defined by ORS 418.625 (3).**

10 **“(2) Reimbursement may be provided under this section only upon a showing that:**

11 **“(a) The course is used to comply with the requirements for a provisional driver license**  
12 **issued under ORS 807.065;**

13 **“(b) The pupil passed the course of traffic safety education; and**

14 **“(c) The pupil complies with any other requirements established by the Department of**  
15 **Human Services by rule.**

16 **“(3) Reimbursements made under this section must be made in the manner provided by**  
17 **ORS 336.810.**

18 **“SECTION 5. ORS 336.810 is amended to read:**

19 **“336.810. (1) There is created the Student Driver Training Fund, separate and distinct from the**  
20 **General Fund. All payments required under ORS 336.795 to 336.815 and moneys paid into the fund**  
21 **under ORS 802.110 and all expenses incurred in the administration of those sections shall be made**  
22 **to and borne by the fund. Interest earned by the fund shall be credited to the fund.**

23 **“(2) The Department of Transportation shall annually distribute the funds available in the Stu-**  
24 **dent Driver Training Fund in the manner provided in ORS 336.805 and section 4 of this 2009**  
25 **Act.**

26 **“(3) The department shall make periodic studies to determine the effectiveness of traffic safety**  
27 **education courses conducted under authority of ORS 336.790 to 336.815.”.**

28 In line 23, delete “3” and insert “6”.

29 On page 5, delete lines 22 through 24 and insert:

30 **“SECTION 7. Section 4 of this 2009 Act and the amendments to ORS 336.800, 336.805,**  
31 **336.810 and 802.110 by sections 1, 2, 5 and 6 of this 2009 Act apply only to reimbursement for**  
32 **pupils beginning a course of traffic safety education on or after the effective date of this 2009**  
33 **Act.”.**

34 In line 25, delete “5” and insert “8”.

35
