

Senate Bill 131

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor Theodore R. Kulongoski for Board of Naturopathic Examiners)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Changes name of Board of Naturopathic Examiners to Oregon Board of Naturopathic Medicine.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 685.160 is amended to read:

9 685.160. (1) There hereby is created the [*Board of Naturopathic Examiners in the Department of*
10 *Human Services*] **Oregon Board of Naturopathic Medicine**. The board [*shall consist*] **consists** of
11 seven members appointed by the Governor for terms of three years commencing July 1, and until
12 their successors are appointed and qualified. A majority of the members of the board constitutes a
13 quorum. If there is a vacancy for any cause, the Governor shall appoint a member to serve for the
14 remainder of the unexpired term. All appointments of members of the board by the Governor are
15 subject to confirmation by the Senate in the manner provided in ORS 171.562 and 171.565.

16 (2) Of the membership of the **Oregon** Board of Naturopathic [*Examiners*] **Medicine**:

17 [(a) *All members must be citizens of this state.*]

18 [(b)] (a) Five members shall be naturopaths who have each practiced continuously in this state
19 for the five years immediately prior to the date of appointment.

20 [(c)] (b) Two shall be members of the general public who do not possess the qualifications set
21 forth in paragraph [(b)] (a) of this subsection.

22 (3) **All members of the board must be residents of this state.**

23 [(3)] (4) The board shall carry into effect the provisions of this chapter and is authorized to issue
24 licenses to practice naturopathic medicine in this state. The possession of a common seal by the
25 board hereby is authorized.

26 **SECTION 2.** ORS 30.302 is amended to read:

27 30.302. (1) As used in this section, "retired physician" means any person:

28 (a) Who holds a degree of Doctor of Medicine or Doctor of Osteopathy or has met the minimum
29 educational requirements for licensure to practice naturopathic medicine;

30 (b) Who has been licensed and is currently retired in accordance with the provisions of ORS
31 chapter 677 or 685;

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted.
New sections are in **boldfaced** type.

1 (c) Who is registered with the Oregon Medical Board as a retired emeritus physician or who
 2 complies with the requirements of the [*Board of Naturopathic Examiners*] **Oregon Board of**
 3 **Naturopathic Medicine** as a retired naturopath;

4 (d) Who registers with the county health officer in the county in which the physician or
 5 naturopath practices; and

6 (e) Who provides medical care as a volunteer without compensation solely through referrals
 7 from the county health officer specified in paragraph (d) of this subsection.

8 (2) Any retired physician who treats patients pursuant to this section shall be considered to be
 9 an agent of a public body for the purposes of ORS 30.260 to 30.300.

10 **SECTION 3.** ORS 433.010 is amended to read:

11 433.010. (1) No person shall willfully cause the spread of any communicable disease within this
 12 state.

13 (2) Whenever Oregon Revised Statutes require a person to secure a health certificate, such
 14 certificate shall be acquired from a physician licensed by the Oregon Medical Board or the [*Board*
 15 *of Naturopathic Examiners*] **Oregon Board of Naturopathic Medicine** in accordance with the rules
 16 of the Department of Human Services.

17 **SECTION 4.** ORS 433.035 is amended to read:

18 433.035. (1)(a) The Public Health Director or a local public health administrator may require
 19 testing or medical examination of any person who may have, or may have been exposed to, a
 20 communicable disease identified by rule of the Department of Human Services to be a reportable
 21 disease, a new or uncommon disease of potential public health significance, or a condition that is
 22 the basis of a state of public health emergency declared by the Governor as authorized by ORS
 23 433.441. The Public Health Director or the local public health administrator must issue a written
 24 order for testing or medical examination pursuant to this section.

25 (b) A written order must:

26 (A) Include findings stating the communicable disease that the Public Health Director or the
 27 local public health administrator believes the person has and the reasons for that belief.

28 (B) State whether medical or laboratory confirmation of the disease is feasible and possible and
 29 whether such confirmation would enable control measures to be taken to minimize infection of oth-
 30 ers with the disease.

31 (C) Include a statement that the person may refuse to submit to the testing or medical exam-
 32 ination and that if the testing or examination is refused, the Public Health Director or the local
 33 public health administrator may seek the imposition of a public health measure, including isolation
 34 or quarantine pursuant to ORS 433.121 or 433.123.

35 (2) When a person is directed to submit to a test or examination under this section and the
 36 person agrees to do so, the person shall submit to any testing or examination as may be necessary
 37 to establish the presence or absence of the communicable disease for which the testing or exam-
 38 ination was directed. The examination shall be carried out by the local health officer or a physician
 39 licensed by the Oregon Medical Board or the [*Board of Naturopathic Examiners.*] **Oregon Board**
 40 **of Naturopathic Medicine.** A written report of the results of the test or examination shall be pro-
 41 vided to the person ordering the test or examination, and upon request, to the person tested or ex-
 42 amined. Laboratory examinations, if any, shall be carried out by the laboratory of the department
 43 whenever the examinations are within the scope of the tests conducted by the laboratory. If treat-
 44 ment is needed, the person or the parent or guardian of the person shall be liable for the costs of
 45 treatment based on the examination carried out under this section, if the person liable is able to

1 pay the treatment costs. Cost of any examination performed by a physician in private practice shall
 2 be paid from public funds available to the local public health administrator, if any, or from county
 3 funds available for general governmental expenses in the county that the local public health ad-
 4 ministrator serves or in the county where the person tested or examined resides if the local public
 5 health administrator serves more than one county or the test or examination was ordered by the
 6 Public Health Director or local public health administrator.

7 (3) If a person has a communicable disease, a new or uncommon disease of potential public
 8 health significance, or a condition that is the basis of a state of public health emergency, the Public
 9 Health Director or the local public health administrator may issue an order requiring the person to
 10 complete an appropriate prescribed course of medication or other treatment for the communicable
 11 disease, including directly observed therapy if appropriate, and to follow infection control provisions
 12 for the disease. The order shall also include statements that the person may refuse the medication
 13 or other treatment and that the person’s failure to comply with the order issued under this sub-
 14 section may result in the Public Health Director or the local public health administrator seeking the
 15 imposition of a public health measure, including isolation or quarantine as authorized by ORS
 16 433.121 and 433.123.

17 (4) The Public Health Director or the local public health administrator must make every effort
 18 to obtain voluntary compliance from a person for any testing, medical examination and treatment
 19 required under this section.

20 (5) Any action taken by the Public Health Director or the local public health administrator un-
 21 der this section to compel testing, medical examination or treatment of a person who has a
 22 communicable disease, a new or uncommon disease of potential public health significance, or a
 23 condition that is the basis of a state of public health emergency must be the least restrictive alter-
 24 native available to accomplish the results necessary to minimize the transmission of the disease to
 25 others.

26 **SECTION 5.** ORS 433.235 is amended to read:

27 433.235. As used in ORS 433.235 to 433.284:

28 (1) “Administrator” means the principal or other person having general control and supervision
 29 of a school or children’s facility.

30 (2) “Children’s facility” or “facility” means:

31 (a) A certified child care facility as described in ORS 657A.030 and 657A.250 to 657A.450, except
 32 as exempted by rule of the Department of Human Services;

33 (b) A program operated by, or sharing the premises with, a certified child care facility, school
 34 or post-secondary institution where care is provided to children, six weeks of age to kindergarten
 35 entry, except as exempted by rule of the department; or

36 (c) A program providing child care or educational services to children, six weeks of age to
 37 kindergarten entry, in a residential or nonresidential setting, except as exempted by rule of the de-
 38 partment.

39 (3) “Local health department” means the district or county board of health, public health officer,
 40 public health administrator or health department having jurisdiction within the area.

41 (4) “Parent” means a parent or guardian of a child or any adult responsible for the child.

42 (5) “Physician” means a physician licensed by the Oregon Medical Board or by the [*Board of*
 43 *Naturopathic Examiners*] **Oregon Board of Naturopathic Medicine** or a physician similarly li-
 44 censed by another state or country in which the physician practices or a commissioned medical of-
 45 ficer of the Armed Forces or Public Health Service of the United States.

1 (6) "School" means a public, private, parochial, charter or alternative educational program of-
 2 fering kindergarten through grade 12 or any part thereof, except as exempted by rule of the De-
 3 partment of Human Services.

4 **SECTION 6.** ORS 656.005 is amended to read:

5 656.005. (1) "Average weekly wage" means the Oregon average weekly wage in covered em-
 6 ployment, as determined by the Employment Department, for the last quarter of the calendar year
 7 preceding the fiscal year in which the injury occurred.

8 (2) "Beneficiary" means an injured worker, and the husband, wife, child or dependent of a
 9 worker, who is entitled to receive payments under this chapter. "Beneficiary" does not include:

10 (a) A spouse of an injured worker living in a state of abandonment for more than one year at
 11 the time of the injury or subsequently. A spouse who has lived separate and apart from the worker
 12 for a period of two years and who has not during that time received or attempted by process of law
 13 to collect funds for support or maintenance is considered living in a state of abandonment.

14 (b) A person who intentionally causes the compensable injury to or death of an injured worker.

15 (3) "Board" means the Workers' Compensation Board.

16 (4) "Carrier-insured employer" means an employer who provides workers' compensation cover-
 17 age with a guaranty contract insurer.

18 (5) "Child" includes a posthumous child, a child legally adopted prior to the injury, a child to-
 19 ward whom the worker stands in loco parentis, [*an illegitimate*] a child **born out of wedlock** and
 20 a stepchild, if such stepchild was, at the time of the injury, a member of the worker's family and
 21 substantially dependent upon the worker for support. [*An invalid*] A dependent child **who is an in-**
 22 **valid** is a child, for purposes of benefits, regardless of age, so long as the child was an invalid at
 23 the time of the accident and thereafter remains an invalid substantially dependent on the worker for
 24 support. For purposes of this chapter, [*an invalid*] a dependent child **who is an invalid** is considered
 25 to be a child under 18 years of age.

26 (6) "Claim" means a written request for compensation from a subject worker or someone on the
 27 worker's behalf, or any compensable injury of which a subject employer has notice or knowledge.

28 (7)(a) A "compensable injury" is an accidental injury, or accidental injury to prosthetic appli-
 29 ances, arising out of and in the course of employment requiring medical services or resulting in
 30 disability or death; an injury is accidental if the result is an accident, whether or not due to acci-
 31 dental means, if it is established by medical evidence supported by objective findings, subject to the
 32 following limitations:

33 (A) No injury or disease is compensable as a consequence of a compensable injury unless the
 34 compensable injury is the major contributing cause of the consequential condition.

35 (B) If an otherwise compensable injury combines at any time with a preexisting condition to
 36 cause or prolong disability or a need for treatment, the combined condition is compensable only if,
 37 so long as and to the extent that the otherwise compensable injury is the major contributing cause
 38 of the disability of the combined condition or the major contributing cause of the need for treatment
 39 of the combined condition.

40 (b) "Compensable injury" does not include:

41 (A) Injury to any active participant in assaults or combats which are not connected to the job
 42 assignment and which amount to a deviation from customary duties;

43 (B) Injury incurred while engaging in or performing, or as the result of engaging in or per-
 44 forming, any recreational or social activities primarily for the worker's personal pleasure; or

45 (C) Injury the major contributing cause of which is demonstrated to be by a preponderance of

1 the evidence the injured worker's consumption of alcoholic beverages or the unlawful consumption
2 of any controlled substance, unless the employer permitted, encouraged or had actual knowledge of
3 such consumption.

4 (c) A "disabling compensable injury" is an injury which entitles the worker to compensation for
5 disability or death. An injury is not disabling if no temporary benefits are due and payable, unless
6 there is a reasonable expectation that permanent disability will result from the injury.

7 (d) A "nondisabling compensable injury" is any injury which requires medical services only.

8 (8) "Compensation" includes all benefits, including medical services, provided for a compensable
9 injury to a subject worker or the worker's beneficiaries by an insurer or self-insured employer pur-
10 suant to this chapter.

11 (9) "Department" means the Department of Consumer and Business Services.

12 (10) "Dependent" means any of the following-named relatives of a worker whose death results
13 from any injury: Father, mother, grandfather, grandmother, stepfather, stepmother, grandson,
14 granddaughter, brother, sister, half sister, half brother, niece or nephew, who at the time of the
15 accident, are dependent in whole or in part for their support upon the earnings of the worker.
16 Unless otherwise provided by treaty, aliens not residing within the United States at the time of the
17 accident other than father, mother, husband, wife or children are not included within the term "de-
18 pendent."

19 (11) "Director" means the Director of the Department of Consumer and Business Services.

20 (12)(a) "Doctor" or "physician" means a person duly licensed to practice one or more of the
21 healing arts in any country or in any state, territory or possession of the United States within the
22 limits of the license of the licentiate.

23 (b) Except as otherwise provided for workers subject to a managed care contract, "attending
24 physician" means a doctor, physician or physician assistant who is primarily responsible for the
25 treatment of a worker's compensable injury and who is:

26 (A) A medical doctor or doctor of osteopathy licensed under ORS 677.100 to 677.228 by the
27 Oregon Medical Board or an oral and maxillofacial surgeon licensed by the Oregon Board of
28 Dentistry or a similarly licensed doctor in any country or in any state, territory or possession of the
29 United States; or

30 (B) For a cumulative total of 60 days from the first visit on the initial claim or for a cumulative
31 total of 18 visits, whichever occurs first, to any of the medical service providers listed in this sub-
32 paragraph, a:

33 (i) Doctor or physician licensed by the State Board of Chiropractic Examiners for the State of
34 Oregon under ORS chapter 684 or a similarly licensed doctor or physician in any country or in any
35 state, territory or possession of the United States;

36 (ii) Podiatric physician and surgeon licensed by the Oregon Medical Board under ORS 677.805
37 to 677.840 or a similarly licensed doctor or physician in any country or in any state, territory or
38 possession of the United States;

39 (iii) Physician assistant licensed by the Oregon Medical Board in accordance with ORS 677.505
40 to 677.525 or a similarly licensed physician assistant in any country or in any state, territory or
41 possession of the United States; or

42 (iv) Doctor of naturopathy or naturopathic physician licensed by the [*Board of Naturopathic*
43 *Examiners licensed*] **Oregon Board of Naturopathic Medicine** under ORS chapter 685 or a simi-
44 larly licensed doctor or physician in any country or in any state, territory or possession of the
45 United States.

1 (c) Except as otherwise provided for workers subject to a managed care contract, “attending
2 physician” does not include a physician who provides care in a hospital emergency room and refers
3 the injured worker to a primary care physician for follow-up care and treatment.

4 (d) “Consulting physician” means a doctor or physician who examines a worker or the worker’s
5 medical record to advise the attending physician or nurse practitioner authorized to provide
6 compensable medical services under ORS 656.245 regarding treatment of a worker’s compensable
7 injury.

8 (13)(a) “Employer” means any person, including receiver, administrator, executor or trustee, and
9 the state, state agencies, counties, municipal corporations, school districts and other public corpo-
10 rations or political subdivisions, who contracts to pay a remuneration for and secures the right to
11 direct and control the services of any person.

12 (b) Notwithstanding paragraph (a) of this subsection, for purposes of this chapter, the client of
13 a temporary service provider is not the employer of temporary workers provided by the temporary
14 service provider.

15 (c) As used in paragraph (b) of this subsection, “temporary service provider” has the meaning
16 for that term provided in ORS 656.850.

17 (14) “Guaranty contract insurer” and “insurer” mean the State Accident Insurance Fund Cor-
18 poration or an insurer authorized under ORS chapter 731 to transact workers’ compensation insur-
19 ance in this state or an assigned claims agent selected by the director under ORS 656.054.

20 (15) “Consumer and Business Services Fund” means the fund created by ORS 705.145.

21 (16) “Invalid” means one who is physically or mentally incapacitated from earning a livelihood.

22 (17) “Medically stationary” means that no further material improvement would reasonably be
23 expected from medical treatment, or the passage of time.

24 (18) “Noncomplying employer” means a subject employer who has failed to comply with ORS
25 656.017.

26 (19) “Objective findings” in support of medical evidence are verifiable indications of injury or
27 disease that may include, but are not limited to, range of motion, atrophy, muscle strength and
28 palpable muscle spasm. “Objective findings” does not include physical findings or subjective re-
29 sponses to physical examinations that are not reproducible, measurable or observable.

30 (20) “Palliative care” means medical service rendered to reduce or moderate temporarily the
31 intensity of an otherwise stable medical condition, but does not include those medical services ren-
32 dered to diagnose, heal or permanently alleviate or eliminate a medical condition.

33 (21) “Party” means a claimant for compensation, the employer of the injured worker at the time
34 of injury and the insurer, if any, of such employer.

35 (22) “Payroll” means a record of wages payable to workers for their services and includes
36 commissions, value of exchange labor and the reasonable value of board, rent, housing, lodging or
37 similar advantage received from the employer. However, “payroll” does not include overtime pay,
38 vacation pay, bonus pay, tips, amounts payable under profit-sharing agreements or bonus payments
39 to reward workers for safe working practices. Bonus pay is limited to payments which are not an-
40 ticipated under the contract of employment and which are paid at the sole discretion of the em-
41 ployer. The exclusion from payroll of bonus payments to reward workers for safe working practices
42 is only for the purpose of calculations based on payroll to determine premium for workers’ com-
43 pensation insurance, and does not affect any other calculation or determination based on payroll for
44 the purposes of this chapter.

45 (23) “Person” includes partnership, joint venture, association, limited liability company and

1 corporation.

2 (24)(a) "Preexisting condition" means, for all industrial injury claims, any injury, disease, con-
3 genital abnormality, personality disorder or similar condition that contributes to disability or need
4 for treatment, provided that:

5 (A) Except for claims in which a preexisting condition is arthritis or an arthritic condition, the
6 worker has been diagnosed with such condition, or has obtained medical services for the symptoms
7 of the condition regardless of diagnosis; and

8 (B)(i) In claims for an initial injury or omitted condition, the diagnosis or treatment precedes
9 the initial injury;

10 (ii) In claims for a new medical condition, the diagnosis or treatment precedes the onset of the
11 new medical condition; or

12 (iii) In claims for a worsening pursuant to ORS 656.273 or 656.278, the diagnosis or treatment
13 precedes the onset of the worsened condition.

14 (b) "Preexisting condition" means, for all occupational disease claims, any injury, disease, con-
15 genital abnormality, personality disorder or similar condition that contributes to disability or need
16 for treatment and that precedes the onset of the claimed occupational disease, or precedes a claim
17 for worsening in such claims pursuant to ORS 656.273 or 656.278.

18 (c) For the purposes of industrial injury claims, a condition does not contribute to disability or
19 need for treatment if the condition merely renders the worker more susceptible to the injury.

20 (25) "Self-insured employer" means an employer or group of employers certified under ORS
21 656.430 as meeting the qualifications set out by ORS 656.407.

22 (26) "State Accident Insurance Fund Corporation" and "corporation" mean the State Accident
23 Insurance Fund Corporation created under ORS 656.752.

24 (27) "Subject employer" means an employer who is subject to this chapter as provided by ORS
25 656.023.

26 (28) "Subject worker" means a worker who is subject to this chapter as provided by ORS
27 656.027.

28 (29) "Wages" means the money rate at which the service rendered is recompensed under the
29 contract of hiring in force at the time of the accident, including reasonable value of board, rent,
30 housing, lodging or similar advantage received from the employer, and includes the amount of tips
31 required to be reported by the employer pursuant to section 6053 of the Internal Revenue Code of
32 1954, as amended, and the regulations promulgated pursuant thereto, or the amount of actual tips
33 reported, whichever amount is greater. The State Accident Insurance Fund Corporation may estab-
34 lish assumed minimum and maximum wages, in conformity with recognized insurance principles, at
35 which any worker shall be carried upon the payroll of the employer for the purpose of determining
36 the premium of the employer.

37 (30) "Worker" means any person, including a minor whether lawfully or unlawfully employed,
38 who engages to furnish services for a remuneration, subject to the direction and control of an em-
39 ployer and includes salaried, elected and appointed officials of the state, state agencies, counties,
40 cities, school districts and other public corporations, but does not include any person whose services
41 are performed as an inmate or ward of a state institution or as part of the eligibility requirements
42 for a general or public assistance grant. For the purpose of determining entitlement to temporary
43 disability benefits or permanent total disability benefits under this chapter, "worker" does not in-
44 clude a person who has withdrawn from the workforce during the period for which such benefits are
45 sought.

1 (31) “Independent contractor” has the meaning for that term provided in ORS 670.600.

2 **SECTION 7.** ORS 656.005, as amended by sections 6 and 7, chapter 241, Oregon Laws 2007, is
 3 amended to read:

4 656.005. (1) “Average weekly wage” means the Oregon average weekly wage in covered em-
 5 ployment, as determined by the Employment Department, for the last quarter of the calendar year
 6 preceding the fiscal year in which the injury occurred.

7 (2) “Beneficiary” means an injured worker, and the husband, wife, child or dependent of a
 8 worker, who is entitled to receive payments under this chapter. “Beneficiary” does not include:

9 (a) A spouse of an injured worker living in a state of abandonment for more than one year at
 10 the time of the injury or subsequently. A spouse who has lived separate and apart from the worker
 11 for a period of two years and who has not during that time received or attempted by process of law
 12 to collect funds for support or maintenance is considered living in a state of abandonment.

13 (b) A person who intentionally causes the compensable injury to or death of an injured worker.

1 the evidence the injured worker's consumption of alcoholic beverages or the unlawful consumption
 2 of any controlled substance, unless the employer permitted, encouraged or had actual knowledge of
 3 such consumption.

4 (c) A "disabling compensable injury" is an injury which entitles the worker to compensation for
 5 disability or death. An injury is not disabling if no temporary benefits are due and payable, unless
 6 there is a reasonable expectation that permanent disability will result from the injury.

7 (d) A "nondisabling compensable injury" is any injury which requires medical services only.

8 (8) "Compensation" includes all benefits, including medical services, provided for a compensable
 9 injury to a subject worker or the worker's beneficiaries by an insurer or self-insured employer pur-
 10 suant to this chapter.

11 (9) "Department" means the Department of Consumer and Business Services.

12 (10) "Dependent" means any of the following-named relatives of a worker whose death results
 13 from any injury: Father, mother, grandfather, grandmother, stepfather, stepmother, grandson,
 14 granddaughter, brother, sister, half sister, half brother, niece or nephew, who at the time of the
 15 accident, are dependent in whole or in part for their support upon the earnings of the worker.
 16 Unless otherwise provided by treaty, aliens not residing within the United States at the time of the
 17 accident other than father, mother, husband, wife or children are not included within the term "de-
 18 pendent."

19 (11) "Director" means the Director of the Department of Consumer and Business Services.

20 (12)(a) "Doctor" or "physician" means a person duly licensed to practice one or more of the
 21 healing arts in any country or in any state, territory or possession of the United States within the
 22 limits of the license of the licentiate.

23 (b) Except as otherwise provided for workers subject to a managed care contract, "attending
 24 physician" means a doctor, physician or physician assistant who is primarily responsible for the
 25 treatment of a worker's compensable injury and who is:

26 (A) A medical doctor or doctor of osteopathy licensed under ORS 677.100 to 677.228 by the
 27 Oregon Medical Board or an oral and maxillofacial surgeon licensed by the Oregon Board of
 28 Dentistry or a similarly licensed doctor in any country or in any state, territory or possession of the
 29 United States; or

30 (B) For a cumulative total of 60 days from the first visit on the initial claim or for a cumulative
 31 total of 18 visits, whichever occurs first, to any of the medical service providers listed in this sub-
 32 paragraph, a:

33 (i) Doctor or physician licensed by the State Board of Chiropractic Examiners for the State of
 34 Oregon under ORS chapter 684 or a similarly licensed doctor or physician in any country or in any
 35 state, territory or possession of the United States;

36 (ii) Podiatric physician and surgeon licensed by the Oregon Medical Board under ORS 677.805
 37 to 677.840 or a similarly licensed doctor or physician in any country or in any state, territory or
 38 possession of the United States;

39 (iii) Physician assistant licensed by the Oregon Medical Board in accordance with ORS 677.505
 40 to 677.525 or a similarly licensed physician assistant in any country or in any state, territory or
 41 possession of the United States; or

42 (iv) Doctor of naturopathy or naturopathic physician licensed by the [*Board of Naturopathic*
 43 *Examiners licensed*] **Oregon Board of Naturopathic Medicine** under ORS chapter 685 or a simi-
 44 larly licensed doctor or physician in any country or in any state, territory or possession of the
 45 United States.

1 (c) Except as otherwise provided for workers subject to a managed care contract, “attending
2 physician” does not include a physician who provides care in a hospital emergency room and refers
3 the injured worker to a primary care physician for follow-up care and treatment.

4 (d) “Consulting physician” means a doctor or physician who examines a worker or the worker’s
5 medical record to advise the attending physician or nurse practitioner authorized to provide
6 compensable medical services under ORS 656.245 regarding treatment of a worker’s compensable
7 injury.

8 (13)(a) “Employer” means any person, including receiver, administrator, executor or trustee, and
9 the state, state agencies, counties, municipal corporations, school districts and other public corpo-
10 rations or political subdivisions, who contracts to pay a remuneration for and secures the right to
11 direct and control the services of any person.

12 (b) Notwithstanding paragraph (a) of this subsection, for purposes of this chapter, the client of
13 a temporary service provider is not the employer of temporary workers provided by the temporary
14 service provider.

15 (c) As used in paragraph (b) of this subsection, “temporary service provider” has the meaning
16 for that term provided in ORS 656.850.

17 (14) “Insurer” means the State Accident Insurance Fund Corporation or an insurer authorized
18 under ORS chapter 731 to transact workers’ compensation insurance in this state or an assigned
19 claims agent selected by the director under ORS 656.054.

20 (15) “Consumer and Business Services Fund” means the fund created by ORS 705.145.

21 (16) “Invalid” means one who is physically or mentally incapacitated from earning a livelihood.

22 (17) “Medically stationary” means that no further material improvement would reasonably be
23 expected from medical treatment, or the passage of time.

24 (18) “Noncomplying employer” means a subject employer who has failed to comply with ORS
25 656.017.

26 (19) “Objective findings” in support of medical evidence are verifiable indications of injury or
27 disease that may include, but are not limited to, range of motion, atrophy, muscle strength and
28 palpable muscle spasm. “Objective findings” does not include physical findings or subjective re-
29 sponses to physical examinations that are not reproducible, measurable or observable.

30 (20) “Palliative care” means medical service rendered to reduce or moderate temporarily the
31 intensity of an otherwise stable medical condition, but does not include those medical services ren-
32 dered to diagnose, heal or permanently alleviate or eliminate a medical condition.

33 (21) “Party” means a claimant for compensation, the employer of the injured worker at the time
34 of injury and the insurer, if any, of such employer.

35 (22) “Payroll” means a record of wages payable to workers for their services and includes
36 commissions, value of exchange labor and the reasonable value of board, rent, housing, lodging or
37 similar advantage received from the employer. However, “payroll” does not include overtime pay,
38 vacation pay, bonus pay, tips, amounts payable under profit-sharing agreements or bonus payments
39 to reward workers for safe working practices. Bonus pay is limited to payments which are not an-
40 ticipated under the contract of employment and which are paid at the sole discretion of the em-
41 ployer. The exclusion from payroll of bonus payments to reward workers for safe working practices
42 is only for the purpose of calculations based on payroll to determine premium for workers’ com-
43 pensation insurance, and does not affect any other calculation or determination based on payroll for
44 the purposes of this chapter.

45 (23) “Person” includes partnership, joint venture, association, limited liability company and

18 (c) For the purposes of industrial injury claims, a condition does not contribute to disability or
19 need for treatment if the condition merely renders the worker more susceptible to the injury.

20 (25) "Self-insured employer" means an employer or group of employers certified under ORS
21 656.430 as meeting the qualifications set out by ORS 656.407.

22 (26) "State Accident Insurance Fund Corporation" and "corporation" mean the State Accident
23 Insurance Fund Corporation created under ORS 656.752.

24 (27) "Subject employer" means an employer who is subject to this chapter as provided by ORS
25 656.023.

26 (28) "Subject worker" means a worker who is subject to this chapter as provided by ORS
27 656.027.

28 (29) "Wages" means the money rate at which the service rendered is recompensed under the
29 contract of hiring in force at the time of the accident, including reasonable value of board, rent,
30 housing, lodging or similar advantage received from the employer, and includes the amount of tips
31 required to be reported by the employer pursuant to section 6053 of the Internal Revenue Code of
32 1954, as amended, and the regulations promulgated pursuant thereto, or the amount of actual tips
33 reported, whichever amount is greater. The State Accident Insurance Fund Corporation may estab-
34 lish assumed minimum and maximum wages, in conformity with recognized insurance principles, at
35 which any worker shall be carried upon the payroll of the employer for the purpose of determining
36 the premium of the employer.

37 (30) "Worker" means any person, including a minor whether lawfully or unlawfully employed,
38 who engages to furnish services for a remuneration, subject to the direction and control of an em-
39 ployer and includes salaried, elected and appointed officials of the state, state agencies, counties,
40 cities, school districts and other public corporations, but does not include any person whose services
41 are performed as an inmate or ward of a state institution or as part of the eligibility requirements
42 for a general or public assistance grant. For the purpose of determining entitlement to temporary

44 clude a person who has withdrawn from the workforce during the period for which such benefits are
