SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes name of State Board of Clinical Social Workers to State Board of Licensed Social Workers.

Provides for registration of social workers with baccalaureate degrees and for licensing of social workers with master's degrees. Provisions relating to registration of baccalaureate social workers and licensing of master's social workers become operative on January 1, 2011.

Exempts certain persons from licensure and certification requirements for practice of clinical social work.

Increases civil penalty for certain violations of social worker regulatory statutes from \$1,000 to \$3,000 per violation. Permits board to impose civil penalty of up to \$5,000 on certain persons who practice or present themselves as qualified to practice clinical social work without license or certificate. **Permits board to impose civil penalty of up to \$3,000 on certain persons who present themselves as regulated social workers or who use title "social worker" to indicate authorization to practice regulated social work.**

10 **breziations, including the title "social worker," that indicate that the person has an author-**

33 ministerial capacity and does not represent that the person is a regulated social worker; or

37 qualified and improper practice of social work, a regulated social worker whose authorization
38 to practice regulated social work has been revoked by the State Board of Licensed Social

41 (2) Represent that the person is a regulated social worker by using any title, words or
42 abbreviations that indicate that the person has an authorization to practice regulated social

45 has complied with the requirements of this section and has paid the fee under ORS 675.571,

23 bacco products or foods.

24 (b) "Facility" means a corporate or governmental entity or other provider of services for the
25 treatment of chemical dependency or for the treatment of mental or nervous conditions.

26 (c) "Group health insurer" means an insurer, a health maintenance organization or a health care
27 service contractor.

28 (d) "Program" means a particular type or level of service that is organizationally distinct within
29 a facility.

30 (e) "Provider" means a person that has met the credentialing requirement of a group health
31 insurer, is otherwise eligible to receive reimbursement for coverage under the policy and is:

32 (A) A health care facility;

33 (B) A residential program or facility;

34 (C) A day or partial hospitalization program;

35 (D) An outpatient service; or

36 (E) An individual behavioral health or medical professional authorized for reimbursement under
37 Oregon law.

38 (2) The coverage may be made subject to provisions of the policy that apply to other benefits
39 under the policy, including but not limited to provisions relating to deductibles and coinsurance.
40 Deductibles and coinsurance for treatment in health care facilities or residential programs or facil-
41 ities may not be greater than those under the policy for expenses of hospitalization in the treatment
42 of other medical conditions. Deductibles and coinsurance for outpatient treatment may not be
43 greater than those under the policy for expenses of outpatient treatment of other medical conditions.

44 (3) The coverage may not be made subject to treatment limitations, limits on total payments for
45 treatment, limits on duration of treatment or financial requirements unless similar limitations or

1 requirements are imposed on coverage of other medical conditions. The coverage of eligible expenses
2 may be limited to treatment that is medically necessary as determined under the policy for other
3 medical conditions.

4 (4)(a) Nothing in this section requires coverage for:

5 (A) Educational or correctional services or sheltered living provided by a school or halfway
6 house;

7 (B) A long-term residential mental health program that lasts longer than 45 days;

8 (C) Psychoanalysis or psychotherapy received as part of an educational or training program,
9 regardless of diagnosis or symptoms that may be present;

10 (D) A court-ordered sex offender treatment program; or

11 (E) A screening interview or treatment program under ORS 813.021.

12 (b) Notwithstanding paragraph (a)(A) of this subsection, an insured may receive covered outpa-
13 tient services under the terms of the insured's policy while the insured is living temporarily in a
14 sheltered living situation.

15 (5) A provider is eligible for reimbursement under this section if:

16 (a) The provider is approved by the Department of Human Services;

17 (b) The provider is accredited for the particular level of care for which reimbursement is being
18 requested by the Joint Commission on Accreditation of Hospitals or the Commission on Accredi-
19 tation of Rehabilitation Facilities;

20 (c) The patient is staying overnight at the facility and is involved in a structured program at
21 least eight hours per day, five days per week; or

22 (d) The provider is providing a covered benefit under the policy.

23 (6) Payments may not be made under this section for support groups.

24 (7) If specified in the policy, outpatient coverage may include follow-up in-home service or out-
25 patient services. The policy may limit coverage for in-home service to persons who are homebound
26 under the care of a physician.

27 (8) Nothing in this section prohibits a group health insurer from managing the provision of
28 benefits through common methods, including but not limited to selectively contracted panels, health
29 plan benefit differential designs, preadmission screening, prior authorization of services, utilization
30 review or other mechanisms designed to limit eligible expenses to those described in subsection (3)
31 of this section.

32 (9) The Legislative Assembly has found that health care cost containment is necessary and in-
33 tends to encourage insurance policies designed to achieve cost containment by ensuring that re-
34 imbursement is limited to appropriate utilization under criteria incorporated into such policies,
35 either directly or by reference.

36 (10)(a) Subject to the patient or client confidentiality provisions of ORS 40.235 relating to phy-
37 sicians, ORS 40.240 relating to nurse practitioners, ORS 40.230 relating to psychologists and ORS
38 40.250 and 675.580 relating to licensed clinical social workers, a group health insurer may provide
39 for review for level of treatment of admissions and continued stays for treatment in health care fa-
40 cilities, residential programs or facilities, day or partial hospitalization programs and outpatient
41 services by either group health insurer staff or personnel under contract to the group health insurer,
42 or by a utilization review contractor, who shall have the authority to certify for or deny level of
43 payment.

44 (b) Review shall be made according to criteria made available to providers in advance upon re-
45 quest.

1 (c) Review shall be performed by or under the direction of a medical or osteopathic physician
2 licensed by the Oregon Medical Board, a psychologist licensed by the State Board of Psychologist
3 Examiners or a clinical social worker licensed by the [*State Board of Clinical Social Workers,*] **State**
4 **Board of Licensed Social Workers**, in accordance with standards of the National Committee for
5 Quality Assurance or Medicare review standards of the Centers for Medicare and Medicaid Ser-
6 vices.

7 (d) Review may involve prior approval, concurrent review of the continuation of treatment,
8 post-treatment review or any combination of these. However, if prior approval is required, provision
9 shall be made to allow for payment of urgent or emergency admissions, subject to subsequent re-
10 view. If prior approval is not required, group health insurers shall permit providers, policyholders
11 or persons acting on their behalf to make advance inquiries regarding the appropriateness of a
12 particular admission to a treatment program. Group health insurers shall provide a timely response
13 to such inquiries. Noncontracting providers must cooperate with these procedures to the same ex-
14 tent as contracting providers to be eligible for reimbursement.

15 (11) Health maintenance organizations may limit the receipt of covered services by enrollees to
16 services provided by or upon referral by providers contracting with the health maintenance organ-
17 ization. Health maintenance organizations and health care service contractors may create substan-
18 tive plan benefit and reimbursement differentials at the same level as, and subject to limitations no
19 more restrictive than, those imposed on coverage or reimbursement of expenses arising out of other
20 medical conditions and apply them to contracting and noncontracting providers.

21 (12) Nothing in this section prevents a group health insurer from contracting with providers of
22 health care services to furnish services to policyholders or certificate holders according to ORS
23 743.531 or 750.005, subject to the following conditions:

24 (a) A group health insurer is not required to contract with all eligible providers.

25 (b) An insurer or health care service contractor shall, subject to subsections (2) and (3) of this
26 section, pay benefits toward the covered charges of noncontracting providers of services for the
27 treatment of chemical dependency or mental or nervous conditions. The insured shall, subject to
28 subsections (2) and (3) of this section, have the right to use the services of a noncontracting provider
29 of services for the treatment of chemical dependency or mental or nervous conditions, whether or
30 not the services for chemical dependency or mental or nervous conditions are provided by con-
31 tracting or noncontracting providers.

32 (13) The intent of the Legislative Assembly in adopting this section is to reserve benefits for
33 different types of care to encourage cost effective care and to ensure continuing access to levels
34 of care most appropriate for the insured's condition and progress.

35 (14) The Director of the Department of Consumer and Business Services, after notice and hear-
36 ing, may adopt reasonable rules not inconsistent with this section that are considered necessary for
37 the proper administration of these provisions.

38 **SECTION 48.** ORS 746.600 is amended to read:

39 746.600. As used in ORS 746.600 to 746.690:

40 (1)(a) "Adverse underwriting decision" means any of the following actions with respect to in-
41 surance transactions involving insurance coverage that is individually underwritten:

42 (A) A declination of insurance coverage.

43 (B) A termination of insurance coverage.

44 (C) Failure of an insurance producer to apply for insurance coverage with a specific insurer that
45 the insurance producer represents and that is requested by an applicant.

1 (D) In the case of life or health insurance coverage, an offer to insure at higher than standard
2 rates.

3 (E) In the case of insurance coverage other than life or health insurance coverage:

4 (i) Placement by an insurer or insurance producer of a risk with a residual market mechanism,
5 an unauthorized insurer or an insurer that specializes in substandard risks.

6 (ii) The charging of a higher rate on the basis of information that differs from that which the
7 applicant or policyholder furnished.

8 (iii) An increase in any charge imposed by the insurer for any personal insurance in connection
9 with the underwriting of insurance. For purposes of this sub-subparagraph, the imposition of a ser-
10 vice fee is not a charge.

11 (b) "Adverse underwriting decision" does not mean any of the following actions, but the insurer
12 or insurance producer responsible for the occurrence of the action must nevertheless provide the
13 applicant or policyholder with the specific reason or reasons for the occurrence:

14 (A) The termination of an individual policy form on a class or statewide basis.

15 (B) A declination of insurance coverage solely because the coverage is not available on a class
16 or statewide basis.

17 (C) The rescission of a policy.

18 (2) "Affiliate of" a specified person or "person affiliated with" a specified person means a person
19 who directly, or indirectly, through one or more intermediaries, controls, or is controlled by, or is
20 under common control with, the person specified.

21 (3) "Applicant" means a person who seeks to contract for insurance coverage, other than a
22 person seeking group insurance coverage that is not individually underwritten.

23 (4) "Consumer" means an individual, or the personal representative of the individual, who seeks
24 to obtain, obtains or has obtained one or more insurance products or services from a licensee that
25 are to be used primarily for personal, family or household purposes, and about whom the licensee
26 has personal information.

27 (5) "Consumer report" means any written, oral or other communication of information bearing
28 on a natural person's creditworthiness, credit standing, credit capacity, character, general reputa-
29 tion, personal characteristics or mode of living that is used or expected to be used in connection
30 with an insurance transaction.

31 (6) "Consumer reporting agency" means a person that, for monetary fees or dues, or on a co-
32 operative or nonprofit basis:

33 (a) Regularly engages, in whole or in part, in assembling or preparing consumer reports;

34 (b) Obtains information primarily from sources other than insurers; and

35 (c) Furnishes consumer reports to other persons.

36 (7) "Control" means, and the terms "controlled by" or "under common control with" refer to,
37 the possession, directly or indirectly, of the power to direct or cause the direction of the manage-
38 ment and policies of a person, whether through the ownership of voting securities, by contract other
39 than a commercial contract for goods or nonmanagement services, or otherwise, unless the power
40 of the person is the result of a corporate office held in, or an official position held with, the con-
41 trolled person.

42 (8) "Covered entity" means:

43 (a) A health insurer;

44 (b) A health care provider that transmits any health information in electronic form to carry out
45 financial or administrative activities in connection with a transaction covered by ORS 746.607 or

1 by rules adopted under ORS 746.608; or

2 (c) A health care clearinghouse.

3 (9) "Credit history" means any written or other communication of any information by a con-
4 sumer reporting agency that:

5 (a) Bears on a consumer's creditworthiness, credit standing or credit capacity; and

6 (b) Is used or expected to be used, or collected in whole or in part, as a factor in determining
7 eligibility, premiums or rates for personal insurance.

8 (10) "Customer" means a consumer who has a continuing relationship with a licensee under
9 which the licensee provides one or more insurance products or services to the consumer that are
10 to be used primarily for personal, family or household purposes.

11 (11) "Declination of insurance coverage" or "decline coverage" means a denial, in whole or in
12 part, by an insurer or insurance producer of an application for requested insurance coverage.

13 (12) "Health care" means care, services or supplies related to the health of an individual.

14 (13) "Health care operations" includes but is not limited to:

15 (a) Quality assessment, accreditation, auditing and improvement activities;

16 (b) Case management and care coordination;

17 (c) Reviewing the competence, qualifications or performance of health care providers or health
18 insurers;

19 (d) Underwriting activities;

20 (e) Arranging for legal services;

21 (f) Business planning;

22 (g) Customer services;

23 (h) Resolving internal grievances;

24 (i) Creating de-identified information; and

25 (j) Fundraising.

26 (14) "Health care provider" includes but is not limited to:

27 (a) A psychologist, occupational therapist, [*clinical*] **regulated** social worker, professional coun-
28 selor or marriage and family therapist licensed **or otherwise authorized to practice** under ORS
29 chapter 675 or an employee of the psychologist, occupational therapist, [*clinical*] **regulated** social
30 worker, professional counselor or marriage and family therapist;

31 (b) A physician, podiatric physician and surgeon, physician assistant or acupuncturist licensed
32 under ORS chapter 677 or an employee of the physician, podiatric physician and surgeon, physician
33 assistant or acupuncturist;

34 (c) A nurse or nursing home administrator licensed under ORS chapter 678 or an employee of
35 the nurse or nursing home administrator;

36 (d) A dentist licensed under ORS chapter 679 or an employee of the dentist;

37 (e) A dental hygienist or denturist licensed under ORS chapter 680 or an employee of the dental
38 hygienist or denturist;

39 (f) A speech-language pathologist or audiologist licensed under ORS chapter 681 or an employee
40 of the speech-language pathologist or audiologist;

41 (g) An emergency medical technician certified under ORS chapter 682;

42 (h) An optometrist licensed under ORS chapter 683 or an employee of the optometrist;

43 (i) A chiropractic physician licensed under ORS chapter 684 or an employee of the chiropractic
44 physician;

45 (j) A naturopathic physician licensed under ORS chapter 685 or an employee of the naturopathic

- 1 physician;
- 2 (k) A massage therapist licensed under ORS 687.011 to 687.250 or an employee of the massage
3 therapist;
- 4 (L) A direct entry midwife licensed under ORS 687.405 to 687.495 or an employee of the direct
5 entry midwife;
- 6 (m) A physical therapist licensed under ORS 688.010 to 688.201 or an employee of the physical
7 therapist;
- 8 (n) A radiologic technologist licensed under ORS 688.405 to 688.605 or an employee of the
9 radiologic technologist;
- 10 (o) A respiratory care practitioner licensed under ORS 688.800 to 688.840 or an employee of the
11 respiratory care practitioner;
- 12 (p) A pharmacist licensed under ORS chapter 689 or an employee of the pharmacist;
- 13 (q) A dietitian licensed under ORS 691.405 to 691.585 or an employee of the dietitian;
- 14 (r) A funeral service practitioner licensed under ORS chapter 692 or an employee of the funeral
15 service practitioner;
- 16 (s) A health care facility as defined in ORS 442.015;
- 17 (t) A home health agency as defined in ORS 443.005;
- 18 (u) A hospice program as defined in ORS 443.850;
- 19 (v) A clinical laboratory as defined in ORS 438.010;
- 20 (w) A pharmacy as defined in ORS 689.005;
- 21 (x) A diabetes self-management program as defined in ORS 743.694; and
- 22 (y) Any other person or entity that furnishes, bills for or is paid for health care in the normal
23 course of business.
- 24 (15) "Health information" means any oral or written information in any form or medium that:
- 25 (a) Is created or received by a covered entity, a public health authority, a life insurer, a school,
26 a university or a health care provider that is not a covered entity; and
- 27 (b) Relates to:
- 28 (A) The past, present or future physical or mental health or condition of an individual;
- 29 (B) The provision of health care to an individual; or
- 30 (C) The past, present or future payment for the provision of health care to an individual.
- 31 (16) "Health insurer" means:
- 32 (a) An insurer who offers:
- 33 (A) A health benefit plan as defined in ORS 743.730;
- 34 (B) A short term health insurance policy, the duration of which does not exceed six months in-
35 cluding renewals;
- 36 (C) A student health insurance policy;
- 37 (D) A Medicare supplemental policy; or
- 38 (E) A dental only policy.
- 39 (b) The Oregon Medical Insurance Pool operated by the Oregon Medical Insurance Pool Board
40 under ORS 735.600 to 735.650.
- 41 (17) "Homeowner insurance" means insurance for residential property consisting of a combina-
42 tion of property insurance and casualty insurance that provides coverage for the risks of owning
43 or occupying a dwelling and that is not intended to cover an owner's interest in rental property or
44 commercial exposures.
- 45 (18) "Individual" means a natural person who:

1 (a) In the case of life or health insurance, is a past, present or proposed principal insured or
2 certificate holder;

3 (b) In the case of other kinds of insurance, is a past, present or proposed named insured or
4 certificate holder;

5 (c) Is a past, present or proposed policyowner;

6 (d) Is a past or present applicant;

7 (e) Is a past or present claimant; or

8 (f) Derived, derives or is proposed to derive insurance coverage under an insurance policy or
9 certificate that is subject to ORS 746.600 to 746.690.

10 (19) "Individually identifiable health information" means any oral or written health information
11 that is:

12 (a) Created or received by a covered entity or a health care provider that is not a covered en-
13 tity; and

14 (b) Identifiable to an individual, including demographic information that identifies the individual,
15 or for which there is a reasonable basis to believe the information can be used to identify an indi-
16 vidual, and that relates to:

17 (A) The past, present or future physical or mental health or condition of an individual;

18 (B) The provision of health care to an individual; or

19 (C) The past, present or future payment for the provision of health care to an individual.

20 (20) "Institutional source" means a person or governmental entity that provides information
21 about an individual to an insurer, insurance producer or insurance-support organization, other than:

22 (a) An insurance producer;

23 (b) The individual who is the subject of the information; or

24 (c) A natural person acting in a personal capacity rather than in a business or professional ca-
25 pacity.

26 (21) "Insurance producer" or "producer" means a person licensed by the Director of the De-
27 partment of Consumer and Business Services as a resident or nonresident insurance producer.

28 (22) "Insurance score" means a number or rating that is derived from an algorithm, computer
29 application, model or other process that is based in whole or in part on credit history.

30 (23)(a) "Insurance-support organization" means a person who regularly engages, in whole or in
31 part, in assembling or collecting information about natural persons for the primary purpose of pro-
32 viding the information to an insurer or insurance producer for insurance transactions, including:

33 (A) The furnishing of consumer reports to an insurer or insurance producer for use in con-
34 nection with insurance transactions; and

35 (B) The collection of personal information from insurers, insurance producers or other
36 insurance-support organizations for the purpose of detecting or preventing fraud, material misrep-
37 resentation or material nondisclosure in connection with insurance underwriting or insurance claim
38 activity.

39 (b) "Insurance-support organization" does not mean insurers, insurance producers, governmental
40 institutions or health care providers.

41 (24) "Insurance transaction" means any transaction that involves insurance primarily for per-
42 sonal, family or household needs rather than business or professional needs and that entails:

43 (a) The determination of an individual's eligibility for an insurance coverage, benefit or payment;
44 or

45 (b) The servicing of an insurance application, policy or certificate.

1 (25) "Insurer" has the meaning given that term in ORS 731.106.

2 (26) "Investigative consumer report" means a consumer report, or portion of a consumer report,
3 for which information about a natural person's character, general reputation, personal character-
4 istics or mode of living is obtained through personal interviews with the person's neighbors, friends,
5 associates, acquaintances or others who may have knowledge concerning such items of information.

6 (27) "Licensee" means an insurer, insurance producer or other person authorized or required to
7 be authorized, or licensed or required to be licensed, pursuant to the Insurance Code.

8 (28) "Loss history report" means a report provided by, or a database maintained by, an
9 insurance-support organization or consumer reporting agency that contains information regarding
10 the claims history of the individual property that is the subject of the application for a homeowner
11 insurance policy or the consumer applying for a homeowner insurance policy.

12 (29) "Nonaffiliated third party" means any person except:

13 (a) An affiliate of a licensee;

14 (b) A person that is employed jointly by a licensee and by a person that is not an affiliate of the
15 licensee; and

16 (c) As designated by the director by rule.

17 (30) "Payment" includes but is not limited to:

18 (a) Efforts to obtain premiums or reimbursement;

19 (b) Determining eligibility or coverage;

20 (c) Billing activities;

21 (d) Claims management;

22 (e) Reviewing health care to determine medical necessity;

23 (f) Utilization review; and

24 (g) Disclosures to consumer reporting agencies.

25 (31)(a) "Personal financial information" means:

26 (A) Information that is identifiable with an individual, gathered in connection with an insurance
27 transaction from which judgments can be made about the individual's character, habits, avocations,
28 finances, occupations, general reputation, credit or any other personal characteristics; or

29 (B) An individual's name, address and policy number or similar form of access code for the in-
30 dividual's policy.

31 (b) "Personal financial information" does not mean information that a licensee has a reasonable
32 basis to believe is lawfully made available to the general public from federal, state or local gov-
33 ernment records, widely distributed media or disclosures to the public that are required by federal,
34 state or local law.

35 (32) "Personal information" means:

36 (a) Personal financial information;

37 (b) Individually identifiable health information; or

38 (c) Protected health information.

39 (33) "Personal insurance" means the following types of insurance products or services that are
40 to be used primarily for personal, family or household purposes:

41 (a) Private passenger automobile coverage;

42 (b) Homeowner, mobile homeowners, manufactured homeowners, condominium owners and
43 renters coverage;

44 (c) Personal dwelling property coverage;

45 (d) Personal liability and theft coverage, including excess personal liability and theft coverage;

1 and

2 (e) Personal inland marine coverage.

3 (34) "Personal representative" includes but is not limited to:

4 (a) A person appointed as a guardian under ORS 125.305, 419B.370, 419C.481 or 419C.555 with
5 authority to make medical and health care decisions;

6 (b) A person appointed as a health care representative under ORS 127.505 to 127.660 or 127.700
7 to 127.737 to make health care decisions or mental health treatment decisions;

8 (c) A person appointed as a personal representative under ORS chapter 113; and

9 (d) A person described in ORS 746.611.

10 (35) "Policyholder" means a person who:

11 (a) In the case of individual policies of life or health insurance, is a current policyowner;

12 (b) In the case of individual policies of other kinds of insurance, is currently a named insured;

13 or

14 (c) In the case of group policies of insurance under which coverage is individually underwritten,
15 is a current certificate holder.

16 (36) "Pretext interview" means an interview wherein the interviewer, in an attempt to obtain
17 personal information about a natural person, does one or more of the following:

18 (a) Pretends to be someone the interviewer is not.

19 (b) Pretends to represent a person the interviewer is not in fact representing.

20 (c) Misrepresents the true purpose of the interview.

21 (d) Refuses upon request to identify the interviewer.

22 (37) "Privileged information" means information that is identifiable with an individual and that:

23 (a) Relates to a claim for insurance benefits or a civil or criminal proceeding involving the in-
24 dividual; and

25 (b) Is collected in connection with or in reasonable anticipation of a claim for insurance benefits
26 or a civil or criminal proceeding involving the individual.

27 (38)(a) "Protected health information" means individually identifiable health information that is
28 transmitted or maintained in any form of electronic or other medium by a covered entity.

29 (b) "Protected health information" does not mean individually identifiable health information in:

30 (A) Education records covered by the federal Family Educational Rights and Privacy Act (20
31 U.S.C. 1232g);

32 (B) Records described at 20 U.S.C. 1232g(a)(4)(B)(iv); or

33 (C) Employment records held by a covered entity in its role as employer.

34 (39) "Residual market mechanism" means an association, organization or other entity involved
35 in the insuring of risks under ORS 735.005 to 735.145, 737.312 or other provisions of the Insurance
36 Code relating to insurance applicants who are unable to procure insurance through normal insur-
37 ance markets.

38 (40) "Termination of insurance coverage" or "termination of an insurance policy" means either
39 a cancellation or a nonrenewal of an insurance policy, in whole or in part, for any reason other than
40 the failure of a premium to be paid as required by the policy.

41 (41) "Treatment" includes but is not limited to:

42 (a) The provision, coordination or management of health care; and

43 (b) Consultations and referrals between health care providers.

44 **SECTION 49. (1) The amendments to ORS 675.590 by section 20 of this 2009 Act are in-**
45 **tended to change the name of the "State Board of Clinical Social Workers" to the "State**

1 **Board of Licensed Social Workers.”**

2 **(2) For the purpose of harmonizing and clarifying statute sections published in Oregon**
3 **Revised Statutes, the Legislative Counsel may substitute for words designating the “State**
4 **Board of Clinical Social Workers,” wherever they occur in Oregon Revised Statutes, other**
5 **words designating the “State Board of Licensed Social Workers.”**

6 **SECTION 50. Sections 4a, 6, 7, 12a and 12b of this 2009 Act and the amendments to ORS**
7 **675.510 and 675.530 by sections 2 and 9 of this 2009 Act become operative on January 1, 2011.**
