

# Senate Bill 210

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Attorney General Hardy Myers for Attorney General's Sexual Assault Task Force and Representative Sara Gelsler)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies definition of mentally incapacitated for purposes of certain criminal statutes.

## A BILL FOR AN ACT

1  
2 Relating to mental incapacitation; creating new provisions; and amending ORS 163.305.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 163.305 is amended to read:

5 163.305. As used in chapter 743, Oregon Laws 1971, unless the context requires otherwise:

6 (1) "Deviate sexual intercourse" means sexual conduct between persons consisting of contact  
7 between the sex organs of one person and the mouth or anus of another.

8 (2) "Forcible compulsion" means to compel by:

9 (a) Physical force; or

10 (b) A threat, express or implied, that places a person in fear of immediate or future death or  
11 physical injury to self or another person, or in fear that the person or another person will imme-  
12 diately or in the future be kidnapped.

13 (3) "Mentally defective" means that a person suffers from a mental disease or defect that ren-  
14 ders the person incapable of appraising the nature of the conduct of the person.

15 (4) "Mentally incapacitated" means that a person is rendered incapable of appraising or con-  
16 trolling the conduct of the person at the time of the alleged offense [*because of*] **as a result of ill-**  
17 **ness**, the influence of a controlled or other intoxicating substance [*administered to the person*  
18 *without the consent of the person or because of any other act committed upon the person without the*  
19 *consent of the person*] **or some other cause.**

20 (5) "Physically helpless" means that a person is unconscious or for any other reason is phys-  
21 ically unable to communicate unwillingness to an act.

22 (6) "Sexual contact" means any touching of the sexual or other intimate parts of a person or  
23 causing such person to touch the sexual or other intimate parts of the actor for the purpose of  
24 arousing or gratifying the sexual desire of either party.

25 (7) "Sexual intercourse" has its ordinary meaning and occurs upon any penetration, however  
26 slight; emission is not required.

27 **SECTION 2. The amendments to ORS 163.305 by section 1 of this 2009 Act apply to con-**  
28 **duct occurring on or after the effective date of this 2009 Act.**
