## Senate Bill 280

Sponsored by Senator COURTNEY (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** 

Increases maximum penalty for crime of participation in cockfighting to five years' imprisonment, \$125,000 fine, or both. Increases maximum penalty for crime of involvement in animal fighting to five years' imprisonment, \$125,000 fine, or both.

## A BILL FOR AN ACT

2 Relating to animal fighting; creating new provisions; and amending ORS 131.602, 167.355 and 167.431.

## **3 Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 167.431 is amended to read:

5 167.431. (1) A person commits the crime of participation in cockfighting if the person knowingly:

6 (a) Attends a cockfight or pays admission at any location to view or bet on a cockfight; or

7 (b) Manufactures, buys, sells, barters, exchanges, possesses, advertises or otherwise offers to sell 8 equipment with the intent that the equipment be used in training or handling a fighting bird or for 9 enhancing the fighting ability of a fighting bird. This paragraph does not apply to a gaff, slasher or 10 other sharp implement designed for attachment to a fighting bird.

11 (2) Participation in cockfighting is a Class [A misdemeanor] C felony.

12 **SECTION 2.** ORS 167.355 is amended to read:

13 167.355. (1) A person commits the crime of involvement in animal fighting if the person:

14 (a) Owns or trains an animal with the intention that the animal engage in an exhibition of 15 fighting;

(b) Promotes, conducts, participates in or is present as a spectator at an exhibition of fighting
 or preparations thereto;

(c) Keeps or uses, or in any way is connected with or interested in the management of, or receives money for the admission of any person to any place kept or used for the purpose of an exhibition of fighting; or

(d) Knowingly suffers or permits any place over which the person has possession or control to
 be occupied, kept or used for the purpose of an exhibition of fighting.

23 (2) For purposes of this section:

(a) "Animal" means any bird, reptile, amphibian, fish or nonhuman mammal, other than a dog
 or a fighting bird as defined in ORS 167.426.

(b) "Exhibition of fighting" means a public or private display of combat between two or more
animals in which the fighting, killing, maiming or injuring of animals is a significant feature. "Exhibition of fighting" does not include demonstrations of the hunting or tracking skills of an animal

29 or the lawful use of animals for hunting, tracking or self-protection.

30 (3) Involvement in animal fighting is a Class [A misdemeanor] C felony.
