SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Removes requirement to list names of relatives and members of household on statement of economic interest.]

Defines "candidate" for purposes relating to government ethics.

Modifies provisions relating to gifts for public officials, candidates and relatives of public officials and candidates.

Modifies provisions relating to reporting requirements for public officials and candidates. Prohibits Oregon Government Ethics Commission from penalizing person who acts in good faith reliance on staff advisory opinion or government ethics manual published by commission.

Delays requirement that commission develop electronic filing system until January 1, 2013.

Declares emergency, effective on passage.

6 Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 244.010 is amended to read:

8 244.010. (1) The Legislative Assembly declares that service as a public official is a public trust

9 and that, as one safeguard for that trust, the people require all public officials to comply with the10 applicable provisions of this chapter.

(2) The Legislative Assembly recognizes and values the work of all public officials,
 whether elected or appointed.

(3) The Legislative Assembly recognizes that many public officials are volunteers and
 serve without compensation.

[(2)] (4) The Legislative Assembly recognizes that it is the policy of the state to have serving on many state and local boards and commissions state and local officials who may have potentially conflicting public responsibilities by virtue of their positions as public officials and also as members of the boards and commissions, and declares it to be the policy of the state that the holding of such offices does not constitute the holding of incompatible offices unless expressly stated in the enabling legislation.

21 (5) The Legislative Assembly recognizes that public officials should put loyalty to the

1 highest ethical standards above loyalty to government, persons, political party or private 2 enterprise.

3 (6) The Legislative Assembly recognizes that public officials should not make private 4 promises that are binding upon the duties of a public official, because a public official has 5 no private word that can be binding on public duty.

6 (7) The Legislative Assembly recognizes that public officials should expose corruption 7 wherever discovered.

8 (8) The Legislative Assembly recognizes that public officials should uphold the principles
9 described in this section, ever conscious of the public's trust.

10 **SECTION 2.** ORS 244.020 is amended to read:

11 244.020. As used in this chapter, unless the context requires otherwise:

(1) "Actual conflict of interest" means any action or any decision or recommendation by a person acting in a capacity as a public official, the effect of which would be to the private pecuniary benefit or detriment of the person or the person's relative or any business with which the person or a relative of the person is associated unless the pecuniary benefit or detriment arises out of circumstances described in subsection [(11)] (12) of this section.

(2) "Business" means any corporation, partnership, proprietorship, firm, enterprise, franchise, association, organization, self-employed individual and any other legal entity operated for economic gain but excluding any income-producing not-for-profit corporation that is tax exempt under section 501(c) of the Internal Revenue Code with which a public official or a relative of the public official is associated only as a member or board director or in a nonremunerative capacity.

(3) "Business with which the person is associated" means:

(a) Any private business or closely held corporation of which the person or the person's relative
is a director, officer, owner or employee, or agent or any private business or closely held corporation in which the person or the person's relative owns or has owned stock, another form of equity
interest, stock options or debt instruments worth \$1,000 or more at any point in the preceding calendar year;

(b) Any publicly held corporation in which the person or the person's relative owns or has
owned \$100,000 or more in stock or another form of equity interest, stock options or debt instruments at any point in the preceding calendar year;

(c) Any publicly held corporation of which the person or the person's relative is a director or
 officer; or

(d) For public officials required to file a statement of economic interest under ORS 244.050, any
 business listed as a source of income as required under ORS 244.060 (3).

(4) "Candidate" means an individual for whom a declaration of candidacy, nominating petition or certificate of nomination to public office has been filed or whose name is printed on a ballot or is expected to be or has been presented, with the individual's consent, for nomination or election to public office.

[(4)] (5) "Development commission" means any entity [which] that has the authority to purchase,
develop, improve or lease land or the authority to operate or direct the use of land. This authority
must be more than ministerial.

42 [(5)(a)] (6)(a) "Gift" means something of economic value given to a public official, a candidate
 43 or a relative or member of the household of the public official or candidate:

(A) Without valuable consideration of equivalent value, including the full or partial forgiveness
 of indebtedness, which is not extended to others who are not public officials or candidates or the

relatives or members of the household of public officials or candidates on the same terms and
 conditions; or

3 (B) For valuable consideration less than that required from others who are not public officials
4 or candidates.

5 (b) "Gift" does not mean:

(B) Gifts from relatives or members of the household of the public official or candidate.

10 (D) Informational material, publications or subscriptions related to the recipient's performance 11 of official duties.

(E) Admission provided to or the cost of food or beverage consumed by a public official, or a member of the household or staff of the public official when accompanying the public official, at a reception, meal or meeting held by an organization [before whom the public official appears to speak or to answer questions as part of a scheduled program] when the public official represents state government as defined in ORS 174.111, a local government as defined in ORS 174.116 or a special government body as defined in ORS 174.117.

18 (F) Reasonable expenses paid by any unit of the federal government, a state or local government, 19 a Native American tribe that is recognized by federal law or formally acknowledged by a state, a 20membership organization to which a public body as defined in ORS 174.109 pays membership dues or a not-for-profit corporation that is tax exempt under section 501(c)(3) of the Internal Revenue 2122Code [and that receives less than five percent of its funding from for-profit organizations or entities], 23for attendance at a convention, fact-finding mission or trip, or other meeting if the public official is 24scheduled to deliver a speech, make a presentation, participate on a panel or represent state gov-25ernment as defined in ORS 174.111, a local government as defined in ORS 174.116 or a special government body as defined in ORS 174.117. 26

(H) Reasonable food, travel or lodging expenses provided to a public official, a relative of the public official accompanying the public official, a member of the household of the public official accompanying the public official or a staff member of the public official accompanying the public official, when the public official is representing state government as defined in ORS 174.111, a local government as defined in ORS 174.116 or a special government body as defined in ORS 174.117:

(ii) In officially designated negotiations, or economic development activities, where receipt of the
 expenses is approved in advance.

(I) Food or beverage consumed by a public official acting in an official capacity:

(i) In association with the review, approval, execution of documents or closing of a borrowing,
investment or other financial transaction, including any business agreement between state government as defined in ORS 174.111, a local government as defined in ORS 174.116 or a special government body as defined in ORS 174.117 and a private entity or public body as defined in ORS 174.109;
(ii) While engaged in due diligence research or presentations by the office of the State Treasurer
related to an existing or proposed investment or borrowing; or

(iii) While engaged in a meeting of an advisory, governance or policy-making body of a corpo ration, partnership or other entity in which the office of the State Treasurer has invested moneys.

1 (J) Waiver or discount of registration expenses or materials provided to a public official or 2 candidate at a continuing education event that the public official or candidate may attend to sat-

3 isfy a professional licensing requirement.

4 (K) Expenses provided by one public official to another public official for travel inside this state 5 to or from an event that bears a relationship to the receiving public official's office and at which 6 the official participates in an official capacity.

7 (L) Food or beverage consumed by a public official **or candidate** at a reception where the food 8 or beverage is provided as an incidental part of the reception and no cost is placed on the food or 9 beverage.

10 (M) Entertainment provided to a public official **or candidate** or a relative or member of the 11 household of the public official **or candidate** that is incidental to the main purpose of another event.

(N) Entertainment provided to a public official or a relative or member of the household of the public official where the public official is acting in an official capacity while representing state government as defined in ORS 174.111, a local government as defined in ORS 174.116 or a special government body as defined in ORS 174.117 for a ceremonial purpose.

(0) Anything of economic value offered to or solicited or received by a public official or
 candidate, or a relative or member of the household of the public official or candidate:

(i) As part of the usual and customary practice of the person's private business, or the
 person's employment or position as a volunteer with a private business, corporation, part nership, proprietorship, firm, enterprise, franchise, association, organization, not-for-profit
 corporation or other legal entity operated for economic value; and

(ii) That bears no relationship to the public official's or candidate's holding of, or candi dacy for, the official position or public office.

[(6)] (7) "Honorarium" means a payment or something of economic value given to a public official in exchange for services upon which custom or propriety prevents the setting of a price. Services include, but are not limited to, speeches or other services rendered in connection with an event.

[(7)] (8) "Income" means income of any nature derived from any source, including, but not limited to, any salary, wage, advance, payment, dividend, interest, rent, honorarium, return of capital,
forgiveness of indebtedness, or anything of economic value.

31 [(8)] (9) "Legislative or administrative interest" means an economic interest, distinct from that 32 of the general public, in [one or more bills, resolutions, regulations, proposals or other matters subject 33 to the action or vote of a person acting in the capacity of a public official.]:

(a) Any matter subject to the decision or vote of the public official acting in the public
 official's capacity as a public official; or

36 (b) Any matter that would be subject to the decision or vote of the candidate who, if 37 elected, would be acting in the capacity of a public official.

(9) (10) "Member of the household" means any person who resides with the public official or
 candidate.

40 [(10)] (11) "Planning commission" means a county planning commission created under ORS

42 [(11)] (12) "Potential conflict of interest" means any action or any decision or recommendation 43 by a person acting in a capacity as a public official, the effect of which could be to the private 44 pecuniary benefit or detriment of the person or the person's relative, or a business with which the 45 person or the person's relative is associated, unless the pecuniary benefit or detriment arises out 1 of the following:

2 (a) An interest or membership in a particular business, industry, occupation or other class re-3 quired by law as a prerequisite to the holding by the person of the office or position.

4 (b) Any action in the person's official capacity which would affect to the same degree a class 5 consisting of all inhabitants of the state, or a smaller class consisting of an industry, occupation or 6 other group including one of which or in which the person, or the person's relative or business with 7 which the person or the person's relative is associated, is a member or is engaged.

8 (c) Membership in or membership on the board of directors of a nonprofit corporation that is 9 tax-exempt under section 501(c) of the Internal Revenue Code.

10 [(12)] (13) "Public office" has the meaning given that term in ORS 260.005.

[(13)] (14) "Public official" means any person who, when an alleged violation of this chapter occurs, is serving the State of Oregon or any of its political subdivisions or any other public body as defined in ORS 174.109 as an elected official, appointed official, employee[,] or agent [or otherwise], irrespective of whether the person is compensated for the services.

15 [(14)] (15) "Relative" means:

16 (a) The spouse of the public official **or candidate**;

17 (b) The domestic partner of the public official **or candidate**;

36 **SECTION 3.** ORS 244.025 is amended to read:

244.025. (1) During a calendar year, a public official, a candidate [for public office] or a relative or member of the household of the public official or candidate may not solicit or receive, directly or indirectly, any gift or gifts with an aggregate value in excess of \$50 from any single source that could reasonably be known to have a legislative or administrative interest [in any governmental agency in which the public official holds, or the candidate if elected would hold, any official position or over which the public official exercises, or the candidate if elected would exercise, any authority].

(2) During a calendar year, a person who has a legislative or administrative interest [in any
governmental agency in which a public official holds any official position or over which the public of
ficial exercises any authority] may not offer to the public official or a relative or member of the

1 household of the public official any gift or gifts with an aggregate value in excess of \$50.

(3) During a calendar year, a person who has a legislative or administrative interest [in any governmental agency in which a candidate for public office if elected would hold any official position
or over which the candidate if elected would exercise any authority] may not offer to the candidate
or a relative or member of the household of the candidate any gift or gifts with an aggregate value
in excess of \$50.

[(4) Notwithstanding subsection (1) of this section:]

SECTION 4. ORS 244.040 is amended to read:

25 244.040. (1) Except as provided in subsection (2) of this section, a public official may not use or 26 attempt to use official position or office to obtain financial gain or avoidance of financial detriment 27 for the public official, a relative or member of the household of the public official, or any business 28 with which the public official or a relative or member of the household of the public official is as-29 sociated, if the financial gain or avoidance of financial detriment would not otherwise be available 30 but for the public official's holding of the official position or office.

through the use of confidential information gained in the course of or by reason of holding position

personal gain of any person through the use of confidential information gained in the course of or
by reason of holding position as a public official or the activities of the person as a public official.

(6) A person may not attempt to represent or represent a client for a fee before the governing
body of a public body of which the person is a member. This subsection does not apply to the person's employer, business partner or other associate.

(7) The provisions of this section apply regardless of whether actual conflicts of interest or po tential conflicts of interest are announced or disclosed under ORS 244.120.

If the public official or candidate fails to comply by the date set by the 14 15commission, the commission may impose a civil penalty as provided in ORS 244.350.

244.060. The statement of economic interest filed under ORS 244.050 shall be on a form pre-17 scribed by the Oregon Government Ethics Commission. The public official or candidate [for public 18 office] filing the statement shall supply the information required by this section and ORS 244.090, 19 20as follows:

(1) The names of all positions as officer of a business and business directorships held by the 2122[person] public official or candidate or a member of the household of the [person] public official 23or candidate during the preceding calendar year, and the principal address and a brief description of each business. 24

25(2) All names under which the *[person]* public official or candidate and members of the household of the [person] public official or candidate do business and the principal address and a brief 2627description of each business.

The member shall provide the notice not later than three business days after the member becomes aware of the possibility of an actual or potential conflict.

(3) Subsection (2) of this section does not apply if the pecuniary benefit or detriment arises out

(4) Complaints of violations of this section may be made to the Oregon Government Ethics

SECTION 20. ORS 441.540 is amended to read:

441.540. (1) An authority shall be managed and controlled by a board of directors, who shall be appointed by the governing body. The directors may be removed for cause or at the will of the governing body. The directors shall serve without compensation. However, the authority may reimburse the directors for their expenses incurred in the performance of their duties.

(2) The board of directors shall adopt and may amend rules for calling and conducting its meetings and carrying out its business and may adopt an official seal.
