

# A-Engrossed Senate Bill 46

Ordered by the Senate February 5  
Including Senate Amendments dated February 5

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Education and General Government)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Allows Department of Education to require fingerprints of all new hires of school districts or private schools. Removes outdated provision related to fingerprinting of employees of districts or private schools.

Requires department to determine whether person knowingly made false statement on *[employment application regarding conviction of crime]* **criminal history form provided by Department of Education**. Allows school districts and private schools to have discretion to hire person who knowingly made false statement.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

1  
2 Relating to background checks for schools; creating new provisions; amending ORS 326.603 and  
3 342.232; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 326.603 is amended to read:

6 326.603. (1) For the purposes of requesting a state or nationwide criminal records check under  
7 ORS 181.534, the Department of Education may require the fingerprints of:

8 (a) A school district or private school contractor, whether part-time or full-time, or an employee  
9 *[thereof]* **of a contractor**, whether part-time or full-time, who has direct, unsupervised contact with  
10 students as determined by the district or private school.

11 (b) A person newly hired, whether part-time or full-time, by a school district or private school  
12 in a capacity not described in ORS 342.223 (1). *[who has direct, unsupervised contact with children*  
13 *as determined by the district or private school.]*

14 *[(c) A person employed, whether part-time or full-time, by a school district or private school in a*  
15 *capacity not described in ORS 342.223 (1) who has direct, unsupervised contact with children as de-*  
16 *termined by the district or private school.]*

17 *[(d)]* (c) A person who is a community college faculty member providing instruction at a  
18 kindergarten through grade 12 school site during the regular school day.

19 *[(e)]* (d) A person who is an employee of a public charter school.

20 (2)(a) A school district shall send to the Department of Education for purposes of a criminal  
21 records check any information, including fingerprints, for each person described in subsection (1)  
22 of this section.

23 (b) A private school may send to the Department of Education for purposes of a criminal records

1 check any information, including fingerprints, for each person described in subsection (1)(a), (b),  
2 **or** (c) [*or (d)*] of this section.

3 (3) The Department of Education shall request that the Department of State Police conduct a  
4 criminal records check as provided in ORS 181.534 and may charge the **school** district or private  
5 school a fee as established by rule under ORS 181.534. The school district or private school may  
6 recover its costs or a portion thereof from the person described in subsection (1) of this section. If  
7 the person described in subsection (1)(b), (c) *or* (e) **or** (d) of this section requests, the **school** dis-  
8 trict shall and a private school may withhold the amount from amounts otherwise due the person,  
9 including a periodic payroll deduction rather than a lump sum payment.

10 (4) Notwithstanding subsection (1) of this section, the Department of **Education** may not require  
11 fingerprints of a person described in subsection (1) of this section if the person or the person's em-  
12 ployer was checked in one school district or private school and is currently seeking to work in an-  
13 other district or private school unless the person lived outside this state during the interval between  
14 the two periods of time of working in the district or private school.

15 (5) Nothing in this section requires a person described in subsection (1)(a), (b) or [(e)] (d) of this  
16 section to submit to fingerprinting until the person has been offered employment or a contract by  
17 a school district or private school. Contractor employees may not be required to submit to finger-  
18 printing until the contractor has been offered a contract.

19 [(6)(a) *If the Superintendent of Public Instruction informs the school district that the person has*  
20 *been convicted of a crime listed in ORS 342.143 or has made a false statement as to the conviction of*  
21 *a crime, the superintendent shall notify the school district of the fact and the district shall not employ*  
22 *or contract with the person. Notification by the superintendent that the school district shall not employ*  
23 *or contract with the person shall remove the person from any school district policies, collective bar-*  
24 *gaining provisions regarding dismissal procedures and appeals and the provisions of ORS 342.805 to*  
25 *342.937.*]

26 [(b) *The Superintendent of Public Instruction shall notify the private school if the person has been*  
27 *convicted of a crime listed in ORS 342.143 or has made a false statement as to the conviction of a*  
28 *crime. Based on the notice, the private school may choose not to employ or contract with the person.*]

29 **(6) If a person described in subsection (1) of this section states on a criminal history form**  
30 **provided by the Department of Education that the person has not been convicted of a crime**  
31 **but the criminal records check indicates that the person has a conviction, the department**  
32 **shall determine whether the person knowingly made a false statement as to the conviction.**  
33 **The department shall develop a process and criteria to use for appeals of a determination**  
34 **under this subsection.**

35 **(7)(a) The Superintendent of Public Instruction shall inform a school district or private**  
36 **school if a person described in subsection (1) of this section has been convicted of a crime**  
37 **listed in ORS 342.143 (3) or has knowingly made a false statement on a criminal history form**  
38 **provided by the Department of Education as to the conviction of any crime.**

39 **(b) If a person described in subsection (1) of this section has been convicted of a crime**  
40 **listed in ORS 342.143 (3), a school district may not employ or contract with the person and**  
41 **a private school may choose not to employ or contract with the person. Notification by the**  
42 **superintendent that the school district may not employ or contract with the person shall**  
43 **remove the person from any school district policies, collective bargaining provisions regard-**  
44 **ing dismissal procedures and appeals and the provisions of ORS 342.805 to 342.937.**

45 **(c) If a person described in subsection (1) of this section has knowingly made a false**

1 **statement on a criminal history form provided by the Department of Education as to the**  
2 **conviction of a crime not listed in ORS 342.143 (3), a school district or private school may**  
3 **choose to employ or contract with the person.**

4 [(7)] (8) If a person described in subsection (1) of this section refuses to consent to the criminal  
5 records check or refuses to be fingerprinted [*or if the person falsely swears to the nonconviction of*  
6 *a crime*], the **school** district shall terminate the employment or contract status of the person. Ter-  
7 mination under this subsection removes the person from any school district policies, collective bar-  
8 gaining provisions regarding dismissal procedures and appeals and the provisions of ORS 342.805 to  
9 342.937.

10 [(8)] (9) A school district may not hire or continue to employ or contract with or allow the  
11 contractor to continue to assign a person to the school project if the person described in subsection  
12 (1) of this section has been convicted of a crime according to the provisions of ORS 342.143.

13 [(9)] (10) As used in this section and ORS 326.607:

14 (a) "Private school" means a school that provides educational services as defined in ORS 345.505  
15 and is registered as a private school under ORS 345.505 to 345.575.

16 (b) "School district" means:

17 (A) A school district as defined in ORS 330.003.

18 (B) The Oregon School for the Blind.

19 (C) The Oregon School for the Deaf.

20 (D) An educational program under the Youth Corrections Education Program.

21 (E) A public charter school as defined in ORS 338.005.

22 (F) An education service district.

23 **SECTION 2.** ORS 342.232 is amended to read:

24 342.232. (1) A school district, education service district, private school or public charter school  
25 may authorize a person described under ORS 326.603 (1)(a), (c) **or** (d) [*or (e)*] to begin carrying out  
26 the terms of a contract pending the return of a state or nationwide criminal records check.

27 (2) A school district, education service district, private school or public charter school may hire  
28 on a probationary basis a person described under ORS 326.603 (1)(b) or [*(e)*] (d) pending the return  
29 of the criminal records check.

30 **SECTION 3.** (1) **The amendments to ORS 326.603 (1) by section 1 of this 2009 Act that**  
31 **relate to fingerprints apply to persons hired on or after the effective date of this 2009 Act.**

32 (2) **The provisions of ORS 326.603 (6) and (7) that relate to false statements on a criminal**  
33 **history form provided by the Department of Education apply to persons for whom a criminal**  
34 **records check is conducted on or after the effective date of this 2009 Act.**

35 **SECTION 4.** **This 2009 Act being necessary for the immediate preservation of the public**  
36 **peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect**  
37 **on its passage.**

38
