SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Sets [*uniform*] deadline of 180 days for notices of claim made on contractor's payment bond in connection with work performed on public contract. **Sets deadline of 200 days for notices of claim for required contribution to fund of employee benefit plan.**

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to deadlines for notices of claim on contractor's payment bonds; creating new provisions;
3 amending ORS 279C.605; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 279C.605 is amended to read:

6 279C.605. (1) The notice of claim required by ORS 279C.600 must be sent by registered or cer-
7 tified mail or hand delivered no later than [*120*] **180** days after the day the person last provided labor
8 or furnished materials or [*120*] **180** days after the worker listed in the notice of claim by the Com-
9 missioner of the Bureau of Labor and Industries last provided labor. The notice may be sent or de-
10 livered to the contractor or subcontractor at any place the contractor or subcontractor maintains
11 an office or conducts business or at the residence of the contractor or subcontractor.

12 (2) Notwithstanding subsection (1) of this section, if the claim is for a required contribution to
13 a fund of [*any*] **an** employee benefit plan, the notice required by ORS 279C.600 must be sent or de-
14 livered within [*150*] **200** days after the employee last provided labor or materials.

15 (3) The notice must be in writing substantially as follows:

7 (4) When notice of claim is given by the commissioner and if the claim includes a worker who
8 is then unidentified, the commissioner shall include in the notice a statement that the claim includes
9 an unidentified worker for whom the commissioner has received information indicating that the
10 worker has not been paid in full at the prevailing rate of wage required by ORS 279C.840 or over-
11 time wages required by ORS 279C.540.

12 (5) The person making the claim or giving the notice shall sign the notice.

13 **SECTION 2. The amendments to ORS 279C.605 by section 1 of this 2009 Act apply to no-**
14 **tices of claim sent in connection with public contracts first advertised or, if not advertised,**
15 **entered into on or after the effective date of this 2009 Act.**

16 **SECTION 3. This 2009 Act being necessary for the immediate preservation of the public**
17 **peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect**
18 **on its passage.**
