SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Columbia River Gorge Commission for biennial expenses.

Appropriates moneys from General Fund to Emergency Board for biennial operating expenses of commission. Specifies that funds are to be allocated to commission and that any funds not allocated to commission by December 1, 2010, are available for use by board.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and federal funds for contract services, but excluding lottery funds and other federal funds, collected or received by commission.

Declares emergency, effective July 1, 2009.

A BILL FOR AN ACT

- Relating to financial administration of the Columbia River Gorge Commission; appropriating money; limiting expenditures; and declaring an emergency.
 - Be It Enacted by the People of the State of Oregon:
- SECTION 1. There are appropriated to the Columbia River Gorge Commission, for the biennium beginning July 1, 2009, out of the General Fund, the following amounts for the following purposes:
- 8 (1) Joint operating program...... \$ 837,777
- 9 (2) Commissioner expenses \$ 23,223
 - SECTION 2. (1) In addition to and not in lieu of any other appropriation, there is appropriated to the Emergency Board, for the biennium beginning July 1, 2009, out of the General Fund, the amount of \$25,000, to be allocated to the Columbia River Gorge Commission for operating expenses.
 - (2) If any of the moneys appropriated by subsection (1) of this section are not allocated by the Emergency Board prior to December 1, 2010, the moneys remaining on that date become available for any purpose for which the Emergency Board lawfully may allocate funds.
 - SECTION 3. Notwithstanding any other law limiting expenditures, the amount of \$73,030 is established for the biennium beginning July 1, 2009, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and including federal funds for contract services, but excluding lottery funds and federal funds not described in this section, collected or received by the Columbia River Gorge Commission for the joint operating program.
 - SECTION 4. This 2009 Act being necessary for the immediate preservation of the public
