SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Board of Examiners of Licensed Dietitians, State Mortuary and Cemetery Board, Board of Naturopathic Examiners, Occupational Therapy Licensing Board, Board of Radiologic Technology, State Board of Examiners for Speech-Language Pathology and Audiology and Oregon State Veterinary Medical Examining Board.

Increases for biennium ending June 30, 2009, limitation on expenditures for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, for Board of Examiners of Licensed Dietitians, Board of Naturopathic Examiners, Board of Radiologic Technology, State Board of Examiners for Speech-Language Pathology and Audiology and Oregon State Veterinary Medical Examining Board.

Declares emergency, effective [*July 1, 2009*] **on passage.**

A BILL FOR AN ACT

2 Relating to financial administration of specified boards; limiting expenditures; and declaring an
3 emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Notwithstanding any other law limiting expenditures, the amount of \$81,866**
6 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
7 **expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
8 **cluding lottery funds and federal funds, collected or received by the Board of Examiners of**
9 **Licensed Dietitians.**

10 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**
11 **\$1,312,966 is established for the biennium beginning July 1, 2009, as the maximum limit for**
12 **payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,**
13 **but excluding lottery funds and federal funds, collected or received by the State Mortuary**
14 **and Cemetery Board.**

15 **SECTION 3. Notwithstanding any other law limiting expenditures, the amount of \$529,869**
16 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
17 **expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
18 **cluding lottery funds and federal funds, collected or received by the Board of Naturopathic**
19 **Examiners.**

20 **SECTION 4. Notwithstanding any other law limiting expenditures, the amount of \$361,756**
21 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**

1 expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-
2 cluding lottery funds and federal funds, collected or received by the Occupational Therapy
3 Licensing Board.

4 **SECTION 5.** Notwithstanding any other law limiting expenditures, the amount of \$659,071
5 is established for the biennium beginning July 1, 2009, as the maximum limit for payment of
6 expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-
7 cluding lottery funds and federal funds, collected or received by the Board of Radiologic
8 Technology.

9 **SECTION 6.** Notwithstanding any other law limiting expenditures, the amount of \$338,982
10 is established for the biennium beginning July 1, 2009, as the maximum limit for payment of
11 expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-
12 cluding lottery funds and federal funds, collected or received by the State Board of Examin-
13 ers for Speech-Language Pathology and Audiology.

14 **SECTION 7.** Notwithstanding any other law limiting expenditures, the amount of \$691,999
15 is established for the biennium beginning July 1, 2009, as the maximum limit for payment of
16 expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-
17 cluding lottery funds and federal funds, collected or received by the Oregon State Veterinary
18 Medical Examining Board.

19 **SECTION 8.** Notwithstanding any other law limiting expenditures of the Board of Exam-
20 iners of Licensed Dietitians for the payment of expenses of the board from fees, moneys or
21 other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal
22 funds, for the biennium ending June 30, 2009, the limitation on expenditures for the Board
23 of Examiners of Licensed Dietitians established by section 1, chapter 262, Oregon Laws 2007,
24 as modified by Emergency Board action or the Legislative Assembly in special session, is
25 increased by \$2,729.

26 **SECTION 9.** Notwithstanding any other law limiting expenditures of the Board of
27 Naturopathic Examiners for the payment of expenses of the board from fees, moneys or
28 other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal
29 funds, for the biennium ending June 30, 2009, the limitation on expenditures for the Board
30 of Naturopathic Examiners established by section 3, chapter 262, Oregon Laws 2007, as
31 modified by Emergency Board action or the Legislative Assembly in special session, is in-
32 creased by \$55,000.

33 **SECTION 10.** Notwithstanding any other law limiting expenditures of the Board of
34 Radiologic Technology for the payment of expenses of the board from fees, moneys or other
35 revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, for
36 the biennium ending June 30, 2009, the limitation on expenditures for the Board of Radiologic
37 Technology established by section 6, chapter 262, Oregon Laws 2007, as modified by Emer-
38 gency Board action or the Legislative Assembly in special session, is increased by \$39,689.

39 **SECTION 11.** Notwithstanding any other law limiting expenditures of the State Board of
40 Examiners for Speech-Language Pathology and Audiology for the payment of expenses of the
41 board from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding
42 lottery funds and federal funds, for the biennium ending June 30, 2009, the limitation on
43 expenditures for the State Board of Examiners for Speech-Language Pathology and Audiology
44 established by section 7, chapter 262, Oregon Laws 2007, as modified by Emergency Board
45 action or the Legislative Assembly in special session, is increased by \$4,785.
