

Senate Bill 5527

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Budget and Management Division, Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Board of Examiners of Licensed Dietitians, State Mortuary and Cemetery Board, Board of Naturopathic Examiners, Occupational Therapy Licensing Board, Board of Radiologic Technology, State Board of Examiners for Speech-Language Pathology and Audiology and Oregon State Veterinary Medical Examining Board. Declares emergency, effective July 1, 2009.

2 Relating to financial administration of specified boards; limiting expenditures; and declaring an
3 emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Notwithstanding any other law limiting expenditures, the amount of \$78,971**
6 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
7 **expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
8 **cluding lottery funds and federal funds, collected or received by the Board of Examiners of**
9 **Licensed Dietitians.**

10 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**
11 **\$1,307,972 is established for the biennium beginning July 1, 2009, as the maximum limit for**
12 **payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,**
13 **but excluding lottery funds and federal funds, collected or received by the State Mortuary**
14 **and Cemetery Board.**

15 **SECTION 3. Notwithstanding any other law limiting expenditures, the amount of \$510,646**
16 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
17 **expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
18 **cluding lottery funds and federal funds, collected or received by the Board of Naturopathic**
19 **Examiners.**

20 **SECTION 4. Notwithstanding any other law limiting expenditures, the amount of \$360,241**
21 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
22 **expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
23 **cluding lottery funds and federal funds, collected or received by the Occupational Therapy**
24 **Licensing Board.**

25 **SECTION 5. Notwithstanding any other law limiting expenditures, the amount of \$894,165**
26 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
27 **expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
28 **cluding lottery funds and federal funds, collected or received by the Board of Radiologic**

1 **Technology.**

2 **SECTION 6. Notwithstanding any other law limiting expenditures, the amount of \$333,907**
3 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
4 **expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
5 **cluding lottery funds and federal funds, collected or received by the State Board of Examin-**
6 **ers for Speech-Language Pathology and Audiology.**

7 **SECTION 7. Notwithstanding any other law limiting expenditures, the amount of \$688,198**
8 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
9 **expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
10 **cluding lottery funds and federal funds, collected or received by the Oregon State Veterinary**
11 **Medical Examining Board.**

12 **SECTION 8. This 2009 Act being necessary for the immediate preservation of the public**
13 **peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect**
14 **July 1, 2009.**

15
