

Senate Bill 62

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of State Treasurer Randall Edwards)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Revises provisions governing investment of moneys by State Treasurer. Creates Oregon Short Term Fund.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 293.701 is amended to read:

12 293.701. As used in ORS 293.701 to 293.820, unless the context requires otherwise:

13 (1) "Council" means the Oregon Investment Council.

14 [(2) "*Investment funds*" means:]

15 [(a) *Public Employees Retirement Fund referred to in ORS 238.660;*]

16 [(b) *Industrial Accident Fund referred to in ORS 656.632;*]

17 [(c) *Consumer and Business Services Fund referred to in ORS 705.145;*]

18 [(d) *Employment Department Special Administrative Fund referred to in ORS 657.822;*]

19 [(e) *Insurance Fund referred to in ORS 278.425;*]

20 [(f) *Funds under the control and administration of the Department of State Lands;*]

21 [(g) *Oregon Student Assistance Fund referred to in ORS 348.570;*]

22 [(h) *Moneys made available to the Commission for the Blind under ORS 346.270 and 346.540 or*
23 *rules adopted thereunder;*]

13 **(2) “Investment moneys” means moneys invested by the State Treasurer under ORS**
 14 **293.701 to 293.820.**

15 (3) “Investment officer” means the State Treasurer in the capacity as investment officer for the
 16 council.

17 **SECTION 2. Sections 3 and 4 of this 2009 Act are added to and made a part of ORS 293.701**
 18 **to 293.820.**

19 **SECTION 3. When investing moneys under ORS 293.701 to 293.820, the State Treasurer**
 20 **may:**

21 (1) **Subject to ORS 293.723, invest moneys separately or on a commingled basis with other**
 22 **investment moneys, in individual or commingled investment vehicles, including the Oregon**
 23 **Short Term Fund established under section 4 of this 2009 Act; and**

24 (2) **Subject to federal law and ORS 293.726, purchase debt obligations issued by the State**
 25 **of Oregon without the obligations being cancelled or extinguished.**

26 **SECTION 4. (1) The Oregon Short Term Fund is established in the State Treasury as a**
 27 **commingled investment vehicle for the moneys described in subsection (2) of this section.**
 28 **Interest earned by the Oregon Short Term Fund shall be credited to the participating in-**
 29 **vestor funds or accounts in the fund in proportion to the amount invested.**

30 (2) **Unless a federal law, court order, settlement or similar agreement or business prac-**
 31 **tice requires otherwise, moneys received by the State Treasurer that may not be discretely**
 32 **invested as provided in ORS 293.723 shall be deposited in the fund. Moneys that may be**
 33 **discretely invested as provided in ORS 293.723 may be deposited in the fund.**

34 (3) **Moneys in the fund may be transferred as provided in ORS 293.205 to 293.225. The**
 35 **State Treasurer is the officer in charge of the fund for purposes of ORS 293.220 and shall**
 36 **determine the interest rate to be charged until the moneys are retransferred to the fund.**
 37 **The interest rate may not be less than the rate specified in ORS 293.220.**

38 **SECTION 5. ORS 293.716 is amended to read:**

39 293.716. (1) **The State Treasurer is the investment officer for the Oregon Investment Council,**
 40 **and shall perform functions in that capacity as authorized or required by law and, consistent with**
 41 **law, by the council.**

42 (2) **The bond of the State Treasurer required from the State Treasurer by law [shall be**
 43 **deemed] is considered to extend to the faithful performance of all functions of the office of invest-**
 44 **ment officer.**

45 (3) **The investment officer may:**

1 (a) Subject to any applicable provision of the State Personnel Relations Law, employ, prescribe
2 the functions and fix the compensation of personnel necessary to facilitate and assist in carrying
3 out the functions of the council and investment officer.

4 (b) Require a fidelity bond of any person employed by the investment officer who has charge of,
5 handles or has access to any [*investment funds*] **investment moneys**, state money or property. The
6 amounts of the bonds shall be fixed by the investment officer, except as otherwise provided by law,
7 and the sureties [*shall*] **must** be approved by the investment officer. The premiums on the bonds
8 [*shall be*] **are** an expense of the State Treasurer.

9 **SECTION 6.** ORS 293.718 is amended to read:

10 293.718. [*As payment for expenses of the investment officer, the State Treasurer may deduct*
11 *monthly a maximum of 0.25 basis points of the most recent market value of assets under management*
12 *for each of the investment funds. However, for the funds described in ORS 293.701 (2)(o), a maximum*
13 *of 0.435 basis points may be deducted monthly. Amounts so deducted shall be deposited into the Mis-*
14 *cellaneous Receipts Account established in the General Fund for the State Treasurer, and are contin-*
15 *uously appropriated for payment of the expenses of the State Treasurer as investment officer.*]

16 **(1) The State Treasurer may deduct an amount each month from the investment moneys**
17 **for the reasonable fees and expenses of the State Treasurer in connection with the services,**
18 **duties and activities of the State Treasurer related to the investment and cash management**
19 **functions of the State Treasurer.**

20 **(2) The State Treasurer shall deposit moneys deducted under this section in the Miscel-**
21 **laneous Receipts Account established in the General Fund for the State Treasurer. Moneys**
22 **deposited under this section are continuously appropriated to the State Treasurer for the**
23 **payment of the reasonable expenses of the State Treasurer in connection with the invest-**
24 **ment and cash management functions of the State Treasurer.**

25 **SECTION 7.** ORS 293.721 is amended to read:

26 293.721. [*Moneys in the investment funds shall be invested and reinvested to achieve the investment*
27 *objective of the investment funds, which is to make the moneys as productive as possible, subject to the*
28 *standard set forth in ORS 293.726.*] **Subject to the standard set forth in ORS 293.726, investment**
29 **moneys shall be invested, reinvested and managed in a manner designed to make the moneys**
30 **as productive as possible.**

31 **SECTION 8.** ORS 293.723 is amended to read:

32 293.723. (1) Moneys in a fund established by law may not be discretely invested unless the law
33 establishing the fund specifically indicates that the moneys may be invested. A provision in a law
34 establishing a fund that requires interest earned by the fund to be retained by the fund is not, by
35 itself, a specific indication that the moneys in the fund may be discretely invested.

36 (2) As used in this section, "discretely invested" means invested in something other than the
37 [*state investment fund established under ORS 293.701 (2)(o)*] **Oregon Short Term Fund established**
38 **under section 4 of this 2009 Act.**

39 **SECTION 9.** ORS 293.726 is amended to read:

40 293.726. (1) [*The investment funds shall be invested and the investments of those funds*] **Invest-**
41 **ment moneys shall be invested, reinvested and managed as a prudent investor would do, under**
42 **the circumstances then prevailing and in light of the purposes, terms, distribution requirements and**
43 **laws governing [each investment fund] particular investment moneys.**

44 (2) The standard stated in subsection (1) of this section requires the exercise of reasonable care,
45 skill and caution, and is to be applied to investments not in isolation but in the context of each

1 *[investment fund's]* investment portfolio and as a part of an overall investment strategy, which should
 2 incorporate risk and return objectives reasonably suitable to the particular investment *[fund]*
 3 **moneys.**

4 (3) In making and implementing investment decisions, the Oregon Investment Council and the
 5 investment officer have a duty to diversify the investments *[of the investment funds]* **made under**
 6 **ORS 293.701 to 293.820** unless, under the circumstances, it is not prudent to do so.

7 (4) In addition to the duties stated in subsection (3) of this section, the council and the invest-
 8 ment officer must:

9 (a) Conform to the fundamental fiduciary duties of loyalty and impartiality;

10 (b) Act with prudence in deciding whether and how to delegate authority and in the selection
 11 and supervision of agents; and

12 (c) Incur only costs that are reasonable in amount and appropriate to the investment responsi-
 13 bilities imposed by law.

14 (5) The duties of the council and the investment officer under this section are subject to con-
 15 trary provisions of privately created public trusts the assets of which by law are made *[investment*
 16 *funds]* **moneys to be invested as provided in ORS 293.701 to 293.820.** Within the limitations of the
 17 standard stated in subsection (1) of this section and subject to subsection (6) of this section, there
 18 may be acquired, retained, managed and disposed of *[as investments of the investment funds]* every
 19 kind of investment which persons of prudence, discretion and intelligence acquire, retain, manage
 20 and dispose of for their own account.

21 (6) Notwithstanding subsection (1) of this section, not more than 50 percent of the moneys con-
 22 tributed to the Public Employees Retirement Fund or the Industrial Accident Fund may be invested
 23 in common stock, and not more than 65 percent of the moneys contributed to the other trust and
 24 endowment funds managed by the Oregon Investment Council or the State Treasurer may be in-
 25 vested in common stock.

26 (7) Subject to the standards set forth in this section, moneys held in the Deferred Compensation
 27 Fund may be invested in the stock of any company, association or corporation, including but not
 28 limited to shares of a mutual fund. Investment of moneys in the Deferred Compensation Fund is not
 29 subject to the limitation imposed by subsection (6) of this section.

30 **SECTION 10.** ORS 293.731 is amended to read:

31 293.731. (1) Subject to the objective set forth in ORS 293.721 and the standards set forth in ORS
 32 293.726, the Oregon Investment Council shall formulate policies for the investment and reinvestment
 33 of **investment** moneys *[in the investment funds]* and the acquisition, retention, management and
 34 disposition of investments *[of the investment funds]*.

35 (2) The council, from time to time, shall review *[those]* **its** policies and make changes *[therein]*
 36 as it considers necessary or desirable. The council may formulate separate policies for any *[fund*
 37 *included in the investment funds]* **of the investment moneys.**

38 (3) This section does not apply to the Oregon Growth Account, the Oregon Growth Account
 39 Board, the Oregon Commercialized Research Fund, the Oregon Innovation Fund or the Oregon In-
 40 novation Council.

41 **SECTION 11.** ORS 293.736 is amended to read:

42 293.736. (1) Except as provided in ORS 293.741, in amounts available for investment purposes
 43 and subject to the policies formulated by the Oregon Investment Council, the investment officer
 44 shall invest and reinvest *[moneys in the investment funds]* **the investment moneys** and acquire, re-
 45 tain, manage, including exercise of any voting rights, and dispose of investments *[of the investment*

1 *funds*].

2 (2) Subject to the direction of the council, the investment officer shall perform the functions
3 described in subsection (1) of this section with respect to the investment in mutual funds of moneys
4 in the Deferred Compensation Fund. The council must approve all mutual funds in which Deferred
5 Compensation Fund moneys are invested.

6 **SECTION 12.** ORS 293.741 is amended to read:

7 293.741. (1) The Oregon Investment Council may enter into contracts with one or more persons
8 whom the council determines to be qualified, whereby the persons undertake, in lieu of or in addi-
9 tion to the investment officer, to perform the functions specified in ORS 293.736 to the extent pro-
10 vided in the contract.

11 (2) Performance of functions under a contract shall be paid for out of the gross interest or other
12 income of the investments with respect to which the functions are performed[, *and*]. The net interest
13 or other income of the investments after [*that*] **the** payment [*shall be*] **is** considered income of the
14 [*investment funds*] **moneys invested as provided in ORS 293.701 to 293.820.**

15 (3) The council may require a person contracted with to give to the state a fidelity bond in a
16 penal sum as may be fixed by law or, if not [*so*] fixed **by law**, as may be fixed by the council, with
17 **a** corporate surety authorized to do business in this state.

18 (4) Contracts entered into under this section and functions performed under the contracts are
19 not subject to [*ORS chapter 240 or ORS 279A.140*] **the State Personnel Relations Law or the**
20 **Public Contracting Code.**

21 **SECTION 13.** ORS 293.746 is amended to read:

22 293.746. (1) In the acquisition or disposition of bonds with which approving legal opinions ordi-
23 narily are furnished, the investment officer may require an original or certified copy of the written
24 opinion of a reputable bond attorney or attorneys, or the written opinion of the Attorney General,
25 certifying to the legality of the bonds.

26 (2) The Oregon Investment Council may arrange for the furnishing to the investment officer of
27 investment counseling services. The furnishing and acquisition of those services are not subject to
28 the State Personnel Relations Law or [*ORS 279A.140*] **the Public Contracting Code.**

29 (3) The investment officer, with the approval of the council, may arrange for services with re-
30 spect to mortgages in which [*moneys in the investment funds*] **investment moneys** are invested.
31 Those services shall be paid for out of the gross interest of the mortgages with respect to which the
32 services are furnished, and the net interest of the mortgages after that payment shall be considered
33 income of the [*investment funds*] **investment moneys.** The furnishing and acquisition of those ser-
34 vices are not subject to the State Personnel Relations Law or [*ORS 279A.140*] **the Public Con-**
35 **tracting Code.**

36 **SECTION 14.** ORS 293.751 is amended to read:

37 293.751. (1) Except as provided in ORS 293.741 and this subsection, all instruments of title of
38 all investments [*of the investment funds*] **made under ORS 293.701 to 293.820** shall remain in the
39 custody of the investment officer. The investment officer may deposit with one or more custodial
40 agents or banks those instruments of title that the State Treasurer considers advisable, to be held
41 in safekeeping by the agents or banks for collection of the principal and interest or other income,
42 or of the proceeds of sale or maturity. For purposes of this section, instruments of title of invest-
43 ments [*of the investment funds*] may include such evidence of title as the investment officer shall
44 consider secure and consistent with modern investment, banking and commercial practices, and may
45 include book entry and automated recordation of such title.

1 (2) Except as provided in ORS 293.741 and 293.746 (3) and subsections (1) and (3) of this section,
 2 the investment officer shall collect the principal and interest or other income of investments [*of the*
 3 *investment funds*] **made under ORS 293.701 to 293.820**, title of which is in the investment officer's
 4 custody, when due and payable, and shall pay the principal and interest or other income, when so
 5 collected, into the appropriate fund. [*Except as otherwise provided by law, interest or other income*
 6 *of investments of funds in the hands of the State Treasurer that are not required to meet current de-*
 7 *mands shall be paid into the General Fund to be available for the payment of general governmental*
 8 *expenses.*]

9 (3) In the event of default in the payment of principal or interest or other income of any in-
 10 vestment [*of the investment funds*] **made under ORS 293.701 to 293.820**, the investment officer, with
 11 the approval of the Oregon Investment Council, may:

12 (a) Institute the proper proceedings to collect the matured principal or interest or other income.

13 (b) Accept for exchange purposes refunding bonds or other evidences of indebtedness at interest
 14 rates to be agreed upon by the investment officer and obligor.

15 (c) Make compromises, adjustments or disposition of the matured principal or interest or other
 16 income as the investment officer considers advisable for the purpose of protecting the moneys in-
 17 vested.

18 (d) Make compromises or adjustments as to future payments of principal or interest or other
 19 income as the investment officer considers advisable for the purposes of protecting the moneys in-
 20 vested.

21 **SECTION 15.** ORS 293.761 is amended to read:

22 293.761. (1) [*The investment officer shall report quarterly to the officer or body having control and*
 23 *administration of each fund included in the investment funds the changes in investments made during*
 24 *the preceding month for the fund. If requested by the officer or body, the investment officer shall fur-*
 25 *nish to the officer or body the details on the investment transactions for any fund*] **The investment**
 26 **officer shall follow generally accepted accounting practices and provide to the officer or body**
 27 **having control and administration of any investment moneys any information necessary for**
 28 **financial reporting required by law.**

29 (2) The investment officer shall separately identify investments held in the Oregon Growth Ac-
 30 count established in ORS 348.702, the Oregon Resource and Technology Development Subaccount
 31 established in ORS 348.706 and the Oregon Commercialized Research Fund created in ORS 284.725
 32 as part of the [*report*] **information provided under this section** on the Education Stability Fund
 33 [*required by this section*].

34 **SECTION 16.** ORS 293.771 is amended to read:

35 293.771. The Oregon Investment Council shall report to the Governor and Legislative Assembly
 36 on the investment [*funds investment program*] **moneys** at each regular session of the Legislative
 37 Assembly and at other times as the council considers in the public interest.

38 **SECTION 17.** ORS 293.776 is amended to read:

39 293.776. (1) The Oregon Investment Council shall provide for an examination and audit of the
 40 investment [*funds investment program*] **moneys**, and for submission to the council of a report based
 41 on the examination and audit, at least once every four years and at other times as the council may
 42 require.

43 (2) The examination, **audit and report** [*and audit, and the report based thereon,*] shall include:

44 (a) An evaluation of current investment [*funds investment*] policies and practices and of specific
 45 investments [*of the investment funds*] in relation to the objective set forth in ORS 293.721, the

1 standard set forth in ORS 293.726 and other criteria as may be appropriate[,]; and

2 (b) Recommendations relating to the investment [*funds investment*] policies and practices and to
3 specific investments [*of the investment funds*] as are considered necessary or desirable.

4 (3) The council shall make copies of the report or a summary [*thereof*] **of the report** available
5 for distribution to interested persons.

6 **SECTION 18.** ORS 293.778 is amended to read:

7 293.778. (1) **When appropriate under the standard prescribed in ORS 293.726**, the investment
8 officer singly, or jointly with other public or institutional investors, may authorize establishment of
9 investment holding companies[*which may be corporations, partnerships or limited liability companies,*
10 *and placement of investment funds or investments in such companies, when it is appropriate to do so*
11 *under the investment standard prescribed in ORS 293.726*] **and placement of investment moneys**
12 **in the companies. The companies may be corporations, partnerships or limited liability**
13 **companies.** An investment holding company authorized by this section has the powers and authority
14 granted by the laws of the jurisdiction in which the company is established.

15 (2) Any person qualified under the laws of the jurisdiction in which an investment holding
16 company is established may serve as an officer, director, member or manager of the company. **Sub-**
17 **ject to subsection (3) of this section**, officers and employees of the office of the State Treasurer
18 may serve as directors, officers and members of investment holding companies authorized by this
19 section.

20 (3) [*However,*] If a conflict arises between the duties of the officer or employee of the office of
21 the State Treasurer under state law and the duties of the officer or employee of the office of the
22 State Treasurer as a director, officer or member of the investment holding company, the officer or
23 employee shall abstain from acting on behalf of the company. If the conflict cannot be avoided by
24 abstention, the officer or employee shall immediately resign from the company.

25 **SECTION 19.** ORS 293.780 is amended to read:

26 293.780. (1) The Oregon Investment Council, for and on behalf of the Public Employees Retirement
27 System and Public Employees Retirement Board, may enter into group annuity contracts with
28 one or more insurance companies authorized to do business in this state.

29 (2) In lieu of any investment of moneys in the Public Employees Retirement Fund as provided
30 in ORS 293.701 to 293.820, the council may pay, from time to time under contracts [*so*] entered into
31 **under this section**, any moneys in [*that fund*] **the Public Employees Retirement Fund** available
32 for investment purposes.

33 (3) Contracts [*so*] entered into **under this section** are not subject to [*ORS 279A.140*] **the Public**
34 **Contracting Code.**

35 **SECTION 20.** ORS 293.790 is amended to read:

36 293.790. (1) Under authority of section 6, Article XI of the Oregon Constitution, [*the state,*] **and**
37 subject to subsection (2) of this section, **the state:**

38 (a) May hold and dispose of the stock of any company, association or corporation, including
39 stock already received, that is donated or bequeathed [*and the state,*]; **and**

40 (b) Acting by and through the State Board of Higher Education, [*subject to subsection (2) of this*
41 *section,*] may invest and reinvest in the stock of any company, association or corporation, any funds
42 or moneys of the State Board of Higher Education that:

43 [(a)] (A) Are or have been donated or bequeathed for higher education purposes;

44 [(b)] (B) Are the proceeds from the disposition of stock that is donated or bequeathed for higher
45 education purposes, including stock already received; or

1 [(c)] (C) Are dividends paid with respect to stock that is donated or bequeathed for higher edu-
 2 cation purposes, including stock already received.

3 (2) The state, including any of its agencies having control of, or authority to invest and reinvest
 4 in, any stock described in subsection (1) of this section, in holding, disposing of or investing and
 5 reinvesting in [such] stock, [shall be] **is** governed by ORS 130.750 to 130.775, notwithstanding the
 6 date of acquisition of [such] **the** stock. Moneys received from the disposition of [such] stock, in-
 7 cluding dividends, shall be maintained separate and distinct from the General Fund, and those
 8 moneys, including interest earned thereon, are appropriated continuously for the purposes of the
 9 donation or bequest and of the investments and reinvestments authorized by subsection (1) of this
 10 section and by ORS 351.130. Except as specifically authorized by law, the state or any of its agencies
 11 may not purchase stock.

12 (3)(a) This section does not apply to investment and reinvestment of moneys in the Public Em-
 13 ployees Retirement Fund, the Industrial Accident Fund, the Deferred Compensation Fund and the
 14 Education Stability Fund or to acquisition, retention, management and disposition of investments of
 15 those funds as provided in ORS 293.701 to 293.820.

16 (b) This section does not apply to investment or reinvestment of moneys or stock resulting from
 17 the holding and disposing of stock by the state as allowed under section 6 (2), Article XI of the
 18 Oregon Constitution.

19 **SECTION 21.** ORS 293.812 is amended to read:

20 293.812. As used in ORS 293.811 to 293.817:

21 (1) "Company" means any sole proprietorship, organization, firm, association, corporation, util-
 22 ity, partnership, venture, public franchise, franchisor, franchisee or its wholly owned subsidiary that
 23 exists for profit-making purposes or otherwise to secure economic advantage.

24 (2) "Doing business" means maintaining equipment, facilities, personnel or any other apparatus
 25 of business or commerce [in Sudan], including the ownership or possession of real or personal
 26 property [located in Sudan].

27 (3) "Investment" or "invest" means the commitment of funds or other assets to a company, in-
 28 cluding a loan or other extension of credit made to that company, or the ownership or control of a
 29 share or interest in that company or of a bond or other debt instrument issued by that company.

30 (4) "Subject investment funds" means:

31 (a) The Public Employees Retirement Fund referred to in ORS 238.660;
