

# Senate Bill 658

Sponsored by COMMITTEE ON JUDICIARY

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Grants special campus security officers of Oregon Health and Science University powers and authority of peace officers.

Requires officers to be trained but not to be authorized to carry firearms.

## A BILL FOR AN ACT

1  
2 Relating to special campus security officers; amending ORS 353.050.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 353.050 is amended to read:

5 353.050. Except as otherwise provided in this chapter, the Oregon Health and Science University  
6 Board of Directors, or university officials acting under the authority of the board, shall exercise all  
7 the powers of the Oregon Health and Science University and shall govern the university. In carrying  
8 out its powers, rights and privileges, the university shall be a governmental entity performing gov-  
9 ernmental functions and exercising governmental powers. The university or the board may either  
10 within or outside the state:

11 (1) Determine or approve policies for the organization, administration and development of the  
12 university.

13 (2) Appoint and employ any instructional, administrative, professional, trade, occupational and  
14 other personnel as are necessary or appropriate to carry out the missions of the university, and  
15 prescribe their compensation and terms of office or employment.

16 (3) Make any and all contracts and agreements, enter into any partnership, joint venture or  
17 other business arrangement, create and participate fully in the operation of any business structure,  
18 including but not limited to the development of business structures for health care delivery systems  
19 and networks with any public or private government, nonprofit or for-profit person or entity that in  
20 the judgment of the university or the board is necessary or appropriate to carry out the university's  
21 missions and goals.

22 (4) Acquire, purchase, receive, hold, control, convey, sell, manage, operate, lease, license, lend,  
23 invest, improve, develop, use, dispose of and hold title to real and personal property of any nature,  
24 including intellectual property, in its own name.

25 (5) Sue in its own name and be sued, plead and be impleaded in all actions, suits or proceedings  
26 in any forum brought by or against it by any and all private or state, local, federal or other public  
27 entities, agencies or persons.

28 (6) Encourage gifts and donations for the benefit of the university, and subject to the terms of  
29 the gift, retain, invest and use such gifts as deemed appropriate by the university or the board.

30 (7) Acquire, receive, hold, keep, pledge, control, convey, manage, use, lend, expend and invest  
31 all funds, appropriations, gifts, bequests, stock and revenue from any source to the university.

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted.  
New sections are in **boldfaced** type.

1 (8) Borrow money for the needs of the university, in such amounts and for such time and upon  
2 such terms as may be determined by the university or the board.

3 (9) Erect, construct, improve, develop, repair, maintain, equip, furnish, lease, lend, convey, sell,  
4 manage, operate, use, dispose of and hold title to buildings, structures and lands for the university.

5 (10) Purchase any and all insurance, operate a self-insurance program or otherwise arrange for  
6 the equivalent of insurance coverage of any nature and the indemnity and defense of its officers,  
7 agents and employees or other persons designated by the university to carry out or further the  
8 missions of the university.

9 (11) Create, develop, supervise, control and adopt academic programs, including standards,  
10 qualifications, policies or practices relating to admissions, curriculum, academic advancement,  
11 grading policy, student conduct, credits and scholarships and the granting of academic degrees,  
12 certificates and other forms of recognition.

13 (12) Authorize, create, eliminate, establish, operate, reorganize, reduce or expand any program,  
14 school, institute, health care facility or other unit of operation.

15 (13) Establish, charge, collect and use charges for enrollment into the university, including  
16 charges such as tuition for education and general services, incidental fees and such other charges  
17 found by the university to be necessary to carry out its educational programs. Fees realized in ex-  
18 cess of amounts allocated and exceeding required reserves shall be considered surplus incidental  
19 fees and shall be allocated for programs under the control of the board and found to be advanta-  
20 geous to the cultural or physical development of students of the university upon the recommendation  
21 of the recognized student government of the university.

22 (14) Establish, charge, collect and use charges and fees for university services and the use of  
23 university facilities.

24 (15) Impose charges, fines, fees and such other regulations considered convenient or necessary  
25 to control and regulate traffic and parking of vehicles to the same extent allowed the State Board  
26 of Higher Education. This authority includes the authority to enforce the regulations of the uni-  
27 versity in a court to the extent allowed the State Board of Higher Education in enforcing the state  
28 board's regulations as provided in ORS 352.360 (7).

29 (16) Commission [as] special campus security officers [*one or more individuals who will have*  
30 *probable cause arrest authority and the accompanying immunities as set forth in ORS 133.310 and*  
31 *133.315 when acting in the scope of their duties, provided that such individuals are*] **to be** trained and  
32 certified by the Department of Public Safety Standards and Training[, *and provided further that such*  
33 *officers shall not be*]. **Officers commissioned under this subsection have all the powers and**  
34 **authority given by statute to peace officers of this state. Special campus security officers**  
35 **must be trained but are not** authorized to carry firearms as police officers [*and shall not be con-*  
36 *sidered*]. **Officers are not** police officers for purposes of ORS [181.610,] 238.005, 243.005 [or],  
37 243.736, **414.805, 414.807 or 414.815**. The university [*shall be considered*] **is** a criminal justice agency  
38 for purposes of ORS 181.715 and 181.720.

39 (17) Enforce and recover for payment to the university any fines that are authorized by this  
40 chapter.

41 (18) Adopt, amend or repeal bylaws, administrative rules, regulations and orders applicable to  
42 the matters that are the subject of this chapter.

43 (19) Contract with any state agency for the performance of such duties, functions and powers  
44 as is appropriate. A state agency shall not charge the university for such services an amount that  
45 is greater than the actual cost of the services.

1 (20) Purchase, receive, subscribe for or otherwise acquire, own, hold, vote, use, sell, mortgage,  
2 lend, pledge, invest in or otherwise dispose of and deal in or with the shares, stock or other equity  
3 or interests in or obligations of any other entity. Separate funds may be established for such in-  
4 vestments. The State of Oregon shall have no proprietary or other interest in such investments or  
5 such funds.

6 (21) Make available, by lease or otherwise, or control access to any health care facilities or  
7 services or other of its properties and assets to such persons, firms, partnerships, associations or  
8 corporations and on such terms as considered appropriate, charge and collect rent or other fees or  
9 charges therefor and terminate or deny any such access or any such lease or other agreement for  
10 such reasons as considered appropriate and as may be consistent with its obligations under any such  
11 lease or other agreement.

12 (22) Contract for the operation of any department, section, equipment or holdings of the uni-  
13 versity and enter into any agreements with any person, firm or corporation for the management by  
14 said person, firm or corporation on behalf of the university of any of its properties or for the more  
15 efficient or economical performance of clerical, accounting, administrative and other functions re-  
16 lating to its health care facilities.

17 (23) Select and appoint faculty as medical and dental staff members and others licensed to  
18 practice the healing arts, delineate and define the privileges granted each such individual, adopt and  
19 direct a plan for faculty clinical income and set the terms and conditions of that plan (including  
20 such modifications to any such existing plan as considered necessary or appropriate upon expiration  
21 of the term of such plan), and determine the extent to which and the terms upon which each such  
22 individual may provide teaching, research, consulting or other services at the university or any  
23 other health care facility.

24 (24) Enter into affiliation, cooperation, territorial, management or other similar agreements with  
25 other public or private universities or health care providers for the sharing, division, allocation or  
26 furnishing of services on an exclusive or a nonexclusive basis, referral of patients, management of  
27 facilities, formation of health care delivery systems and other similar activities.

28 (25) Perform any other acts that in the judgment of the board or university are requisite, nec-  
29 essary or appropriate in accomplishing the purposes described in or carrying out the powers granted  
30 by this chapter.

31 (26) Exercise these powers, notwithstanding that as a consequence of the exercise of such pow-  
32 ers, the university engages in activities that might otherwise be deemed anticompetitive within the  
33 contemplation of state or federal antitrust laws.
