

Senate Bill 664

Sponsored by Senator PROZANSKI

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Authorizes expansion of pilot project allowing temporary transfer of water rights.
Extends sunset for pilot project.

A BILL FOR AN ACT

1
2 Relating to pilot project for temporary transfer of water rights; amending sections 23, 24 and 25,
3 chapter 705, Oregon Laws 2003.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** Section 23, chapter 705, Oregon Laws 2003, is amended to read:

6 **Sec. 23.** (1) In order to increase district water management flexibility, the Water Resources
7 Department shall establish a pilot project in which districts may temporarily allow, for water uses
8 subject to transfer, the use of water on any land within the legal boundaries of the district estab-
9 lished pursuant to ORS chapter 545, 547, 552, 553 or 554.

10 (2) The use of water on any land within the legal boundaries of the district may be allowed if:

11 (a) The rate and duty, and the total number of acres to which water will be applied under the
12 transfer, do not exceed existing limits on the water use subject to transfer;

13 (b) The type of use authorized under the water use subject to transfer remains the same; and

14 (c) The land from which the water use is being transferred does not receive any water under
15 the right being transferred during the irrigation season in which the change is made.

16 (3) The department shall [*allow the pilot project to be implemented in the Talent Irrigation Dis-*
17 *trict, the Owyhee Irrigation District and the Tualatin Valley Irrigation District or their successor ir-*
18 *rigation districts. However, any*] **select a maximum of 25 districts, including the Talent**
19 **Irrigation District, the Owyhee Irrigation District and the Tualatin Valley Irrigation District**
20 **or their successor irrigation districts, in which to implement the pilot project. A district**
21 participating in the project must:

22 (a) Have defined state irrigation district boundaries;

23 (b) Have a management structure that can ensure that water is applied only where the water
24 use is authorized;

25 (c) Not irrigate an area in any one irrigation season that exceeds the maximum number of acres
26 allowed to be irrigated under the original water right;

27 (d) Have a full and accurate measurement of the water appropriated;

28 (e) Have an accurate map identifying the location of authorized use, by priority date, for
29 [*watermaster*] review upon request **and provide a copy of the map to the watermaster**; and

30 (f) Have on file statements by any landowner affected by the water use change indicating that
31 the landowner agrees to the change.

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted.
New sections are in **boldfaced** type.

1 (4) If any of the specified irrigation districts are unable to participate in the project, the de-
2 partment may identify another district for the project.

3 (5) The department may require that use of water under the pilot project cease and that the use
4 revert to the use allowed under the water right of record if the department determines that:

5 (a) The district does not meet the qualifications established in subsection (3) of this section;

6 (b) The water is being used in a manner that violates the requirements in subsection (2) of this
7 section; or

8 (c) The changes made to the use of water would result in injury to existing water rights or an
9 enlargement of the original water right.

10 (6) Use of water under the pilot project constitutes a beneficial use of water and does not con-
11 stitute nonuse for purposes of forfeiture under ORS 540.610.

12 **SECTION 2.** Section 24, chapter 705, Oregon Laws 2003, as amended by section 1, chapter 10,
13 Oregon Laws 2007, is amended to read:

14 **Sec. 24.** The Water Resources Department shall report to the [*Seventy-fifth*] Legislative
15 Assembly[, *no later than January 31, 2009,*] **at least once every five years after January 31, 2009,**
16 on the operation of the pilot project established under section 23, chapter 705, Oregon Laws 2003.

17 **SECTION 3.** Section 25, chapter 705, Oregon Laws 2003, as amended by section 2, chapter 10,
18 Oregon Laws 2007, is amended to read:

19 **Sec. 25.** Sections 22 and 23, chapter 705, Oregon Laws 2003, are repealed on June 30, [2010]
20 **2020.**
