Senate Bill 734

Sponsored by Senator MORRISETTE; Senators BATES, TELFER

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires certain health insurers to cover tobacco use cessation programs.

1	A BILL FOR AN ACT
2	Relating to health insurance; creating new provisions; and amending ORS 750.055 and 750.333.
3	Be It Enacted by the People of the State of Oregon:
4	SECTION 1. Section 2 of this 2009 Act is added to and made a part of the Insurance Code.
5	SECTION 2. (1) A health benefit plan as defined in ORS 743.730 must provide payment,
6	coverage or reimbursement of at least \$500 for a tobacco use cessation program for a person
7	enrolled in the plan who is 15 years of age or older.
8	(2) As used in this section, "tobacco use cessation program" means a program recom-
9	mended by a physician that follows the United States Public Health Service guidelines for
10	tobacco use cessation. "Tobacco use cessation program" includes education and medical
11	treatment components designed to assist a person in ceasing the use of tobacco products.
12	(3) This section is exempt from ORS 743A.001.
