# **B-Engrossed** Senate Bill 771

Ordered by the House May 20 Including Senate Amendments dated April 15 and House Amendments dated May 20

Sponsored by Senator BONAMICI (at the request of General Landlord-Tenant Coalition)

#### **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

Creates 60-day no-cause notice for terminating tenancy. Allows 30-day notice if termination meets specified criteria. Specifies procedures for terminating various forms of tenancy. Allows

including explanation for termination of tenancy with no-cause notice. Allows landlords, tenants and guests of tenant to enter into agreement for guest to become temporary occupant of premises. Specifies agreement contents and rights of parties.

Specifies procedure for disposition of certain personal property landlord presumes is abandoned due to death of tenant.

Requires landlord to disclose deposits, fees and rent before entering into rental agreement or accepting payment. Regulates assessment of fees. Prohibits landlord use of liquidated damages provisions. Regulates charging of security deposits and claims against security deposits.

6	SIXTY-DAY NO-CAUSE NOTICE
7	
8	SECTION 1. ORS 90.427 is amended to read:
9	90.427. (1) As used in this section, "first year of occupancy" includes all periods in which
10	any of the tenants has resided in the dwelling unit for one year or less.
11	(2) If a tenancy is a week-to-week tenancy, the landlord or the tenant may terminate [a
12	week-to-week] the tenancy by a written notice given to the other at least 10 days before the termi-
13	nation date specified in the notice.
14	[(2) The landlord or the tenant may terminate a month-to-month tenancy by giving to the other, at
15	any time during the tenancy, not less than 30 days' notice in writing prior to the date designated in the
16	notice for the termination of the tenancy.]
17	(3) If a tenancy is a month-to-month tenancy:
18	(a) At any time during the tenancy, the tenant may terminate the tenancy by giving the
19	landlord notice in writing not less than 30 days prior to the date designated in the notice for
20	the termination of the tenancy.
21	(b) At any time during the first year of occupancy, the landlord may terminate the
22	tenancy by giving the tenant notice in writing not less than 30 days prior to the date desig
23	nated in the notice for the termination of the tenancy.

(c) At any time after the first year of occupancy, the landlord may terminate the tenancy 1 2 by giving the tenant notice in writing not less than 60 days prior to the date designated in

the notice for the termination of the tenancy. 3

(4) If the tenancy is for a fixed term of at least one year and by its terms becomes a 4 month-to-month tenancy after the fixed term:  $\mathbf{5}$ 

(a) At any time during the fixed term, notwithstanding subsection (3) of this section, the 6 landlord or the tenant may terminate the tenancy without cause by giving the other notice 7 in writing not less than 30 days prior to the specified ending date for the fixed term or not 8 9 less than 30 days prior to the date designated in the notice for the termination of the tenancy, whichever is later. 10

(b) After the specified ending date for the fixed term, at any time during the month-to-11 12 month tenancy, the landlord may terminate the tenancy without cause only by giving the tenant notice in writing not less than 60 days prior to the date designated in the notice for 13 the termination of the tenancy. 14

15 (5) Notwithstanding subsections (3)(c) and (4)(b) of this section, the landlord may terminate a month-to-month tenancy at any time by giving the tenant notice in writing not less 16 than 30 days prior to the date designated in the notice for the termination of the tenancy if: 17 18

(a) The dwelling unit is purchased separately from any other dwelling unit;

19 (b) The landlord has accepted an offer to purchase the dwelling unit from a person who intends in good faith to occupy the dwelling unit as the person's primary residence; and 20

(c) The landlord has provided the notice, and written evidence of the offer to purchase 2122the dwelling unit, to the tenant not more than 120 days after accepting the offer to purchase. 23[(3)] (6) The tenancy shall terminate on the date designated and without regard to the expiration of the period for which, by the terms of the tenancy, rents are to be paid. Unless otherwise agreed, 2425rent is uniformly apportionable from day to day.

[(4)] (7) If the tenant remains in possession without the landlord's consent after expiration of the 2627term of the rental agreement or its termination, the landlord may bring an action for possession. In addition, the landlord may recover from the tenant any actual damages resulting from the tenant 28holding over, including the value of any rent accruing from the expiration or termination of the 2930 rental agreement until the landlord knows or should know that the tenant has relinquished pos-31 session to the landlord. If the landlord consents to the tenant's continued occupancy, ORS 90.220 32[(6)] (7) applies.

(8)(a) A notice given to terminate a tenancy under subsection (2) or (3) of this section 33 34 need not state a reason for the termination.

35 (b) Notwithstanding paragraph (a) of this subsection, a landlord or tenant may include in a notice of termination given under subsection (2) or (3) of this section an explanation of 36 37 the reason for the termination without having to prove the reason. An explanation does not give the person receiving the notice of termination a right to cure the reason if the notice 38 states that: 39

(A) The notice is given without stated cause; 40

(B) The recipient of the notice does not have a right to cure the reason for the termi-41 nation; and 42

(C) The person giving the notice need not prove the reason for the termination in a court 43 action. 44

[(5)] (9) Subsections [(1) and (2)] (2) to (5) of this section [shall] do not apply to a month-to-

36	SECTION 5. Section 6 of this 2009 Act is added to and made a part of ORS 90.100 to 90.465.
37	SECTION 6. (1) As provided under this section, a landlord may allow an individual to
38	become a temporary occupant of the tenant's dwelling unit as a guest of the tenant. To
39	create a temporary occupancy, the landlord, tenant and proposed temporary occupant must
40	enter into a written temporary occupancy agreement that describes the temporary occu-
41	pancy relationship.
42	(2) The temporary occupant:
43	(a) Is not a tenant entitled to occupy the dwelling unit to the exclusion of others; and
44	(b) Does not have the rights of a tenant.
45	(3) The temporary occupancy agreement may be terminated by:

(a) The tenant without cause at any time; and 1 2 (b) The landlord only for cause that is a material violation of the temporary occupancy agreement. 3 (4) The temporary occupant does not have a right to cure a violation that causes a 4 landlord to terminate the temporary occupancy agreement. 5 (5) Before entering into a temporary occupancy agreement, a landlord may screen the 6 proposed temporary occupant for issues regarding conduct or for a criminal record. The 7 landlord may not screen the proposed temporary occupant for credit history or income level. 8 9 (6) A temporary occupancy agreement: 10 (a) Shall expressly include the requirements of subsections (2) to (4) of this section; (b) May provide that the temporary occupant is required to comply with any applicable 11 12 rules for the premises; and 13 (c) May have a specific ending date. (7) The landlord, tenant and temporary occupant may extend or renew a temporary oc-14 15 cupancy agreement or may enter into a new temporary occupancy agreement. 16(8) A landlord or tenant is not required to give the temporary occupant written notice 17 of the termination of a temporary occupancy agreement. 18 (9) The temporary occupant shall promptly vacate the dwelling unit if a landlord terminates a temporary occupancy agreement for material violation of the temporary occupancy 19 agreement or if the temporary occupancy agreement ends by its terms. Except as provided 20in ORS 90.449, the landlord may terminate the tenancy of the tenant as provided under ORS 212290.392 or 90.630 if the temporary occupant fails to promptly vacate the dwelling unit or if the 23tenant materially violates the temporary occupancy agreement. (10) A temporary occupant shall be treated as a squatter if the temporary occupant 24 continues to occupy the dwelling unit after a tenancy has ended or after the tenant revokes 25permission for the occupancy by terminating the temporary occupancy agreement. 2627(11)(a) A landlord may not enter into a temporary occupancy agreement for the purpose of evading landlord responsibilities under this chapter or to diminish the rights of an appli-28cant or tenant under this chapter. 2930 (b) A tenant may not become a temporary occupant in the tenant's own dwelling unit.

31 (c) A tenancy may not consist solely of a temporary occupancy. Each tenancy must have 32at least one tenant.

SECTION 7. ORS 90.100 is amended to read: 34 90.100. As used in this chapter, unless the context otherwise requires:

35 (1) "Accessory building or structure" means any portable, demountable or permanent structure, including but not limited to cabanas, ramadas, storage sheds, garages, awnings, carports, decks, 36 37 steps, ramps, piers and pilings, that is:

(a) Owned and used solely by a tenant of a manufactured dwelling or floating home; or

(b) Provided pursuant to a written rental agreement for the sole use of and maintenance by a 39 tenant of a manufactured dwelling or floating home. 40

(2) "Action" includes recoupment, counterclaim, setoff, suit in equity and any other proceeding 41 in which rights are determined, including an action for possession. 42

(3) "Applicant screening charge" means any payment of money required by a landlord of an 43 applicant prior to entering into a rental agreement with that applicant for a residential dwelling 44 unit, the purpose of which is to pay the cost of processing an application for a rental agreement for 45

1 a residential dwelling unit.

2 (4) "Building and housing codes" includes any law, ordinance or governmental regulation con-3 cerning fitness for habitation, or the construction, maintenance, operation, occupancy, use or ap-4 pearance of any premises or dwelling unit.

5 (5) "Conduct" means the commission of an act or the failure to act.

6 (6) "Dealer" means any person in the business of selling, leasing or distributing new or used 7 manufactured dwellings or floating homes to persons who purchase or lease a manufactured dwelling 8 or floating home for use as a residence.

(a) Abuse between family or household members, as those terms are defined in ORS 107.705; or

9 (7) "Domestic violence" means:

10

11 (b) Abuse, as defined in ORS 107.705, between partners in a dating relationship.

12 (8) "Drug and alcohol free housing" means a dwelling unit described in ORS 90.243.

(9) "Dwelling unit" means a structure or the part of a structure that is used as a home, residence or sleeping place by one person who maintains a household or by two or more persons who maintain a common household. "Dwelling unit" regarding a person who rents a space for a manufactured dwelling or recreational vehicle or regarding a person who rents moorage space for a floating home as defined in ORS 830.700, but does not rent the home, means the space rented and not the manufactured dwelling, recreational vehicle or floating home itself.

19 (10) "Essential service" means:

(a) For a tenancy not consisting of rental space for a manufactured dwelling, floating home or
 recreational vehicle owned by the tenant and not otherwise subject to ORS 90.505 to 90.840:

(A) Heat, plumbing, hot and cold running water, gas, electricity, light fixtures, locks for exterior
doors, latches for windows and any cooking appliance or refrigerator supplied or required to be
supplied by the landlord; and

(B) Any other service or habitability obligation imposed by the rental agreement or ORS 90.320,
the lack or violation of which creates a serious threat to the tenant's health, safety or property or
makes the dwelling unit unfit for occupancy.

(b) For a tenancy consisting of rental space for a manufactured dwelling, floating home or rec reational vehicle owned by the tenant or that is otherwise subject to ORS 90.505 to 90.840:

(A) Sewage disposal, water supply, electrical supply and, if required by applicable law, any
 drainage system; and

(B) Any other service or habitability obligation imposed by the rental agreement or ORS 90.730,
the lack or violation of which creates a serious threat to the tenant's health, safety or property or
makes the rented space unfit for occupancy.

(11) "Facility" means a manufactured dwelling park or a marina.

(12) "Facility purchase association" means a group of three or more tenants who reside in a
 facility and have organized for the purpose of eventual purchase of the facility.

(13) "Fee" means a nonrefundable payment of money.

(14) "First class mail" does not include certified or registered mail, or any other form of mail
 that may delay or hinder actual delivery of mail to the recipient.

(15) "Fixed term tenancy" means a tenancy that has a fixed term of existence, continuing to a
specific ending date and terminating on that date without requiring further notice to effect the termination.

(16) "Floating home" has the meaning given that term in ORS 830.700. "Floating home" includes
 an accessory building or structure.

1 (17) "Good faith" means honesty in fact in the conduct of the transaction concerned.

2 (18) "Hotel or motel" means "hotel" as that term is defined in ORS 699.005.

3 (19) "Informal dispute resolution" means, but is not limited to, consultation between the landlord
4 or landlord's agent and one or more tenants, or mediation utilizing the services of a third party.

5 (20) "Landlord" means the owner, lessor or sublessor of the dwelling unit or the building or 6 premises of which it is a part. "Landlord" includes a person who is authorized by the owner, lessor 7 or sublessor to manage the premises or to enter into a rental agreement.

8 (21) "Landlord's agent" means a person who has oral or written authority, either express or 9 implied, to act for or on behalf of a landlord.

10 (22) "Last month's rent deposit" means a type of security deposit, however designated, the pri-11 mary function of which is to secure the payment of rent for the last month of the tenancy.

(23) "Manufactured dwelling" means a residential trailer, a mobile home or a manufactured
home as those terms are defined in ORS 446.003. "Manufactured dwelling" includes an accessory
building or structure. "Manufactured dwelling" does not include a recreational vehicle.

(24) "Manufactured dwelling park" means a place where four or more manufactured dwellings
are located, the primary purpose of which is to rent space or keep space for rent to any person for
a charge or fee.

18 (25) "Marina" means a moorage of contiguous dwelling units that may be legally transferred as 19 a single unit and are owned by one person where four or more floating homes are secured, the pri-20 mary purpose of which is to rent space or keep space for rent to any person for a charge or fee.

(26) "Month-to-month tenancy" means a tenancy that automatically renews and continues for successive monthly periods on the same terms and conditions originally agreed to, or as revised by the parties, until terminated by one or both of the parties.

(27) "Organization" includes a corporation, government, governmental subdivision or agency,
business trust, estate, trust, partnership or association, two or more persons having a joint or common interest, and any other legal or commercial entity.

(28) "Owner" includes a mortgagee in possession and means one or more persons, jointly or se verally, in whom is vested:

29 (a) All or part of the legal title to property; or

30 (b) All or part of the beneficial ownership and a right to present use and enjoyment of the 31 premises.

32 (29) "Person" includes an individual or organization.

33 (30) "Premises" means:

(a) A dwelling unit and the structure of which it is a part and facilities and appurtenancestherein;

36 (b) Grounds, areas and facilities held out for the use of tenants generally or the use of which 37 is promised to the tenant; and

(c) A facility for manufactured dwellings or floating homes.

(31) "Prepaid rent" means any payment of money to the landlord for a rent obligation not yet
 due. In addition, "prepaid rent" means rent paid for a period extending beyond a termination date.

41 (32) "Recreational vehicle" has the meaning given that term in ORS 446.003.

42 (33) "Rent" means any payment to be made to the landlord under the rental agreement, periodic 43 or otherwise, in exchange for the right of a tenant and any permitted pet to occupy a dwelling unit 44 to the exclusion of others. "Rent" does not include security deposits, fees or utility or service 45 charges as described in ORS 90.315 (4) and 90.532.

1 (34) "Rental agreement" means all agreements, written or oral, and valid rules and regulations 2 adopted under ORS 90.262 or 90.510 (6) embodying the terms and conditions concerning the use and 3 occupancy of a dwelling unit and premises. "Rental agreement" includes a lease. A rental agreement 4 shall be either a week-to-week tenancy, month-to-month tenancy or fixed term tenancy.

5 (35) "Roomer" means a person occupying a dwelling unit that does not include a toilet and ei-6 ther a bathtub or a shower and a refrigerator, stove and kitchen, all provided by the landlord, and 7 where one or more of these facilities are used in common by occupants in the structure.

8 (36) "Screening or admission criteria" means a written statement of any factors a landlord 9 considers in deciding whether to accept or reject an applicant and any qualifications required for 10 acceptance. "Screening or admission criteria" includes, but is not limited to, the rental history, 11 character references, public records, criminal records, credit reports, credit references and incomes 12 or resources of the applicant.

(37) "Security deposit" means a refundable payment or deposit of money, however designated,
the primary function of which is to secure the performance of a rental agreement or any part of a
rental agreement. "Security deposit" does not include a fee.

(38) "Sexual assault" has the meaning given that term in ORS 147.450.

(39) "Squatter" means a person occupying a dwelling unit who is not so entitled under a rental
agreement or who is not authorized by the tenant to occupy that dwelling unit. "Squatter" does
not include a tenant who holds over as described in ORS 90.427 [(4)] (7).

20 (40) "Stalking" means the behavior described in ORS 163.732.

(41) "Statement of policy" means the summary explanation of information and facility policies
to be provided to prospective and existing tenants under ORS 90.510.

(42) "Surrender" means an agreement, express or implied, as described in ORS 90.148 between
a landlord and tenant to terminate a rental agreement that gave the tenant the right to occupy a
dwelling unit.

26 (43) "Tenant":

#### 27 (a) Except as provided in paragraph (b) of this subsection:

(A) Means a person, including a roomer, entitled under a rental agreement to occupy a dwelling
unit to the exclusion of others, including a dwelling unit owned, operated or controlled by a public
housing authority. ["Tenant" also includes]

(B) Means a minor, as defined and provided for in ORS 109.697. [As used in ORS 90.505 to
 90.840, "tenant" includes]

(b) For purposes of ORS 90.505 to 90.840, means only a person who owns and occupies as a
 residence a manufactured dwelling or a floating home in a facility and persons residing with that
 tenant under the terms of the rental agreement.

36 (c) Does not mean a guest or temporary occupant.

37 (44) "Transient lodging" means a room or a suite of rooms.

(45) "Transient occupancy" means occupancy in transient lodging that has all of the followingcharacteristics:

40 (a) Occupancy is charged on a daily basis and is not collected more than six days in advance;

(b) The lodging operator provides maid and linen service daily or every two days as part of the
 regularly charged cost of occupancy; and

43 (c) The period of occupancy does not exceed 30 days.

44 (46) "Vacation occupancy" means occupancy in a dwelling unit, not including transient occu-45 pancy in a hotel or motel, that has all of the following characteristics:

(a) The occupant rents the unit for vacation purposes only, not as a principal residence; 1 2 (b) The occupant has a principal residence other than at the unit; and (c) The period of authorized occupancy does not exceed 45 days. 3 (47) "Victim" means: 4 (a) The person against whom an incident related to domestic violence, sexual assault or stalking 5 6 is perpetrated; or (b) The parent or guardian of a minor household member against whom an incident related to 7 domestic violence, sexual assault or stalking is perpetrated, unless the parent or guardian is the 8 9 perpetrator. 8 (c) A county tax collector aggrieved by the noncompliance may recover from the landlord the 9 actual damages sustained by the tax collector, if the noncompliance is part of an effort by the landlord to defraud the tax collector.
