

Senate Bill 82

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor Theodore R. Kulongoski for Oregon State Lottery)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Changes requirements for Oregon State Lottery Commission budget report to Governor, Legislative Fiscal Officer and Legislative Revenue Officer. Changes reporting period from biennial to annual.

Repeals provision requiring commission, for purpose of calculating constitutional limit on allowable administrative expenses, to segregate prizes and administrative costs for video lottery games from prizes and administrative costs for other lottery games.

A BILL FOR AN ACT

2 Relating to preparation of state lottery budget report; amending ORS 461.140 and 461.725; and re-
3 pealing ORS 461.548.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 461.140 is amended to read:

6 461.140. *[(1) The Oregon State Lottery Commission shall prepare in each even-numbered year a*
7 *budget report for the biennium beginning July 1 of the following year.]*

8 *[(2) The commission estimates and requests and appropriation measures shall be prepared in a*
9 *manner approved by the Legislative Fiscal Officer.]*

10 *[(3) Not later than November 10 of each even-numbered year, the commission shall cause its budget*
11 *estimates and requests to be made available to the Governor, the Legislative Fiscal Officer and to the*
12 *Legislative Revenue Officer. Before December 1, the Legislative Fiscal Officer or staff and the Legis-*
13 *lative Revenue Officer or staff shall not reveal to any other person the contents or nature of the budget*
14 *and other materials, except with the written consent of the commission.]*

15 *[(4) The commission shall furnish the Legislative Assembly any further information required con-*
16 *cerning its budget. The commission, upon request, shall furnish a representative to assist the Legislative*
17 *Assembly, its Joint Committee on Ways and Means, appointed under ORS 171.555, and the Legislative*
18 *Revenue Officer in the consideration of its budget and any accompanying measures.]*

19 *[(5) In all other respects the budget of the Oregon State Lottery Commission shall be treated in the*
20 *same manner as the budgets of all other state agencies.]*

21 **The Oregon State Lottery Commission shall:**

22 **(1) Prepare and provide an annual budget report to the Governor, the Legislative Fiscal**
23 **Officer and the Legislative Revenue Officer in a manner and within a time frame established**
24 **by the Legislative Fiscal Officer.**

25 **(2) Furnish the Legislative Assembly with any further information about the state lottery**
26 **budget requested by the Legislative Fiscal Officer.**

27 **(3) Upon request, make available a representative to assist the Legislative Assembly, its**
28 **Joint Committee on Ways and Means, appointed under ORS 171.555, and the Legislative Re-**

2 **ures.**

3 **SECTION 2.** ORS 461.725 is amended to read:

4 461.725. Out of the funds available to the Oregon State Lottery Commission to meet the admin-
5 istrative expenses of the Oregon State Lottery, the lottery commission shall employ or contract for
6 at least three undercover enforcement officers to enforce the prohibition on gray machines imposed
7 by ORS 162.305, 164.377, 166.715, 167.117, 167.164, 167.166, 461.210, 461.215, 461.217, 461.400, 461.445,
8 461.535, [461.548,] 461.725 and 464.250.

9 **SECTION 3.** ORS 461.548 is repealed.
