SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

- Modifies collateral requirements for depositories holding public funds.
- Revises provisions that govern investments of moneys by State Treasurer, **including moneys in State Highway Fund and State Lottery Fund.**
- Establishes Oregon Short Term Fund as investment vehicle for certain funds held by State Treasurer.
- Declares emergency, effective on passage.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 295.001 is amended to read:

8 295.001. As used in ORS 295.001 to 295.108, unless the context requires otherwise:

9 (1) "Adequately capitalized" means a bank depository that is classified as adequately capitalized
10 by its primary federal regulatory authority.

11 (2) "Bank depository" means an insured institution or trust company that:

12 (a) Maintains a head office or branch in this state in the capacity of an insured institution or
13 trust company; and

14 (b) Complies with ORS 295.008.

15 (3) "Business day" means any day other than a federal or State of Oregon legal holiday or a day
16 on which offices of the State of Oregon are otherwise authorized by law to remain closed.

17 (4) **"Closed depository" means a bank depository that is subject to a loss.**

18 [(4)] (5) "Credit union depository" means a credit union as defined in ORS 723.006 or a federal
19 credit union if:

20 (a) The shares and deposits of the credit union or federal credit union are insured by the Na-
21 tional Credit Union Share Insurance Fund; and

22 (b) The credit union or federal credit union maintains a head office or branch in this state in
23 the capacity of a credit union or federal credit union.

24 [(5)] (6) "Custodian bank" or "custodian" means one of the following institutions designated by
25 the bank depository for its own account:

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted.
New sections are in **boldfaced** type.

- 1 (a) The Federal Home Loan Bank designated to serve this state, or any branch of that bank; or
- 2 (b) Any insured institution or trust company that:
 - 3 (A) Is authorized to accept deposits or transact trust business in this state;
 - 4 (B) Complies with ORS 295.008; and
 - 5 (C) Has been approved by the State Treasurer to serve as a custodian bank, if the State Treas-
 - 6 urer has approved custodians under ORS 295.008.

7 [(6)] (7) “Custodian’s receipt” or “receipt” means a document issued by a custodian bank de-

8 scribing the securities deposited with it by a bank depository to secure public fund deposits.

9 [(7)] (8) “Depository” means a bank depository or a credit union depository.

10 [(8)] (9) “Financial institution outside this state” means a financial institution, as defined in ORS

11 706.008, that is not an extranational institution, as defined in ORS 706.008, and is not a bank de-

12 pository or credit union depository, as defined in this section.

13 [(9)] (10) “Insured institution” means an insured institution as defined in ORS 706.008.

14 [(10)] (11) “Loss” means the issuance of an order by a regulatory or supervisory authority or a

15 court of competent jurisdiction:

- 16 (a) Restraining a bank depository from making payments of deposit liabilities; or
- 17 (b) Appointing a receiver for a [*public*] depository.

18 (12) “**Maximum liability**” means a sum equal to 10 percent of the greater of:

19 (a) **All uninsured public funds deposits held by the bank depository as shown on the date**

20 **of its most recent treasurer report; or**

21 (b) **The average of the balances of uninsured public funds deposits on the last two im-**

22 **mediately preceding treasurer reports.**

23 [(11)] (13) [*“Maximum liability” of*] “**Minimum collateral requirement**” for a bank depository

24 on any given date means a sum equal to:

25 (a) For a well capitalized bank depository **that has not been required to increase its collat-**

26 **eral pursuant to ORS 295.018**, 10 percent of the greater of:

27 (A) All **uninsured** public funds held by the bank depository, as shown on the most recent

28 treasurer report;

29 (B) The average of the balances of **uninsured** public funds held by the bank depository, as

30 shown on the last [*four*] **two** immediately preceding treasurer reports; or

31 (C) An amount otherwise prescribed in ORS 295.001 to 295.108.

32 (b) For [*an adequately capitalized bank depository, 25 percent of the greater of*] **a well capitalized**

33 **bank depository that has been required to increase its collateral pursuant to ORS 295.018,**

34 **the percentage required by the State Treasurer pursuant to ORS 295.018 multiplied by the**

35 **greater of:**

36 (A) All **uninsured** public funds held by the bank depository, as shown on the most recent

37 treasurer report;

38 (B) The average of the balances of **uninsured** public funds held by the bank depository, as

39 shown on the last [*four*] **two** immediately preceding treasurer reports; or

40 (C) An amount otherwise prescribed in ORS 295.001 to 295.108.

41 (c) For an **adequately capitalized bank depository or an** undercapitalized bank depository, 110

42 percent of the greater of:

43 (A) All **uninsured** public funds held by the bank depository; or

44 (B) The average of the balances of **uninsured** public funds held by the bank depository, as

45 shown on the last [*four*] **two** immediately preceding treasurer reports.

1 [(12)] (14) “Net worth” of a bank depository means[:]

2 [(a)] the [equity] **total risk-based** capital of the bank depository, as shown on the immediately
3 preceding report of condition and income, and may include capital notes and debentures that are
4 subordinate to the interests of depositors[: or]

5 [(b) *An amount of equity capital designated by the State Treasurer.*]

6 [(13)] (15) “Pledge agreement” means a written agreement among an insured institution or trust
7 company, the State Treasurer and a custodian that pledges the securities deposited by the insured
8 institution or trust company with the custodian as collateral for deposits of **uninsured** public funds
9 held by the insured institution or trust company. The agreement must be approved by the board of
10 directors or loan committee of the insured institution or trust company and must be continuously
11 maintained as a written record of the insured institution or trust company.

12 [(14)] (16) “Public funds” or “funds” means funds under the control or in the custody of a public
13 official by virtue of office.

14 [(15)] (17) “Public official” means each officer or employee of this state or any agency, political
15 subdivision or public or municipal corporation thereof, or any housing authority, who by law is made
16 the custodian of or has control of any public funds.

17 [(16)] (18) “Report of condition and income” means the quarterly report submitted to a bank
18 depository’s primary federal regulatory authority.

19 [(17)] (19) “Security” or “securities” means:

20 (a) Obligations of the United States, including those of its agencies and instrumentalities and
21 of government sponsored enterprises;

22 (b) Obligations of the International Bank for Reconstruction and Development;

23 (c) Bonds of any state of the United States:

24 (A) That are rated in one of the four highest grades by a recognized investment service organ-
25 ization that has been engaged regularly and continuously for a period of not less than 10 years in
26 rating state and municipal bonds; or

27 (B) Having once been so rated are ruled to be eligible securities for the purposes of ORS 295.001
28 to 295.108, notwithstanding the loss of such rating;

29 (d) Bonds of any county, city, school district, port district or other public body in the United
30 States payable from or secured by ad valorem taxes and that meet the rating requirement or are
31 ruled to be eligible securities as provided in paragraph (c) of this subsection;

32 (e) Bonds of any county, city, school district, port district or other public body issued pursuant
33 to the Constitution or statutes of the State of Oregon or the charter or ordinances of any county
34 or city within the State of Oregon, if the [issuing body has not been in default with respect to the
35 payment of principal or interest on any of its bonds within the preceding 10 years or during the period
36 of its existence if that is less than 10 years] **bonds have a long-term rating of AA or better;**

37 (f) With the permission of the State Treasurer and in accordance with rules adopted by the State
38 Treasurer, loans made to any county, city, school district, port district or other public body in the
39 State of Oregon, if the borrower has not been in default with respect to the payment of principal
40 or interest on any of its loans within the preceding 10 years or during the period of its existence
41 if that is less than 10 years;

42 (g) With the permission of the State Treasurer and in accordance with rules adopted by the
43 State Treasurer, bond anticipation notes issued, sold or assumed by an authority under ORS 441.560;

44 (h) Bonds, notes, letters of credit or other securities or evidence of indebtedness constituting the
45 direct and general obligation of a federal home loan bank or Federal Reserve bank;

1 (i) Debt obligations of domestic corporations that are rated in one of the three highest grades
2 by a recognized investment service organization that has been engaged regularly and continuously
3 for a period of not less than 10 years in rating corporate debt obligations; and

4 (j) Collateralized mortgage obligations and real estate mortgage investment conduits that are
5 rated in one of the two highest grades by a recognized investment service organization that has been
6 engaged regularly and continuously for a period of not less than 10 years in rating corporate debt
7 obligations.

8 [(18)] (20) "Treasurer report" means a written report signed or authenticated by an officer of a
9 bank depository **that has in its possession uninsured public funds deposits** setting forth as of
10 the close of business on a specified date:

11 (a) The total amount of **uninsured** public funds on deposit with the bank depository;

12 **(b) The total amount of public funds on deposit with the bank depository;**

13 [(b)] (c) The net worth of the bank depository;

14 [(c)] (d) The amount and nature of eligible collateral then on deposit with its custodian to
15 collateralize the bank depository's public funds deposits; and

16 [(d)] (e) The identity of its custodian.

17 [(19)] (21) "Treasurer report due date" means a date not less than 10 business days after the
18 date a bank depository's report of condition and income is due to be submitted [*to its federal regu-*
19 *latory authority*].

20 [(20)] (22) "Trust company" means a trust company as defined in ORS 706.008.

21 [(21)] (23) "Undercapitalized" means a bank depository that is classified as undercapitalized,
22 **significantly undercapitalized or critically undercapitalized** by its primary federal regulatory
23 authority.

24 (24) **"Uninsured public funds" or "uninsured public funds deposits" means public funds**
25 **deposited in a bank depository that exceed the amounts insured or guaranteed as described**
26 **in ORS 295.002 (1)(a) and (b) and does not include public funds deposited in a certificate of**
27 **deposit or time deposit under ORS 295.004.**

28 [(22)] (25) "Value" means the current market value of securities.

29 [(23)] (26) "Well capitalized" means a bank depository that is classified as well capitalized by
30 its primary federal regulatory authority.

31 **SECTION 2.** ORS 295.004 is amended to read:

32 295.004. (1) A public official may deposit public funds in a bank depository in an amount in ex-
33 cess of the amount allowed in ORS 295.002 without requiring the bank depository to show that it
34 has entered into [*the agreement described in ORS 295.008 (2)(b)*] **a pledge agreement** or deposited
35 securities pursuant to ORS 295.015 (1) if the funds are initially deposited into a bank depository in
36 Oregon and the Oregon bank depository participates in a program through which:

37 (a) The Oregon bank depository arranges for deposit of the funds into one or more certificates
38 of deposit or time deposits issued by other financial institutions in the United States;

39 (b) Each certificate of deposit or time deposit is fully insured by the Federal Deposit Insurance
40 Corporation;

41 (c) The Oregon bank depository administers the funds on behalf of the public official; and

42 (d) Other financial institutions participating in the program place funds into the Oregon depos-
43 itory in an amount at least equal to the amount deposited into the Oregon bank depository by the
44 public official for purposes of the program.

45 (2) Until the Oregon bank depository places public funds into one or more certificates of deposit

1 or time deposits as provided in subsection (1) of this section, any **uninsured** public funds held by
2 the Oregon bank depository pending such placement [*that are in excess of the amounts allowed in*
3 *ORS 295.002*] must be collateralized as provided in ORS 295.001 to 295.108 for other **uninsured**
4 public funds deposits.

5 (3) The provisions of ORS 295.006, 295.013, 295.015, 295.018 and 295.037 do not apply to public
6 funds deposits deposited into a bank depository in Oregon that the bank depository arranges for
7 under the provisions of the program described in this section. The provisions of ORS 294.035 and
8 295.001 requiring deposit of public funds into depositories that have offices or branches in Oregon
9 do not apply to certificates of deposit or time deposits that an Oregon bank depository arranges for
10 under the provisions of the program described in this section.

11 **SECTION 3.** ORS 295.006 is amended to read:

12 295.006. (1) Each bank depository shall keep on file with the State Treasurer the name and ad-
13 dress of its custodian bank.

14 (2) Each public official shall keep on file with the State Treasurer the names, addresses and such
15 other information as the State Treasurer shall prescribe by rule of each depository in which the
16 public official deposits public funds.

17 **(3) If a public official changes a bank depository in which the public official deposits**
18 **public funds, the public official shall report the information required under subsection (2) of**
19 **this section or by rule regarding the change to the State Treasurer within three business**
20 **days after the effective date of the change.**

21 **SECTION 4.** ORS 295.008 is amended to read:

22 295.008. (1)(a) An insured institution or trust company may not be a custodian bank under ORS
23 295.001 to 295.108, unless it certifies in writing to the State Treasurer that it will furnish the reports
24 required under ORS 714.075 to the Director of the Department of Consumer and Business Services.

25 (b) The State Treasurer may approve one or more insured institutions or trust companies to
26 serve as custodians [*for bank depositories*]. The State Treasurer shall promptly notify all bank de-
27 positaries of the approval of an insured institution or trust company to serve as a custodian.

28 (2) An insured institution or trust company may not be a bank depository under ORS 295.001 to
29 295.108, unless it:

30 (a) Certifies in writing to the State Treasurer that it will furnish, **by the time specified by the**
31 **Director of the Department of Consumer and Business Services:**

32 **(A)** The reports required under ORS 714.075 to the director [*of the Department of Consumer and*
33 *Business Services*]; **and**

34 **(B) Any other information the director considers necessary to determine whether to ad-**
35 **vice the State Treasurer to order a bank depository to increase its collateral under ORS**
36 **295.018.**

37 (b) Except as provided in subsection (4) of this section, enters into a pledge agreement; and

38 (c) Complies with subsection (3) of this section.

39 (3) [*After July 1, 2008,*] Any insured institution or trust company [*that is not acting as a bank*
40 *depository on July 1, 2008, and*] that wishes to become a bank depository shall file with the State
41 Treasurer an initial written report signed or authenticated by an officer of the insured institution
42 or trust company setting forth, as of the date the insured institution or trust company intends to
43 commence acting as a bank depository:

44 (a) The estimated total amount of public funds that will be on deposit with the insured institu-
45 tion or trust company;

1 (b) The estimated net worth of the insured institution or trust company;

2 (c) The amount and nature of the collateral that will be deposited with its custodian to
3 collateralize the public funds deposits; and

4 (d) The identity of its custodian.

5 (4) An insured institution or trust company may be a bank depository under ORS 295.001 to
6 295.108 without entering into a pledge agreement or complying with subsection (3) of this section
7 if the insured institution or trust company does not hold any [*funds on deposit for a public official*
8 *that exceed the limits specified in ORS 295.002 for that type of depository*] **uninsured public funds**
9 **deposits**. The provisions of ORS 295.006, 295.013, 295.015, 295.018, 295.037 and 295.061 do not apply
10 to an insured institution or trust company that is a bank depository under this subsection.

11 **(5) An insured institution or trust company that merges with, acquires all the assets of,**
12 **acquires ownership of or otherwise becomes a successor entity to a bank depository that has**
13 **entered into a pledge agreement must execute a new pledge agreement or provide evidence**
14 **satisfactory to the State Treasurer of the assumption by the successor insured institution**
15 **or trust company of all of the duties and obligations of the bank depository under the exist-**
16 **ing pledge agreement. An insured institution or trust company that fails to enter into a**
17 **pledge agreement or provide evidence of its assumption of the existing pledge agreement**
18 **within the time specified by the State Treasurer shall be treated as a bank depository holding**
19 **uninsured public funds that has failed to pledge adequate collateral under ORS 295.031.**

20 **SECTION 5.** ORS 295.013 is amended to read:

21 295.013. (1) Upon receipt of securities from the bank depository, the custodian bank shall issue
22 to the State Treasurer, with a copy to the bank depository, a custodian's receipt describing the se-
23 curities.

24 (2) Each custodian shall:

25 (a) Maintain an accurate inventory of the securities of each bank depository described in the
26 custodian's receipts issued by the custodian to the State Treasurer, and adjust the inventory to re-
27 flect withdrawals and substitutions of securities previously inventoried.

28 (b) Appraise the value of the securities added to and withdrawn from the inventory of the bank
29 depository, and appraise the value of the entire inventory of the bank depository on the last day of
30 each month and at such other times as the State Treasurer directs.

31 (c) Provide a monthly report to the State Treasurer listing the securities pledged by each bank
32 depository and setting forth the value of each security and of the entire inventory of securities
33 pledged by the bank depository.

34 (d) Notify a bank depository in writing [*whenever*] **within one business day after the custo-**
35 **dian determines that** the value of the securities held by the custodian for the bank depository is
36 less than **the minimum collateral requirement for the bank depository.**[.]

37 [(A) For a bank depository that is subject to increased collateral requirements under ORS 295.018,
38 110 percent of the greater of:]

39 [(i) All public funds held by the bank depository; or]

40 [(ii) The average of the balances of public funds held by the bank depository, as shown on the last
41 four immediately preceding treasurer reports; or]

42 [(B) For a bank depository that is not subject to increased collateral requirements under ORS
43 295.018, the maximum liability for the bank depository.]

44 (e) Notify the State Treasurer in writing [*if*] **within one business day after the custodian**
45 **learns that** a bank depository [*fails*] **failed** to increase the value of its securities within [*five busi-*

1 *ness days after receipt of notice under paragraph (d) of this subsection]* **the time required under**
 2 **ORS 295.015 (3)(b).**

3 (f) Notify the State Treasurer in writing if a bank depository increases the value of its securities
 4 to an adequate amount after receipt of notice under paragraph (d) of this subsection.

5 (g) Notify the State Treasurer [*whenever*] **within one business day after the custodian de-**
 6 **termines that** a bond in the inventory of a bank depository no longer meets the rating requirements
 7 described in ORS 295.001 [(17)(c) or (d)] **(19)(c) or (d).**

8 **SECTION 6.** ORS 295.015 is amended to read:

9 295.015. Except as provided in ORS 295.018:

10 (1)(a) Each bank depository throughout the period of its possession of [*public fund deposits in*
 11 *excess of the amounts insured or guaranteed as described in ORS 295.002 (1)(a) and (b)]* **any**
 12 **uninsured public funds deposits** shall maintain on deposit with its custodian, at its own expense,
 13 securities having a value at least equal to its [*maximum liability*] **minimum collateral requirement**
 14 and as otherwise prescribed in ORS 295.001 to 295.108. Such collateral shall be deposited with the
 15 bank depository's custodian and shall be clearly designated **by the bank depository and the**
 16 **custodian** as security for the benefit of depositors of public funds under ORS 295.001 to 295.108.

17 (b) For purposes of this section, when pledged as collateral for public funds deposits, loans de-
 18 scribed in ORS 295.001 [(17)(f)] **(19)(f)** shall be discounted to 75 percent of the unpaid principal bal-
 19 ance owing on the loan from time to time, or to a lower value determined by the State Treasurer
 20 from time to time.

21 (c) When a bond anticipation note is pledged as collateral for public funds deposits, if there is
 22 no readily determinable market value for the note, it shall be discounted to 75 percent of the unpaid
 23 principal balance owing on the note from time to time, or to a lower value determined by the State
 24 Treasurer from time to time.

25 (2) The bank depository may deposit other eligible securities with its custodian and withdraw
 26 from deposit securities theretofore pledged to secure deposits of public funds, if the remaining se-
 27 curities have a value not less than its [*maximum liability*] **minimum collateral requirement.** The
 28 State Treasurer shall execute such releases and surrender such custodian's receipts as are appro-
 29 priate to effect substitutions and withdrawals of matured and excess pledged securities.

30 (3) If a bank depository's [*maximum liability*] **minimum collateral requirement** increases be-
 31 cause it ceases to be a well capitalized bank depository [*or because it ceases to be an adequately*
 32 *capitalized bank depository,*] **as reflected in the bank depository's last treasurer report, call**
 33 **report or other public filing, or if the bank depository receives notice from the bank deposi-**
 34 **tory's custodian under ORS 295.013 (2)(d) or the State Treasurer:**

35 (a) Within [*five*] **three** business days after the date on which the bank depository's [*maximum*
 36 *liability*] **minimum collateral requirement** increases, the bank depository shall[:]

37 [*(a)*] notify its custodian, **the Director of the Department of Consumer and Business Ser-**
 38 **vices** and the State Treasurer in writing that the bank depository's [*maximum liability*] **minimum**
 39 **collateral requirement** has increased, setting forth the bank depository's new [*maximum liability*]
 40 **minimum collateral requirement and the bank depository's plan for increasing its pledged**
 41 **collateral to the minimum collateral requirement;** and

42 (b) **Within five business days after the date on which the bank depository's minimum**
 43 **collateral requirement increases, or within a longer period approved by the State Treasurer**
 44 **and the director, the bank depository shall, in accordance with the plan approved by the**
 45 **State Treasurer and the director,** tender to its custodian additional securities having sufficient

1 value to increase the total value of its securities pledged as collateral for public funds deposits to
2 the new [*maximum liability*] **minimum collateral requirement** of the bank depository.

3 (4) If a bank depository's [*maximum liability*] **minimum collateral requirement** decreases be-
4 cause it moves from being an undercapitalized bank depository **or an adequately capitalized bank**
5 **depository** to being a well capitalized bank depository [*or an adequately capitalized bank depository,*
6 *or because it moves from being an adequately capitalized bank depository to a well capitalized bank*
7 *depository*], **or because the State Treasurer no longer requires the bank depository to pledge**
8 **additional collateral under ORS 295.018**, the bank depository may:

9 (a) Notify its custodian and the State Treasurer in writing that the bank depository's [*maximum*
10 *liability*] **minimum collateral requirement** has decreased, setting forth the bank depository's new
11 [*maximum liability*] **minimum collateral requirement**; and

12 (b) With the written approval of the State Treasurer, withdraw from its custodian any securities
13 that exceed the bank depository's new [*maximum liability*] **minimum collateral requirement**.

14 (5) The State Treasurer shall act upon requests for releases and withdrawals of securities under
15 subsections (2) and (4)(b) of this section within three business days after the receipt of each request.

16 **SECTION 7.** ORS 295.018 is amended to read:

17 295.018. (1)(a) The State Treasurer may require any bank depository during any period when it
18 has in its possession [*public fund*] **any uninsured public funds** deposits to maintain on deposit with
19 its custodians securities having a value not less than 110 percent of the greater of:

20 [(a)] (A) All **uninsured** public funds held by the bank depository; or

21 [(b)] (B) The average of the balances of **uninsured** public funds held by the bank depository,
22 as shown on the last [*four*] **two** immediately preceding treasurer reports.

23 (b) **In consultation with the Director of the Department of Consumer and Business Ser-**
24 **VICES, the State Treasurer may permit a bank depository to increase its collateral as required**
25 **under paragraph (a) of this subsection over a period of time specified by the State Treasurer**
26 **or may require a bank depository to increase its collateral to an amount that is less than**
27 **the amount specified in paragraph (a) of this subsection.**

28 (2) An increase in collateral under subsection (1) of this section shall be ordered upon the advice
29 of the director [*of the Department of Consumer and Business Services*]. If the bank depository is a
30 national bank or a federally chartered savings bank or savings and loan association, in giving advice
31 to the State Treasurer the director may rely exclusively on information provided to the director by
32 federal regulatory agencies and by the **bank, savings bank or** association on forms prescribed by
33 the director. As a condition of being analyzed and reviewed by the director, a [*federal association*]
34 **national bank or a federally chartered savings bank or savings and loan association** shall
35 agree and consent to provide the director with accurate, pertinent and timely information.

36 (3) **If the State Treasurer orders a bank depository to increase its collateral under sub-**
37 **section (1) of this section, the State Treasurer shall give notice of the order to the director**
38 **and the custodian of the bank depository within one business day after issuing the order.**

39 [(3)] (4) Failure of the director to inform the State Treasurer of the condition of any bank de-
40 pository does not give any public depositor any right or impose any liability on the director. The
41 State Treasurer shall not be liable to any public depositor or to any bank depository for increasing
42 or not increasing the collateral requirement as authorized in subsection (1) of this section.

41 or lease of goods or services required by the commission including, but not limited to, the costs of
42 supplies, materials, tickets, independent audit services, independent studies, data transmission, ad-
43 vertising, promotion, incentives, public relations, communications, compensation paid to lottery
44 game retailers, bonding for lottery game retailers, printing, distribution of tickets and shares, reim-
45 bursing other governmental entities for services provided to the state lottery, transfers to a con-

1 contingency reserve, and for any other goods and services necessary for effectuating the purposes of
2 this chapter. No more than 16 percent of the total annual revenues accruing from the sale of all
3 lottery tickets and shares from all lottery games shall be allocated for the payment of the expenses
4 of the state lottery. The commission shall determine the amount necessary for a reasonable contin-
5 gency reserve within the amount allocated for payment of expenses.

6 (5) The state lottery shall pay all prizes and all of its expenses out of the revenues it receives
7 from the sale of tickets and shares to the public and turn over the net proceeds therefrom to a fund
8 to be established by the Legislative Assembly from which the Legislative Assembly shall make ap-
9 propriations for the benefit of the public purpose described in section 4, Article XV of the Consti-
10 tution of the State of Oregon.

11 **(6) Moneys in the State Lottery Fund may be invested as provided in ORS 293.701 to**
12 **293.820. Interest earned by the fund shall be credited to the fund.**

13 **SECTION 31. ORS 295.087 is repealed.**

14 **SECTION 32. (1) The amendments to ORS 295.001 by section 1 of this 2009 Act apply to**

13 **SECTION 33. This 2009 Act being necessary for the immediate preservation of the public**
14 **peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect**
15 **on its passage.**
