Senate Bill 852

Sponsored by Senator GEORGE

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Removes Department of State Police as designated state point of contact for purposes of National Instant Criminal Background Check System. Requires gun dealer to obtain authorization to transfer firearm directly from system.

5	SECTION 1. ORS 166.412 is amended to read:
6	166.412. (1) As used in this section:
7	(a) "Antique firearm" has the meaning given that term in 18 U.S.C. 921;
8	[(b) "Department" means the Department of State Police;]
9	[(c)] (b) "Firearm" has the meaning given that term in ORS 166.210, except that it does not in-
10	clude an antique firearm;
11	[(d)] (c) "Firearms transaction record" means the firearms transaction record required by 18
12	U.S.C. 921 to 929;
13	[(e) "Firearms transaction thumbprint form" means a form provided by the department under sub-
14	section (12) of this section;]
15	[(f)] (d) "Gun dealer" means a person engaged in the business, as defined in 18 U.S.C. 921, of
16	selling, leasing or otherwise transferring a firearm, whether the person is a retail dealer,
17	pawnbroker or otherwise;
18	[(g) "Handgun" has the meaning given that term in ORS 166.210; and]
19	[(h)] (e) "Purchaser" means a person who buys, leases or otherwise receives a firearm from a
20	gun dealer[.] ; and
21	(f) "System" means the National Instant Criminal Background Check System described
22	in 18 U.S.C. 922.
23	(2) A gun dealer may not transfer a firearm unless:
24	(a) The transfer is between two persons who are licensed as dealers under 18 U.S.C. 923;
25	or
26	(b) The gun dealer complies with subsection (3) of this section and:
27	(A) The system provides the gun dealer with a unique identification number for the
28	transfer; or
29	(B) The system fails to notify the gun dealer within three business days after the date
30	the gun dealer requested a background check from the system that the transfer would vio-
31	late state or federal law.

[(2)] (3) Except as provided in [subsections (3)(c) and (13)] subsection (2)(a) of this section, a
 gun dealer shall comply with the following before a [handgun] firearm is delivered to a purchaser:
 (a) The purchaser shall present to the dealer current identification meeting the requirements
 of subsection (4) of this section.
 (b) The gun dealer shall complete the firearms transaction record and obtain the signature of
 the purchaser on the record.

7 [(c) The gun dealer shall obtain the thumbprints of the purchaser on the firearms transaction 8 thumbprint form and attach the form to the gun dealer's copy of the firearms transaction record to be 9 filed with that copy.]

10 [(d)] (c) The gun dealer shall request, electronically or by telephone, that the [department] 11 system conduct a [criminal history record] background check on the purchaser and shall provide 12 the following information to the [department] system:

13 (A) The federal firearms license number of the gun dealer;

14 (B) The business name of the gun dealer;

15 (C) The place of transfer;

16 (D) The name of the person making the transfer;

(E) The make, model, caliber and manufacturer's number of the [handgun] firearm being trans ferred;

19 (F) The name and date of birth of the purchaser;

20 (G) The Social Security number of the purchaser if the purchaser voluntarily provides this 21 number to the gun dealer; and

22 (H) The type, issuer and identification number of the identification presented by the purchaser.

[(e)] (d) When the gun dealer [shall receive] receives a unique [approval] identification number for the transfer from the [department and] system, the gun dealer shall record the [approval] identification number on the firearms transaction record [and on the firearms transaction thumbprint form].

27 [(f) The gun dealer may destroy the firearms transaction thumbprint form five years after the 28 completion of the firearms transaction thumbprint form.]

[(3)(a) Upon receipt of a request of the gun dealer for a criminal history record check, the depart ment shall immediately, during the gun dealer's telephone call or by return call:]

[(A) Determine, from criminal records and other information available to it, whether the purchaser
 is disqualified under ORS 166.470 from completing the purchase; and]

[(B) Notify the dealer when a purchaser is disqualified from completing the transfer or provide the
 dealer with a unique approval number indicating that the purchaser is qualified to complete the
 transfer.]

36 [(b) If the department is unable to determine if the purchaser is qualified or disqualified from 37 completing the transfer within 30 minutes, the department shall notify the dealer and provide the dealer 38 with an estimate of the time when the department will provide the requested information.]

39 [(c) If the department fails to provide a unique approval number to a gun dealer or to notify the 40 gun dealer that the purchaser is disqualified under paragraph (a) of this subsection before the close 41 of the gun dealer's next business day following the request by the dealer for a criminal history record 42 check, the dealer may deliver the handgun to the purchaser.]

(4)(a) Identification required of the purchaser under subsection [(2)] (3) of this section shall include one piece of current identification bearing a photograph and the date of birth of the purchaser

1 (A) Is issued under the authority of the United States Government, a state, a political subdivi-2 sion of a state, a foreign government, a political subdivision of a foreign government, an interna-3 tional governmental organization or an international quasi- governmental organization; and

4 (B) Is intended to be used for identification of an individual or is commonly accepted for the 5 purpose of identification of an individual.

6 (b) If the identification presented by the purchaser under paragraph (a) of this subsection does 7 not include the current address of the purchaser, the purchaser shall present a second piece of 8 current identification that contains the current address of the purchaser. The Superintendent of 9 State Police may specify by rule the type of identification that may be presented under this para-10 graph.

11 [(c) The department may require that the dealer verify the identification of the purchaser if that 12 identity is in question by sending the thumbprints of the purchaser to the department.]

[(5) The department shall establish a telephone number that shall be operational seven days a week
between the hours of 8 a.m. and 10 p.m. for the purpose of responding to inquiries from dealers for
a criminal history record check under this section.]

16 [(6) No public employee, official or agency shall be held criminally or civilly liable for performing 17 the investigations required by this section provided the employee, official or agency acts in good faith 18 and without malice.]

19 [(7)(a) The department may retain a record of the information obtained during a request for a 20 criminal records check for no more than five years.]

21 [(b) The record of the information obtained during a request for a criminal records check by a gun 22 dealer is exempt from disclosure under public records law.]

[(8)] (5) The Department of Human Services shall provide the Department of State Police with direct electronic access to information from the Department of Human Services' database of information identifying persons meeting the criteria in ORS 166.470 (1)(e) and (f) who were committed or subject to an order under ORS 426.130. The Department of State Police and the Department of Human Services shall enter into an agreement describing the access to information under this subsection.

[(9)] (6) A law enforcement agency may inspect the records of a gun dealer relating to transfers of [handguns] firearms with the consent of a gun dealer in the course of a reasonable inquiry during a criminal investigation or under the authority of a properly authorized subpoena or search warrant.

33 [(10)] (7) When a [handgun] firearm is delivered, it shall be unloaded.

[(11)] (8) In accordance with applicable provisions of ORS chapter 183, the Superintendent of
 State Police may adopt rules necessary for:

SECTION 2. ORS 166.436 is amended to read: 1 2 166.436. [(1) The Department of State Police shall make the telephone number established under 3 ORS 166.412 (5) available for requests from persons other than gun dealers for criminal background checks under this section.] 4 (1) The Department of State Police shall establish a telephone number that shall be op-5 erational seven days a week between the hours of 8 a.m. and 10 p.m. for the purpose of re-6 sponding to inquiries from persons other than gun dealers for a criminal background check 7 under this section. (3)(a) Upon receipt of a request for a criminal background check under this section, the de-2122partment shall immediately, during the telephone call or by return call: 23(A) Determine from criminal records and other information available to it whether the recipient is disqualified under ORS 166.470 from completing the transfer or is otherwise prohibited by state 24 or federal law from possessing a firearm; and 25(B) Notify the transferor when a recipient is disqualified from completing the transfer or provide 2627the transferor with a unique approval number indicating that the recipient is qualified to complete the transfer. The unique approval number is a permit valid for 24 hours for the requested transfer. 28

If the firearm is not transferred from the transferor to the recipient within 24 hours after receipt of the unique approval number, a new request must be made by the transferor.

(b) If the department is unable to determine whether the recipient is qualified for or disqualified from completing the transfer within 30 minutes of receiving the request, the department shall notify the transferor and provide the transferor with an estimate of the time when the department will provide the requested information.

(4) A public employee or public agency incurs no criminal or civil liability for performing the
 criminal background checks required by this section, provided the employee or agency acts in good
 faith and without malice.

(5)(a) The department may retain a record of the information obtained during a request for a
criminal background check under this section for [*the period of time provided in ORS 166.412 (7*)]
no more than five years.

(b) The record of the information obtained during a request for a criminal background checkunder this section is exempt from disclosure under public records law.
