SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Authorizes certain qualified accountants licensed in other states to practice public accountancy in Oregon. *[Permits]* **Requires** Oregon Board of Accountancy to *[discipline]* **investigate** Oregon licensees for unprofessional conduct committed in other states. **Subjects licensees to disciplinary action in this state.** Requires Oregon Board of Accountancy to adopt certain national accounting standards for provision of professional services. **Sets specific fees for registration of public accountants, permit to practice public accountancy and grant of inactive status.**

Becomes operative on January 1, 2010.
Declares emergency, effective on passage.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 673.010 is amended to read:

7 673.010. As used in ORS 673.010 to 673.457:

8 *[(1) "Attest," "attesting" or "attestation" means the opinion of a licensee as to the reliability or*
9 *fairness of information that is used for guidance in the financial transactions of, accounting for or as-*
10 *sessing the status or performance of, commercial and noncommercial enterprises, whether public or*
11 *private, following the completion of an audit, in accordance with generally accepted accounting and*
12 *auditing standards. The board by rule shall further define what constitutes attestation services in*
13 *conformance, to the extent possible, with professional standards, including but not limited to the*
14 *Statements on Auditing Standards (SAS) for audits or other engagements, the Statement of Standards*
15 *for Accounting and Review Services (SSARS) for the review of financial statements and the Statements*
16 *on Standards for Attestation Engagements (SSAE) for examinations of prospective financial informa-*
17 *tion.]*

18 **(1) "Attestation services" means the following professional services required to be per-**
19 **formed under rules adopted by the Oregon Board of Accountancy pursuant to ORS 673.445**
20 **as follows:**

21 **(a) An audit or other engagement for which performance standards are included in the**
22 **Statements on Auditing Standards (SAS);**

23 **(b) Review of a financial statement for which performance standards are included in the**
24 **Statements on Standards for Accounting and Review Services (SSARS);**

25 **(c) Examination of prospective financial information for which performance standards**

New sections are in **boldfaced** type.

1 **are included in the Statements on Standards for Attestation Engagements (SSAE); and**

2 **(d) Engagements for which performance standards are included in the Auditing Stan-**
3 **dards of the Public Company Accounting Oversight Board.**

4 [(2) “Board” means the Oregon Board of Accountancy created by ORS 673.410.]

5 [(3)] (2) “Business organization” means any form of business organization authorized by law,
6 including but not limited to a proprietorship, partnership, corporation, limited liability company,
7 limited liability partnership or professional corporation.

8 [(4)] (3) “Certificate” means a certificate of certified public accountant issued under ORS
9 673.040.

10 [(5)] (4) “Client” means a person who agrees with a licensee to receive any professional service
11 from the licensee.

12 [(6)] (5) “Commission” means money or other consideration recognized as a commission under
13 rules adopted by the board pursuant to ORS 673.012.

14 [(7)] (6) “Compilation **services**” means [*those services as defined by the board by rule.*] **profes-**
15 **sional services required to be performed in accordance with the Statements on Standards for**
16 **Accounting and Review Services (SSARS) under rules adopted by the Oregon Board of**
17 **Accountancy pursuant to ORS 673.445 in which the person performing the services presents**
18 **a financial statement that:**

19 **(a) Is based on the representation of the owner or management of the company for which**
20 **the statement is presented; and**

21 **(b) Does not include assurances by the person that the representations in the financial**
22 **statement conform to generally accepted accounting principles.**

23 [(8)] (7) “Contingent fee” means a fee established for the performance of any professional service
24 and directly or indirectly paid to a licensee pursuant to an arrangement in which no fee will be
25 charged unless a specified finding or result is attained, or in which the amount of the fee is other-
26 wise dependent upon the finding or result of such service. [*The board by rule may further define*
27 *“contingent fee.”*] A fee is not contingent if the fee:

28 (a) Is fixed by courts or other public authorities; or

29 (b) In tax matters, is determined based on the results of judicial proceedings or the findings of
30 governmental agencies.

31 [(9)] (8) “License” means:

32 (a) A certificate, permit or registration, or a license issued under ORS 673.100, enabling the
33 holder thereof to practice public accountancy in this state; or

34 (b) A certificate, permit, registration or other authorization issued by a jurisdiction outside this
35 state enabling the holder thereof to practice public accountancy in that jurisdiction.

36 [(10)] (9) “Licensee” means the holder of a license [*under*] **as defined in** subsection [(9)(a)] (8)(a)
37 of this section.

38 [(11)] (10) “Manager” means a manager of a limited liability company.

39 [(12)] (11) “Member” means a member of a limited liability company.

40 [(13)] (12) “Peer review” means a study, appraisal or review of one or more aspects of the public
41 accountancy work of a holder of a permit under ORS 673.150, or of a registered business organiza-
42 tion that performs attestation or compilation services, that is conducted by:

43 (a) A certified public accountant who holds an active permit issued under ORS 673.150 or an
44 active license issued by the licensing authority for the practice of public accountancy in another
45 state and who is independent of the permit holder or registered business organization being re-

1 viewed; or

2 (b) A public accountant who holds an active permit issued under ORS 673.150 and who is inde-
3 pendent of the permit holder or registered business organization being reviewed.

4 [(14)] (13) "Permit" means a permit to practice public accountancy issued under ORS 673.150.

5 (14) "**Principal place of business**" means the office location designated by a person for
6 purposes of substantial equivalency and reciprocity.

7 (15) "Professional" means arising out of or related to the specialized knowledge or skills asso-
8 ciated with certified public accountants and public accountants.

9 (16) "Public accountant" means a public accountant licensed under ORS 673.100.

10 (17) "Referral fee" means a fee recognized as a referral fee under rules adopted by the board
11 pursuant to ORS 673.012.

12 (18) "Registration" means the authority issued under ORS 673.160 by the Oregon Board of
13 Accountancy to a business organization to practice public accountancy in this state.

14 (19)(a) "Report," when used with reference to [attestation or compilation services,] **financial**
15 **statements**, means an opinion or other form of written language that states or implies assurance
16 as to the reliability of [any] **the** financial [statements] **statement** and that [also] includes or is ac-
17 companied by [any] **a** statement or implication that the person issuing the report has special
18 knowledge or competence in public accountancy. Such a statement or implication of special knowl-
19 edge or competence may arise from use by the issuer of the report of names or titles indicating that
20 the issuer is a public accountancy professional or organization or may arise from the language of
21 the report itself.

22 [(a)] (b) "Report" includes any form of written language that:

23 (A) Disclaims an opinion when the form of language implies any positive assurance as to the
24 reliability of the financial statements referred to or special knowledge or competence on the part
25 of the person issuing the language;

26 (B) Implies any positive assurance as to the reliability of the financial statements referred to
27 or special knowledge or competence on the part of the person issuing the language; or

28 (C) Relates to the financial affairs of a person and that is conventionally used by licensees in
29 reports or financial statements.

30 [(b)] (c) "Report" does not include:

31 (A) The following statement signed by a person who does not hold a certificate, license or permit
32 under ORS 673.010 to 673.457 as long as the statement is not accompanied by any wording indicating
33 the person is an accountant or auditor or any other language prohibited by ORS 673.310 or 673.320:

36 The accompanying balance sheet (or _____) of XYZ Company as of (date), and the related
37 statements of income (or retained earnings or cash flow) for the year then ended have been prepared
38 by me (us).

39 The information presented in these financial statements is the representation of management
40 (owners).

43 (B) Any other financial statements or reports that are not and do not purport to be in compli-
44 ance with national standards, including but not limited to Statements [of] **on** Standards for Ac-
45 counting and Review Services (SSARS) and Statements on Standards for Attestation Engagements

1 (SSAE) adopted by the board by rule, when the statements or reports are issued by persons not
2 otherwise subject to regulation by the board under ORS 673.010 to 673.457.

3 (20) "State" means any state, territory or insular possession of the United States, and the Dis-
4 trict of Columbia.

5 [(21) "Substantial equivalency" means a determination by the National Qualification Appraisal
6 Service of the National Association of State Boards of Accountancy that:]

7 [(a) The education, examination and experience requirements contained in the statutes and admin-
8 istrative rules of another jurisdiction are equivalent to or exceed the education, examination and expe-
9 rience requirements established under ORS 673.040, 673.050 and 673.060 and adopted by the board by
10 rule under ORS 670.310; or]

11 [(b) An individual's education, examination and experience qualifications are equivalent to or ex-
12 ceed the education, examination and experience requirements established under ORS 673.040, 673.050
13 and 673.060 and adopted by the board by rule under ORS 670.310.]

14 (21) "Substantial equivalency" means that:

15 (a) An individual holds a valid license as a certified public accountant from another state
16 that requires an individual, as a condition of licensure as a certified public accountant, to:

17 (A) Complete at least 150 semester hours of college education and obtain a baccalaureate
18 or higher degree conferred by a college or university;

19 (B) Achieve a passing grade on the Uniform Certified Public Accountant Examination;
20 and

21 (C) Possess at least one year of experience, verified by a licensee, providing any type of
22 service or advice involving the use of accounting, attestation, compilation, management ad-
23 visory, financial advisory, tax or related consulting skills, obtained through public practice
24 or government, industry or academic work; or

25 (b) An individual has the qualifications specified in paragraph (a) of this subsection and
26 holds a valid license as a certified public accountant from another state that does not require
27 an individual to have the qualifications specified in paragraph (a) of this subsection as a
28 condition of licensure as a certified public accountant.

29 **SECTION 2.** ORS 673.012 is amended to read:

30 673.012. **Consistent with the definitions in ORS 657.010:**

31 (1) The Oregon Board of Accountancy shall adopt rules **further** defining the terms
32 "commission" and "referral fee" for purposes of ORS 673.010 to 673.457.

33 (2) **The board may adopt rules further defining "contingent fee" for purposes of ORS**
34 **673.010 to 673.457.**

35 **SECTION 3.** ORS 673.153 is amended to read:

36 673.153. (1) [*The Oregon Board of Accountancy may authorize*] A holder of a license with a
37 principal place of business in another state [*to*] **may** practice public accountancy in this state if the
38 holder [*holds in good standing a valid certificate and license as a certified public accountant from:*]

39 [(a)] **has a license from** another state that is [*verified to be*] of substantial equivalency, as de-
40 fined in ORS 673.010 (21)[(a)].

41 [(b) *Another state that is not verified to be of substantial equivalency, as defined in ORS 673.010*
42 *(21)(a), but the holder's skills are verified to be of substantial equivalency, as defined in ORS 673.010*
43 *(21)(b).*]

44 (2)(a) A holder authorized under subsection (1) of this section [*shall be presumed to meet*] **meets**
45 this state's requirements to practice public accountancy and [*shall have*] **has** all the rights and

1 privileges of certificate holders and licensees of this state without the need to obtain a certificate
2 under ORS 673.040 or a permit under ORS 673.150.

3 **(b) The Oregon Board of Accountancy may not require, as a condition for practicing**
4 **public accountancy under this section, an authorized holder to:**

5 **(A) Provide notice that the holder practices or intends to practice public accountancy in**
6 **this state;**

7 **(B) Pay an annual fee for the authorization; or**

8 **(C) Provide any other submission.**

9 *[(3) A holder of a license from another state who is engaged in the practice of public accountancy*
10 *under this section shall:]*

11 *[(a) Notify the board of the holder's intent to practice public accountancy in this state on a form*
12 *provided by the board;]*

13 *[(b) Pay an annual fee in an amount and by the date determined by the board by rule;]*

14 **(3) An authorized holder practicing public accountancy under this section is deemed to:**

15 *[(c)] (a) Consent to the personal and subject matter jurisdiction of the board;*

16 *[(d)] (b) Agree to comply with the requirements of ORS 673.010 to 673.457 and any rules adopted*
17 *thereunder; [and]*

18 **(c) If the license under which the holder is authorized to practice public accountancy**
19 **under this section is no longer valid, agree to immediately cease offering or rendering pro-**
20 **fessional services in this state individually or on behalf of a business firm; and**

21 *[(e)] (d) Agree to the appointment of the other state's licensing authority as the agent of the*
22 *holder, upon whom process may be served in any action or proceeding by the board against the*
23 *holder.*

24 **(4)(a) A business organization that employs a holder authorized to practice public**
25 **accountancy under this section is deemed to:**

26 **(A) Consent to the personal and subject matter jurisdiction of the board;**

27 **(B) Agree to comply with the requirements of ORS 673.010 to 673.457 and any rules**
28 **adopted thereunder;**

29 **(C) If the license under which the holder is authorized to practice public accountancy**
30 **under this section is no longer valid, agree to require the following persons to immediately**
31 **cease offering or rendering professional services in this state:**

32 **(i) The holder; and**

33 **(ii) Any other person who is employed by the business organization and who is offering**
34 **or rendering professional services in this state pursuant to the holder being authorized to**
35 **practice public accountancy under this section; and**

36 **(D) Agree to the appointment of the licensing authority of the state issuing the license**
37 **that is the basis of the holder's authorization to practice public accountancy under this**
38 **section as the agent of the business organization, upon whom process may be served in any**
39 **action or proceeding by the board against the business organization that employs the holder**
40 **during the time the holder is practicing public accountancy in this state.**

41 **(b) For purposes of this subsection, a person practicing as a sole proprietor is a business**
42 **organization.**

43 **(5) A holder authorized to practice public accountancy under this section may not per-**
44 **form the following professional services for a business organization that has its home office**
45 **in this state unless the business organization is registered under ORS 673.160:**

1 (a) **Financial statement audits or other engagements to be performed in accordance with**
2 **the Statements on Auditing Standards (SAS);**

3 (b) **Examinations of prospective financial information to be performed in accordance with**
4 **the Statements on Standards for Attestation Engagements (SSAE); and**

5 (c) **Engagements to be performed in accordance with the auditing standards of the Public**
6 **Company Accounting Oversight Board.**

7 **SECTION 4.** ORS 673.160 is amended to read:

8 673.160. (1) Business organizations of certified public accountants or of public accountants shall
9 register with the Oregon Board of Accountancy if the business organization:

10 (a) **Has an office in this state and:**

11 [(a)] (A) Uses the terms “certified public accountants” or “public accountants” or abbreviations
12 for such terms in this state; **or**

13 [(b)] *Holds itself out to clients in this state or the public in this state as a business organization*
14 *engaged in the practice of public accountancy; or]*

15 [(c)] (B) Performs attestation or compilation services in this state[.];

16 (b) **Holds itself out to clients in this state or the public in this state as a business or-**
17 **organization engaged in the practice of public accountancy; or**

18 (c) **Does not have an office in this state and performs attestation services described in**
19 **ORS 673.010 (1)(a), (c) or (d) for a client having an office in this state.**

20 (2) [*Nothing in this section shall be construed to*] **This section does not** require a holder of a
21 permit under ORS 673.150 to register under this section unless the permit holder:

22 (a) Holds the permit holder out to clients in this state or the public in this state as a business
23 organization composed of more than one licensee except as authorized by ORS 673.320 (12); or

24 (b) Performs attestation or compilation services in this state.

25 (3)(a) **Notwithstanding subsection (1) of this section, a business organization of certified**
26 **public accountants that does not have an office in this state may perform attestation ser-**
27 **vices described in ORS 673.010 (1)(b) or compilation services for a client in this state and**
28 **may use the terms “certified public accountants” or “certified public accounting firm,” ab-**
29 **breiations of those terms or any similar title, designation, words or letters without obtain-**
30 **ing a registration issued by the board under this section if the business organization:**

31 (A) **Has the qualifications described in subsection (5) of this section; and**

32 (B) **Performs the services through a person authorized to practice public accountancy in**
33 **this state under ORS 673.153.**

34 (b) **A business organization of certified public accountants that is not a business organ-**
35 **ization described in subsection (1) of this section or paragraph (a) of this subsection may**
36 **perform professional services in this state, other than attestation or compilation services,**
37 **using the terms “certified public accountants” or “certified public accounting firm” or ab-**
38 **breiations of those terms without registering with the board under this section if the busi-**
39 **ness organization:**

40 (A) **Performs the professional services through a person authorized to practice public**
41 **accountancy in this state under ORS 673.153; and**

42 (B) **May lawfully perform the professional services in the state where the principal place**
43 **of business of the person authorized to practice public accountancy in this state under ORS**
44 **673.153 is located.**

45 [(3)] (4) Registrations shall be issued and renewed for periods of not more than two years. Ap-

1 plications for registration shall be made in a form prescribed by the board by rule. Applications for
2 renewal shall be made between the dates prescribed by the board by rule.

3 [(4)] (5) The following requirements must be satisfied before a registration may be issued or re-
4 newed under this section:

5 (a)(A) Notwithstanding any other provision of law, a simple majority of the ownership of the
6 business organization, in terms of financial interests and voting rights of all partners, officers,
7 shareholders, members or managers, [shall] **must** belong to holders of permits or holders of certif-
8 icates who are licensed in any state, and the partners, officers, shareholders, members or managers
9 of the business organization whose principal place of business is in this state and who perform
10 public accountancy services in this state, [shall] **must** be holders of permits under ORS 673.150. If
11 a majority of the ownership of the business organization is held by holders of permits who are public
12 accountants holding licenses issued under ORS 673.100, the business organization may not use the
13 name "C.P.A. Firm" or any similar name indicating that a majority of the ownership of the firm
14 holds certificates issued under ORS 673.040.

15 (B) A business organization registered under this section that does not meet the ownership re-
16 quirement specified in subparagraph (A) of this paragraph may request an extension of time to
17 comply with the ownership requirement in accordance with the process for granting an extension
18 for compliance that the board shall adopt by rule.

19 (b) In the case of a business organization that includes owners who are not holders of permits
20 under ORS 673.150, a holder of a permit in this state shall be responsible for the management and
21 proper registration of the business organization.

22 (c) **In the case of a business organization required to register under subsection (1) of this**
23 **section, a person who is authorized to practice public accountancy in this state under ORS**
24 **673.153 is responsible for the management and proper registration of the business organiza-**
25 **tion.**

26 [(c)] (d) All owners of the business organization who are not [holders of permits under ORS
27 673.150 shall] **licensees must** be active individual participants in the business organization or af-
28 filiated entities.

29 [(d)] (e) Any person who is responsible for supervising attestation or compilation services and
30 who signs or authorizes someone to sign the accountant's report on the financial statements on be-
31 half of the business organization in this state, [shall] **must:**

32 (A)(i) Hold a permit under ORS 673.150 [and]; or

33 (ii) **Be authorized to practice public accountancy in this state under ORS 673.153; and**

34 (B) Meet the competency requirements established **in the professional standards adopted** by
35 the board by rule **under ORS 673.445.**

36 [(5)] (6) An application for registration or renewal of registration under this section shall:

37 (a) List all states in which the business organization has applied for or holds permits to practice
38 public accountancy; and

39 (b) Provide evidence that the requirements of subsection [(4)] (5) of this section are satisfied.

40 [(6)] (7) Each applicant for registration or renewal under this section and each registrant shall
41 notify the board in writing, within the time period specified by the board by rule, of:

42 (a) The identities of partners, officers, shareholders, members, managers or owners of the busi-
43 ness organization who work regularly in this state;

44 (b) The number or location of offices in this state;

45 (c) The identity of the persons in charge of the offices in this state;

1 (d) Any issuance, denial, revocation, lapse or suspension of authority to perform professional or
2 other services in any jurisdiction against a partner, officer, shareholder, member, manager or owner
3 of the applicant or registrant that seeks registration or is registered in this state; and

4 (e) The filing of a lawsuit relating to professional services of the business organization, the
5 commencement of any civil action an essential element of which involves fraud, dishonesty or mis-
6 representation, or of any criminal action against the applicant or registrant that seeks registration
7 or is registered in this state or against a partner, officer, shareholder, member, manager or owner
8 of the applicant or registrant that seeks registration or is registered in this state.

9 [(7)] **(8)** The board shall charge a fee for each application for issuance or renewal of registration
10 under this section in [*an amount prescribed by the board by rule*] **the amount of \$175**. A registration
11 under this section that is not renewed by the close of the registration period may be restored upon
12 payment to the board of a delinquent renewal fee in an amount determined by the board by rule.

13 [(8)] **(9)** Applicants for renewals of registrations under this section shall undergo a peer review
14 as provided under ORS 673.455, unless the registrant notifies the board that the registrant is exempt
15 from peer review requirements because the registrant does not perform attestation or compilation
16 services in this state.

17 **SECTION 5.** ORS 673.170 is amended to read:

18 673.170. (1) The Oregon Board of Accountancy may take any of the following disciplinary
19 actions:

20 (a) Revoke, suspend or refuse to issue any certificate issued under ORS 673.040 to 673.075.

21 (b) Revoke, suspend or refuse to issue any public accountant's license issued under ORS 673.100.

22 (c) Revoke, suspend, refuse to renew or refuse to issue any permit described in ORS 673.150.

23 [(d) *Revoke, suspend, refuse to renew or refuse to issue authorization to practice public accountancy*
24 *in this state under ORS 673.153.*]

25 **(d) Censure a person authorized to practice public accountancy in this state under ORS**
26 **673.153.**

27 (e) Censure the holder of any permit described in ORS 673.150 or authorization described in ORS
28 673.153.

29 (f) Revoke, suspend, refuse to renew or refuse to issue any registration issued under ORS
30 673.160.

31 (g) Censure the holder of any registration issued under ORS 673.160.

32 **(h) Censure a business organization providing accounting services in this state that is**
33 **exempt from registering under ORS 673.160 (3).**

34 (2) The board may take any of the actions described in subsection (1) of this section for any one
35 or any combination of the following causes:

36 (a) Fraud or deceit in obtaining or applying for:

37 (A) A certificate under ORS 673.040 to 673.075;

38 (B) A public accountant's license under ORS 673.100;

39 (C) A registration under ORS 58.345 or 673.160;

40 (D) A permit under ORS 673.150;

41 (E) Authorization to practice public accountancy in this state under [*the provisions of*] ORS
42 673.153; or

43 (F) Admission to the roster of authorized accountants referred to in ORS 297.670.

44 (b) Dishonesty, fraud or gross negligence in the practice of public accountancy.

45 (c) Incompetence in the practice of public accountancy. A holder of a license issued under ORS

1 673.100, certificate, permit or registration **or a person authorized to practice public accountancy**
2 **in this state under ORS 673.153** is incompetent in the practice of public accountancy if the holder:

3 (A) Engages or has engaged in conduct that evidences a lack of ability or fitness to discharge
4 the duty owed to a client or the general public; or

5 (B) Engages or has engaged in conduct that evidences a lack of knowledge or ability to apply
6 principles or skills of the practice of public accountancy, as adopted by the board.

7 (d) Violation of any of the provisions of ORS 673.010 to 673.457.

8 (e) Violation of any of the provisions of ORS 297.405 to 297.555.

9 (f) Violation of any provision of the Code of Professional Conduct **or accounting standards**
10 adopted by the board [*under the authority granted by ORS 673.010 to 673.457,*] **under ORS 673.445**
11 or rules adopted by the board under ORS 670.310.

12 (g) Conduct resulting in a conviction of a felony under the laws of any state, of any foreign ju-
13 risdiction or of the United States. However, such conduct may be considered only to the extent
14 permissible under the provisions of ORS 670.280.

15 (h) Conviction of any crime, an essential element of which is dishonesty, fraud or misrepresen-
16 tation, under the laws of any state, of any foreign jurisdiction or of the United States.

17 (i) Conviction of willful failure to pay any tax, file any tax return, keep records or supply in-
18 formation required under the tax laws of any state, of any foreign jurisdiction or of the United
19 States, or conviction of the willful making, rendering, delivery, disclosure, signing or verifying of
20 any false or fraudulent list, return, account, statement or other document, or of supplying any false
21 or fraudulent information, required under the tax laws of any state, of any foreign jurisdiction or
22 of the United States.

23 (j) Cancellation, revocation[,] **or suspension of**, or refusal to renew, authority to practice as a
24 certified public accountant or a public accountant in any state or foreign jurisdiction.

25 (k) Cancellation, suspension, revocation or refusal to renew by any state, any foreign jurisdic-
26 tion or any federal agency of the right to practice law, to practice as an enrolled agent before the
27 Internal Revenue Service pursuant to 31 C.F.R. part 10, or to practice under other regulatory law
28 if the cancellation, suspension, revocation or refusal to renew was related to the practice of public
29 accountancy or if dishonesty, fraud or deception was involved.

30 (L) Failure to comply with the continuing education requirements under ORS 673.165 unless
31 such requirements have been waived by the board.

32 (m) Failure to pay a civil penalty imposed by the board after the period for requesting a hearing
33 on the civil penalty terminates if the person or business organization against whom the penalty is
34 imposed has not requested a hearing, or after the period for seeking judicial review of the order
35 assessing the civil penalty has passed.

36 (n) Failure to comply with the terms of a consent agreement described in subsection (3) of this
37 section.

38 (o) Failure to comply with any reporting or other requirement established by the board by rule.

39 (p) Issuance of a cease and desist order against the person under subsection [(7)] **(8)** of this
40 section.

41 (3) In lieu of disciplinary actions under subsection (1) of this section, the board may enter into
42 a consent agreement with the holder of any certificate described in ORS 673.040 to 673.075, the
43 holder of any public accountant's license, the holder of any registration described in ORS 673.160,
44 the holder of any permit described in ORS 673.150 or the holder of any authorization described in
45 ORS 673.153, under which the holder agrees to comply with conditions prescribed by the board.

1 (4) In addition to the causes in subsection (2) of this section, the board may take any of the
2 actions described in subsection (1) of this section for dishonesty, fraud or misrepresentation not in
3 the practice of public accountancy.

20 professional services, in this state or any other jurisdiction, of any partner, officer, shareholder,
21 member, manager or owner of the business organization; or

23 business organization to practice public accountancy or provide other professional services in any
24 other state or foreign jurisdiction.

36 section is in addition to, and not in lieu of, any other action taken by the board. Moneys collected
37 under this subsection shall be deposited in the Oregon Board of Accountancy Account established
38 in the General Fund pursuant to ORS 670.335.
