**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Revises various provisions governing condominiums and planned communities.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1. Sections 2 and 3 of this 2009 Act are added to and made a part of ORS 94.550**  
9 **to 94.783.**

10 **SECTION 2. (1) Each member of the board of directors must be an individual and, except**  
11 **as provided in subsections (2) and (3) of this section, an owner or co-owner of a lot in the**  
12 **planned community.**

13 **(2) A director appointed by a declarant under ORS 94.600 need not be an owner or co-**  
14 **owner of a lot in the planned community.**

15 **(3)(a) Except as otherwise provided in the bylaws, prior to election to the board of di-**  
16 **rectors, an individual described in this subsection shall, upon request of the board, provide**  
17 **the board with documentation satisfactory to the board that the individual is qualified to**  
18 **represent the entity or is a trustee or is serving in a fiduciary capacity for the owner of a**  
19 **lot.**

20 **(b) If a corporation, limited liability company or partnership owns a lot in the planned**  
21 **community or owns an interest in an entity that owns a lot in the planned community, an**  
22 **officer, employee or agent of a corporation, a member, manager, employee or agent of a**  
23 **limited liability company, or a partner, employee or agent of a partnership may serve on the**  
24 **board of directors.**

25 **(c) A trustee may serve on the board of directors if the trustee holds legal title to a lot**  
26 **in the planned community for the benefit of the owner of the beneficial interest in the lot.**

27 **(d) An executor, administrator, guardian, conservator, or other individual appointed by**  
28 **a court to serve in a fiduciary capacity for an owner of a lot in the planned community, or**  
29 **an officer or employee of an entity if an entity is appointed, may serve on the board of di-**

1 **rectors.**

2 (4) **The position of an individual serving on the board of directors under subsection (3)**  
3 **of this section automatically becomes vacant if the individual no longer meets the require-**  
4 **ments of subsection (3) of this section.**

5 **SECTION 3. (1) If a homeowners association is at any time dissolved, whether inadvert-**  
6 **ently or deliberately:**

7 (a) **The association automatically continues as an unincorporated association under the**  
8 **same name.**

9 (b) **The unincorporated association:**

10 (A) **Has all the property, powers and obligations of the incorporated association existing**  
11 **immediately prior to dissolution;**

12 (B) **Shall be governed by the bylaws and, to the extent applicable, the articles of incor-**  
13 **poration of the incorporated association; and**

14 (C) **Shall be served by the members of the board of directors and the officers who served**  
15 **immediately prior to dissolution.**

16 (2) **A separate association is not created when an association is reinstated after admin-**  
17 **istrative dissolution under ORS 65.654 or again incorporated following dissolution. The asso-**  
18 **ciation automatically continues without any further action by incorporators, directors or**  
19 **officers that may otherwise be required under ORS chapter 65.**

20 (3)(a) **The association described in subsection (2) of this section has all the property,**  
21 **powers and obligations of the unincorporated association that existed immediately prior to**  
22 **incorporation or reinstatement.**

23 (b) **The bylaws in effect immediately prior to incorporation or reinstatement constitute**  
24 **the bylaws of the incorporated association.**

25 (c) **The members of the board of directors and the officers continue to serve as directors**  
26 **and officers.**

27 (4) **The provisions of this section apply notwithstanding any provision of a governing**  
28 **document of a planned community that appears to be contrary.**

29 **SECTION 3a.** ORS 94.572 is amended to read:

30 94.572. (1)(a) A Class I or Class II planned community created before January 1, 2002, that was  
31 not created under ORS 94.550 to 94.783 is subject to this section and ORS 94.550, 94.590, 94.595 (5)  
32 to (9), 94.625, 94.630 (1), (3) and (4), 94.640, 94.641, 94.642, 94.645, 94.647, 94.650, 94.652, 94.655, 94.657,  
33 94.658, 94.660, 94.661, 94.662, 94.665, 94.670, 94.675, 94.676, 94.680, 94.690, 94.695, 94.704, 94.709,  
34 94.712, 94.716, 94.719, 94.723, 94.728, 94.733, 94.770, 94.775, 94.777 and 94.780 **and sections 2 and 3**  
35 **of this 2009 Act** to the extent that those statutes are consistent with any governing documents. If  
36 the governing documents do not provide for the formation of an association, the requirements of this  
37 subsection are not effective until the formation of an association in accordance with paragraph (b)  
38 of this subsection. If a provision of the governing documents is inconsistent with this subsection, the  
39 owners may amend the governing documents using the procedures in this subsection:

40 (A) In accordance with the procedures for the adoption of amendments in the governing docu-  
41 ments and subject to any limitations in the governing documents, the owners may amend the in-  
42 consistent provisions of the governing documents to conform to the extent feasible with this section  
43 and ORS 94.550, 94.590, 94.595 (5) to (9), 94.625, 94.630 (1), (3) and (4), 94.640, 94.641, 94.642, 94.645,  
44 94.647, 94.650, 94.652, 94.655, 94.657, 94.658, 94.660, 94.661, 94.662, 94.665, 94.670, 94.675, 94.676,  
45 94.680, 94.690, 94.695, 94.704, 94.709, 94.712, 94.716, 94.719, 94.723, 94.728, 94.733, 94.770, 94.775, 94.777

1 and 94.780 **and sections 2 and 3 of this 2009 Act**. Nothing in this paragraph requires the owners  
2 to amend a declaration or bylaws to include the information required by ORS 94.580 or 94.635.

3 (B) If there are no procedures for amendment in the governing documents:

4 (i) For an amendment to a recorded governing document other than bylaws, the owners may  
5 amend the inconsistent provisions of the document to conform to this section and ORS 94.550, 94.590,  
6 94.595 (5) to (9), 94.625, 94.630 (1), (3) and (4), 94.640, 94.641, 94.642, 94.645, 94.647, 94.650, 94.652,  
7 94.655, 94.657, 94.658, 94.660, 94.661, 94.662, 94.665, 94.670, 94.675, 94.676, 94.680, 94.690, 94.695,  
8 94.704, 94.709, 94.712, 94.716, 94.719, 94.723, 94.728, 94.733, 94.770, 94.775, 94.777 and 94.780 **and**  
9 **sections 2 and 3 of this 2009 Act** by a vote of at least 75 percent of the owners in the planned  
10 community.

11 (ii) For an amendment to the bylaws, the owners may amend the inconsistent provisions of the  
12 bylaws to conform to this section and ORS 94.550, 94.590, 94.595 (5) to (9), 94.625, 94.630 (1), (3) and  
13 (4), 94.640, 94.641, 94.642, 94.645, 94.647, 94.650, 94.652, 94.655, 94.657, 94.658, 94.660, 94.661, 94.662,  
14 94.665, 94.670, 94.675, 94.676, 94.680, 94.690, 94.695, 94.704, 94.709, 94.712, 94.716, 94.719, 94.723,  
15 94.728, 94.733, 94.770, 94.775, 94.777 and 94.780 **and sections 2 and 3 of this 2009 Act** by a vote of  
16 at least a majority of the owners in the planned community.

17 (iii) An amendment may be adopted at a meeting held in accordance with the governing docu-  
18 ments or by another procedure permitted by the governing documents following the procedures  
19 prescribed in ORS 94.647, 94.650 or 94.660.

20 (iv) An amendment to a recorded declaration shall be executed, certified and recorded as pro-  
21 vided in ORS 94.590 (2) and (3) and shall be subject to ORS 94.590 (5). An amendment to the bylaws  
22 and any other governing document shall be executed and certified as provided in ORS 94.590 (3) and  
23 shall be recorded in the office of the recording officer of every county in which the planned com-  
24 munity is located if the bylaws or other governing document to which the amendment relates were  
25 recorded.

26 (C) An amendment adopted pursuant to this paragraph shall include:

27 (i) A reference to the recording index numbers and date of recording of the declaration or other  
28 governing document, if recorded, to which the amendment relates; and

29 (ii) A statement that the amendment is adopted pursuant to the applicable subparagraph of this  
30 paragraph.

31 (b)(A) If the governing documents do not provide for the formation of an association of owners,  
32 at least 10 percent of the owners in the planned community or any governing entity may initiate the  
33 formation of an association as provided in this paragraph. The owners or the governing entity ini-  
34 tiating the association formation shall call an organizational meeting for the purpose of voting  
35 whether to form an association described in ORS 94.625. The notice of the meeting shall:

36 (i) Name the initiating owners or governing entity;

37 (ii) State that the organizational meeting is for the purpose of voting whether to form an asso-  
38 ciation in accordance with the proposed articles of incorporation;

39 (iii) State that if the owners vote to form an association, the owners may elect the initial board  
40 of directors provided for in the articles of incorporation and may adopt the initial bylaws;

41 (iv) State that to form an association requires an affirmative vote of at least a majority of the  
42 owners in the planned community, or, if a larger percentage is specified in the applicable governing  
43 document, the larger percentage;

44 (v) State that to adopt articles of incorporation, to elect the initial board of directors pursuant  
45 to the articles of incorporation or to adopt the initial bylaws requires an affirmative vote of at least

1 a majority of the owners present;

2 (vi) State that if the initial board of directors is not elected, an interim board of directors shall  
3 be elected pursuant to bylaws adopted as provided in subparagraph (C) of this paragraph;

4 (vii) State that a copy of the proposed articles of incorporation and bylaws will be available at  
5 least five business days before the meeting and state the method of requesting a copy; and

6 (viii) Be delivered in accordance with the declaration and bylaws. If there is no governing doc-  
7 ument or the document does not include applicable provisions, the owners or governing entity shall  
8 follow the procedures prescribed in ORS 94.650 (4).

9 (B) At least five business days before the organizational meeting, the initiating owners or gov-  
10 erning entity shall cause articles of incorporation and bylaws to be drafted. The bylaws shall in-  
11 clude, to the extent applicable, the information required by ORS 94.635.

12 (C) At the organizational meeting:

13 (i) Representatives of the initiating owners or governing entity shall, to the extent not incon-  
14 sistent with the governing documents, conduct the meeting according to Robert's Rules of Order as  
15 provided in ORS 94.657.

16 (ii) The initiating owners or governing entity shall make available copies of the proposed arti-  
17 cles of incorporation and the proposed bylaws.

18 (iii) The affirmative vote of at least a majority of the owners of a planned community, or, if a  
19 larger percentage is specified in the applicable governing document, the larger percentage, is re-  
20 quired to form an association under this paragraph.

21 (iv) If the owners vote to form an association, the owners shall adopt articles of incorporation  
22 and may elect the initial board of directors as provided in the articles of incorporation, adopt bylaws  
23 and conduct any other authorized business by an affirmative vote of at least a majority of the  
24 owners present. If the owners do not elect the initial board of directors, owners shall elect an in-  
25 terim board of directors by an affirmative vote of at least a majority of the owners present to serve  
26 until the initial board of directors is elected.

27 (v) An owner may vote by proxy, or by written ballot, if approved, in the discretion of a majority  
28 of the initiating owners or governing entity.

29 (D) Not later than 10 business days after the organizational meeting, the board of directors  
30 shall:

31 (i) Cause the articles of incorporation to be filed with the Secretary of State under ORS chapter  
32 65;

33 (ii) Cause the notice of planned community described in subsection (4) of this section to be  
34 prepared, executed and recorded in accordance with subsection (4) of this section;

35 (iii) Provide a copy of the notice of planned community to each owner, together with a copy of  
36 the adopted articles of incorporation and bylaws, if any, or a statement of the procedure and method  
37 for adoption of bylaws described in subparagraph (C) of this paragraph. The copies and any state-  
38 ment shall be delivered to each lot, mailed to the mailing address of each lot or mailed to the  
39 mailing addresses designated by the owners in writing; and

40 (iv) Cause a statement of association information to be prepared, executed and recorded in ac-  
41 cordance with ORS 94.667.

42 (E) If the owners vote to form an association, all costs incurred under this paragraph, including  
43 but not limited to the preparation and filing of the articles of incorporation, drafting of bylaws,  
44 preparation of notice of meeting and the drafting, delivery and recording of all notices and state-  
45 ments shall be a common expense of the owners and shall be allocated as provided in the appropri-

1 ate governing document or any amendment thereto.

2 (2)(a) The owners of lots in a Class I or Class II planned community that are subject to the  
3 provisions of ORS chapter 94 specified in subsection (1) of this section may elect to be subject to  
4 any other provisions of ORS 94.550 to 94.783 upon compliance with the procedures prescribed in  
5 subsection (1) of this section.

6 (b) If the owners of lots in a Class I or Class II planned community elect to be subject to addi-  
7 tional provisions of ORS 94.550 to 94.783, unless the notice of planned community otherwise required  
8 or permitted under subsection (4) of this section includes a statement of the election pursuant to this  
9 paragraph, the board of directors of the association shall cause the notice of planned community  
10 described in subsection (4) of this section to be prepared, executed and recorded in accordance with  
11 subsection (4) of this section.

12 (3)(a) The owners of lots in a Class III planned community created before January 1, 2002, may  
13 elect to be subject to provisions of ORS 94.550 to 94.783 upon compliance with the applicable pro-  
14 cedures in subsection (1) of this section.

15 (b) If the owners of lots in a Class III planned community elect to be subject to provisions of  
16 ORS 94.550 to 94.783, the board of directors of the association shall cause the notice of planned  
17 community described in subsection (4) of this section to be prepared, executed and recorded in ac-  
18 cordance with subsection (4) of this section.

19 (4) The notice of planned community required or permitted by this section shall be:

20 (a) Titled "Notice of Planned Community under ORS 94.572";

21 (b) Executed by the president and secretary of the association; and

22 (c) Recorded in the office of the recording officer of every county in which the property is lo-  
23 cated.

24 (5) The notice of planned community shall include:

25 (a) The name of the planned community and association as identified in the recorded declaration,  
26 conditions, covenants and restrictions or other governing document and, if different, the current  
27 name of the association;

28 (b) A list of the properties, described as required for recordation in ORS 93.600, within the ju-  
29 risdiction of the association;

30 (c) Information identifying the recorded declaration, conditions, covenants and restrictions or  
31 other governing documents and a reference to the recording index numbers and date of recording  
32 of the governing documents;

33 (d) A statement that the property described in accordance with paragraph (b) of this subsection  
34 is subject to specific provisions of the Oregon Planned Community Act;

35 (e) A reference to the specific provisions of the Oregon Planned Community Act that apply to  
36 the subject property and a reference to the subsection of this section under which the application  
37 is made; and

38 (f) If an association is formed under subsection (1)(b)(A) of this section, a statement to that ef-  
39 fect.

40 (6) An amended statement shall include a reference to the recording index numbers and the date  
41 of recording of prior statements.

42 (7) The county clerk may charge a fee for recording a statement under this section according  
43 to the provisions of ORS 205.320 (4).

44 (8) The board of directors of an association not otherwise required to cause a notice of planned  
45 community described in subsection (4) of this section to be prepared and recorded under this section

1 may cause a notice of planned community to be prepared, executed and recorded as provided in  
2 subsection (4) of this section.

3 (9) Title to a unit, lot or common property in a Class I or Class II planned community created  
4 before January 1, 2002, may not be rendered unmarketable or otherwise affected by a failure of the  
5 planned community to be in compliance with a requirement of this section.

6 (10) As used in this section:

7 (a) "Governing entity" means an incorporated or unincorporated association, committee, person  
8 or any other entity that has authority, under a governing document, to maintain commonly main-  
9 tained property, impose assessments on lots or to act on behalf of lot owners within the planned  
10 community on matters of common concern.

11 (b) "Recorded declaration" means an instrument recorded with the county recording officer of  
12 the county in which the planned community is located that contains conditions, covenants and re-  
13 strictions binding lots in the planned community or imposes servitudes upon the real property.

14 **SECTION 4.** ORS 94.595 is amended to read:

15 94.595. (1) The declarant, on behalf of a homeowners association, shall:

16 (a) Conduct an initial reserve study as described in subsection (3) of this section;

17 (b) Prepare an initial maintenance plan as described in subsection (4) of this section; and

18 (c) Establish a reserve account as provided in subsection (2) of this section.

19 (2)(a) A reserve account shall be established to fund major maintenance, repair or replacement  
20 of all items of common property which will normally require major maintenance, repair or replace-  
21 ment, in whole or in part, in more than one and less than 30 years, for exterior painting if the  
22 common property includes exterior painted surfaces, for other items, whether or not involving com-  
23 mon property, if the association has responsibility to maintain the items and for other items required  
24 by the declaration or bylaws. The reserve account need not include reserves for those items:

25 (A) That can reasonably be funded from the general budget or other funds or accounts of the  
26 association; or

27 (B) For which one or more, but less than all, owners are responsible for maintenance and re-  
28 placement under the provisions of the declaration or bylaws.

29 (b) The reserve account shall be established in the name of the homeowners association. The  
30 association is responsible for administering the account and for making periodic payments into the  
31 account.

32 (c) The reserve portion of the initial assessment determined by the declarant shall be based on:

33 (A) The reserve study described in subsection (3) of this section; or

34 (B) Other reliable information.

35 (d) A reserve account established under this section must be funded by assessments against the  
36 individual lots for which the reserves are established.

37 (e) Unless the declaration provides otherwise, the assessments under this subsection begin ac-  
38 cruing for all lots from the date the first lot is conveyed.

39 (3)(a) The board of directors of the association annually shall conduct a reserve study or review  
40 and update an existing study to determine the reserve account requirements. [and may:] **Subject**  
41 **to subsection (8) of this section, after review of the reserve study or reserve study update,**  
42 **the board of directors may, without any action by owners:**

43 (A) Adjust the amount of payments as indicated by the study or update; and

44 (B) Provide for other reserve items that the board of directors, in its discretion, may deem ap-  
45 propriate.

1 (b) The reserve study shall:

2 (A) Identify all items for which reserves are or will be established;

3 (B) Include the estimated remaining useful life of each item as of the date of the reserve study;  
4 and

5 (C) Include for each item, as applicable, an estimated cost of maintenance and repair and re-  
6 placement at the end of the item's useful life.

7 (4)(a) The board of directors shall prepare a maintenance plan for the maintenance, repair and  
8 replacement of all property for which the association has maintenance, repair or replacement re-  
9 sponsibility under the declaration or bylaws or ORS 94.550 to 94.783. The maintenance plan shall:

10 (A) Describe the maintenance, repair and replacement to be conducted;

11 (B) Include a schedule for the maintenance, repair and replacement;

12 (C) Be appropriate for the size and complexity of the maintenance, repair and replacement re-  
13 sponsibility of the association; and

14 (D) Address issues that include but are not limited to warranties and the useful life of the items  
15 for which the association has maintenance, repair and replacement responsibility.

16 (b) The board of directors shall review and update the maintenance plan described under this  
17 subsection as necessary.

18 (5)(a) If the declaration or bylaws require a reserve account, the reserve study requirements of  
19 subsection (3) of this section and the maintenance plan requirements of subsection (4) of this section  
20 first apply to the association of a subdivision that meets the definition of a planned community un-  
21 der ORS 94.550 and is recorded prior to October 23, 1999, when:

22 (A) The board of directors adopts a resolution in compliance with the bylaws that applies the  
23 requirements of subsections (3) and (4) of this section to the association; or

24 (B) A petition signed by a majority of owners is submitted to the board of directors mandating  
25 that the requirements of subsections (3) and (4) of this section apply to the association.

26 (b) A reserve study and maintenance plan shall be completed within one year of adoption of the  
27 resolution or submission of the petition to the board of directors.

28 (6)(a) Except as provided in paragraph (b) of this subsection, the reserve account may be used  
29 only for the purposes for which reserves have been established and is to be kept separate from other  
30 funds.

31 (b) After the individual lot owners have assumed responsibility for administration of the planned  
32 community under ORS 94.616, if the board of directors has adopted a resolution, which may be an  
33 annual continuing resolution, authorizing the borrowing of funds:

34 (A) The board of directors may borrow funds from the reserve account to meet high seasonal  
35 demands on the regular operating funds or to meet unexpected increases in expenses.

36 (B) Not later than the adoption of the budget for the following year, the board of directors shall  
37 adopt by resolution a written payment plan providing for repayment of the borrowed funds within  
38 a reasonable period.

39 (7) *[Nothing in this section prohibits prudent investment of reserve account funds subject to any*  
40 *constraints imposed by the declaration, bylaws or rules of the association.]* **The reserve account is**  
41 **subject to the requirements and restrictions of ORS 94.670 and any additional restrictions**  
42 **or requirements imposed by the declaration, bylaws or rules of the homeowners association.**

43 *[(8) In addition to the authority of the board of directors under subsection (3)(a) of this section,*  
44 *following the second year after the association has assumed administrative responsibility for the*  
45 *planned community under ORS 94.616:]*

1        *[(a) By an affirmative vote of at least 75 percent of the owners of the planned community, the as-*  
2        *sociation may elect to reduce or increase future assessments for the reserve account; and]*

3        *[(b) The association may, on an annual basis by a unanimous vote, elect not to fund the reserve*  
4        *account.]*

5        **(8)(a) Except as provided under paragraph (b) of this subsection, unless the board of di-**  
6        **rectors under subsection (3) of this section determines that the reserve account will be ad-**  
7        **equately funded for the following year, the board of directors or the owners may not vote**  
8        **to eliminate funding a reserve account required under this section or under the declaration**  
9        **or bylaws.**

10       **(b) Following the turnover meeting described in ORS 94.609, on an annual basis, the board**  
11       **of directors, with the approval of all owners, may elect not to fund the reserve account for**  
12       **the following year.**

13       (9) Assessments paid into the reserve account are the property of the association and are not  
14       refundable to sellers or owners of lots.

15       **SECTION 5.** ORS 94.625 is amended to read:

16       94.625. (1) Except as provided in subsection (2) of this section, not later than the date on which  
17       the first lot in the planned community is conveyed, the declarant shall:

18       (a) Organize the homeowners association as a nonprofit corporation under ORS chapter 65;

19       (b) Adopt, on behalf of the association, the initial bylaws required under ORS 94.635 to govern  
20       the administration of the planned community; and

21       (c) Record the bylaws in the office of the recording officer of each county in which the planned  
22       community is located.

23       (2) If the plat contains a conveyance of any property to the homeowners association, the  
24       declarant shall organize the homeowners association as a nonprofit corporation under ORS chapter  
25       65 before the plat is recorded.

26       (3)(a) The board of directors of an association of a planned community created under ORS 94.550  
27       to 94.783 before January 1, 2002, or a planned community described in ORS 94.572 shall cause the  
28       bylaws of the association and amendments to the bylaws in effect but not codified in the bylaws to  
29       be certified as provided in this subsection and recorded in the office of the recording officer of each  
30       county in which the planned community is located within 180 days of receipt of a written request  
31       from an owner that the bylaws be recorded.

32       (b) The president and secretary of the association shall certify and acknowledge, in the manner  
33       provided for acknowledgment of deeds, that:

34       (A) The bylaws are the duly adopted bylaws of the association; and

35       (B) Each amendment to the bylaws was duly adopted in accordance with the bylaws of the as-  
36       sociation.

37       (c) The 180-day period specified in paragraph (a) of this subsection may be extended as necessary  
38       if the board of directors is unable to record the bylaws for justifiable reasons.

39       (d) Failure to record the bylaws or amendments to the bylaws in accordance with this subsection  
40       does not render the bylaws or amendments to the bylaws ineffective.

41       **(e) After the bylaws are recorded under this section, all amendments to the bylaws**  
42       **adopted thereafter must be recorded as provided in this section.**

43       (4) Unless otherwise provided in the bylaws, amendments to the bylaws may be proposed by a  
44       majority of the board of directors or by at least 30 percent of the owners of the planned community.

45       (5) Subject to subsection (6) of this section, an amendment is not effective unless the amendment



1 is:

2 (a) Approved, unless otherwise provided in the bylaws, by a majority of the votes in a planned  
3 community present, in person or by proxy, at a duly constituted meeting, by written ballot in lieu  
4 of a meeting under ORS 94.647 or other procedure permitted under the declaration or bylaws;

5 (b) Certified by the president and secretary of the association as having been adopted in ac-  
6 cordance with the bylaws and this section and acknowledged in the manner provided for acknowl-  
7 edgment of deeds if the amendment is required to be recorded under paragraph (c) of this subsection;  
8 and

9 (c) Recorded in the office of the recording officer if the bylaws to which the amendment relates  
10 were recorded.

11 (6) If a provision required to be in the declaration under ORS 94.580 is included in the bylaws,  
12 the voting requirements for amending the declaration shall also govern the amendment of the pro-  
13 vision in the bylaws.

14 (7) Notwithstanding a provision in the bylaws, including bylaws adopted prior to July 14, 2003,  
15 that requires an amendment to be executed, or executed and acknowledged, by all owners approving  
16 the amendment, amendments to the bylaws under this section become effective after approval by the  
17 owners if executed and certified on behalf of the association by the president and secretary in ac-  
18 cordance with subsection (5)(b) of this section.

19 (8) An amendment to the bylaws is conclusively presumed to have been regularly adopted in  
20 compliance with all applicable procedures relating to the amendment unless an action is brought  
21 within one year after the effective date of the amendment or the face of the amendment indicates  
22 that the amendment received the approval of fewer votes than required for approval. Nothing in this  
23 subsection prevents the further amendment of an amended bylaw.

24 (9) Failure to comply with subsection (1) of this section does not invalidate a conveyance from

26 (10) The board of directors, by resolution and without the further approval of the owners, may  
27 cause restated bylaws to be prepared and recorded to codify individual amendments that have been  
28 adopted in accordance with subsection (5) of this section. Bylaws restated under this subsection

30 (a) Include all previously adopted amendments that are in effect and may not include any other  
31 changes except to correct scriveners' errors or to conform format and style;

32 (b) Include a statement that the board of directors has adopted a resolution in accordance with  
33 this subsection and is causing the bylaws to be restated and recorded under this subsection;

34 (c) Include a reference to the recording index numbers and date of recording of the initial by-  
35 laws, if recorded, and all previously recorded amendments that are in effect and are being codified;

36 (d) Include a certification by the president and secretary of the association that the restated  
37 bylaws include all previously adopted amendments that are in effect and no other changes except,  
38 if applicable, to correct scriveners' errors or to conform form and style; and

39 (e) Be executed and acknowledged by the president and secretary of the association and re-  
40 corded in the deed records of each county in which the planned community is located.

42 94.630. (1) Subject to subsection (2) of this section and except as otherwise provided in its dec-  
43 laration or bylaws, a homeowners association may:

44 (a) Adopt and amend bylaws, rules and regulations for the planned community;

45 (b) Adopt and amend budgets for revenues, expenditures and reserves, and collect assessments

1 from owners for common expenses and the reserve account established under ORS 94.595;

2 (c) Hire and terminate managing agents and other employees, agents and independent contrac-  
3 tors;

4 (d) Defend against any claims, proceedings or actions brought against it;

5 (e) Subject to subsection (4) of this section, initiate or intervene in litigation or administrative  
6 proceedings in its own name and without joining the individual owners in the following:

7 (A) Matters relating to the collection of assessments and the enforcement of governing docu-  
8 ments;

9 (B) Matters arising out of contracts to which the association is a party;

10 (C) Actions seeking equitable or other nonmonetary relief regarding matters that affect the  
11 common interests of the owners, including but not limited to the abatement of nuisance;

12 (D) Matters, including but not limited to actions for damage, destruction, impairment or loss of  
13 use, relating to or affecting:

14 (i) Individually owned real property, the expenses for which, including maintenance, repair or  
15 replacement, insurance or other expenses, the association is responsible; or

16 (ii) Common property;

17 (E) Matters relating to or affecting the lots or interests of the owners including but not limited  
18 to damage, destruction, impairment or loss of use of a lot or portion thereof, if:

19 (i) Resulting from a nuisance or a defect in or damage to common property or individually  
20 owned real property, the expenses for which, including maintenance, repair or replacement, insur-  
21 ance or other expenses, the association is responsible; or

22 (ii) Required to facilitate repair to any common property; and

23 (F) Any other matter to which the association has standing under law or pursuant to the dec-  
24 laration or bylaws;

25 (f) Make contracts and incur liabilities;

26 (g) Regulate the use, maintenance, repair, replacement and modification of common property;

27 (h) Cause additional improvements to be made as a part of the common property;

28 (i) Acquire, hold, encumber and convey in its own name any right, title or interest to real or  
29 personal property, except that common property may be conveyed or subjected to a security interest  
30 only pursuant to ORS 94.665;

31 (j) Grant easements, leases, licenses and concessions through or over the common property **as**  
32 **provided in ORS 94.665;**

33 (k) Modify, close, remove, eliminate or discontinue the use of common property, including any  
34 improvement or landscaping, regardless of whether the common property is mentioned in the decla-  
35 ration, provided that:

36 (A) Nothing in this paragraph is intended to limit the authority of the association to seek ap-  
37 proval of the modification, closure, removal, elimination or discontinuance by the owners; and

38 (B) Modification, closure, removal, elimination or discontinuance other than on a temporary  
39 basis of any swimming pool, spa or recreation or community building must be approved by at least  
40 a majority of owners voting on the matter at a meeting or by written ballot held in accordance with  
41 the declaration, bylaws or ORS 94.647;

42 (L) Impose and receive any payments, fees or charges for the use, rental or operation of the  
43 common property and services provided to owners;

44 (m) Adopt rules regarding the termination of utility services paid for out of assessments of the  
45 association and access to and use of recreational and service facilities available to owners. The

1 rules must provide for written notice and an opportunity to be heard before the association may  
2 terminate the rights of any owners to receive the benefits or services until the correction of any  
3 violation covered by the rule has occurred;

4 (n) Impose charges for late payment of assessments and attorney fees related to the collection  
5 of assessments and, after giving written notice and an opportunity to be heard, levy reasonable fines  
6 for violations of the declaration, bylaws, rules and regulations of the association, provided that the

8 (A) On a schedule contained in the declaration or bylaws, or an amendment to either that is

34 (b) The percentage of votes that [*shall constitute*] **constitutes a quorum in accordance with**

36 (5)(a) The election of a board of directors [*from among the unit owners*] and the number of per-

39 (c) Any compensation of the directors; and

40 (d) The method of removing directors from office in accordance with ORS 94.640 (6).

41 (6) The terms of office of directors.

43 and a statement that all meetings of the board of directors shall be open to owners.

44 (8) The offices of president, secretary and treasurer and any other offices of the association, and  
45 the method of selecting and removing officers and filling vacancies in the offices.

- 1 (9) The preparation and adoption of a budget in accordance with ORS 94.645.
- 2 (10)(a) The program for maintenance, upkeep, repair and replacement of the common property;
- 3 (b) The method of payment for the expense of the program and other expenses of the planned
- 4 community; and
- 5 (c) The method of approving payment vouchers.
- 6 (11) The employment of personnel necessary for the administration of the planned community
- 7 and maintenance, upkeep and repair of the common property.
- 8 (12) The manner of collecting assessments from the owners.
- 9 (13) Insurance coverage in accordance with ORS 94.675 and 94.685.
- 10 (14) The preparation and distribution of the annual financial statement required under ORS
- 11 94.670.
- 12 (15) The method of adopting administrative rules and regulations governing the details for the
- 13 operation of the planned community and use of the common property.
- 14 (16) The method of amending the bylaws in accordance with ORS 94.630. The bylaws may re-
- 15 quire no greater than an affirmative majority of votes to amend any provision of the bylaws.
- 16 (17) If additional property is proposed to be annexed pursuant to ORS 94.580 (3), the method of
- 17 apportioning common expenses if new lots are added during the fiscal year.
- 18 (18) Any other details regarding the planned community that the declarant or the association
- 19 consider desirable. However, if a provision required to be in the declaration under ORS 94.580 is
- 20 included in the bylaws, the voting requirements for amending the declaration shall govern the

- 22 **SECTION 8.** ORS 94.640 is amended to read:
- 23 94.640. (1) The board of directors of an association may act on behalf of the association except
- 24 as limited by the declaration and the bylaws. In the performance of their duties, officers and mem-
- 25 bers of the board of directors are governed by this section and the applicable provisions of ORS
- 26 65.357, 65.361, 65.367, 65.369 and 65.377, whether or not the association is incorporated under ORS

- 28 (2) Unless otherwise provided in the bylaws, the board of directors may fill vacancies in its

15 (b) **Subject to any limitations imposed by the declaration or bylaws, funds of the associ-**  
16 **ation maintained in accounts established under this subsection may be used to purchase ob-**  
17 **ligations of the United States government.**

18 (c) All expenses of the association shall be paid from the association account.

19 (3) The association shall keep financial records sufficiently detailed for proper accounting pur-  
20 poses.

21 (4) Within 90 days after the end of the fiscal year, the board of directors shall:

22 (a) Prepare or cause to be prepared an annual financial statement consisting of a balance sheet  
23 and income and expenses statement for the preceding fiscal year; and

24 (b) Distribute to each owner and, upon written request, any mortgagee of a lot, a copy of the  
25 annual financial statement.

26 [(4)] (5) Subject to section 24, chapter 803, Oregon Laws 2003, the association of a planned  
27 community that has annual assessments exceeding \$75,000 shall cause the financial statement re-  
28 quired under subsection [(3)] (4) of this section to be reviewed within 180 days after the end of the  
29 fiscal year by an independent certified public accountant licensed in the State of Oregon in ac-  
30 cordance with the Statements on Standards for Accounting and Review Services issued by the  
31 American Institute of Certified Public Accountants.

32 [(5)] (6) The association of a planned community created on or after January 1, 2004, or the  
33 association of a planned community described in ORS 94.572 that has annual assessments of \$75,000  
34 or less shall cause the most recent financial statement required by subsection [(3)] (4) of this section  
35 to be reviewed in the manner described in subsection [(4)] (5) of this section within 180 days after  
36 the association receives a petition requesting review signed by at least a majority of the owners.

37 [(6)] (7) An association subject to the requirements of subsection [(4)] (5) of this section may  
38 elect, on an annual basis, not to comply with the requirements of subsection [(4)] (5) of this section  
39 by an affirmative vote of at least 60 percent of the owners, not including the votes of the declarant  
40 with respect to lots owned by the declarant.

41 [(7)(a)] (8)(a) The association shall provide, within 10 business days of receipt of a written re-  
42 quest from an owner, a written statement that provides:

43 (A) The amount of assessments due from the owner and unpaid at the time the request was re-

8 ciation has commenced litigation by filing a complaint against the owner and the litigation is  
9 pending when the statement would otherwise be due.

10 [(8)] **(9)(a) Except as provided in paragraph (b) of this subsection**, the association shall make  
11 the documents, information and records described in subsections (1) and [(3)] **(4)** of this section and  
12 all other records of the association reasonably available for examination and, upon written request,  
13 available for duplication by an owner and any mortgagee of a lot that makes the request in good  
14 faith for a proper purpose. [ *except that*]

15 **(b)** Records kept by or on behalf of the association may be withheld from examination and du-  
16 plication to the extent the records concern:

17 [(a)] **(A)** Personnel matters relating to a specific identified person or a person's medical records.

18 [(b)] **(B)** Contracts, leases and other business transactions that are currently under negotiation  
19 to purchase or provide goods or services.

20 [(c)] **(C)** Communications with legal counsel that relate to matters specified in [*paragraphs (a)*  
21 *and (b)*] **subparagraphs (A) and (B)** of this [*subsection*] **paragraph and the rights and duties of**  
22 **the association regarding existing or potential litigation or criminal matters.**

23 [(d)] **(D)** Disclosure of information in violation of law.

24 [(e)] **(E)** Documents, correspondence or management or board reports compiled for or on behalf  
25 of the association or the board of directors by its agents or committees for consideration by the  
26 board of directors in executive session held in accordance with ORS 94.640 (7).

27 [(f)] **(F)** Documents, correspondence or other matters considered by the board of directors in  
28 executive session held in accordance with ORS 94.640 (7).

29 [(g)] **(G)** Files of individual owners, other than those of a requesting owner or requesting  
30 mortgagee of an individual owner, including any individual owner's file kept by or on behalf of the  
31 association.

32 [(9)] **(10)** The association shall maintain a copy, suitable for the purpose of duplication, of the  
33 following:

34 (a) The declaration and bylaws, including amendments or supplements in effect, the recorded  
35 plat, if feasible, and the association rules and regulations currently in effect.

36 (b) The most recent financial statement prepared pursuant to subsection [(3)] **(4)** of this section.

37 (c) The current operating budget of the association.

38 (d) The reserve study, if any, described in ORS 94.595.

39 (e) Architectural standards and guidelines, if any.

40 [(10)] **(11)** The association, within 10 business days after receipt of a written request by an  
41 owner, shall furnish the requested information required to be maintained under subsection [(9)] **(10)**  
42 of this section.

43 [(11)] **(12)** The board of directors, by resolution, may adopt reasonable rules governing the fre-  
44 quency, time, location, notice and manner of examination and duplication of association records and  
45 the imposition of a reasonable fee for furnishing copies of any documents, information or records

1 described in this section. The fee may include reasonable personnel costs for furnishing the docu-  
2 ments, information or records.

3 **SECTION 14.** ORS 94.700 is amended to read:

4 94.700. (1) **Except as provided in subsection (2) of this section**, if entered into prior to the  
5 meeting called under ORS 94.609, no management agreement, service contract or employment con-  
6 tract which is directly made by or on behalf of the association, the board of directors or the owners  
7 as a group shall be in excess of three years.

8 **(2)(a) Subject to paragraph (b) of this subsection, the limitations under subsection (1) of**

13 **(b) A contract described in paragraph (a) of this subsection:**

14 **(A) May not have an initial term of more than 20 years; and**

15 **(B) Must be recorded with the recording officer in each county in which the planned**

17 **(c) As used in this subsection, “renewable energy facilities” means facilities generating**  
18 **electricity, heat or cooling by means of:**

19 **(A) Solar, wind, ocean, hydropower, biomass or geothermal resources; or**

20 **(B) Biofuels or hydrogen derived from renewable resources.**

21 [(2)] **(3) Any contract or agreement subject to subsection (1) of this section and entered into**  
22 **after July 1, 1982, may terminate without penalty to the declarant, the association or the board of**  
23 **directors elected under ORS 94.616 if the board of directors gives not less than 30 days written no-**  
24 **tice of termination to the other party not later than 60 days after the meeting called under ORS**  
25 **94.609.**

26 **SECTION 15.** ORS 94.704 is amended to read:

27 94.704. (1) Subject to subsection (2) of this section, the declarant of a planned community shall  
28 pay all common expenses of the planned community until the individual lots subject to assessment  
29 are assessed for common expenses as specified in the declaration pursuant to ORS 94.580 (2).

30 (2) If the declaration expressly authorizes deferment, the declarant may defer payment of ac-  
31 crued assessments for reserves required under ORS 94.595 for a lot subject to assessment until the  
32 date the lot is conveyed. However, the declarant may not defer payment of accrued assessments for  
33 reserves:

34 (a) Beyond the date of the turnover meeting provided for in the bylaws in accordance with ORS  
35 94.635 (3); or

36 (b) If a turnover meeting is not held, the date the owners assume administrative control of the

44 **the association has maintenance, repair or replacement responsibility under the declaration**

1 (B) To make emergency repairs to a lot that are necessary for the public safety or to

43 100.020. (1) Except as otherwise provided in subsections (2) and (3) of this section, ORS 100.100  
44 to 100.625 apply only to property located within this state which a person elects to submit to the  
45 condominium form of ownership as provided in ORS 100.005 to 100.625.

1 (2) Unless the declarant elects otherwise, ORS 100.175, 100.185, 100.200 (2), 100.205, 100.210,  
2 100.300, 100.305, 100.310, 100.315 and 100.320 apply only to condominiums that include units to be  
3 used for residential purposes.

4 (3) Property may not be submitted to the condominium form of ownership under ORS 100.005 to  
5 100.625 unless:

6 (a) Each unit has legal access to a public street or highway or, if the unit has such access only  
7 by virtue of common ownership with other units, the declaration executed under ORS 100.110 pro-  
8 hibits conveyance of the unit unless after conveyance the unit will continue to have legal access to

10 (b) Subject to paragraph (c) of this subsection, each unit consists of:

12 (B) A space used for the parking or storage of automobiles, trucks, boats, campers or other ve-

5 allocation of undivided interest in the common elements, the method of determining liability for  
6 common expenses, the method of determining the right to common profits or the method of deter-  
7 mining voting rights of any unit unless such amendment has been approved by the owners of the  
8 affected units.

9 (7) The declaration may not be amended to limit or diminish any right of a declarant reserved  
10 under ORS 100.105 (2) or (7) or any other special declarant right without the consent of the  
11 declarant. However, the declarant may waive the declarant's right of consent.

12 (8) Nothing in this section shall affect any other approval that may be required by the declara-  
13 tion, bylaws or other instrument.

26 (C) Be executed by the chairperson and secretary of the association and acknowledged in the  
27 manner provided for acknowledgment of deeds.

28 (e) After recording a statement under paragraph (c) of this subsection, the association shall  
29 provide a copy of the recorded statement to the county surveyor. [*Upon receipt of the copy or other*  
30 *notification, the county surveyor shall, upon the surveyor’s copy of all previously recorded plats relating*  
31 *to the condominium and any copies of the plat filed under ORS 92.120 (3), make appropriate marks and*  
32 *notations, including the date and the surveyor’s name or initials, with archival quality black ink in a*  
33 *manner that denotes the reclassification or withdrawal. The recording index numbers and date of re-*  
34 *coding of the statement shall also be referenced on the copy of each plat.] The original plat may not  
35 be changed or corrected after it is recorded with the county clerk.*

- 45 [(3)] (2) The supplemental plat required under ORS 100.150 (1) shall be recorded simultaneously

1 with the supplemental declaration. *[Upon request, the person offering the supplemental plat for re-*  
2 *ording shall also file an exact copy, certified by the surveyor who made the plat to be an exact copy*  
3 *of the plat, with the county assessor and the county surveyor. The exact copy shall be made on suitable*  
4 *drafting material having the characteristics of strength, stability and transparency required by the*  
5 *county surveyor.]* The supplemental plat[,] **shall be** titled in accordance with subsection [(4)] **(3)** of  
6 this section[,] **and** shall:

7 (a) Comply with ORS 92.050, 92.060 (1), (2) and (4), 92.080, 92.120 and subsections [(4) and] **(3)**  
8 **to** (5) of this section.

9 (b) If any property is withdrawn:

10 (A) Show the resulting perimeter boundaries of the condominium after the withdrawal; and

11 (B) Show the information required under subsection [(2)(i)] **(1)(i)** of this section as it relates to  
12 any remaining variable property.

13 (c) If any property is reclassified, show the information required under subsection [(2)(a)] **(1)(a)**  
14 to (d) of this section.

15 (d) Include a “Declarant’s Statement” that the property described on the supplemental plat is  
16 reclassified or withdrawn from the condominium and that the condominium exists as described and  
17 depicted on the plat.

18 (e) Include a surveyor’s *[affidavit]* **certificate** complying with ORS 92.070.

19 [(4)] **(3)** The title of each supplemental plat described in ORS 100.120 shall include the complete  
20 name of the condominium, followed by the additional language specified in this subsection and the  
21 appropriate reference to the stage being annexed or tract of variable property being reclassified.  
22 Each supplemental plat for a condominium recorded on or after January 1, 2002, shall be numbered  
23 sequentially and shall:

24 (a) If property is annexed under ORS 100.125, include the words “Supplemental Plat No.  
25 \_\_\_\_\_: Annexation of Stage \_\_\_\_\_; or

26 (b) If property is reclassified under ORS 100.150, include the words “Supplemental Plat No.  
27 \_\_\_\_\_: Reclassification of Variable Property, Tract \_\_\_\_\_.

28 **(4) Upon request of the county surveyor or assessor, the person offering a plat or sup-**  
29 **plemental plat for recording shall also file an exact copy, certified by the surveyor who made**  
30 **the plat to be an exact copy of the plat, with the county assessor and the county surveyor.**  
31 **The exact copy shall be made on suitable drafting material having the characteristics of**  
32 **strength, stability and transparency required by the county surveyor.**

33 (5) Before a plat or a supplemental plat may be recorded, it must be approved by the city or  
34 county surveyor as provided in ORS 92.100. Before approving the plat as required by this section,  
35 the city or county surveyor shall:

36 (a) Check the boundaries of the plat and units and take measurements and make computations  
37 necessary to determine that the plat complies with this section.

38 (b) Determine that the name complies with ORS 100.105 (5) and (6).

39 (c) Determine that the following are consistent:

40 (A) The designation and area in square feet of each unit shown on the plat and the unit desig-  
41 nations and areas contained in the declaration in accordance with ORS 100.105 (1)(d);

42 (B) Limited common elements identified on the plat and the information contained in the decla-  
43 ration in accordance with ORS 100.105 (1)(h);

44 (C) The description of the property in the surveyor’s certificate included on the plat and the  
45 description contained in the declaration in accordance with ORS 100.105 (1)(a); and

1 (D) For a flexible condominium, the variable property depicted on the plat and the identification  
2 of the property contained in the declaration in accordance with ORS 100.105 (7)(c).

3 (6) The person offering the plat **or supplemental plat** for approval shall:

4 (a) Submit a copy of the proposed declaration and bylaws or applicable supplemental declaration  
5 at the time the plat is submitted; and

6 (b) Submit the original or a copy of the executed declaration and bylaws or the applicable sup-  
7 plemental declaration approved by the commissioner if required by law prior to approval.

8 (7) For performing the services described in subsection (5)(a) to (c) of this section, the city sur-  
9 veyor or county surveyor shall collect from the person offering the plat for approval a fee of \$150  
10 plus \$25 per building. The governing body of a city or county may establish a higher fee by resol-  
11 ution or order.

12 *[(8)(a) Whenever variable property is reclassified or withdrawn as provided in ORS 100.155 (1) or*  
13 *(2) or property is removed as provided in ORS 100.600 (2), the county surveyor shall, upon the sur-*  
14 *veyor's copy of all previously recorded plats relating to the variable property or property being removed*  
15 *and upon any copy thereof certified by the county clerk, trace, shade or make other appropriate marks*  
16 *or notations, including the date and the surveyor's name or initials, with archival quality black ink in*  
17 *such manner as to denote the reclassification, withdrawal or removal. The recording index numbers*  
18 *and date of recording of the supplemental declaration and plat or amendment and amended plat shall*  
19 *also be referenced on the copy of each plat. The original plat may not be changed or corrected after the*  
20 *plat is recorded.]*

21 *[(b) For performing the activities described in this subsection, the county clerk shall collect a fee*  
22 *set by the county governing body. The county clerk shall also collect a fee set by the county governing*  
23 *body to be paid to the county surveyor for services provided under this subsection.]*

24 *[(9) In addition to the provisions of subsection (12) of this section, a plat, including any floor plans*  
25 *that are a part of the plat, may be amended as follows:]*

26 *[(a)(A) Except as otherwise provided in ORS 100.600, a change to the boundary of the property, a*  
27 *unit or a limited common element or a change to the configuration of other information required to be*  
28 *graphically depicted on the plat shall be made by a plat entitled "Plat Amendment" that shall reference*  
29 *in the title of the amendment the recording information of the original plat and any previous plat*  
30 *amendments.]*

31 *[(B) The plat amendment shall comply with ORS 92.050, 92.060 (1), (2) and (4), 92.080 and 92.120*  
32 *and shall include:]*

33 *[(i) A graphic depiction of the change.]*

34 *[(ii) For a change to the boundary of the property, a surveyor's certificate, complying with ORS*  
35 *92.070.]*

36 *[(iii) For a change to a boundary of a unit or a limited common element or a change to other in-*  
37 *formation required to be graphically depicted, the statement of a registered architect, registered pro-*  
38 *fessional land surveyor or registered professional engineer described in subsection (2)(d) of this*  
39 *section.]*

40 *[(iv) A declaration by the chairperson and secretary on behalf of the association of unit owners that*  
41 *the plat is being amended pursuant to this subsection. Such declaration shall be executed and ac-*  
42 *knowledged in the manner provided for acknowledgment of deeds.]*

43 *[(C) The plat amendment shall be accompanied by an amendment to the declaration authorizing*  
44 *such plat amendment. The declaration amendment shall be executed, approved and recorded in ac-*  
45 *cordance with ORS 100.110 and 100.135.]*

1        *[(D) Before a plat amendment may be recorded, it must be approved by the city or county surveyor*  
2 *as provided in ORS 92.100. The surveyor shall approve the plat amendment if it complies with the*  
3 *requirements of this subsection. The person offering the plat amendment shall:]*

4        *[(i) Submit a copy of the proposed amendment to the declaration required under this paragraph*  
5 *when the plat amendment is submitted; and]*

6        *[(ii) Submit the original or a copy of the executed amendment to the declaration approved by the*  
7 *commissioner if required by law prior to approval of the plat amendment.]*

8        *[(E) Upon request, the person offering the plat amendment for recording shall also file an exact*  
9 *copy, certified by the surveyor who made the plat to be an exact copy of the plat amendment, with the*  
10 *county assessor and the county surveyor. The exact copy shall be made on suitable drafting material*  
11 *having the strength, stability and transparency required by the county surveyor.]*

12        *[(b)(A) A change to a restriction or other information not required to be graphically depicted on*  
13 *the plat may be made by amendment of the declaration without a plat amendment described in para-*  
14 *graph (a) of this subsection. An amendment under this paragraph shall include:]*

15        *[(i) A reference to recording index numbers and date of recording of the declaration, plat and any*  
16 *applicable supplemental declarations, amendments, supplemental plats or plat amendments.]*

17        *[(ii) A description of the change to the plat.]*

18        *[(iii) A statement that the amendment was approved in accordance with the declaration and ORS*  
19 *100.135.]*

20        *[(B) The amendment shall be executed, approved and recorded in accordance with ORS 100.110*  
21 *and 100.135.]*

22        *[(C) Before the amendment may be recorded, it must be approved by the city or county surveyor*  
23 *as provided in ORS 92.100. The surveyor shall approve the amendment if it complies with this sub-*  
24 *section. Such approval shall be evidenced by execution of the amendment or by written approval at-*  
25 *tached thereto.]*

26        *[(c)(A) Floor plans of a condominium for which a plat was not required at the time of creation*  
27 *may be amended by an amendment to the declaration. An amendment under this paragraph shall in-*  
28 *clude:]*

29        *[(i) A reference to recording index numbers and date of recording of the declaration and any ap-*  
30 *plicable supplemental declarations or amendments.]*

31        *[(ii) A description of the change to the floor plans.]*

32        *[(iii) A graphic depiction of any change to the boundaries of a unit or common element and a*  
33 *statement by a registered architect, registered professional land surveyor or registered professional en-*  
34 *gineer certifying that such graphic depiction fully and accurately depicts the boundaries of the unit or*  
35 *common element as it currently exists.]*

36        *[(B) The amendment shall be approved and recorded in accordance with ORS 100.110 and 100.135*  
37 *except that any change to the floor plans need only comply with the requirements of the unit ownership*  
38 *laws in effect at the time the floor plans were initially recorded.]*

39        *[(10) After recording of any declaration amendment or plat amendment pursuant to subsection (9)*  
40 *of this section, the county surveyor shall, upon the surveyor's copy of all previously recorded plats re-*  
41 *lating to the condominium and any copies filed under ORS 92.120 (3), make such appropriate marks*  
42 *or notations, including the date and the surveyor's name or initials, with archival quality black ink in*  
43 *such manner as to denote the changes. The recording index numbers and date of recording of the*  
44 *declaration amendment and any plat amendment shall also be referenced on the copy of each plat. The*  
45 *original plat may not be changed or corrected after the plat is recorded.]*

1       [(11) For performing the services described in subsections (9) and (10) of this section, the county  
2 surveyor shall collect from the person offering the plat amendment or declaration amendment for ap-  
3 proval a fee established by the county governing body.]

4       [(12) The following may be amended by an affidavit of correction in accordance with ORS  
5 92.170:]

6       [(a) A plat, whenever recorded.]

7       [(b) Floor plans recorded prior to October 15, 1983.]

8       **SECTION 42.** Section 43 of this 2009 Act is added to and made a part of ORS chapter 100.

9       **SECTION 43.** (1) A plat, including any floor plans that are a part of a plat, recorded be-  
10 fore October 15, 1983, may be amended as provided in this section.

11       (2)(a) Except as otherwise provided in ORS 100.600, the following must be made by a plat  
12 entitled "Plat Amendment":

13       (A) A change to the boundary of the property, a unit or a limited common element;

14       (B) The creation of an additional unit from common elements; or

15       (C) A change to the configuration of other information required to be graphically depicted  
16 on the plat.

17       (b) The plat amendment shall reference in the title of the amendment the recording in-  
18 formation of the original plat and any previous plat amendments.

19       (3) The plat amendment shall comply with ORS 92.050, 92.060 (1), (2) and (4), 92.080 and  
20 92.120 and shall include:

21       (a) A graphic depiction of the change;

22       (b) For a change to the boundary of the property, a surveyor's certificate that complies  
23 with ORS 92.070;

24       (c) If the plat amendment is an amendment by correction under section 43b of this 2009  
25 Act, a statement that the plat amendment is an amendment by correction under section 43b  
26 of this 2009 Act;

27       (d) A certification, including signature and official seal, of a registered professional land  
28 surveyor that:

29       (A) The plat amendment accurately depicts the amendments to the plat described in the  
30 declaration amendment recorded under subsection (5) of this section; and

31       (B) Any construction that changes the boundaries of a unit or limited common element  
32 or the construction of any additional unit or limited common element has been completed;  
33 and

34       (e) A declaration by the chairperson and secretary on behalf of the association of unit  
35 owners that the plat is being amended pursuant to this section. If the amendment to the  
36 declaration required under subsection (5) of this section is a correction amendment under  
37 section 43a of this 2009 Act, the declaration shall be by the declarant if the declarant adopts  
38 the correction amendment under section 43a of this 2009 Act.

39       (4) The declaration required under subsection (3)(e) of this section shall be executed and  
40 acknowledged in the manner provided for acknowledgment of deeds.

41       (5) The plat amendment shall be accompanied by an amendment to the declaration au-  
42 thorizing the plat amendment. The declaration amendment shall be executed, approved and  
43 recorded in accordance with ORS 100.110 and 100.135 or section 43a of this 2009 Act, if the  
44 declaration amendment is a correction amendment under section 43a of this 2009 Act.

45       (6) Before a plat amendment may be recorded, it must be approved by the city or county

1 surveyor as provided in ORS 92.100. The surveyor shall approve the plat amendment if it  
2 complies with the requirements of this subsection. The person offering the plat amendment  
3 shall:

4 (a) Submit a copy of the proposed amendment to the declaration required under sub-  
5 section (3) of this section when the plat amendment is submitted.

6 (b) Submit the original or a copy of the executed amendment to the declaration approved  
7 by the Real Estate Commissioner if required by law prior to approval of the plat amendment.

8 (c) Upon request, file an exact copy, certified by the surveyor who made the plat to be  
9 an exact copy of the plat amendment, with the county assessor and the county surveyor. The  
10 exact copy shall be made on suitable drafting material having the strength, stability and  
11 transparency required by the county surveyor.

12 (7) A change to a restriction or other information not required to be graphically depicted  
13 on the plat may be made by amendment of the declaration without a plat amendment de-  
14 scribed in subsection (3) of this section. A declaration amendment under this subsection shall  
15 include:

16 (a) References to recording index numbers and date of recording of the declaration or  
17 plat and any applicable supplemental declarations, amendments, supplemental plats or plat  
18 amendments.

19 (b) A description of the change to the plat.

20 (c) A statement that the amendment was approved in accordance with the declaration  
21 and ORS 100.135.

22 (8) The declaration amendment described in subsection (7) of this section shall be exe-  
23 cuted, approved and recorded in accordance with ORS 100.110 and 100.135.

24 (9) Before the declaration amendment described in subsection (7) of this section may be  
25 recorded, it must be approved by the city or county surveyor as provided in ORS 92.100. The  
26 surveyor shall approve the declaration amendment if it complies with subsection (7) of this  
27 section. Such approval shall be evidenced by execution of the amendment or by written ap-  
28 proval attached thereto.

29 (10) Floor plans of a condominium for which a plat was not required at the time of cre-  
30 ation may be amended by amendment of the declaration. An amendment under this sub-  
31 section shall include:

32 (a) References to recording index numbers and date of recording of the declaration and  
33 any applicable supplemental declarations or amendments.

34 (b) A description of the change to the floor plans.

35 (c) A graphic depiction of any change to the boundaries of a unit or common element and  
36 a statement by a registered architect, registered professional land surveyor or registered  
37 professional engineer certifying that such graphic depiction fully and accurately depicts the  
38 boundaries of the unit or common element as it currently exists.

39 (11) The declaration amendment described in subsection (10) of this section shall be ap-  
40 proved and recorded in accordance with ORS 100.110 and 100.135 except that any change to  
41 the floor plans need only comply with the requirements of the unit ownership laws in effect  
42 at the time the floor plans were initially recorded.

43 (12) After recording of any declaration amendment or plat amendment pursuant to this  
44 section, the county surveyor shall, upon the surveyor's copy of all previously recorded plats  
45 relating to the condominium and any copies filed under ORS 92.120 (3), make such appropri-

1 ate marks or notations, including the date and the surveyor's name or initials, with archival  
2 quality black ink in such manner as to denote the changes. The recording index numbers and  
3 date of recording of the declaration amendment and any plat amendment shall also be ref-  
4 erenced on the copy of each plat. The original plat may not be changed or corrected after  
5 the plat is recorded.

6 (13) For performing the services described in subsections (9) and (12) of this section, the  
7 county surveyor shall collect from the person offering the plat amendment or declaration  
8 amendment for approval a fee established by the county governing body.

9 **SECTION 43a.** (1) As used in this section and section 43b of this 2009 Act, "document"  
10 means the declaration, supplemental declaration or bylaws of a condominium.

11 (2) Notwithstanding a provision in a document or this chapter, a document or an  
12 amendment to a document may be corrected by a correction amendment under this section  
13 to:

14 (a) Correct the omission of an exhibit to a document.

15 (b) Correct a mathematical mistake, including, but not limited to:

16 (A) The calculation of the stated interest of affected units in the common elements;

17 (B) The area in square feet of a unit specified in the declaration or supplement declara-  
18 tion; and

19 (C) Liability of a unit for common expenses or right to common profits.

20 (c) Correct an inconsistency within a document or between or among the documents or  
21 a plat, supplemental plat or plat amendment.

22 (d) Correct an ambiguity, inconsistency or error with respect to an objectively verifiable  
23 fact.

24 (e) Conform the declaration or supplemental declaration to a plat amendment under  
25 section 43 of this 2009 Act or an affidavit of correction under section 43b of this 2009 Act.

26 (f) Correct a provision that is inconsistent with this chapter.

27 (g) Correct the omission of a provision required under this chapter.

28 (3) A correction amendment adopted under subsection (4) of this section shall include:

29 (a) The words "Correction Amendment" in or after the title;

30 (b) A reference to the recording index numbers and date of recording of the declaration,  
31 bylaws, plat, the document being corrected and any other applicable supplemental declara-  
32 tions, supplemental plats or amendments to the documents;

33 (c) A statement of the purpose of the correction; and

34 (d) A reference to this section.

35 (4) The board of directors may adopt a correction amendment under this section after  
36 giving notice as provided in subsection (8) of this section. No action by the unit owners is  
37 required.

38 (5) The declarant of the condominium may unilaterally adopt a correction amendment  
39 under this section to:

40 (a) A document or an amendment to a document, before the conveyance of the first unit  
41 in the condominium.

42 (b) A supplemental declaration or an amendment to the supplemental declaration, before  
43 conveyance of the first unit in the particular phase or stage.

44 (6) A correction amendment under this section shall be approved by the Real Estate  
45 Commissioner under ORS 100.110 and, to the extent required, ORS 100.410, the county

1 assessor in accordance with ORS 100.110 and, if required, the county tax collector.

2 (7) A correction amendment that corrects the boundary of a unit, common element,  
3 variable property or other property interest constitutes a conveyance to the extent neces-  
4 sary to effectuate the correction.

5 (8)(a) Except for a correction amendment adopted by a declarant under subsection (5) of  
6 this section, the notice of any meeting of the board of directors at which the board intends  
7 to consider adoption of a correction amendment under this section must:

8 (A) State that the board intends to consider the adoption of a correction amendment.

9 (B) Specify the document to be corrected.

10 (C) Include a general description of the nature of the correction.

11 (b) At least three days before the meeting of the board of directors, a notice of the  
12 meeting must be given to all owners in the manner described in ORS 100.420 (3).

13 (9) The owner of a unit materially affected by the correction must be given notice of the  
14 meeting of the board of directors under subsection (8) of this section in the manner required  
15 under ORS 100.407 (4).

16 (10) The board of directors shall provide a copy of the recorded correction amendment  
17 and any plat amendment by correction or by affidavit of correction under section 43b of this  
18 2009 Act recorded concurrently with the correction amendment to any owner described un-  
19 der subsection (9) of this section and to any owner if the correction changes that owner's:

20 (a) Allocation of voting rights;

21 (b) Liability for common expenses that changes the amount of any assessment; or

22 (c) Allocation of interest in the common elements.

23 **SECTION 43b.** (1) Unless the context requires otherwise, as used in this section "plat"  
24 means:

25 (a) A plat recorded under ORS 100.115.

26 (b) Floor plans made part of a plat that was recorded before October 15, 1983.

27 (c) A supplemental plat recorded under ORS 100.115.

28 (d) A plat amendment recorded under section 43 of this 2009 Act.

29 (2) Notwithstanding a provision in a document of a condominium or this chapter, a plat  
30 may be corrected by a plat amendment under section 43 of this 2009 Act as provided in sub-  
31 section (3) of this section or by an affidavit of correction as provided in subsection (4) of this  
32 subsection.

33 (3) Except as provided in subsection (4) of this section, a correction to a plat must be  
34 made by a plat amendment in accordance with section 43 of this 2009 Act. The plat amend-  
35 ment by correction may:

36 (a) Conform the designation, depiction or boundaries of a unit, common elements or  
37 variable property on the plat to the physical location or actual dimensions of the unit, com-  
38 mon elements or variable property.

39 (b) Correct a mathematical mistake.

40 (c) Correct the designation of a unit or limited common element.

41 (d) Make any other correction permitted under section 43a of this 2009 Act.

42 (4) An affidavit of correction may correct a plat to:

43 (a) Show any courses or distances omitted from the plat.

44 (b) Correct an error in any courses or distances shown on the plat.

45 (c) Correct an error in the description of the real property shown on the plat.



1 (d) Correct any other errors or omissions when the error or omission is ascertainable  
2 from the data shown on the plat.

3 (e) Correct any other errors or omissions on the plat determined by the county surveyor.

4 (5) Nothing in subsection (4) of this section may be construed to permit changes in  
5 courses or distances for the purpose of redesigning unit, common element or variable prop-  
6 erty configurations by affidavit of correction under this section.

7 (6) The affidavit of correction shall be prepared by the registered professional land sur-  
8 veyor whose signature and seal are on the plat. In the event of the death, disability or re-  
9 tirement from practice of the surveyor, the county surveyor may prepare and record the  
10 affidavit of correction.

11 (7) The affidavit of correction prepared under subsection (6) of this section shall:

12 (a) Set forth in detail the corrections made; and

13 (b) Contain the seal and signature of the registered professional land surveyor making  
14 the correction which shall be affixed to the affidavit of correction.

15 (8) The affidavit of correction shall be submitted to the county surveyor for examination  
16 and a determination that:

17 (a) The changes shown on the affidavit of correction are permitted under subsection (4)  
18 of this section; and

19 (b) The affidavit of correction complies with subsection (7)(a) of this section.

20 (9) If the county surveyor determines that the affidavit of correction complies with sub-  
21 section (7) of this section, the county surveyor shall sign a certification that the affidavit  
22 of correction has been examined and complies with this section. The certification shall be a  
23 part of or an attachment to the affidavit of correction.

24 (10)(a) Before an affidavit of correction is recorded, it must be approved by the Real Es-  
25 tate Commissioner. The affidavit of correction shall be filed with the commissioner under  
26 ORS 100.670.

27 (b) The commissioner shall approve the affidavit of correction if it complies with this  
28 section. The approval shall be evidenced by execution of the affidavit of correction.

29 (11)(a) The surveyor who prepared the affidavit of correction shall cause the affidavit of  
30 correction to be recorded by the recording officer of the county where the plat or supple-  
31 mental plat is recorded.

32 (b) If a correction by an affidavit of correction requires a correction amendment to a  
33 document under section 43a of this 2009 Act, the affidavit of correction must be recorded  
34 concurrently with the correction amendment.

35 (12) The surveyor who prepared the affidavit of correction shall cause a copy of the re-  
36 corded affidavit of correction to be provided to:

37 (a) The association of unit owners of the condominium, at the address shown in the  
38 Condominium Information Report filed in accordance with ORS 100.250 or such other address  
39 of which the surveyor has knowledge.

40 (b) The county surveyor, unless otherwise directed by the county surveyor.

41 (c) The commissioner.

42 (13)(a) Unless otherwise specified in the affidavit of correction, after recording the affi-  
43 davit of correction, the county clerk shall return the affidavit of correction to the county  
44 surveyor.

45 (b) Upon receipt of the original recorded affidavit of correction or a copy, the county

1 surveyor shall note the correction and the recorder's filing information, with permanent ink,  
2 upon any true and exact copies filed in accordance with ORS 92.120 (3). The corrections and  
3 filing information shall be marked in such a manner so as not to obliterate any portion of  
4 the plat.

5 (14) For recording the affidavit of correction under subsection (11) of this section, the  
6 county clerk shall collect a fee as provided in ORS 205.320. Corrections or changes are not  
7 allowed on the original plat once it is recorded.

8 (15) For performing the services described in this section, the county surveyor shall  
9 collect from the person submitting the affidavit of correction a fee established by the county  
10 governing body.

11 **SECTION 44.** ORS 100.120 is amended to read:

12 100.120. (1) To annex additional property to the condominium or to reclassify variable property  
13 under ORS 100.125 or 100.150, a supplemental declaration and a supplemental plat shall be executed,  
14 approved and recorded by declarant at the time of each annexation or reclassification. The supple-  
15 mental plat shall comply with ORS 100.115 and the supplemental declarations shall:

16 (a) Include a reference to recording index numbers and date of recording of the initial declara-  
17 tion and bylaws.

18 (b) Be consistent with the provisions of the original declaration prepared pursuant to ORS  
19 100.105 and any prior recorded supplemental declarations.

20 (c) Contain the information required by ORS 100.105 (1) insofar as that information relates to  
21 the property being annexed or reclassified.

22 (d) State the allocation of undivided interest in the common elements of each unit previously  
23 submitted to the provisions of this chapter upon the creation or annexation of the additional prop-  
24 erty.

25 (e) If the stage being annexed contains any variable property, include the information required  
26 under ORS 100.105 (7) insofar as that information relates to the property being annexed. The ter-  
27 mination date shall be consistent with the information included in the declaration in accordance  
28 with ORS 100.105 (2)(b) but may not exceed seven years from the recording of the conveyance of the  
29 first unit in the stage to a person other than the declarant. Recording shall be in the county in  
30 which the property is located.

31 (2) If the Condominium Information Report and the Annual Report described in ORS 100.250 are  
32 designated current as provided in ORS 100.255, all such supplemental declarations and plats shall  
33 be approved, executed and recorded as provided in ORS 100.100, 100.110 and 100.115. No unit being  
34 annexed or created by a supplemental declaration shall be conveyed until after such recording.

35 (3) To withdraw all or a portion of variable property from a flexible condominium pursuant to  
36 ORS 100.150 (1)(b), a supplemental declaration and plat shall be recorded in accordance with sub-  
37 section (2) of this section. The supplemental plat shall comply with ORS 100.115 [(3)] (2) and the  
38 supplemental declaration shall:

39 (a) Be consistent with the provisions of the declaration or supplemental declaration drawn pur-  
40 suant to ORS 100.105 (7).

41 (b) Include a metes and bounds legal description of the variable property being withdrawn.

42 (c) Include a metes and bounds legal description of the resulting boundaries of the condominium  
43 after the withdrawal.

44 (d) State whether or not any variable property remains which may be reclassified or withdrawn  
45 from the condominium and, if property may be withdrawn, include the statement required under ORS

1 100.105 (7)(m).

2 (e) If any variable property is being redesignated as “nonwithdrawable variable property,” in-  
3 clude the information required under ORS 100.105 (7)(L).

4 (4) Except as provided in subsection (5) of this section, as to property submitted to unit owner-  
5 ship after October 4, 1977, additional units may not be added within property previously submitted  
6 to unit ownership unless all unit owners consent to an amendment to the declaration, plat and any  
7 floor plans recorded pursuant to [ORS 100.115] **section 43 of this 2009 Act** in order to provide for  
8 such additional units.

9 (5) As to property submitted to unit ownership before September 27, 1987, if the declaration  
10 provides that additional property may be annexed to the condominium, any subsequent stage may  
11 contain variable property. The termination date may not be later than the earlier of:

12 (a) The date specified in the declaration under ORS 100.105 (2)(b); or

13 (b) Seven years from the recording of the conveyance of the first unit in the condominium to a  
14 person other than the declarant. Recording shall be in the county in which the property is located.

15 **SECTION 45.** ORS 100.125 is amended to read:

16 100.125. Subject to ORS 100.120 (4), if the declaration complies with ORS 100.105 (2), until the  
17 termination date, additional property may be annexed to the condominium by the recording of a  
18 supplemental declaration and supplemental plat in accordance with ORS [100.115 and] 100.120 **and**  
19 **section 43 of this 2009 Act.**

20 **SECTION 46.** ORS 100.130 is amended to read:

21 100.130. (1) Subject to any limitations contained in the declaration, the boundaries between ad-  
22 joining units, including any intervening common elements, may be relocated or eliminated by an  
23 amendment to the declaration. The owners of the affected units shall submit to the board of direc-  
24 tors of the association a proposed amendment which shall identify the units involved, state any re-  
25 allocations of common element interest, voting rights, common expense liability and right to common  
26 profits and contain words of conveyance. The board of directors shall approve the amendment unless  
27 it determines within 45 days that the reallocations are unreasonable or the relocation or elimination

45 100.515. (1) Each unit shall be entitled to an undivided interest in the common elements in the

1 allocation expressed in the declaration. Such allocation shall be expressed as a fraction or percent-  
 2 age of undivided interest in the common elements. Except as otherwise provided in this chapter, the  
 3 allocation of undivided interest of each unit in the common elements as expressed in a declaration  
 4 shall not be altered unless all unit owners having an interest in the particular common element
