

Senate Bill 965

Sponsored by Senator JOHNSON; Senator BONAMICI, Representatives BOONE, RILEY, WITT (at the request of Cornelius Pass Task Force and Taija Belwood Foundation)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Authorizes photo radar in Multnomah County on Cornelius Pass Road.

A BILL FOR AN ACT

2 Relating to photo radar; amending ORS 810.438.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 810.438 is amended to read:

5 810.438. (1) The following jurisdictions may, at their own cost, operate photo radar:

6 (a) Albany.

7 (b) Beaverton.

8 (c) Bend.

9 (d) Eugene.

10 (e) Gladstone.

11 (f) Medford.

12 (g) Milwaukie.

13 (h) Oregon City.

14 (i) Portland.

15 (j) Tigard.

16 **(k) Multnomah County, for the purpose of operating photo radar on the portion of**
17 **Cornelius Pass Road within the boundaries of Multnomah County.**

18 (2) A photo radar system operated under this section:

19 (a) May be used on streets in residential areas or school zones.

20 (b) May be used in other areas if the governing body of the *[city]* **jurisdiction** makes a finding
21 that speeding has had a negative impact on traffic safety in those areas.

22 (c) May not be used for more than four hours per day in any one location.

23 (d) May not be used on controlled access highways.

24 (e) May not be used unless a sign is posted announcing "Traffic Laws Photo Enforced." The sign
25 posted under this paragraph must be all of the following:

26 (A) On the *[street]* **highway** on which the photo radar unit is being used.

27 (B) Between 100 and 400 yards before the location of the photo radar unit.

28 (C) At least two feet above ground level.

29 (3) A *[city]* **jurisdiction** that operates a photo radar system under this section shall, once each
30 biennium, conduct a process and outcome evaluation for the purposes of subsection (4) of this sec-
31 tion that includes:

- 1 (a) The effect of the use of the photo radar system on traffic safety;
- 2 (b) The degree of public acceptance of the use of the photo radar system; and
- 3 (c) The process of administration of the use of the photo radar system.
- 4 (4) By March 1 of the year of each regular session of the Legislative Assembly:

5 (a) The Department of Transportation shall provide to the Legislative Assembly an executive
6 summary of the process and outcome evaluations conducted under subsection (3) of this section; and

7 (b) Each [*city*] **jurisdiction** that operates a photo radar system under this section shall present
8 to the Legislative Assembly the process and outcome evaluation conducted by the [*city*] **jurisdiction**
9 under subsection (3) of this section.
