 - "(g) Committees shall consider measures in the chamber of origin no later than April 28, 2009. This paragraph does not apply to the Joint Committee on Ways and Means, other joint committees, Senate Committee on Finance and Revenue, House Committee on Revenue, Senate Committee on Rules and House Committee on Rules.
 - "(h) Committee chairpersons shall schedule work sessions for measures in the second chamber no later than May 20, 2009. This paragraph does not apply to the Joint Committee on Ways and Means, other joint committees, Senate Committee on Finance and Revenue, House Committee on Revenue, Senate Committee on Rules and House Committee on Rules.
 - "(i) Committees of the Senate and House of Representatives shall close no later than May 28, 2009. This paragraph does not apply to the Joint Committee on Ways and Means, other joint committees, Senate Committee on Finance and Revenue, House Committee on Revenue, Senate Committee on Rules and House Committee on Rules.
 - "(j) The Seventy-fifth Legislative Assembly shall adjourn no later than June 30, 2009.
 - "(2) The rules of the Senate and House of Representatives shall apply to matters not specified in this resolution. The rules of the Senate and House of Representatives may establish timelines for priority measures, for measures approved by the presiding officers or for appropriation and fiscal measures approved by the Joint Committee on Ways and Means that are different from the timelines
