Whereas the work of the Legislative Fiscal Office is vital to the legislative process; and

Whereas the Legislative Fiscal Office has tirelessly served the Legislative Assembly for 50 years; now, therefore,

Be It Resolved by the Legislative Assembly of the State of Oregon:
