### JOINT RESOLUTION

2 Whereas the Legislative Fiscal Office is a permanent, nonpartisan legislative service agency;

4 Whereas the Legislative Fiscal Office provides the Legislative Assembly with research, analysis  
5 and evaluation of state expenditures, financial affairs, program administration and agency organ-  
6 ization; and

7 Whereas the Legislative Fiscal Office ascertains facts and makes recommendations to the Leg-  
8 islative Assembly concerning the Governor's budget report; and

9 Whereas the Legislative Fiscal Office ascertains facts and makes recommendations on such  
10 other matters as may be provided for by joint or concurrent resolution; and

11 Whereas the Legislative Fiscal Office serves as the committee administrative staff for the Joint  
12 Committee on Ways and Means and the Emergency Board; and

13 Whereas the Legislative Fiscal Office furnishes such assistance in the performance of their du-  
14 ties as is requested by the other committees and members of the Legislative Assembly; and

15 Whereas the work of the Legislative Fiscal Office is vital to the legislative process; and

16 Whereas the Legislative Fiscal Office has tirelessly served the Legislative Assembly for 50  
17 years; now, therefore,

### 18 **Be It Resolved by the Legislative Assembly of the State of Oregon:**

19 That we, the members of the Seventy-fifth Legislative Assembly, extend our gratitude to the  
20 Legislative Fiscal Office for 50 years of exceptional service to the Legislative Assembly.
