WHAT THE MEASURE DOES: Modifies date on which regular sessions of Legislative Assembly are to begin. Establishes that modification becomes operative only if Senate Joint Resolution 41 (2010) is approved by the people at next regular general election. Allows Legislative Assembly to adjourn for more than three calendar days during January 2011 and suspends payment for per diem during January 2011 for days during which Legislative Assembly is in recess. Clarifies that authorization to adjourn for more than three days and suspension of per diem during January 2011 only becomes operative if Senate Joint Resolution 41 (2010) is not approved by the people at next regular general election.

ISSUES DISCUSSED:

EFFECT OF COMMITTEE AMENDMENT: No amendment.

BACKGROUND: Article IV, Section 10 of the Oregon Constitution establishes that “the sessions of the Legislative Assembly shall be held biennially at the Capitol of the State commencing on the second Monday of September, in the year eighteen hundred and fifty eight, and on the same day of every second year thereafter, unless a different date shall have been appointed by law.”

ORS 171.010 establishes that “the sessions of the Legislative Assembly shall be held at the capital of the state and shall commence on the second Monday in January of each odd-numbered year.” Senate Bill 1063 would change the date for the start of a regular Legislative Session from the second Monday in January to the first day of February of each year. If the first day of February is a Thursday, Friday, Saturday or Sunday, the regular session would begin on the following Monday.

Article IV, Section 11 of the Oregon Constitution proscribes rules of proceedings and adjournment of the Legislative Assembly. Section 11 states that “neither house shall without the concurrence of the other, adjourn for more than three days.” Senate Bill 1063 would permit the Legislative Assembly to adjourn for period of more than three days during January 2011, if Senate Joint Resolution 41 (2010) is not approved by voters at the next general election.

ORS 171.072(3) allows members of the Legislative Assembly to receive per diem for each day that the assembly is in session. If Senate Joint Resolution 41 (2010) is not approved by voters at the next general election, Senate Bill 1063 would suspend per diem for days that the Legislative Assembly is in recess during January 2011.
