SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs Home Care Commission to create Developmental Disabilities and Mental Health Committee for advisory purposes.

Modifies and creates definitions related to home care services for purpose of providing workers' compensation to certain individuals who receive compensation from Department of Human Services, certain agencies or support services brokerages. Requires department to collect names of, and other information pertaining to, those individuals before October 1, 2010. Requires department to keep and maintain information until July 1, 2013.

Provides workers' compensation to certain individuals who receive compensation from department, certain agencies or support services brokerages beginning January 1, 2011. Requires inclusion of names of, and other information pertaining to, those individuals in registry maintained by Home Care Commission on or after July 1, 2013.

Declares emergency, effective on passage.

2 Relating to home care workers; creating new provisions; amending ORS 410.600, 410.604, 410.606 and

4 Whereas home care workers and personal support workers provide essential services to seniors,
5 persons with physical disabilities and persons experiencing a developmental disability or mental ill-
6 ness; and

7 Whereas the state has a duty to provide workers' compensation coverage to home care workers
8 and personal support workers who receive funding from the state; and

9 Whereas the Legislative Assembly does not intend to compromise the resources and choices
10 available to seniors, persons with physical disabilities, persons experiencing a developmental disa-
11 bility or mental illness or the family members of seniors, persons with physical disabilities or per-
12 sons experiencing a developmental disability or mental illness; and

13 Whereas seniors, persons with physical disabilities, persons experiencing a developmental disa-
14 bility or mental illness and the family members of seniors, persons with physical disabilities and
15 persons experiencing a developmental disability or mental illness have a right to choose among
16 available services, activities and purchases, including adult support services; and

17 Whereas the Legislative Assembly does not intend to reduce the amount or scope of those ser-
18 vices, activities and purchases or to compromise the services, activities and purchases currently
19 available to persons who receive care from a home care worker or personal support worker who is
20 currently registered in the registry maintained by the Home Care Commission; now, therefore,

1 **Be It Enacted by the People of the State of Oregon:**

2 **SECTION 1. Sections 2 and 3 of this 2010 Act are added to and made a part of ORS 410.600**
3 **to 410.625.**

4 **SECTION 2. The Legislative Assembly finds and declares that the interest and welfare**
5 **of the public are served by the Home Care Commission that operates in accordance with**
6 **section 11, Article XV of the Oregon Constitution, and ORS 410.600 to 410.625 and also are**
7 **served by operations that:**

8 (1) **Do not compromise the resources of elderly persons, persons with physical disabili-**
9 **ties, persons with developmental disabilities or mental illnesses or the family members of**
10 **elderly persons, persons with physical disabilities or persons with developmental disabilities**
11 **or mental illnesses;**

12 (2) **Do not compromise the ability of elderly persons, persons with physical disabilities,**
13 **persons with developmental disabilities or mental illnesses or the family members of elderly**
14 **persons, persons with physical disabilities or persons with developmental disabilities or**
15 **mental illnesses to choose from among services, activities and purchases, including adult**
16 **support services; and**

17 (3) **Do not reduce the amount and scope of the services, activities and purchases, in-**
18 **cluding adult support services, available to elderly persons, persons with physical disabilities,**
19 **persons with developmental disabilities or mental illnesses or the family members of elderly**
20 **persons, persons with physical disabilities or persons with developmental disabilities or**
21 **mental illnesses.**

22 **SECTION 3. (1) The Home Care Commission shall create a Developmental Disabilities and**
23 **Mental Health Committee.**

24 (2) **The committee shall provide information and make recommendations to the commis-**
25 **sion on:**

26 (a) **Methods of improving the quality of services available to persons with developmental**
27 **disabilities or mental illnesses and the family members of persons with developmental disa-**
28 **bilities or mental illnesses;**

29 (b) **Means of ensuring that an adequate amount of services are available to persons with**
30 **developmental disabilities or mental illnesses and the family members of persons with de-**
31 **velopmental disabilities or mental illnesses; and**

32 (c) **All the duties and functions under ORS 410.600 to 410.625 as those duties and func-**
33 **tions pertain to persons with developmental disabilities or mental illnesses and the family**
34 **members of persons with developmental disabilities or mental illnesses, including but not**
35 **limited to:**

36 (A) **Qualifications for personal support workers;**

37 (B) **Registration of personal support workers;**

38 (C) **Referrals for routine, emergency and respite care;**

39 (D) **Training opportunities for personal support workers; and**

40 (E) **Collective bargaining.**

41 (3) **The commission shall consider the recommendations of the committee. When the**
42 **commission does not follow the recommendations of the committee, the commission shall**
43 **inform the committee of the reasons for not following the recommendations.**

44 (4) **The commission shall appoint members to the committee. In appointing members to**
45 **the committee, the commission shall include at least one:**

1 (a) Consumer of services, activities or purchases available to persons with developmental
2 disabilities;

3 (b) Consumer of services, activities or purchases available to persons with mental ill-
4 nesses;

5 (c) Family member of a person with a developmental disability;

6 (d) Family member of a person with a mental illness;

7 (e) Advocate for persons with developmental disabilities or mental illnesses;

8 (f) Personal support worker;

9 (g) Representative from an agency that assists persons with developmental disabilities
10 or mental illnesses in finding and arranging resources for home care services; and

11 (h) Representative from a support services brokerage that assists persons with develop-
12 mental disabilities or mental illnesses in finding and arranging resources for home care
13 services.

13 geographic area, who have been placed on the registry maintained by the Home Care Commission.

15 (a) The name and address of any home care worker:

16 (A) Who provides home care services;

17 (B) Whose compensation is funded in whole or in part with state funds; and

18 (C) Who is not listed on the registry maintained by the commission;

40 (a) Establishing qualifications for home care workers with the advice and consent of the De-
41 partment of Human Services [*as the single state Medicaid agency*];

42 (b) Providing training opportunities for home care workers and elderly persons and persons with
43 disabilities who employ home care workers;

44 (c) Establishing and maintaining a registry of qualified home care workers;

45 (d) Providing routine, emergency and respite referrals of home care workers;

1 (e) Entering into contracts with public and private organizations and individuals for the purpose
2 of obtaining or developing training materials and curriculum or other services as may be needed by
3 the commission; and

4 (f) Working cooperatively with area agencies and state and local agencies to accomplish the
5 duties listed in paragraphs (a) to (e) of this subsection.

6 (2)(a) The commission shall enter into an interagency agreement with the department to con-
7 tract for a department employee to serve as executive director of the commission. The executive
8 director shall be appointed by the Director of Human Services in consultation with the Governor

10 Services. The commission may delegate to the executive director the authority to act on behalf of

27 cumber, insure, sell, replace, deal in and with and dispose of real and personal property in its own

29 **SECTION 9.** ORS 656.039 is amended to read:

30 656.039. (1) An employer of one or more persons defined as nonsubject workers or not defined
31 as subject workers may elect to make them subject workers. If the employer is or becomes a
32 carrier-insured employer, the election shall be made by filing written notice thereof with the insurer
33 with a copy to the Director of the Department of Consumer and Business Services. The effective
34 date of coverage is governed by ORS 656.419 (3). If the employer is or becomes a self-insured em-
35 ployer, the election shall be made by filing written notice thereof with the director, the effective
36 date of coverage to be the date specified in the notice.

37 (2) Any election under subsection (1) of this section may be canceled by written notice thereof
38 to the insurer or, in the case of a self-insured employer, by notice thereof to the director. The can-
39 cellation is effective at 12 midnight ending the day the notice is received by the insurer or the di-
40 rector, unless a later date is specified in the notice. The insurer shall, within 10 days after receipt
41 of a notice of cancellation under this section, send a copy of the notice to the director.

42 (3) When necessary the insurer or the director shall fix assumed minimum or maximum wages
43 for persons made subject workers under this section.

44 (4) Notwithstanding any other provision of this section, a person or employer not subject to this
45 chapter who elects to become covered may apply to an insurer for coverage. An insurer other than

1 the State Accident Insurance Fund Corporation may provide such coverage. However, the State
2 Accident Insurance Fund Corporation shall accept any written notice filed and provide coverage as
3 provided in this section if all subject workers of the employers will be insured with the State Acci-
4 dent Insurance Fund Corporation and the coverage of those subject workers is not considered by
5 the State Accident Insurance Fund Corporation to be a risk properly assignable to the assigned risk
6 pool.

7 (5)(a) The Home Care Commission created by ORS 410.602 shall elect coverage on behalf of cli-
8 ents of the Department of Human Services **or the Oregon Health Authority** who employ home care
9 workers to make home care workers subject workers if the home care worker is *[paid]* **funded** by
10 the state on behalf of the client.

11 (b) As used in this subsection, "home care worker" has the meaning given that term in ORS
12 410.600.

13 **SECTION 10. (1) The amendments to ORS 410.600, 410.604, 410.606 and 656.039 by sections**

10 **partment of Human Services, area agencies, other public agencies and support services bro-**
11 **kerages may take any action necessary before the operative date specified in subsection (1)**
12 **of this section to enable the commission, the department, area agencies, other public agen-**
13 **cies and support services brokerages to exercise, on and after the operative date specified**
14 **in subsection (1) of this section, all the duties, functions and powers conferred on the com-**
15 **mission, the department, area agencies, other public agencies and support services broker-**
16 **ages by the amendments to ORS 410.606 by section 11 of this 2010 Act.**

17 **SECTION 13.** **This 2010 Act being necessary for the immediate preservation of the public**
18 **peace, health and safety, an emergency is declared to exist, and this 2010 Act takes effect**
19 **on its passage.**
