

HOUSE AMENDMENTS TO HOUSE BILL 3673

February 16

1 On page 1 of the printed bill, delete line 12 and insert:

2 “(c) Does not include the fee for a winter recreation parking permit or any other parking fee
3 of \$15 or less per day.”.

4 On page 2, delete lines 18 through 42 and insert:

5 “(4) If the owner charges for permission to use the owner’s land for one or more specific rec-
6 reational purposes and the owner provides notice in the manner provided by subsection (8) of this
7 section, the immunities provided by ORS 105.682 apply to any use of the land other than the activ-
8 ities for which the charge is imposed. If the owner charges for permission to use a specified part
9 of the owner’s land for recreational purposes and the owner provides notice in the manner provided
10 by subsection (8) of this section, the immunities provided by ORS 105.682 apply to the remainder of
11 the owner’s land.

12 “(5) The immunities provided by ORS 105.682 for gardening do not apply if the owner charges
13 more than \$25 per year for the use of the land for gardening. If the owner charges more than \$25
14 per year for the use of the land for gardening, the immunities provided by ORS 105.682 apply to any
15 use of the land other than gardening. If the owner charges more than \$25 per year for permission
16 to use a specific part of the owner’s land for gardening and the owner provides notice in the manner
17 provided by subsection (8) of this section, the immunities provided by ORS 105.682 apply to the re-
18 mainder of the owner’s land.

19 “(6) The immunities provided by ORS 105.682 for woodcutting do not apply if the owner charges
20 more than \$75 per cord for permission to use the land for woodcutting. If the owner charges more
21 than \$75 per cord for the use of the land for woodcutting, the immunities provided by ORS 105.682
22 apply to any use of the land other than woodcutting. If the owner charges more than \$75 per cord
23 for permission to use a specific part of the owner’s land for woodcutting and the owner provides
24 notice in the manner provided by subsection (8) of this section, the immunities provided by ORS
25 105.682 apply to the remainder of the owner’s land.

26 “(7) The immunities provided by ORS 105.682 for the harvest of special forest products do not
27 apply if the owner makes any charge for permission to use the land for the harvest of special forest
28 products. If the owner charges for permission to use the owner’s land for the harvest of special
29 forest products, the immunities provided by ORS 105.682 apply to any use of the land other than the
30 harvest of special forest products. If the owner charges for permission to use a specific part of the
31 owner’s land for harvesting special forest products and the owner provides notice in the manner
32 provided by subsection (8) of this section, the immunities provided by ORS 105.682 apply to the re-
33 mainder of the owner’s land.

34 “(8) Notices under subsections (4) to (7) of this section may be given by posting, as part of a
35 receipt, or by such other means as may be reasonably calculated to apprise a person of:

1 “(a) The limited uses of the land for which the charge is made, and the immunities provided
2 under ORS 105.682 for other uses of the land; or

3 “(b) The portion of the land the use of which is subject to the charge, and the immunities pro-
4 vided under ORS 105.682 for the remainder of the land.”.
