

House Bill 3684

Sponsored by COMMITTEE ON REVENUE

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law.

Takes effect on 91st day following adjournment sine die.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 238A.005 is amended to read:

8 238A.005. For the purposes of this chapter:

9 (1) "Active member" means a member of the pension program or the individual account program
10 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

11 (2) "Actuarial equivalent" means a payment or series of payments having the same value as the
12 payment or series of payments replaced, computed on the basis of interest rate and mortality as-
13 sumptions adopted by the board.

14 (3) "Board" means the Public Employees Retirement Board.

15 (4) "Eligible employee" means a person who performs services for a participating public em-
16 ployer, including elected officials other than judges. "Eligible employee" does not include:

17 (a) Persons engaged as independent contractors;

18 (b) Aliens working under a training or educational visa;

19 (c) Persons, other than workers in the Industries for the Blind Program under ORS 346.190,
20 provided sheltered employment or make-work by a public employer;

21 (d) Persons categorized by a participating public employer as student employees;

22 (e) Any person who is an inmate of a state institution;

23 (f) Employees of foreign trade offices of the Oregon Business Development Department who live
24 and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g);

25 (g) An employee actively participating in an alternative retirement program established under
26 ORS 353.250 or an optional retirement plan established under ORS 341.551;

27 (h) Employees of the Oregon University System who are actively participating in an optional
28 retirement plan offered under ORS 243.800;

29 (i) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,
30 for membership in the system under the provisions of ORS chapter 238 or other law;

31 (j) Any person who belongs to a class of employees who are not eligible to become members of

1 the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

2 (k) Any person who is retired under ORS 238A.100 to 238A.245 or ORS chapter 238 and who
3 continues to receive retirement benefits while employed; and

4 (L) Judges.

5 (5) "Firefighter" means:

6 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
7 duties include the fighting of fires;

8 (b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;
9 and

10 (c) An employee of the State Forestry Department who is certified by the State Forester as a
11 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
12 fires as described in ORS 477.064.

13 (6) "Fund" means the Public Employees Retirement Fund.

14 (7)(a) "Hour of service" means:

15 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
16 by a participating public employer for performance of duties in a qualifying position; and

17 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
18 during which an employee does not perform duties but for which the employee is directly or indi-
19 rectly paid or entitled to payment by a participating public employer for services in a qualifying
20 position, as long as the hour is within the number of hours regularly scheduled for the performance
21 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-
22 thorized leave.

23 (b) "Hour of service" does not include any hour for which payment is made or due under a plan
24 maintained solely for the purpose of complying with applicable workers' compensation laws or un-
25 employment compensation laws.

26 (8) "Inactive member" means a member of the pension program or the individual account pro-
27 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who
28 is not a retired member and who is not employed in a qualifying position.

29 (9) "Individual account program" means the defined contribution individual account program of
30 the Oregon Public Service Retirement Plan established under ORS 238A.025.

31 (10) "Member" means an eligible employee who has established membership in the pension pro-
32 gram or the individual account program of the Oregon Public Service Retirement Plan and whose
33 membership has not been terminated under ORS 238A.110 or 238A.310.

34 (11) "Participating public employer" means a public employer as defined in ORS 238.005 that
35 provides retirement benefits for employees of the public employer under the system.

36 (12) "Pension program" means the defined benefit pension program of the Oregon Public Service
37 Retirement Plan established under ORS 238A.025.

38 (13) "Police officer" means a police officer as described in ORS 238.005.

39 (14) "Qualifying position" means one or more jobs with one or more participating public em-
40 ployers in which an eligible employee performs 600 or more hours of service in a calendar year,
41 excluding any service in a job for which benefits are not provided under the Oregon Public Service
42 Retirement Plan pursuant to ORS 238A.070 (2).

43 (15) "Retired member" means a pension program member who is receiving a pension as provided
44 in ORS 238A.180 to 238A.195.

45 (16)(a) "Salary" means the remuneration paid to an active member in return for services to the

1 participating public employer, including remuneration in the form of living quarters, board or other
 2 items of value, to the extent the remuneration is includable in the employee's taxable income under
 3 Oregon law. Salary includes the additional amounts specified in paragraph (b) of this subsection,
 4 but does not include the amounts specified in paragraph (c) of this subsection, regardless of whether
 5 those amounts are includable in taxable income.

6 (b) "Salary" includes the following amounts:

7 (A) Payments of employee and employer money into a deferred compensation plan that are made
 8 at the election of the employee.

9 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the
 10 employee.

11 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit
 12 plan by the employer at the election of the employee and that is not includable in the taxable in-
 13 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on [May 1,] **December 31,**
 14 2009.

15 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the
 16 election of the employee and that is not included in the taxable income of the employee by reason
 17 of 26 U.S.C. 402(e)(3), as in effect on [May 1,] **December 31,** 2009.

18 (E) Retroactive payments made to an employee to correct a clerical error, pursuant to an award
 19 by a court or by order of or pursuant to a conciliation agreement with an administration agency
 20 charged with enforcing federal or state law protecting the employee's rights to employment or
 21 wages, which shall be allocated to and deemed paid in the periods in which the work was done or
 22 in which the work would have been done.

23 (F) The amount of an employee contribution to the individual account program that is paid by
 24 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
 25 (1) and (2)(a).

26 (G) The amount of an employee contribution to the individual account program that is not paid
 27 by the employer under ORS 238A.335.

28 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
 29 652.190.

30 (c) "Salary" does not include the following amounts:

31 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
 32 employer.

33 (B) Payments made on account of an employee's death.

34 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
 35 leave.

36 (D) Any severance payment, accelerated payment of an employment contract for a future period
 37 or advance against future wages.

38 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

39 (F) Payment for a leave of absence after the date the employer and employee have agreed that
 40 no future services in a qualifying position will be performed.

41 (G) Payments for instructional services rendered to institutions of the Oregon University System
 42 or the Oregon Health and Science University when those services are in excess of full-time em-
 43 ployment subject to this chapter. A person employed under a contract for less than 12 months is
 44 subject to this subparagraph only for the months covered by the contract.

45 (H) The amount of an employee contribution to the individual account program that is paid by

1 the employer and is not deducted from the compensation of the employee, as provided under ORS
 2 238A.335 (1) and (2)(b).

3 (I) Any amount in excess of \$200,000 for a calendar year. If any period over which salary is
 4 determined is less than 12 months, the \$200,000 limitation for that period shall be multiplied by a
 5 fraction, the numerator of which is the number of months in the determination period and the de-
 6 nominator of which is 12. The board shall adopt rules adjusting this dollar limit to incorporate
 7 cost-of-living adjustments authorized by the Internal Revenue Service.

8 (17) "System" means the Public Employees Retirement System.

9 **SECTION 2.** ORS 238A.125 is amended to read:

10 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall
 11 be paid an annual pension for the life of the member as follows:

12 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied
 13 by the number of years of retirement credit attributable to service as a police officer or firefighter.

14 (b) For service as other than a police officer or firefighter, 1.5 percent of final average salary
 15 multiplied by the number of years of retirement credit attributable to service as other than a police
 16 officer or firefighter.

17 (2) Notwithstanding any provision of ORS 238A.100 to 238A.245, the annual benefit payable to
 18 a member under the pension program and under any other tax-qualified defined benefit plan main-
 19 tained by the participating public employer may not exceed the applicable limitations set forth in
 20 26 U.S.C. 415(b), as in effect on [May 1,] **December 31**, 2009. The Public Employees Retirement
 21 Board shall adopt rules for the administration of this limitation, including adjustments in the annual
 22 dollar limitation to reflect cost-of-living adjustments authorized by the Internal Revenue Service.

23 (3) The board shall make no actuarial adjustment in a member's pension calculated under this
 24 section by reason of the member's retirement after normal retirement age.

25 **SECTION 3.** ORS 238A.150 is amended to read:

26 238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to 238A.245, an eligible em-
 27 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
 28 vices, and who subsequently returns to employment with a participating public employer with
 29 reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the
 30 probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS
 31 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2)
 32 of this section.

33 (2) The board shall adopt rules establishing benefits and service credit for any period of service
 34 in the uniformed services by an employee described in subsection (1) of this section. For the purpose
 35 of adopting rules under this subsection, the board shall consider and take into account all federal
 36 law relating to benefits and service credit for any period of service in the uniformed services, in-
 37 cluding 26 U.S.C. 414(u), as in effect on [May 1,] **December 31**, 2009. Benefits and service credit
 38 under rules adopted by the board pursuant to this subsection may not exceed benefits and service
 39 credit required under federal law for periods of service in the uniformed services.

40 **SECTION 4.** ORS 238A.170 is amended to read:

41 238A.170. (1) An active member of the pension program who is 70-1/2 years of age or older must
 42 retire not later than April 1 of the calendar year following the calendar year in which the member
 43 terminates employment with all participating public employers. An inactive member of the pension
 44 program must retire not later than April 1 of the calendar year following the calendar year in which
 45 the member attains 70-1/2 years of age.

1 (2) Notwithstanding any other provision of ORS 238A.100 to 238A.245, the entire interest of a
2 member of the pension program must be distributed over a time period commencing no later than
3 the required beginning date set forth in subsection (1) of this section, and must be distributed in a
4 manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regu-
5 lations implementing that section, as in effect on [May 1,] **December 31**, 2009. The Public Employees
6 Retirement Board shall adopt rules implementing those minimum distribution requirements.

7 **SECTION 5.** ORS 238A.230 is amended to read:

8 238A.230. (1) If a member of the pension program who is vested dies before the member's effec-
9 tive date of retirement, the Public Employees Retirement Board shall pay the death benefit provided
10 for in this section to the spouse of the member or to any other person who is constitutionally re-
11 quired to be treated in the same manner as a spouse for the purpose of retirement benefits.

12 (2)(a) The death benefit to be paid under this section shall be for the life of the spouse or other
13 person who is constitutionally required to be treated in the same manner as a spouse, and shall be
14 the actuarial equivalent of 50 percent of the pension that would otherwise have been paid to the
15 deceased member.

16 (b) For the purpose of paragraph (a) of this subsection, the amount of the pension that would
17 otherwise have been paid to the deceased member shall be calculated:

18 (A) As of the date of death if the member dies after the earliest retirement date for the member
19 under ORS 238A.165; or

20 (B) As if the member became an inactive member on the date of death and thereafter retired
21 at the earliest retirement date if the member dies before the earliest retirement date for the member
22 under ORS 238A.165.

23 (3) The death benefit provided under this section is first effective on the first day of the month
24 following the date of death of the member. The surviving spouse or other person entitled to the
25 death benefit may elect to delay payment of the death benefit, but payment must commence no later
26 than December 31 of the calendar year in which the member would have reached 70-1/2 years of age.

27 (4) Notwithstanding any other provision of ORS 238A.100 to 238A.245, distributions of death
28 benefits under the pension program must comply with the minimum distribution requirements of 26
29 U.S.C. 401(a)(9) and the regulations implementing that section, as in effect on [May 1,] **December**
30 **31**, 2009. The board shall adopt rules implementing those minimum distribution requirements.

31 **SECTION 6.** ORS 238A.370 is amended to read:

32 238A.370. Notwithstanding any other provision of ORS 238A.300 to 238A.415, the annual addition
33 to the employee and employer accounts of a member of the individual account program for a cal-
34 endar year, together with the annual additions to the accounts of the member under any other de-
35 fined contribution plan maintained by the participating public employer for a calendar year, may
36 not exceed the lesser of \$40,000, or 100 percent of the member's compensation for that calendar year.
37 For purposes of this section, "annual addition" has the meaning given that term in 26 U.S.C.
38 415(c)(2), as in effect on [May 1,] **December 31**, 2009, and "compensation" has the meaning given
39 the term "participant's compensation" in 26 U.S.C. 415(c)(3), as in effect on [May 1,] **December 31**,
40 2009. The Public Employees Retirement Board shall adopt rules for the administration of this limi-
41 tation, including adjustments in the annual dollar limitation to reflect cost-of-living adjustments au-
42 thorized by the Internal Revenue Service.

43 **SECTION 7.** ORS 238A.400 is amended to read:

44 238A.400. (1) Upon retirement on or after the earliest retirement date, as described in ORS
45 238A.165, a member of the individual account program shall receive in a lump sum the amounts in

1 the member's employee account, rollover account and employer account to the extent the member
2 is vested in those accounts under ORS 238A.320.

3 (2) In lieu of a lump sum payment under subsection (1) of this section, a member of the individ-
4 ual account program may elect to receive the amounts in the member's employee account and em-
5 ployer account, to the extent the member is vested in those accounts under ORS 238A.320, in
6 substantially equal installments paid over a period of 5, 10, 15 or 20 years, or over a period that is
7 equal to the anticipated life span of the member as actuarially determined by the Public Employees
8 Retirement Board. Installments may be made on a monthly, quarterly or annual basis. In no event
9 may the period selected by the member exceed the time allowed by the minimum distribution re-
10 quirements described in subsection (5) of this section. The board shall by rule establish the manner
11 in which installments will be adjusted to reflect investment gains and losses on the unpaid balance
12 during the payout period elected by the member under this subsection. The board by rule may es-
13 tablish minimum monthly amounts payable under this subsection. The board may require that a
14 lump sum payment, or an installment schedule different than the schedules provided for in this
15 subsection, be used to pay the vested amounts in the member's accounts if those amounts are not
16 adequate to generate the minimum monthly amounts specified by the rule.

17 (3) A member of the individual account program electing to receive installments under sub-
18 section (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies
19 before all amounts in the employee and vested employer accounts are paid, all remaining installment
20 payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary
21 may elect to receive a lump sum distribution of the remaining amounts.

22 (4) A member who is entitled to receive retirement benefits under ORS chapter 238 may receive
23 vested amounts in the member's employee account, rollover account and employer account in the
24 manner provided by this section when the member retires for service under the provisions of ORS
25 chapter 238.

26 (5) Notwithstanding any other provision of ORS 238A.300 to 238A.415, the entire interest of a
27 member of the individual account program must be distributed over a time period commencing no
28 later than the latest retirement date set forth in ORS 238A.170, and must be distributed in a manner
29 that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations im-
30 plementing that section, as in effect on [May 1,] **December 31**, 2009. The board shall adopt rules
31 implementing those minimum distribution requirements.

32 **SECTION 8.** ORS 238A.410 is amended to read:

33 238A.410. (1) If a member of the individual account program dies before retirement, the amounts
34 in the member's employee account, rollover account and employer account, to the extent the member
35 is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the beneficiary or
36 beneficiaries designated by the member for the purposes of this section.

37 (2) If a member of the individual account program is married at the time of death, or there exists
38 at the time of death any other person who is constitutionally required to be treated in the same
39 manner as a spouse for the purpose of retirement benefits, the spouse or other person shall be the
40 beneficiary for purposes of the death benefit payable under this section unless the spouse or other
41 person consents to the designation of a different beneficiary or beneficiaries before the designation
42 has been made and the consent has not been revoked by the spouse or other person as of the time
43 of the member's death. Consent and revocation of consent must be in writing, acknowledged by a
44 notary public, and submitted to the Public Employees Retirement Board in accordance with rules
45 adopted by the board. If the member's spouse is designated as the member's beneficiary and the

1 marriage of the member and spouse is subsequently dissolved, the former spouse shall be treated as
2 predeceasing the member for purposes of this section, unless the member expressly designates the
3 former spouse as beneficiary after the effective date of the dissolution or the former spouse is re-
4 quired to be designated as a beneficiary under the provisions of ORS 238.465.

5 (3) For purposes of this section and ORS 238A.400 (3), if a member fails to designate a benefi-
6 ciary, or if the person or persons designated do not survive the member, the death benefit provided
7 for in this section shall be paid to the following person or persons, in the following order of priority:

8 (a) The member's surviving spouse or other person who is constitutionally required to be treated
9 in the same manner as a spouse;

10 (b) The member's surviving children, in equal shares; or

11 (c) The member's estate.

12 (4) The entire amount of a deceased member's vested accounts must be distributed by December
13 31 of the fifth calendar year after the year in which the member died. Notwithstanding any other
14 provision of this chapter, distributions of death benefits under the individual account program must
15 comply with the minimum distribution requirements of 26 U.S.C. 401(a)(9) and the regulations im-
16 plementing that section, as in effect on [May 1,] **December 31**, 2009. The Public Employees Retirement
17 Board shall adopt rules implementing those minimum distribution requirements.

18 **SECTION 9.** ORS 238A.415 is amended to read:

19 238A.415. (1) Notwithstanding any other provision of ORS 238A.300 to 238A.415, an eligible em-
20 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
21 vices, and who subsequently returns to employment with a participating public employer with
22 reemployment rights under federal law, is entitled to credit toward the probationary period required
23 by ORS 238A.300, credit toward the vesting requirements of ORS 238A.320 and contributions under
24 rules adopted by the Public Employees Retirement Board pursuant to subsection (2) of this section.

25 (2) The board shall adopt rules establishing contributions and service credit for any period of
26 service in the uniformed services by an employee described in subsection (1) of this section. For the
27 purpose of adopting rules under this subsection, the board shall consider and take into account all
28 federal law relating to benefits and service credit for any period of service in the uniformed ser-
29 vices, including 26 U.S.C. 414(u), as in effect on [May 1,] **December 31**, 2009. Contributions and
30 service credit under rules adopted by the board pursuant to this subsection may not exceed contri-
31 butions and service credit required under federal law for periods of service in the uniformed ser-
32 vices.

33 **SECTION 10.** ORS 238A.430 is amended to read:

34 238A.430. (1) To the extent required by law, and except as otherwise provided by rules adopted
35 by the Public Employees Retirement Board under subsection (4) of this section, any portion of a
36 distribution of benefits described in subsection (2) of this section shall, at the election of and in lieu
37 of distribution to the distributee, be paid directly to an eligible retirement plan specified by the
38 distributee.

39 (2) The provisions of subsection (1) of this section apply to a distribution of any benefit under
40 the pension program or the individual account program except:

41 (a) A distribution that is one of a series of substantially equal periodic payments made at least
42 annually for the life or life expectancy of the distributee, or for the joint lives or life expectancies
43 of the distributee and a designated beneficiary;

44 (b) A distribution that is one of a series of substantially equal periodic payments made at least
45 annually for a specified period of 10 years or more; and

1 (c) A distribution to the extent that the distribution is required under 26 U.S.C. 401(a)(9).

2 (3) The provisions of subsection (1) of this section apply to any portion of a distribution of
 3 benefits under the pension program or the individual account program even though the portion
 4 consists of after-tax employee contributions that are not includable in gross income. Any portion of
 5 a distribution that consists of after-tax employee contributions that are not includable in gross in-
 6 come may be transferred only to an individual retirement account or annuity described in 26 U.S.C.
 7 408(a) or (b), or to a qualified defined contribution or defined benefit plan described in 26 U.S.C.
 8 401(a) or 403(b) that agrees to account separately for amounts transferred, including accounting
 9 separately for the portion of the distribution that is includable in gross income and the portion of
 10 the distribution that is not includable in gross income. The amount transferred shall be treated as
 11 consisting first of the portion of the distribution that is includable in gross income, determined
 12 without regard to 26 U.S.C. 402(c)(1).

13 (4) The board shall adopt rules implementing the direct rollover requirements of 26 U.S.C.
 14 401(a)(31) and the regulations implementing that section, and may adopt administrative exceptions
 15 to the direct rollover requirements to the extent permitted by 26 U.S.C. 401(a)(31) and the regu-
 16 lations implementing that section.

17 (5) All references in this section to federal laws and regulations are to the laws and regulations
 18 in effect on [May 1,] **December 31, 2009**.

19 (6) For purposes of this section:

20 (a) "Distributee" means a member, a member's surviving spouse or a member's alternate payee
 21 under ORS 238.465.

22 (b) "Eligible retirement plan" means:

23 (A) An individual retirement account described in 26 U.S.C. 408(a);

24 (B) An individual retirement annuity described in 26 U.S.C. 408(b), other than an endowment
 25 contract;

26 (C) A qualified trust under 26 U.S.C. 401(a), that is a defined contribution or defined benefit plan
 27 and permits the acceptance of rollover contributions;

28 (D) An annuity plan described in 26 U.S.C. 403(a);

29 (E) An eligible deferred compensation plan described in 26 U.S.C. 457(b) that is maintained by
 30 an eligible governmental employer described in 26 U.S.C. 457(e)(1)(A) and that agrees to account
 31 separately for amounts transferred into such plan from the distributing plan; or

32 (F) An annuity contract described in 26 U.S.C. 403(b).

33 **SECTION 11.** ORS 305.230 is amended to read:

34 305.230. (1) Notwithstanding ORS 9.320:

35 (a) Any person who is qualified to practice law or public accountancy in this state, any person
 36 who has been granted active enrollment to practice before the Internal Revenue Service and who
 37 is qualified to prepare tax returns in this state or any person who is the authorized employee of a
 38 taxpayer and is regularly employed by the taxpayer in tax matters may represent the taxpayer be-
 39 fore a tax court magistrate or the Department of Revenue in any conference or proceeding with
 40 respect to the administration of any tax.

41 (b) Any person who is licensed by the State Board of Tax Practitioners or who is exempt from
 42 such licensing requirement as provided for and limited by ORS 673.610 may represent a taxpayer
 43 before a tax court magistrate or the department in any conference or proceeding with respect to the
 44 administration of any tax on or measured by net income.

45 (c) Any shareholder of an S corporation, as defined in section 1361 of the Internal Revenue

14 or property owner, whether stated as a minimum, fixed or variable amount. "Actual cost" includes,
15 but is not limited to, the costs of labor, materials, supplies, equipment rental, property acquisition,
16 permits, engineering, financing, reasonable program delinquencies, return on investment, required
17 fees, insurance, administration, accounting, depreciation, amortization, operation, maintenance, re-
18 pair or replacement and debt service, including debt service payments or payments into reserve ac-
19 counts for debt service and payment of amounts necessary to meet debt service coverage
20 requirements.

21 (2) "Assessment for local improvement" means any tax, fee, charge or assessment that does not
22 exceed the actual cost incurred by a unit of government for design, construction and financing of
23 a local improvement.

24 (3) "Bonded indebtedness" means any formally executed written agreement representing a
25 promise by a unit of government to pay to another a specified sum of money, at a specified date or
26 dates at least one year in the future.

27 (4) "Capital construction":

28 (a) For bonded indebtedness issued prior to December 5, 1996, and for the proceeds of any
29 bonded indebtedness approved by electors prior to December 5, 1996, that were spent or
30 contractually obligated to be spent prior to June 20, 1997, means the construction, modification,
31 replacement, repair, remodeling or renovation of a structure, or addition to a structure, that is ex-
32 pected to have a useful life of more than one year, and includes, but is not limited to:

33 (A) Acquisition of land, or a legal interest in land, in conjunction with the capital construction
34 of a structure.

35 (B) Acquisition, installation of machinery or equipment, furnishings or materials that will be-
36 come an integral part of a structure.

37 (C) Activities related to the capital construction, including planning, design, authorizing, issuing,
38 carrying or repaying interim or permanent financing, research, land use and environmental impact
39 studies, acquisition of permits or licenses or other services connected with the construction.

 13 is functionally related and subordinate to real property, machinery, equipment or furnishings having
 14 a useful life longer than one year.

15 (b) For bonded indebtedness issued on or after December 5, 1996, except for the proceeds of any
 16 bonded indebtedness approved by electors prior to December 5, 1996, that were spent or
 17 contractually obligated to be spent before June 20, 1997, has the meaning given that term in para-
 18 graph (a) of this subsection, except that "capital improvements":

19 (A) Includes public safety and law enforcement vehicles with a projected useful life of five years
 20 or more; and

21 (B) Does not include:

22 (i) Maintenance and repairs, the need for which could be reasonably anticipated;

23 (ii) Supplies and equipment that are not intrinsic to the structure; or

30 (a) Means activities, the type of which may be deducted as an expense under the provisions of
 31 the federal Internal Revenue Code, as amended and in effect on [May 1,] **December 31, 2009**, that
 32 keep the property in ordinarily efficient operating condition and that do not add materially to the
 33 value of the property nor appreciably prolong the life of the property;

34 (b) Does not include maintenance and repair of property that is required by damage, destruction
 35 or defect in design, or that was otherwise not reasonably expected at the time the property was
 36 constructed or acquired, or the addition of material that is in the nature of the replacement of
 37 property and that arrests the deterioration or appreciably prolongs the useful life of the property;
 38 and

39 (c) Does not include street and highway construction, overlay and reconstruction.

40 (11) "Projected useful life" means the useful life, as reasonably estimated by the unit of gov-
 41 ernment undertaking the capital construction or capital improvement project, beginning with the
 42 date the property was acquired, constructed or reconstructed and based on the property's condition
 43 at the time the property was acquired, constructed or reconstructed.

44 (12) "Routine obligations of ownership" means a standard of operation, maintenance, use or care
 45 of property established by law, or if established by custom or common law, a standard that is rea-

1 sonable for the type of property affected.

2 (13) "Single assessment" means the complete assessment process, including preassessment, as-
 3 sessment or reassessment, for any local improvement authorized by ORS 223.387 to 223.399, or a
 4 local ordinance or resolution that provides the procedure to be followed in making local assessments

7 (14) "Special benefit only to specific properties" shall have the same meaning as "special and

10 (a) An affirmative act by a property owner to seek or obtain delivery of goods or services;

11 (b) An affirmative act by a property owner, the legal consequence of which is to cause the de-

 14 owner of the property.

15 (16) "Structure" means any temporary or permanent building or improvement to real property
 16 of any kind that is constructed on or attached to real property, whether above, on or beneath the

18 (17) "Supplies and equipment intrinsic to a structure" means the supplies and equipment that
 19 are necessary to permit a structure to perform the functions for which the structure was con-

30 (1) "Contract rent" means rental paid to the landlord for the right to occupy a homestead, in-
 31 cluding the right to use the personal property located therein. "Contract rent" does not include
 32 rental paid for the right to occupy a homestead that is exempt from taxation, unless payments in lieu
 33 of taxes of 10 percent or more of the rental exclusive of fuel and utilities are made on behalf of the
 34 homestead. "Contract rent" does not include advanced rental payments for another period and rental
 35 deposits, whether or not expressly set out in the rental agreement, or payments made to a nonprofit
 36 home for the elderly described in ORS 307.375. If a landlord and tenant have not dealt with each

41 (3) "Fuel and utility payments" includes payments for heat, lights, water, sewer and garbage
 42 made solely to secure those commodities or services for the homestead of the taxpayer. "Fuel and
 43 utility payments" does not include telephone service.

44 (4) "Gross rent" means contract rent paid plus the fuel and utility payments made for the
 45 homestead in addition to the contract rent, during the calendar year for which the claim is filed.

1 (5) "Homestead" means the taxable principal dwelling located in Oregon, either real or personal
 2 property, rented by the taxpayer, and the taxable land area of the tax lot upon which it is built.

3 (6) "Household" means the taxpayer, the spouse of the taxpayer and all other persons residing

32 (O) Welfare payments, except as follows:

33 (i) Payments for medical care, drugs and medical supplies, if the payments are not made directly
 34 to the welfare recipient;

35 (ii) In-home services authorized and approved by the Department of Human Services; and

36 (iii) Direct or indirect reimbursement of expenses paid or incurred for participation in work or
 37 training programs.

38 (P) Nontaxable dividends.

39 (Q) Nontaxable interest not included in federal adjusted gross income.

40 (R) Rental allowance paid to a minister that is excluded from federal gross income.

41 (S) Income from sources without the United States that is excluded from federal gross income.

42 (b) Adjusted gross income shall be increased due to the disallowance of the following deductions:

43 (A) The amount of the net loss, in excess of \$1,000, from all dispositions of tangible or intangible
 44 properties.

45 (B) The amount of the net loss, in excess of \$1,000, from the operation of a farm or farms.

1 (C) The amount of the net loss, in excess of \$1,000, from all operations of a trade or business,
 2 profession or other activity entered into for the production or collection of income.

3 (D) The amount of the net loss, in excess of \$1,000, from tangible or intangible property held for
 4 the production of rents, royalties or other income.

5 (E) The amount of any net operating loss carryovers or carrybacks included in federal adjusted
 6 gross income.

7 (F) The amount, in excess of \$5,000, of the combined deductions or other allowances for depre-
 8 ciation, amortization or depletion.

 27 and business corporations for the privilege of carrying on or doing business in this state.

28 (6) “Financial institution” has the meaning given that term in ORS 314.610 except that it does
 29 not include a credit union as defined in ORS 723.006, an interstate credit union as defined in ORS
 30 723.001 or a federal credit union.

31 (7) “Internal Revenue Code,” except where the Legislative Assembly has provided otherwise,
 32 refers to the laws of the United States or to the Internal Revenue Code as they are amended and
 33 in effect:

34 (a) On [*May 1,*] **December 31, 2009**; or

35 (b) If related to the definition of taxable income, as applicable to the tax year of the taxpayer.

36 (8) “Oregon taxable income” means taxable income, less the deduction allowed under ORS
 37 317.476, except as otherwise provided with respect to insurers in subsection (11) of this section and
 38 ORS 317.650 to 317.665.

39 (9) “Oregon net loss” means taxable loss, except as otherwise provided with respect to insurers
 40 in subsection (11) of this section and ORS 317.650 to 317.665.

41 (10) “Taxable income or loss” means the taxable income or loss determined, or in the case of a
 42 corporation for which no federal taxable income or loss is determined, as would be determined, un-
 43 der chapter 1, Subtitle A of the Internal Revenue Code and any other laws of the United States
 44 relating to the determination of taxable income or loss of corporate taxpayers, with the additions,
 45 subtractions, adjustments and other modifications as are specifically prescribed by this chapter ex-

cept that in determining taxable income or loss for any year, no deduction under ORS 317.476 or 317.478 and section 45b, chapter 293, Oregon Laws 1987, shall be allowed. If the corporation is a corporation to which ORS 314.280 or 314.605 to 314.675 (requiring or permitting apportionment of income from transactions or activities carried on both within and without the state) applies, to derive taxable income or loss, the following shall occur:

(a) From the amount otherwise determined under this subsection, subtract nonbusiness income, or add nonbusiness loss, whichever is applicable.

(b) Multiply the amount determined under paragraph (a) of this subsection by the Oregon apportionment percentage defined under ORS 314.280, 314.650 or 314.670, whichever is applicable. The resulting product shall be Oregon apportioned income or loss.

(c) To the amount determined as Oregon apportioned income or loss under paragraph (b) of this subsection, add nonbusiness income allocable entirely to Oregon under ORS 314.280 or 314.625 to 314.645, or subtract nonbusiness loss allocable entirely to Oregon under ORS 314.280 or 314.625 to 314.645. The resulting figure is “taxable income or loss” for those corporations carrying on taxable transactions or activities both within and without Oregon.

(11) As used in ORS 317.122 and 317.650 to 317.665, “insurer” means any domestic, foreign or alien insurer as defined in ORS 731.082 and any interinsurance and reciprocal exchange and its attorney in fact with respect to its attorney in fact net income as a corporate attorney in fact acting as attorney in compliance with ORS 731.458, 731.462, 731.466 and 731.470 for the reciprocal or interinsurance exchange. However, “insurer” does not include title insurers or health care service contractors operating pursuant to ORS 750.005 to 750.095.

SECTION 29. ORS 317.018 is amended to read:

317.018. It is the intent of the Legislative Assembly:

(1) To make the Oregon corporate excise tax law, insofar as it relates to the measurement of taxable income, identical to the provisions of the federal Internal Revenue Code, as in effect and applicable on [May 1,] **December 31, 2009**, to the end that taxable income of a corporation for Oregon purposes is the same as it is for federal income tax purposes, subject to Oregon’s jurisdiction to tax, and subject to the additions, subtractions, adjustments and modifications contained in this chapter.

(2) To achieve the results desired under subsection (1) of this section by application of the various provisions of the federal Internal Revenue Code relating to the definitions for corporations, of income, deductions, accounting methods, accounting periods, taxation of corporations, basis and other pertinent provisions relating to gross income. It is not the intent of the Legislative Assembly to adopt federal Internal Revenue Code provisions dealing with the computation of tax, tax credits or any other provisions designed to mitigate the amount of tax due.

(3) To impose on each corporation doing business within this state an excise tax for the privilege of carrying on or doing that business measured by its federal taxable income as adjusted in this chapter.

SECTION 30. ORS 317.097 is amended to read:

317.097. (1) As used in this section:

(a) “Annual rate” means the yearly interest rate specified on the note, and not the annual percentage rate, if any, disclosed to the applicant to comply with the federal Truth in Lending Act.

(b) “Finance charge” means the total of all interest, loan fees, interest on any loan fees financed by the lending institution, and other charges related to the cost of obtaining credit.

(c) “Lending institution” means any insured institution, as that term is defined in ORS 706.008,

1 any mortgage banking company that maintains an office in this state or any community development
2 corporation that is organized under the Oregon Nonprofit Corporation Law.

3 (d) "Manufactured dwelling park" has the meaning given that term in ORS 446.003.

4 (e) "Nonprofit corporation" means a corporation that is exempt from income taxes under section
5 501(c)(3) or (4) of the Internal Revenue Code as amended and in effect on [May 1,] **December 31,**
6 2009.

7 (f) "Preservation project" means housing that was previously developed as affordable housing
8 with a contract for rent assistance from the United States Department of Housing and Urban De-
9 velopment or the United States Department of Agriculture and that is being acquired by a spon-
10 soring entity.

11 (g) "Qualified assignee" means any investor participating in the secondary market for real estate
12 loans.

13 (h) "Qualified borrower" means any borrower that is a sponsoring entity that has a controlling
14 interest in the real property that is financed by a qualified loan. A controlling interest includes, but
15 is not limited to, a controlling interest in the general partner of a limited partnership that owns the
16 real property.

17 (i) "Qualified loan" means:

18 (A) A loan that meets the criteria stated in subsection (5) of this section or that is made to re-
19 finance a loan that meets the criteria described in subsection (5) of this section; or

20 (B) The purchase by a lending institution of bonds, as defined in ORS 286A.001, issued on behalf
21 of the Housing and Community Services Department, the proceeds of which are used to finance or
22 refinance a loan that meets the criteria described in subsection (5) of this section.

23 (j) "Sponsoring entity" means a nonprofit corporation, nonprofit cooperative, state governmental
24 entity, local unit of government as defined in ORS 466.706, housing authority or any other person,
25 provided that the person has agreed to restrictive covenants imposed by a nonprofit corporation,
26 nonprofit cooperative, state governmental entity, local unit of government or housing authority.

27 (2) The Department of Revenue shall allow a credit against taxes otherwise due under this
28 chapter for the taxable year to a lending institution that makes a qualified loan certified by the
29 Housing and Community Services Department as provided in subsection (7) of this section. The
30 amount of the credit is equal to the difference between:

31 (a) The amount of finance charge charged by the lending institution during the taxable year at
32 an annual rate less than the market rate for a qualified loan that is made before January 1, 2014,
33 that complies with the requirements of this section; and

34 (b) The amount of finance charge that would have been charged during the taxable year by the
35 lending institution for the qualified loan for housing construction, development, acquisition or re-
36 habilitation measured at the annual rate charged by the lending institution for nonsubsidized loans
37 made under like terms and conditions at the time the qualified loan for housing construction, de-
38 velopment, acquisition or rehabilitation is made.

39 (3) The maximum amount of credit for the difference between the amounts described in sub-
40 section (2)(a) and (b) of this section may not exceed four percent of the average unpaid balance of
41 the qualified loan during the tax year for which the credit is claimed.

42 (4) Any tax credit allowed under this section that is not used by the taxpayer in a particular
43 year may be carried forward and offset against the taxpayer's tax liability for the next succeeding
44 tax year. Any credit remaining unused in the next succeeding tax year may be carried forward and
45 used in the second succeeding tax year, and likewise, any credit not used in that second succeeding

1 tax year may be carried forward and used in the third succeeding tax year, and any credit not used
 2 in that third succeeding tax year may be carried forward and used in the fourth succeeding tax year,
 3 and any credit not used in that fourth succeeding tax year may be carried forward and used in the
 4 fifth succeeding tax year, but may not be carried forward for any tax year thereafter.

5 (5) To be eligible for the tax credit allowable under this section, a lending institution must make
 6 a qualified loan by either purchasing bonds, as defined in ORS 286A.001, issued on behalf of the
 7 Housing and Community Services Department, the proceeds of which are used to finance or refi-

 10 nity rehabilitation program and are certified by the local government or its designated agent as
 11 having an income level when the loan is made of less than 80 percent of the area median income;

12 (b) A qualified borrower who:

13 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
 14 of housing; and

15 (B) Provides a written certification executed by the Housing and Community Services Depart-
 16 ment that the:

17 (i) Housing created by the loan is or will be occupied by households earning less than 80 percent
 18 of the area median income; and

19 (ii) Full amount of savings from the reduced interest rate provided by the lending institution is
 20 or will be passed on to the tenants in the form of reduced housing payments, regardless of other
 21 subsidies provided to the housing project;

22 (c) Subject to subsection (14) of this section, a qualified borrower who:

23 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
 24 of housing consisting of a manufactured dwelling park; and

25 (B) Provides a written certification executed by the Housing and Community Services Depart-
 26 ment that the housing will continue to be operated as a manufactured dwelling park during the pe-
 27 riod for which the tax credit is allowed; or

28 (d) A qualified borrower who:

29 (A) Uses the loan proceeds to finance acquisition or rehabilitation of housing consisting of a
 30 preservation project; and

31 (B) Provides a written certification executed by the Housing and Community Services Depart-

 36 and Urban Development or the United States Department of Agriculture that will be maintained by

38 (6) A loan made to refinance a loan that meets the criteria stated in subsection (5) of this sec-
 39 tion must be treated the same as a loan that meets the criteria stated in subsection (5) of this sec-
 40 tion.

41 (7) For a qualified loan to be eligible for the tax credit allowable under this section, the Housing
 42 and Community Services Department must execute a written certification for the qualified loan that:

43 (a) Specifies the period, not to exceed 20 years, as determined by the Housing and Community
 44 Services Department, during which the tax credit is allowed for the qualified loan; and

45 (b) States that the qualified loan is within the limitation imposed by subsection (8) of this sec-

1 tion.

2 (8) The Housing and Community Services Department may certify qualified loans that are eligi-
 3 ble under subsection (5) of this section if the total credits attributable to all qualified loans eligible
 4 for credits under this section and then outstanding do not exceed \$17 million for any fiscal year. In
 5 making loan certifications under subsection (7) of this section, the Housing and Community Services
 6 Department shall attempt to distribute the tax credits statewide, but shall concentrate the tax
 7 credits in those areas of the state that are determined by the State Housing Council to have the
 8 greatest need for affordable housing.

9 (9) The tax credit provided for in this section may be taken whether or not:

10 (a) The financial institution is eligible to take a federal income tax credit under section 42 of

20 (11) A lending institution may sell a qualified loan for which a certification has been executed
 21 to a qualified assignee whether or not the lending institution retains servicing of the qualified loan
 22 so long as a designated lending institution maintains records, annually verified by a loan servicer,
 23 that establish the amount of tax credit earned by the taxpayer throughout each year of eligibility.

24 (12) Notwithstanding any other provision of law, a lending institution that is a community de-
 25 velopment corporation organized under the Oregon Nonprofit Corporation Law may transfer all or
 26 part of a tax credit allowed under this section to one or more other lending institutions that are

 36 nonprofit cooperative, state governmental entity, local unit of government as defined in ORS 466.706
 37 or housing authority.

38 (15) The Housing and Community Services Department and the Department of Revenue may
 39 adopt rules to carry out the provisions of this section.

40 **SECTION 31.** ORS 458.670 is amended to read:

41 458.670. As used in this section and ORS 458.675 to 458.700, unless the context requires other-
 42 wise:

43 (1) "Account holder" means a resident of this state who:

44 (a) Is 12 years of age or older;

45 (b) Is a member of a lower income household; and

1 (c) Has established an individual development account with a fiduciary organization.

2 (2) "Fiduciary organization" means an organization selected under ORS 458.695 to administer
3 state moneys directed to individual development accounts and that is:

4 (a) A nonprofit, fund raising organization that is exempt from taxation under section 501(c)(3)
5 of the Internal Revenue Code as amended and in effect on [May 1,] **December 31**, 2009; or

6 (b) A federally recognized Oregon Indian tribe that is located, to a significant degree, within the
7 boundaries of this state.

8 (3) "Financial institution" means:

9 (a) An organization regulated under ORS chapters 706 to 716 or 723; or

10 (b) In the case of individual development accounts established for the purpose described in ORS
11 458.685 (1)(c), a financial institution as defined in ORS 348.841.

12 (4) "Individual development account" means a contract between an account holder and a
13 fiduciary organization, for the deposit of funds into a financial institution by the account holder, and
14 the deposit of matching funds into the financial institution by the fiduciary organization, to allow
15 the account holder to accumulate assets for use toward achieving a specific purpose approved by
16 the fiduciary organization.

17 (5) "Lower income household" means a household having an income equal to or less than the
18 greater of the following:

19 (a) 80 percent of the median household income for the area as determined by the Housing and
20 Community Services Department. In making the determination, the department shall give consider-
21 ation to any data on area household income published by the United States Department of Housing
22 and Urban Development.

23 (b) 200 percent of the poverty guidelines as determined by the Housing and Community Services
24 Department. In making the determination, the department shall give consideration to poverty
25 guidelines published by the United States Department of Health and Human Services and may con-

30 (1) "Base year" means the first four of the last five completed calendar quarters preceding the
31 benefit year.

32 (2) "Benefits" means the money allowances payable to unemployed persons under this chapter.

33 (3) "Benefit year" means a period of 52 consecutive weeks commencing with the first week with
34 respect to which an individual files an initial valid claim for benefits, and thereafter the 52 consec-
35 utive weeks period beginning with the first week with respect to which the individual next files an
36 initial valid claim after the termination of the individual's last preceding benefit year except that
37 the benefit year shall be 53 weeks if the filing of an initial valid claim would result in overlapping

39 (4) "Calendar quarter" means the period of three consecutive calendar months ending on March
40 31, June 30, September 30 or December 31, or the approximate equivalent thereof, as the Director

42 (5) "Contribution" or "contributions" means the taxes, as defined in subsection (13) of this sec-

 28 section 501(c)(3) of the Internal Revenue Code that is exempt from income tax under section 501(a)
 29 of the Internal Revenue Code.

30 (12) "State" includes, in addition to the states of the United States of America, the District of
 31 Columbia and Puerto Rico. However, for all purposes of this chapter the Virgin Islands shall be
 32 considered a state on and after the day on which the United States Secretary of Labor first approves
 33 the Virgin Islands' law under section 3304(a) of the Federal Unemployment Tax Act as amended by
 34 Public Law 94-566.

35 (13) "Taxes" means the money payments to the Unemployment Compensation Trust Fund re-
 36 quired, or voluntary payments permitted, by this chapter.

37 (14) "Valid claim" means any claim for benefits made in accordance with ORS 657.260 if the
 38 individual meets the wages-paid-for-employment requirements of ORS 657.150.

39 (15) "Week" means any period of seven consecutive calendar days ending at midnight, as the
 40 director may, by regulation, prescribe. The director may by regulation prescribe that a "week" shall
 41 be "in," "within," or "during" the calendar quarter that includes the greater part of such week.

42 **SECTION 33. (1) Except as provided in subsections (2) and (3) of this section, the**

20 305.270 or 314.415 or other law, the refund or portion thereof shall be paid without interest.

21 (c) Any changes required because of the amendments to ORS 305.230, 305.494, 305.690,
22 307.130, 307.147, 308A.450, 310.140, 310.630, 310.800, 311.689, 314.011, 315.004, 316.012, 316.013,
23 317.010, 317.018 and 317.097 by sections 11 to 21, 23, 24, 26, 27, 29 and 30 of this 2010 Act for
24 a tax year beginning before January 1, 2010, shall be made by filing an amended return within
25 the time prescribed by law.

26 (d) If a taxpayer fails to file an amended return under paragraph (c) of this subsection,
27 the Department of Revenue shall make any changes under paragraph (c) of this subsection
28 on the return to which the changes relate within the period specified for issuing a notice of
29 deficiency or claiming a refund as otherwise provided by law with respect to that return, or
30 within one year after a return for a tax year beginning on or after January 1, 2010, and be-
