

# A-Engrossed House Bill 3696

Ordered by the House February 23  
Including House Amendments dated February 23

Sponsored by JOINT COMMITTEE ON WAYS AND MEANS

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Authorizes interim Joint Committee on Ways and Means to review changes in state agency salary plans during interim.

Modifies periods for which semi-independent state agencies must report certain information to Governor and Legislative Assembly.

Directs Oregon Department of Administrative Services to use moneys in Oregon Judicial Facilities Fund for purpose of financing construction and maintenance of county court facilities.

**Modifies certain provisions relating to operating expenses of and fees and surcharges collected by specified public bodies.**

**Makes specified allocations from Judicial System Surcharge Account.**

**Authorizes Department of Justice to grant specified amount to Project Clean Slate.**

**Transfers certain duties, functions, powers and unexpended revenues relating to inter-operable communication from Department of State Police to Department of Transportation.**

**Transfers specified amounts from certain funds and accounts to General Fund for general governmental purposes.**

**Authorizes tax refund to estates when inheritance tax liability under provision allowing natural resource property tax credit is greater than tax liability under previous provision allowing exclusion for similar estates.**

Declares emergency, effective on passage.

12 **SECTION 1.** ORS 291.371 is amended to read:

13 291.371. (1) As used in this section, "legislative review agency" means the Joint Committee on  
14 Ways and Means during the period when the Legislative Assembly is in session and the Emergency  
15 Board **or the interim Joint Committee on Ways and Means** during the interim period between  
16 sessions.

17 (2) Prior to making any changes in a salary plan, the Oregon Department of Administrative  
18 Services shall submit the proposed changes to the legislative review agency.

19 (3)(a) The Oregon Department of Administrative Services may approve the reallocation of posi-

1 tions or the establishment of new positions not specifically provided for in the budget of the affected  
2 agency if it finds that the proposed change:

3 (A) Can be financed by the agency within the limits of its biennial budget and legislatively ap-  
4 proved program;

5 (B) Will not produce future budgetary increases; and

6 (C) Conforms to legislatively approved salary policies.

7 (b) Proposed changes not meeting the requirements of paragraph (a) of this subsection shall be  
8 presented to the legislative review agency.

9 (4) Agencies within the Department of Human Services, the Oregon Health Authority and the  
10 Department of Corrections shall report on a biennial basis to the legislative review agency. Each  
11 report shall include the number of vacant budgeted positions, including all job categories and clas-  
12 sifications, within the agency. The legislative review agency shall order the reporting agency to  
13 show cause why the budgeted positions have not been filled and shall assess fully the impact the  
14 vacancies have on:

15 (a) The agency's delivery of services, accounting for any seasonal fluctuation in the need for  
16 those services;

17 (b) The agency's budget due to increased use of overtime;

18 (c) The agency's use of temporary employees; and

19 (d) Employee workload.

20 (5) It is declared to be the policy of this state that the total personal services, budget and full-  
21 time equivalent positions approved for any state agency shall be the maximum amount necessary to  
22 meet the requirements of the agency for the biennium. Notwithstanding ORS 291.232 to 291.260, the  
23 Governor and the Oregon Department of Administrative Services may transfer vacant position au-  
24 thority among and within state agencies to achieve maximum utilization of authorized positions  
25 within agencies.

27 **SEMI-INDEPENDENT STATE AGENCIES**

28  
29 **SECTION 2.** ORS 182.472 is amended to read:

30 182.472. Not later than [*January 1*] **April 1** of each even-numbered year, each board subject to  
31 ORS 182.456 to 182.472 shall submit a report to the Governor, the President of the Senate, the  
32 Speaker of the House of Representatives and the Legislative Fiscal Officer. The Legislative Fiscal  
33 Officer shall review the reports and shall prepare and submit a statement of findings and conclu-  
34 sions to the Joint Legislative Audit Committee **and the Joint Committee on Ways and Means.**  
35 The report must include the following:

36 (1) A copy of the most recent audit or financial review of the board.

37 (2) A copy of the actual budget for the prior biennium and a copy of the board's adopted budget  
38 for the biennium in which the report is made. The budget documents must show:

39 (a) The beginning balance and ending balance for each of the two biennia;

40 (b) A description of material changes between the two biennia;

41 (c) A description of the public hearing process used to establish the budget adopted for the  
42 current biennium; and

43 (d) A description of current fees and proposed changes to fees, along with information support-  
44 ing the amounts of the current fees and any proposed changes to the fees.

45 (3) A description of all temporary and permanent rules adopted by the board [*since the last report*]

1 *was submitted*] **during the prior biennium.**

2 (4) A description of board actions promoting consumer protection that were taken [*since the last*  
3 *report was submitted*] **during the prior biennium.**

4 (5) If the board issues licenses, a description of the board's licensing activities performed [*since*  
5 *the last report*] **during the prior biennium** that is adequate to allow evaluation of the board's per-  
6 formance of its licensing responsibilities, including:

7 (a) The number of license applications;

8 (b) The number of licenses issued;

9 (c) The number of examinations conducted;

10 (d) The average time between application for and issuance of licenses;

11 (e) The number and types of complaints received about persons holding licenses;

12 (f) The number and types of investigations conducted;

13 (g) The number and types of resolutions of complaints;

14 (h) The number and type of sanctions imposed; and

15 (i) The number of days between beginning an investigation and reaching a resolution.

16 (6) A description of all other actions taken [*since the last report*] **during the prior biennium** in  
17 the performance of the board's statutory responsibilities that is adequate to allow evaluation of the  
18 board's performance.

19 **SECTION 3. The amendments to ORS 182.472 by section 2 of this 2010 Act apply to re-**  
20 **ports, audits and financial reviews required to be submitted on or after the effective date of**  
21 **this 2010 Act.**

22 **SECTION 4.** Section 7, chapter 218, Oregon Laws 2007, is amended to read:

23 **Sec. 7.** (1) The amendments to ORS 182.464 and 182.472 by sections 1 and 2 [*of this 2007 Act*],  
24 **chapter 218, Oregon Laws 2007**, apply to financial review schedules for financial reviews to be  
25 included in reports to be submitted to the Governor and the Legislative Assembly [*not later than the*  
26 *date on which the Seventy-fifth Legislative Assembly convenes*] **on or after January 12, 2009.**

38 **COUNTY COURT FACILITIES**

39  
40 **SECTION 5.** Section 24, chapter 906, Oregon Laws 2009, is amended to read:

41 **Sec. 24.** (1) The Legislative Assembly finds that:

42 (a) The Oregon judicial system is an essential component of the public safety system that fosters  
43 an orderly and stable environment in which business can develop and thrive.

44 (b) Construction and maintenance of **county** court facilities is necessary so that the judicial  
45 system can continue to function effectively.

1 (c) The factors described in paragraphs (a) and (b) of this subsection will create construction  
2 jobs and encourage and promote economic development through the maintenance of an orderly and  
3 stable business environment, and the issuance of lottery bonds for the purpose described in sub-  
4 section (3) of this section is therefore an appropriate use of state lottery funds under section 4,  
5 Article XV of the Oregon Constitution, and ORS 461.510.

6 (2) For the biennium beginning July 1, 2009, at the request of the Oregon Department of Ad-  
7 ministrative Services, after consultation with the Judicial Department, the State Treasurer is au-  
8 thorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount not to exceed  
9 net proceeds of \$11,271,656 for the purpose described in subsection (3) of this section, plus an addi-  
10 tional amount, to be estimated by the State Treasurer, for payment of bond-related costs.

11 (3) Net proceeds of bonds issued pursuant to this section shall be deposited in the Oregon Ju-  
12 dicial Facilities Fund to finance construction and maintenance of **county** court facilities.

13 (4) Bond-related costs for the lottery bonds authorized by this section must be paid from the  
14 gross proceeds of the lottery bonds and from allocations for the purposes of ORS 286A.576 (1)(c).

15 **SECTION 6.** Section 25, chapter 906, Oregon Laws 2009, is amended to read:

16 **Sec. 25.** The Oregon Judicial Facilities Fund is established in the State Treasury, separate and  
17 distinct from the General Fund. The Oregon Judicial Facilities Fund shall consist of moneys depos-  
18 ited in the fund under section 24 [of this 2009 Act], **chapter 906, Oregon Laws 2009**. The moneys  
19 in the Oregon Judicial Facilities Fund and the interest earnings on moneys in the fund are contin-  
20 uously appropriated to the Oregon Department of Administrative Services for [disbursement to  
21 Oregon counties to finance] **the purpose of financing** construction and maintenance of **county** court  
22 facilities.

24 **OREGON DEPARTMENT OF AVIATION**

25  
26 **SECTION 7.** ORS 836.072 is amended to read:

27 836.072. (1) Moneys from the increases in taxes by the amendments to ORS 319.020 by sections  
28 1 and 3, chapter 1037, Oregon Laws 1999, shall be used by the Oregon Department of Aviation:

29 (a) To establish and fund a program to maintain and preserve the pavements used for runways,  
30 taxiways and aircraft parking areas at public use airports in this state[.]; **or**

31 (b) **For operating expenses of the department.**

32 (2) Projects for maintenance and preservation of pavements at public use airports that are  
33 identified in the plan developed under ORS 835.015 are eligible for funding under this section. The  
34 following expenses of projects selected may be funded under this section:

35 (a) Construction expenses;

36 (b) Engineering expenses; and

37 (c) Administrative expenses.

38 (3) The Director of the Oregon Department of Aviation shall prepare a list of recommended  
39 projects. Factors to be used by the director include, but are not limited to:

40 (a) The age and condition of pavements;

41 (b) An airport's role in the state's aviation system, as described by the plan developed under  
42 ORS 835.015; and

43 (c) Local financial participation in projects.

44 (4) The director shall forward the list of recommended projects to the State Aviation Board for  
45 approval.

1 (5) The department may adopt such rules as it deems necessary for implementation of the airport  
2 pavement preservation program.

3 (6) **For purposes of this section, “operating expenses of the department” includes, but is**

32 **DEPARTMENT OF LAND CONSERVATION AND DEVELOPMENT**

33  
34 **SECTION 10.** ORS 197.090 is amended to read:

35 197.090. (1) Subject to policies adopted by the Land Conservation and Development Commission,  
36 the Director of the Department of Land Conservation and Development shall:

37 (a) Be the administrative head of the Department of Land Conservation and Development.

38 (b) Coordinate the activities of the department in its land conservation and development func-  
39 tions with such functions of federal agencies, other state agencies, local governments and special  
40 districts.

41 (c) Appoint, reappoint, assign and reassign all subordinate officers and employees of the de-  
42 partment, prescribe their duties and fix their compensation, subject to the State Personnel Relations  
43 Law.

44 (d) Represent this state before any agency of this state, any other state or the United States  
45 with respect to land conservation and development within this state.

1      *[(e) Provide clerical and other necessary support services for the board.]*

2      (2)(a) Subject to local government requirements and the provisions of ORS 197.830 to 197.845,  
3 the director may participate in and seek review of a land use decision, expedited land division or  
4 limited land use decision involving the goals, acknowledged comprehensive plan or land use regu-  
5 lation or other matter within the statutory authority of the department or commission under ORS  
6 chapters 195, 196 and 197. The director shall report to the commission on each case in which the  
7 department participates and on the positions taken by the director in each case.

8      (b) If a meeting of the commission is scheduled prior to the close of the period for seeking re-  
9 view of a land use decision, expedited land division or limited land use decision, the director shall  
10 obtain formal approval from the commission prior to seeking review of the decision. However, if the  
11 land use decision, expedited land division or limited land use decision becomes final less than 15  
12 days before a meeting of the commission, the director shall proceed as provided in paragraph (c) of  
13 this subsection. If the director requests approval from the commission, the applicant and the affected  
14 local government shall be notified in writing that the director is seeking commission approval. The  
15 director, the applicant and the affected local government shall be given reasonable time to address  
16 the commission regarding the director’s request for approval to seek review. The parties shall limit  
17 their testimony to the factors established under subsection (3) of this section. No other testimony  
18 shall be taken by the commission.

19      (c) If a meeting of the commission is not scheduled prior to the close of the period for seeking  
20 review of a land use decision, expedited land division or limited land use decision, at the next  
21 commission meeting the director shall report to the commission on each case for which the depart-  
22 ment has sought review. The director shall request formal approval to proceed with each appeal.  
23 The applicant and the affected local government shall be notified of the commission meeting in  
24 writing by the director. The director, the applicant and the affected local government shall be given  
25 reasonable time to address the commission regarding the director’s request for approval to proceed  
26 with the appeal. The parties shall limit their testimony to the factors established under subsection  
27 (3) of this section. No other testimony shall be taken by the commission. If the commission does not  
28 formally approve an appeal, the director shall file a motion with the appropriate tribunal to dismiss  
29 the appeal.

30      (d) A decision by the commission under this subsection is not subject to appeal.

31      (e) For purposes of this subsection, “applicant” means a person seeking approval of a permit,  
32 as defined in ORS 215.402 or 227.160, expedited land division or limited land use decision.

33      (3) The commission by rule shall adopt a set of factors for the commission to consider when  
34 determining whether to appeal or intervene in the appeal of a land use decision, expedited land di-  
35 vision or limited land use decision that involves the application of the goals, acknowledged com-  
36 prehensive plan, land use regulation or other matter within the authority of the department or  
37 commission under ORS chapters 195, 196 and 197.

38      (4) The director may intervene in an appeal of a land use decision, expedited land division or  
39 limited land use decision brought by another person in the manner provided for an appeal by the  
40 director under subsection (2)(b) and (c) of this section.

43  
44      **SECTION 11.** ORS 480.350 is amended to read:

45      480.350. (1) Except as provided in ORS 480.355, a nonretail facility shall not operate without a

1 license issued under this section.

2 (2) The State Fire Marshal shall issue a nonretail facility license to a person if the person sub-  
3 mits an application to the State Fire Marshal on a form approved by the State Fire Marshal for each  
4 nonretail facility and the application includes:

5 (a) A statement that the applicant will comply with the requirements of ORS 480.345;

6 (b) A copy of the form that will be used by the applicant as the agreement required under ORS  
7 480.345 between the applicant and nonretail customers permitted to dispense fuel at the nonretail  
8 facility;

9 (c) A sworn statement, as defined in ORS 162.055, that information supplied in the application  
10 is true and correct; and

11 (d) An application fee of [~~\$250~~] **\$300**.

12 (3) The applicant for a nonretail facility license shall bear the burden of proof that the re-  
13 quirements of this section and of any rules of the State Fire Marshal adopted to implement this  
14 section are satisfied.

15 (4) In addition to any license or renewal fees, a licensee shall pay an annual fee of [~~\$5~~] **\$7.50**  
16 for each nonretail customer that enters into a written agreement with the owner or operator of the  
17 nonretail facility under ORS 480.345.

18 (5) A license issued under this section shall be valid for a period of one year from the date of  
19 issuance.

20 (6) A license may be renewed upon payment to the State Fire Marshal of an annual license re-  
21 newal fee of [~~\$250~~] **\$300**.

22 (7) All fees received by the State Fire Marshal pursuant to this section shall be deposited with  
23 the State Treasurer and shall be placed in the State Fire Marshal Fund.

24 **SECTION 12.** ORS 480.350, as amended by section 11 of this 2010 Act, is amended to read:

25 480.350. (1) Except as provided in ORS 480.355, a nonretail facility shall not operate without a  
26 license issued under this section.

27 (2) The State Fire Marshal shall issue a nonretail facility license to a person if the person sub-  
28 mits an application to the State Fire Marshal on a form approved by the State Fire Marshal for each  
29 nonretail facility and the application includes:

30 (a) A statement that the applicant will comply with the requirements of ORS 480.345;

31 (b) A copy of the form that will be used by the applicant as the agreement required under ORS  
32 480.345 between the applicant and nonretail customers permitted to dispense fuel at the nonretail  
33 facility;

34 (c) A sworn statement, as defined in ORS 162.055, that information supplied in the application  
35 is true and correct; and

36 (d) An application fee of \$300.

37 (3) The applicant for a nonretail facility license shall bear the burden of proof that the re-

8 **SECTION 14.** ORS 480.345, as amended by section 2, chapter 328, Oregon Laws 2001, is  
9 amended to read:

10 480.345. Notwithstanding ORS 480.330 and 480.340, the owner, operator or employee of a dis-  
11 pensing facility may permit nonretail customers other than the owner, operator or employee to use  
12 or manipulate at the dispensing facility a card activated or key activated device for dispensing Class  
13 1 flammable liquids into the fuel tank of a motor vehicle or other container under the following  
14 conditions:

15 (1) The owner or operator shall hold a current nonretail facility license issued by the State Fire  
16 Marshal under ORS 480.350;

17 (2) After April 1, 1992, a nonretail customer shall purchase at least [2,400] **900** gallons of Class  
18 1 flammable liquids or diesel fuel from any source during a 12-month period or, if the amount of such  
19 liquids or fuel purchased is less than [2,400] **900** gallons annually, file documentation that:

20 (a) The fuel qualifies as a deductible farming expense on the customer's federal income tax re-  
21 turn; or

22 (b) The fuel was purchased by a governmental agency providing fire, ambulance or police ser-  
23 vices;

24 (3) The nonretail customer shall provide a federal employer identification number or equivalent  
25 documentation to indicate participation in a business or employment with a government agency or  
26 nonprofit or charitable organization;

27 (4) The nonretail customer, other than the owner or operator, dispensing Class 1 flammable  
28 liquids shall be employed by a business, government agency or nonprofit or charitable organization  
29 and shall dispense Class 1 flammable liquids only into the fuel tank of a motor vehicle or other  
30 container owned [*and*] **or** used by the business, government agency or nonprofit or charitable or-  
31 ganization;

32 (5) The nonretail customer, other than the owner, operator or employee, dispensing Class 1  
33 flammable liquids shall have satisfied safety training requirements in compliance with rules of the  
34 State Fire Marshal; and

35 (6) The owner or operator shall enter into a written agreement with nonretail customers per-  
36 mitted under this section to dispense fuel at the nonretail facility. Except as otherwise provided in  
37 ORS 480.355, the agreement shall at a minimum:

38 (a) Certify that the nonretail customer will purchase at least [2,400] **900** gallons of Class 1  
39 flammable liquids or diesel fuel from any source during a 12-month period or, if the amount of such  
40 liquids or fuel purchased is less than [2,400] **900** gallons annually, file documentation that:

41 (A) The fuel qualifies as a deductible farming expense on the customer's federal income tax re-  
42 turn; or

43 (B) The fuel was purchased by a governmental agency providing fire, ambulance or police ser-  
44 vices;

45 (b) Provide a federal employer identification number or equivalent documentation to indicate



1 participation in a business or employment with a government agency or nonprofit or charitable or-  
2 ganization;

3 (c) Certify that the nonretail customer is employed by a business, government agency or  
4 nonprofit or charitable organization and that the nonretail customer shall dispense Class 1  
5 flammable liquids only into the fuel tank of a motor vehicle or other container owned [and] or used  
6 by the business, government agency or nonprofit or charitable organization;

7 (d) Certify that the nonretail customer has satisfied safety training requirements in compliance  
8 with rules of the State Fire Marshal; and

9 (e) Require the nonretail customer to submit a sworn statement, as defined in ORS 162.055, that  
10 the information supplied in the agreement is true and correct.

11 **SECTION 15. Section 3, chapter 328, Oregon Laws 2001, is repealed.**

12  
13 **PROJECT CLEAN SLATE**

14  
15 **SECTION 16. Notwithstanding any other provision of law, during the biennium beginning**  
16 **July 1, 2009, the Department of Justice is authorized to grant to Project Clean Slate the**  
17 **amount of \$175,000 from moneys appropriated to the department, out of the General Fund,**  
18 **for the biennium beginning July 1, 2009.**

19  
20 **JUDICIAL SYSTEM SURCHARGE ACCOUNT ALLOCATIONS**

21  
22 **SECTION 17. (1) During the biennium commencing July 1, 2009, the Department of Re-**

**SECTION 73.** Notwithstanding ORS 345.080 and 345.110, the amount of \$1,000,000 is transferred from the Tuition Protection Fund to the General Fund for general governmental purposes.

**SECTION 74.** Notwithstanding ORS 342.430, the amount of \$346,000 is transferred from the Teacher Standards and Practices Commission Account to the General Fund for general governmental purposes.

PUBLIC SAFETY

**SECTION 75.** Notwithstanding ORS 180.180, the amount of \$2,973,501 is transferred from the Department of Justice Operating Account to the General Fund for general governmental purposes.

**SECTION 76.** Notwithstanding ORS 180.095, the amount of \$2,500,000 is transferred from the Department of Justice Protection and Education Revolving Account to the General Fund for general governmental purposes.

**SECTION 77.** Notwithstanding any other provision of law, the amount of \$500,000 is transferred from the Public Defense Services Account created under ORS 151.225 from moneys received under ORS 151.225 (3) to the General Fund for general governmental purposes.

ECONOMIC DEVELOPMENT

**SECTION 78.** Notwithstanding ORS 458.720, the amount of \$750,000 is transferred from the Community Development Incentive Project Fund from moneys consisting of loan repayments to the General Fund for general governmental purposes.

**SECTION 79.** Notwithstanding ORS 285B.215, the amount of \$1,000,000 is transferred from the Credit Enhancement Fund to the General Fund for general governmental purposes.

**SECTION 80.** Notwithstanding ORS 285B.266, the amount of \$300,000 is transferred from

1 the Strategic Reserve Fund to the General Fund for general governmental purposes.

2 **SECTION 81.** Notwithstanding ORS 407.585, for the biennium ending June 30, 2011, mon-  
3 eys in the Veterans' Small Business Repair Loan Fund established by ORS 407.585 shall be  
4 used for educational benefits for veterans provided under ORS 408.010 to 408.090.

5  
6 **TRANSFERS**

7  
8 **SECTION 82.** The transfers, reductions of allocations and dedications of moneys de-  
9 scribed in sections 62 to 81, 83 and 84 of this 2010 Act shall be made from moneys maintained,  
10 on the effective date of this 2010 Act, in the funds, accounts and reserves from which the  
11 transfers, reductions and dedications are made.

12  
13 **LABOR AND INDUSTRIES**

14  
15 **SECTION 83.** Notwithstanding ORS 651.185, the amount of \$1,600,000 is transferred from  
16 the Prevailing Wage Education and Enforcement Account to the General Fund for general  
17 governmental purposes.

18  
19 **DEPARTMENT OF REVENUE**

20  
21 **SECTION 84.** Notwithstanding section 7, chapter 710, Oregon Laws 2009, the amount of  
22 \$31,000,000 is transferred from the Tax Amnesty Fund to the General Fund for general gov-  
23 ernmental purposes.

24 **SECTION 85.** Sections 86 and 87 of this 2010 Act are added to and made a part of ORS  
25 118.005 to 118.840.

26 **SECTION 86.** An estate for which the amount calculated in subsection (1) of this section  
27 is greater than the amount calculated in subsection (2) of this section shall be eligible for a  
28 refund of an amount equal to the difference between:

29 (1) The tax payable under this chapter with the allowance of a credit as provided in sec-  
30 tion 2, chapter 28, Oregon Laws 2008; and

31 (2) The tax imposed under this chapter against estates taking into account an exclusion  
32 for natural resource property pursuant to section 68, chapter 843, Oregon Laws 2007.

33 **SECTION 87.** (1) The Department of Revenue shall adopt by rule procedures for admin-  
34 istering section 86 of this 2010 Act, including application procedures and deadlines.

35 (2) The department shall make the refunds required under section 86 of this 2010 Act to  
36 eligible estates following the filing of an application by an executor. The department may  
37 require the filing of an amended return and provision of additional information by an estate  
38 prior to making a refund.

39 **SECTION 88.** Sections 86 and 87 of this 2010 Act apply to estates of decedents who die  
40 on or after January 1, 2007, and before March 11, 2008.

41  
42 **CAPTIONS AND EMERGENCY CLAUSE**

43  
44 **SECTION 89.** The unit captions used in this 2010 Act are provided only for the conven-  
45 ience of the reader and do not become part of the statutory law of this state or express any



1 legislative intent in the enactment of this 2010 Act.

2 **SECTION 90. This 2010 Act being necessary for the immediate preservation of the public**  
3 **peace, health and safety, an emergency is declared to exist, and this 2010 Act takes effect**  
4 **on its passage.**
