

SENATE AMENDMENTS TO SENATE BILL 1008

1 On page 2 of the printed bill, after line 3, insert:

2 “(5) A person described in subsection (4)(a) of this section who is barred from possessing a
3 firearm under ORS 166.250 (1)(c)(C) or barred from purchasing a firearm under ORS 166.470 (1)(b)
4 may file a petition for relief from the bar in accordance with ORS 166.274.”.

5 In line 4, delete “(5)” and insert “(6)”.

6 Delete lines 14 through 17 and insert:

7 “(2) A petition for relief described in this section must be filed in the circuit court in the
8 petitioner’s county of residence.”.

9 On page 3, delete lines 21 through 24 and insert:

10 “(2) A petition for relief described in this section must be filed in the circuit court in the
11 petitioner’s county of residence.”.

12 On page 4, delete lines 25 through 28 and insert:

13 “(2) A petition for relief described in this section must be filed in the circuit court in the
14 petitioner’s county of residence.”.

15 On page 5, delete lines 37 and 38 and insert:

16 “(D) Was committed under ORS 426.130 to either the Department of Human Services or the
17 Oregon Health Authority;”.

18 On page 6, line 14, before the comma insert “or if the vehicle is a motorcycle, an all-terrain
19 vehicle or a snowmobile”.

20 Delete lines 37 and 38 and insert:

21 “(D) Was committed under ORS 426.130 to either the Department of Human Services or the
22 Oregon Health Authority;”.

23 On page 7, line 14, before the comma insert “or if the vehicle is a motorcycle, an all-terrain
24 vehicle or a snowmobile”.

25 Delete lines 37 and 38 and insert:

26 “(D) Was committed under ORS 426.130 to either the Department of Human Services or the
27 Oregon Health Authority;”.

28 On page 8, line 14, before the comma insert “or if the vehicle is a motorcycle, an all-terrain
29 vehicle or a snowmobile”.

30 On page 9, delete lines 15 and 16 and insert:

31 “(e) Was committed under ORS 426.130 to either the Department of Human Services or the
32 Oregon Health Authority;”.

33 Delete lines 43 and 44 and insert:

34 “(e) Was committed under ORS 426.130 to either the Department of Human Services or the
35 Oregon Health Authority;”.

1 On page 10, delete lines 26 and 27 and insert:
2 “(e) Was committed under ORS 426.130 to either the Department of Human Services or the
3 Oregon Health Authority;”.

4 On page 11, delete lines 36 and 37 and insert:
5 “(i) Has not been committed under ORS 426.130 to either the Department of Human Services or
6 the Oregon Health Authority;”.

7 On page 13, delete line 7.
8 In line 8, delete “ORS 426.130” and insert “been committed under ORS 426.130 to either the
9 Department of Human Services or the Oregon Health Authority”.

10 On page 15, delete lines 32 and 33 and insert:
11 “(i) Has not been committed under ORS 426.130 to either the Department of Human Services or
12 the Oregon Health Authority;”.

13 On page 17, delete line 4.
14 In line 5, delete “ORS 426.130” and insert “been committed under ORS 426.130 to either the
15 Department of Human Services or the Oregon Health Authority”.

16 On page 19, delete lines 29 and 30 and insert:
17 “(i) Has not been committed under ORS 426.130 to either the Department of Human Services or
18 the Oregon Health Authority;”.

19 On page 20, delete line 45.
20 On page 21, line 1, delete “ORS 426.130” and insert “been committed under ORS 426.130 to ei-
21 ther the Department of Human Services or the Oregon Health Authority”.
