SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law.

Allows deduction in 2009 tax year for certain contributions made in 2010 for victims of earthquake in Haiti.

Takes effect on 91st day following adjournment sine die.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 238A.005 is amended to read:

9 238A.005. For the purposes of this chapter:

10 (1) "Active member" means a member of the pension program or the individual account program
11 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

12 (2) "Actuarial equivalent" means a payment or series of payments having the same value as the
13 payment or series of payments replaced, computed on the basis of interest rate and mortality as-
14 sumptions adopted by the board.

15 (3) "Board" means the Public Employees Retirement Board.

16 (4) "Eligible employee" means a person who performs services for a participating public em-
17 ployer, including elected officials other than judges. "Eligible employee" does not include:

18 (a) Persons engaged as independent contractors;

19 (b) Aliens working under a training or educational visa;

20 (c) Persons, other than workers in the Industries for the Blind Program under ORS 346.190,
21 provided sheltered employment or make-work by a public employer;

22 (d) Persons categorized by a participating public employer as student employees;

23 (e) Any person who is an inmate of a state institution;

24 (f) Employees of foreign trade offices of the Oregon Business Development Department who live
25 and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g);

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (g) An employee actively participating in an alternative retirement program established under
2 ORS 353.250 or an optional retirement plan established under ORS 341.551;

3 (h) Employees of the Oregon University System who are actively participating in an optional
4 retirement plan offered under ORS 243.800;

5 (i) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,
6 for membership in the system under the provisions of ORS chapter 238 or other law;

7 (j) Any person who belongs to a class of employees who are not eligible to become members of
8 the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

9 (k) Any person who is retired under ORS 238A.100 to 238A.245 or ORS chapter 238 and who
10 continues to receive retirement benefits while employed; and

11 (L) Judges.

12 (5) "Firefighter" means:

13 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
14 duties include the fighting of fires;

15 (b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;
16 and

17 (c) An employee of the State Forestry Department who is certified by the State Forester as a
18 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
19 fires as described in ORS 477.064.

20 (6) "Fund" means the Public Employees Retirement Fund.

21 (7)(a) "Hour of service" means:

22 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
23 by a participating public employer for performance of duties in a qualifying position; and

24 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
25 during which an employee does not perform duties but for which the employee is directly or indi-
26 rectly paid or entitled to payment by a participating public employer for services in a qualifying
27 position, as long as the hour is within the number of hours regularly scheduled for the performance
28 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-
29 thorized leave.

30 (b) "Hour of service" does not include any hour for which payment is made or due under a plan
31 maintained solely for the purpose of complying with applicable workers' compensation laws or un-
32 employment compensation laws.

33 (8) "Inactive member" means a member of the pension program or the individual account pro-
34 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who
35 is not a retired member and who is not employed in a qualifying position.

36 (9) "Individual account program" means the defined contribution individual account program of
37 the Oregon Public Service Retirement Plan established under ORS 238A.025.

38 (10) "Member" means an eligible employee who has established membership in the pension pro-
39 gram or the individual account program of the Oregon Public Service Retirement Plan and whose
40 membership has not been terminated under ORS 238A.110 or 238A.310.

41 (11) "Participating public employer" means a public employer as defined in ORS 238.005 that
42 provides retirement benefits for employees of the public employer under the system.

43 (12) "Pension program" means the defined benefit pension program of the Oregon Public Service
44 Retirement Plan established under ORS 238A.025.

45 (13) "Police officer" means a police officer as described in ORS 238.005.

1 (14) "Qualifying position" means one or more jobs with one or more participating public em-
2 ployers in which an eligible employee performs 600 or more hours of service in a calendar year,
3 excluding any service in a job for which benefits are not provided under the Oregon Public Service
4 Retirement Plan pursuant to ORS 238A.070 (2).

5 (15) "Retired member" means a pension program member who is receiving a pension as provided
6 in ORS 238A.180 to 238A.195.

7 (16)(a) "Salary" means the remuneration paid to an active member in return for services to the
8 participating public employer, including remuneration in the form of living quarters, board or other
9 items of value, to the extent the remuneration is includable in the employee's taxable income under
10 Oregon law. Salary includes the additional amounts specified in paragraph (b) of this subsection,
11 but does not include the amounts specified in paragraph (c) of this subsection, regardless of whether
12 those amounts are includable in taxable income.

13 (b) "Salary" includes the following amounts:

14 (A) Payments of employee and employer money into a deferred compensation plan that are made
15 at the election of the employee.

16 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the
17 employee.

18 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit
19 plan by the employer at the election of the employee and that is not includable in the taxable in-
20 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on [*May 1,*] **December 31,**
21 2009.

22 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the
23 election of the employee and that is not included in the taxable income of the employee by reason
24 of 26 U.S.C. 402(e)(3), as in effect on [*May 1,*] **December 31,** 2009.

25 (E) Retroactive payments made to an employee to correct a clerical error, pursuant to an award
26 by a court or by order of or pursuant to a conciliation agreement with an administration agency
27 charged with enforcing federal or state law protecting the employee's rights to employment or
28 wages, which shall be allocated to and deemed paid in the periods in which the work was done or
29 in which the work would have been done.

30 (F) The amount of an employee contribution to the individual account program that is paid by
31 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
32 (1) and (2)(a).

33 (G) The amount of an employee contribution to the individual account program that is not paid
34 by the employer under ORS 238A.335.

35 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
36 652.190.

37 (c) "Salary" does not include the following amounts:

38 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
39 employer.

40 (B) Payments made on account of an employee's death.

41 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
42 leave.

43 (D) Any severance payment, accelerated payment of an employment contract for a future period
44 or advance against future wages.

45 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

1 (F) Payment for a leave of absence after the date the employer and employee have agreed that
2 no future services in a qualifying position will be performed.

3 (G) Payments for instructional services rendered to institutions of the Oregon University System
4 or the Oregon Health and Science University when those services are in excess of full-time em-
5 ployment subject to this chapter. A person employed under a contract for less than 12 months is
6 subject to this subparagraph only for the months covered by the contract.

7 (H) The amount of an employee contribution to the individual account program that is paid by
8 the employer and is not deducted from the compensation of the employee, as provided under ORS
9 238A.335 (1) and (2)(b).

10 (I) Any amount in excess of \$200,000 for a calendar year. If any period over which salary is
11 determined is less than 12 months, the \$200,000 limitation for that period shall be multiplied by a
12 fraction, the numerator of which is the number of months in the determination period and the de-
13 nominator of which is 12. The board shall adopt rules adjusting this dollar limit to incorporate
14 cost-of-living adjustments authorized by the Internal Revenue Service.

15 (17) "System" means the Public Employees Retirement System.

16 **SECTION 2.** ORS 238A.125 is amended to read:

17 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall
18 be paid an annual pension for the life of the member as follows:

19 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied
20 by the number of years of retirement credit attributable to service as a police officer or firefighter.

21 (b) For service as other than a police officer or firefighter, 1.5 percent of final average salary
22 multiplied by the number of years of retirement credit attributable to service as other than a police
23 officer or firefighter.

24 (2) Notwithstanding any provision of ORS 238A.100 to 238A.245, the annual benefit payable to
25 a member under the pension program and under any other tax-qualified defined benefit plan main-
26 tained by the participating public employer may not exceed the applicable limitations set forth in
27 26 U.S.C. 415(b), as in effect on [May 1,] **December 31**, 2009. The Public Employees Retirement
28 Board shall adopt rules for the administration of this limitation, including adjustments in the annual
29 dollar limitation to reflect cost-of-living adjustments authorized by the Internal Revenue Service.

30 (3) The board shall make no actuarial adjustment in a member's pension calculated under this
31 section by reason of the member's retirement after normal retirement age.

32 **SECTION 3.** ORS 238A.150 is amended to read:

33 238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to 238A.245, an eligible em-
34 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
35 vices, and who subsequently returns to employment with a participating public employer with
36 reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the
37 probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS
38 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2)
39 of this section.

40 (2) The board shall adopt rules establishing benefits and service credit for any period of service
41 in the uniformed services by an employee described in subsection (1) of this section. For the purpose
42 of adopting rules under this subsection, the board shall consider and take into account all federal
43 law relating to benefits and service credit for any period of service in the uniformed services, in-
44 cluding 26 U.S.C. 414(u), as in effect on [May 1,] **December 31**, 2009. Benefits and service credit
45 under rules adopted by the board pursuant to this subsection may not exceed benefits and service

1 credit required under federal law for periods of service in the uniformed services.

2 **SECTION 4.** ORS 238A.170 is amended to read:

3 238A.170. (1) An active member of the pension program who is 70-1/2 years of age or older must
4 retire not later than April 1 of the calendar year following the calendar year in which the member
5 terminates employment with all participating public employers. An inactive member of the pension
6 program must retire not later than April 1 of the calendar year following the calendar year in which
7 the member attains 70-1/2 years of age.

8 (2) Notwithstanding any other provision of ORS 238A.100 to 238A.245, the entire interest of a
9 member of the pension program must be distributed over a time period commencing no later than
10 the required beginning date set forth in subsection (1) of this section, and must be distributed in a
11 manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regu-
12 lations implementing that section, as in effect on [May 1,] **December 31, 2009**. The Public Employees
13 Retirement Board shall adopt rules implementing those minimum distribution requirements.

14 **SECTION 5.** ORS 238A.230 is amended to read:

15 238A.230. (1) If a member of the pension program who is vested dies before the member's effec-
16 tive date of retirement, the Public Employees Retirement Board shall pay the death benefit provided
17 for in this section to the spouse of the member or to any other person who is constitutionally re-
18 quired to be treated in the same manner as a spouse for the purpose of retirement benefits.

19 (2)(a) The death benefit to be paid under this section shall be for the life of the spouse or other
20 person who is constitutionally required to be treated in the same manner as a spouse, and shall be
21 the actuarial equivalent of 50 percent of the pension that would otherwise have been paid to the
22 deceased member.

23 (b) For the purpose of paragraph (a) of this subsection, the amount of the pension that would
24 otherwise have been paid to the deceased member shall be calculated:

25 (A) As of the date of death if the member dies after the earliest retirement date for the member
26 under ORS 238A.165; or

27 (B) As if the member became an inactive member on the date of death and thereafter retired
28 at the earliest retirement date if the member dies before the earliest retirement date for the member
29 under ORS 238A.165.

30 (3) The death benefit provided under this section is first effective on the first day of the month
31 following the date of death of the member. The surviving spouse or other person entitled to the
32 death benefit may elect to delay payment of the death benefit, but payment must commence no later
33 than December 31 of the calendar year in which the member would have reached 70-1/2 years of age.

34 (4) Notwithstanding any other provision of ORS 238A.100 to 238A.245, distributions of death
35 benefits under the pension program must comply with the minimum distribution requirements of 26
36 U.S.C. 401(a)(9) and the regulations implementing that section, as in effect on [May 1,] **December**
37 **31, 2009**. The board shall adopt rules implementing those minimum distribution requirements.

38 **SECTION 6.** ORS 238A.370 is amended to read:

39 238A.370. Notwithstanding any other provision of ORS 238A.300 to 238A.415, the annual addition
40 to the employee and employer accounts of a member of the individual account program for a cal-
41 endar year, together with the annual additions to the accounts of the member under any other de-
42 fined contribution plan maintained by the participating public employer for a calendar year, may
43 not exceed the lesser of \$40,000, or 100 percent of the member's compensation for that calendar year.
44 For purposes of this section, "annual addition" has the meaning given that term in 26 U.S.C.
45 415(c)(2), as in effect on [May 1,] **December 31, 2009**, and "compensation" has the meaning given

1 the term “participant’s compensation” in 26 U.S.C. 415(c)(3), as in effect on [*May 1,*] **December 31,**
 2 2009. The Public Employees Retirement Board shall adopt rules for the administration of this limi-
 3 tation, including adjustments in the annual dollar limitation to reflect cost-of-living adjustments au-
 4 thorized by the Internal Revenue Service.

5 **SECTION 7.** ORS 238A.400 is amended to read:

6 238A.400. (1) Upon retirement on or after the earliest retirement date, as described in ORS
 7 238A.165, a member of the individual account program shall receive in a lump sum the amounts in
 8 the member’s employee account, rollover account and employer account to the extent the member
 9 is vested in those accounts under ORS 238A.320.

10 (2) In lieu of a lump sum payment under subsection (1) of this section, a member of the individ-
 11 ual account program may elect to receive the amounts in the member’s employee account and em-
 12 ployer account, to the extent the member is vested in those accounts under ORS 238A.320, in
 13 substantially equal installments paid over a period of 5, 10, 15 or 20 years, or over a period that is
 14 equal to the anticipated life span of the member as actuarially determined by the Public Employees
 15 Retirement Board. Installments may be made on a monthly, quarterly or annual basis. In no event
 16 may the period selected by the member exceed the time allowed by the minimum distribution re-
 17 quirements described in subsection (5) of this section. The board shall by rule establish the manner
 18 in which installments will be adjusted to reflect investment gains and losses on the unpaid balance
 19 during the payout period elected by the member under this subsection. The board by rule may es-
 20 tablish minimum monthly amounts payable under this subsection. The board may require that a
 21 lump sum payment, or an installment schedule different than the schedules provided for in this
 22 subsection, be used to pay the vested amounts in the member’s accounts if those amounts are not
 23 adequate to generate the minimum monthly amounts specified by the rule.

24 (3) A member of the individual account program electing to receive installments under sub-
 25 section (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies
 26 before all amounts in the employee and vested employer accounts are paid, all remaining installment
 27 payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary
 28 may elect to receive a lump sum distribution of the remaining amounts.

29 (4) A member who is entitled to receive retirement benefits under ORS chapter 238 may receive
 30 vested amounts in the member’s employee account, rollover account and employer account in the
 31 manner provided by this section when the member retires for service under the provisions of ORS
 32 chapter 238.

33 (5) Notwithstanding any other provision of ORS 238A.300 to 238A.415, the entire interest of a
 34 member of the individual account program must be distributed over a time period commencing no
 35 later than the latest retirement date set forth in ORS 238A.170, and must be distributed in a manner
 36 that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations im-
 37 plementing that section, as in effect on [*May 1,*] **December 31,** 2009. The board shall adopt rules
 38 implementing those minimum distribution requirements.

39 **SECTION 8.** ORS 238A.410 is amended to read:

40 238A.410. (1) If a member of the individual account program dies before retirement, the amounts
 41 in the member’s employee account, rollover account and employer account, to the extent the member
 42 is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the beneficiary or
 43 beneficiaries designated by the member for the purposes of this section.

44 (2) If a member of the individual account program is married at the time of death, or there exists
 45 at the time of death any other person who is constitutionally required to be treated in the same

1 manner as a spouse for the purpose of retirement benefits, the spouse or other person shall be the
 2 beneficiary for purposes of the death benefit payable under this section unless the spouse or other
 3 person consents to the designation of a different beneficiary or beneficiaries before the designation
 4 has been made and the consent has not been revoked by the spouse or other person as of the time
 5 of the member's death. Consent and revocation of consent must be in writing, acknowledged by a
 6 notary public, and submitted to the Public Employees Retirement Board in accordance with rules
 7 adopted by the board. If the member's spouse is designated as the member's beneficiary and the
 8 marriage of the member and spouse is subsequently dissolved, the former spouse shall be treated as
 9 predeceasing the member for purposes of this section, unless the member expressly designates the
 10 former spouse as beneficiary after the effective date of the dissolution or the former spouse is re-
 11 quired to be designated as a beneficiary under the provisions of ORS 238.465.

12 (3) For purposes of this section and ORS 238A.400 (3), if a member fails to designate a benefi-
 13 ciary, or if the person or persons designated do not survive the member, the death benefit provided
 14 for in this section shall be paid to the following person or persons, in the following order of priority:

15 (a) The member's surviving spouse or other person who is constitutionally required to be treated
 16 in the same manner as a spouse;

17 (b) The member's surviving children, in equal shares; or

18 (c) The member's estate.

19 (4) The entire amount of a deceased member's vested accounts must be distributed by December
 20 31 of the fifth calendar year after the year in which the member died. Notwithstanding any other
 21 provision of this chapter, distributions of death benefits under the individual account program must
 22 comply with the minimum distribution requirements of 26 U.S.C. 401(a)(9) and the regulations im-
 23 plementing that section, as in effect on [May 1,] **December 31, 2009**. The Public Employees Retire-
 24 ment Board shall adopt rules implementing those minimum distribution requirements.

25 **SECTION 9.** ORS 238A.415 is amended to read:

26 238A.415. (1) Notwithstanding any other provision of ORS 238A.300 to 238A.415, an eligible em-
 27 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
 28 vices, and who subsequently returns to employment with a participating public employer with
 29 reemployment rights under federal law, is entitled to credit toward the probationary period required
 30 by ORS 238A.300, credit toward the vesting requirements of ORS 238A.320 and contributions under
 31 rules adopted by the Public Employees Retirement Board pursuant to subsection (2) of this section.

32 (2) The board shall adopt rules establishing contributions and service credit for any period of
 33 service in the uniformed services by an employee described in subsection (1) of this section. For the
 34 purpose of adopting rules under this subsection, the board shall consider and take into account all
 35 federal law relating to benefits and service credit for any period of service in the uniformed ser-
 36 vices, including 26 U.S.C. 414(u), as in effect on [May 1,] **December 31, 2009**. Contributions and
 37 service credit under rules adopted by the board pursuant to this subsection may not exceed contri-
 38 butions and service credit required under federal law for periods of service in the uniformed ser-
 39 vices.

40 **SECTION 10.** ORS 238A.430 is amended to read:

41 238A.430. (1) To the extent required by law, and except as otherwise provided by rules adopted
 42 by the Public Employees Retirement Board under subsection (4) of this section, any portion of a
 43 distribution of benefits described in subsection (2) of this section shall, at the election of and in lieu
 44 of distribution to the distributee, be paid directly to an eligible retirement plan specified by the
 45 distributee.

1 (2) The provisions of subsection (1) of this section apply to a distribution of any benefit under
2 the pension program or the individual account program except:

3 (a) A distribution that is one of a series of substantially equal periodic payments made at least
4 annually for the life or life expectancy of the distributee, or for the joint lives or life expectancies
5 of the distributee and a designated beneficiary;

6 (b) A distribution that is one of a series of substantially equal periodic payments made at least
7 annually for a specified period of 10 years or more; and

8 (c) A distribution to the extent that the distribution is required under 26 U.S.C. 401(a)(9).

9 (3) The provisions of subsection (1) of this section apply to any portion of a distribution of
10 benefits under the pension program or the individual account program even though the portion
11 consists of after-tax employee contributions that are not includable in gross income. Any portion of
12 a distribution that consists of after-tax employee contributions that are not includable in gross in-
13 come may be transferred only to an individual retirement account or annuity described in 26 U.S.C.
14 408(a) or (b), or to a qualified defined contribution or defined benefit plan described in 26 U.S.C.
15 401(a) or 403(b) that agrees to account separately for amounts transferred, including accounting
16 separately for the portion of the distribution that is includable in gross income and the portion of
17 the distribution that is not includable in gross income. The amount transferred shall be treated as
18 consisting first of the portion of the distribution that is includable in gross income, determined
19 without regard to 26 U.S.C. 402(c)(1).

20 (4) The board shall adopt rules implementing the direct rollover requirements of 26 U.S.C.
21 401(a)(31) and the regulations implementing that section, and may adopt administrative exceptions
22 to the direct rollover requirements to the extent permitted by 26 U.S.C. 401(a)(31) and the regu-
23 lations implementing that section.

24 (5) All references in this section to federal laws and regulations are to the laws and regulations
25 in effect on [May 1,] **December 31**, 2009.

26 (6) For purposes of this section:

27 (a) "Distributee" means a member, a member's surviving spouse or a member's alternate payee
28 under ORS 238.465.

29 (b) "Eligible retirement plan" means:

30 (A) An individual retirement account described in 26 U.S.C. 408(a);

31 (B) An individual retirement annuity described in 26 U.S.C. 408(b), other than an endowment
32 contract;

33 (C) A qualified trust under 26 U.S.C. 401(a), that is a defined contribution or defined benefit plan
34 and permits the acceptance of rollover contributions;

35 (D) An annuity plan described in 26 U.S.C. 403(a);

36 (E) An eligible deferred compensation plan described in 26 U.S.C. 457(b) that is maintained by
37 an eligible governmental employer described in 26 U.S.C. 457(e)(1)(A) and that agrees to account
38 separately for amounts transferred into such plan from the distributing plan; or

39 (F) An annuity contract described in 26 U.S.C. 403(b).

40 **SECTION 11.** ORS 305.230 is amended to read:

41 305.230. (1) Notwithstanding ORS 9.320:

42 (a) Any person who is qualified to practice law or public accountancy in this state, any person
43 who has been granted active enrollment to practice before the Internal Revenue Service and who
44 is qualified to prepare tax returns in this state or any person who is the authorized employee of a
45 taxpayer and is regularly employed by the taxpayer in tax matters may represent the taxpayer be-

1 fore a tax court magistrate or the Department of Revenue in any conference or proceeding with
2 respect to the administration of any tax.

14 registered appraiser under ORS 308.010 may represent a taxpayer before a tax court magistrate or
15 the department in any conference or proceeding with respect to the administration of any ad

23 permits, engineering, financing, reasonable program delinquencies, return on investment, required
24 fees, insurance, administration, accounting, depreciation, amortization, operation, maintenance, re-
25 pair or replacement and debt service, including debt service payments or payments into reserve ac-
26 counts for debt service and payment of amounts necessary to meet debt service coverage
27 requirements.

28 (2) "Assessment for local improvement" means any tax, fee, charge or assessment that does not
29 exceed the actual cost incurred by a unit of government for design, construction and financing of
30 a local improvement.

31 (3) "Bonded indebtedness" means any formally executed written agreement representing a
32 promise by a unit of government to pay to another a specified sum of money, at a specified date or
33 dates at least one year in the future.

23 bonded indebtedness approved by electors prior to December 5, 1996, that were spent or
24 contractually obligated to be spent before June 20, 1997, has the meaning given that term in para-

1 (c) Does not include street and highway construction, overlay and reconstruction.

2 (11) "Projected useful life" means the useful life, as reasonably estimated by the unit of gov-
3 ernment undertaking the capital construction or capital improvement project, beginning with the
4 date the property was acquired, constructed or reconstructed and based on the property's condition
5 at the time the property was acquired, constructed or reconstructed.

6 (12) "Routine obligations of ownership" means a standard of operation, maintenance, use or care
7 of property established by law, or if established by custom or common law, a standard that is rea-
8 sonable for the type of property affected.

9 (13) "Single assessment" means the complete assessment process, including preassessment, as-
10 sessment or reassessment, for any local improvement authorized by ORS 223.387 to 223.399, or a

5 utility payments" does not include telephone service.

6 (4) "Gross rent" means contract rent paid plus the fuel and utility payments made for the
7 homestead in addition to the contract rent, during the calendar year for which the claim is filed.

8 (C) The amount of the net loss, in excess of \$1,000, from all operations of a trade or business,

38 (7) “Internal Revenue Code,” except where the Legislative Assembly has provided otherwise,
39 refers to the laws of the United States or to the Internal Revenue Code as they are amended and
40 in effect:

41 (a) On [*May 1,*] **December 31,** 2009; or

42 (b) If related to the definition of taxable income, as applicable to the tax year of the taxpayer.

43 (8) “Oregon taxable income” means taxable income, less the deduction allowed under ORS
44 317.476, except as otherwise provided with respect to insurers in subsection (11) of this section and
45 ORS 317.650 to 317.665.

1 (9) "Oregon net loss" means taxable loss, except as otherwise provided with respect to insurers
2 in subsection (11) of this section and ORS 317.650 to 317.665.

3 (10) "Taxable income or loss" means the taxable income or loss determined, or in the case of a
4 corporation for which no federal taxable income or loss is determined, as would be determined, un-
5 der chapter 1, Subtitle A of the Internal Revenue Code and any other laws of the United States
6 relating to the determination of taxable income or loss of corporate taxpayers, with the additions,
7 subtractions, adjustments and other modifications as are specifically prescribed by this chapter ex-
8 cept that in determining taxable income or loss for any year, no deduction under ORS 317.476 or

29 **SECTION 29.** ORS 317.018 is amended to read:

30 317.018. It is the intent of the Legislative Assembly:

31 (1) To make the Oregon corporate excise tax law, insofar as it relates to the measurement of
32 taxable income, identical to the provisions of the federal Internal Revenue Code, as in effect and
33 applicable on [*May 1,*] **December 31**, 2009, to the end that taxable income of a corporation for
34 Oregon purposes is the same as it is for federal income tax purposes, subject to Oregon's jurisdiction

(a) "Annual rate" means the yearly interest rate specified on the note, and not the annual percentage rate, if any, disclosed to the applicant to comply with the federal Truth in Lending Act.

(b) "Finance charge" means the total of all interest, loan fees, interest on any loan fees financed by the lending institution, and other charges related to the cost of obtaining credit.

(c) "Lending institution" means any insured institution, as that term is defined in ORS 706.008, any mortgage banking company that maintains an office in this state or any community development corporation that is organized under the Oregon Nonprofit Corporation Law.

(d) "Manufactured dwelling park" has the meaning given that term in ORS 446.003.

(e) "Nonprofit corporation" means a corporation that is exempt from income taxes under section 501(c)(3) or (4) of the Internal Revenue Code as amended and in effect on [May 1,] **December 31, 2009**.

(f) "Preservation project" means housing that was previously developed as affordable housing with a contract for rent assistance from the United States Department of Housing and Urban Development or the United States Department of Agriculture and that is being acquired by a sponsoring entity.

(g) "Qualified assignee" means any investor participating in the secondary market for real estate loans.

(h) "Qualified borrower" means any borrower that is a sponsoring entity that has a controlling interest in the real property that is financed by a qualified loan. A controlling interest includes, but is not limited to, a controlling interest in the general partner of a limited partnership that owns the real property.

(i) "Qualified loan" means:

(A) A loan that meets the criteria stated in subsection (5) of this section or that is made to refinance a loan that meets the criteria described in subsection (5) of this section; or

(B) The purchase by a lending institution of bonds, as defined in ORS 286A.001, issued on behalf of the Housing and Community Services Department, the proceeds of which are used to finance or refinance a loan that meets the criteria described in subsection (5) of this section.

(j) "Sponsoring entity" means a nonprofit corporation, nonprofit cooperative, state governmental entity, local unit of government as defined in ORS 466.706, housing authority or any other person, provided that the person has agreed to restrictive covenants imposed by a nonprofit corporation, nonprofit cooperative, state governmental entity, local unit of government or housing authority.

(2) The Department of Revenue shall allow a credit against taxes otherwise due under this chapter for the taxable year to a lending institution that makes a qualified loan certified by the Housing and Community Services Department as provided in subsection (7) of this section. The amount of the credit is equal to the difference between:

(a) The amount of finance charge charged by the lending institution during the taxable year at an annual rate less than the market rate for a qualified loan that is made before January 1, 2014, that complies with the requirements of this section; and

(b) The amount of finance charge that would have been charged during the taxable year by the lending institution for the qualified loan for housing construction, development, acquisition or rehabilitation measured at the annual rate charged by the lending institution for nonsubsidized loans made under like terms and conditions at the time the qualified loan for housing construction, development, acquisition or rehabilitation is made.

1 (3) The maximum amount of credit for the difference between the amounts described in sub-
2 section (2)(a) and (b) of this section may not exceed four percent of the average unpaid balance of
3 the qualified loan during the tax year for which the credit is claimed.

4 (4) Any tax credit allowed under this section that is not used by the taxpayer in a particular
5 year may be carried forward and offset against the taxpayer's tax liability for the next succeeding
6 tax year. Any credit remaining unused in the next succeeding tax year may be carried forward and
7 used in the second succeeding tax year, and likewise, any credit not used in that second succeeding

17 (b) In the case of individual development accounts established for the purpose described in ORS

19 (4) "Individual development account" means a contract between an account holder and a
20 fiduciary organization, for the deposit of funds into a financial institution by the account holder, and
21 the deposit of matching funds into the financial institution by the fiduciary organization, to allow
22 the account holder to accumulate assets for use toward achieving a specific purpose approved by
23 the fiduciary organization.
