## A-Engrossed Senate Bill 1032

## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Creates unlawful practice of manufacturing, distributing or selling liquid or food in container made with bisphenol A if liquid or food is intended primarily for consumption by child under three years of age.]

[Creates unlawful practice of manufacturing, distributing or selling container made with bisphenol A if container is designed to be filled with liquid or food intended primarily for consumption by child under three years of age.]

[Takes effect January 1, 2012.]

Creates unlawful practice of manufacturing, distributing, selling or offering for sale any commercially available child's beverage container made with bisphenol A. Requires manufacturers of child's beverage containers made with bisphenol A to recall containers.

Becomes operative on July 1, 2011.

## A BILL FOR AN ACT

- 2 Relating to containers made with bisphenol A; creating new provisions; and amending ORS 646.608.
- Be It Enacted by the People of the State of Oregon:
  - SECTION 1. (1) As used in this section and sections 2 and 3 of this 2010 Act:
  - (a) "Child's beverage container" means an empty baby bottle or cup, including a spill-proof cup, designed to be filled with liquid intended primarily for consumption by a child under three years of age.
    - (b) "Person" has the meaning given that term in ORS 646.605.
  - (2) A person may not willfully or knowingly manufacture, distribute, sell or offer for sale in this state any commercially available child's beverage container made with bisphenol A.
  - SECTION 2. A person who manufactures any child's beverage container made with bisphenol A for distribution, sale or offer for sale in this state shall make a reasonable effort to notify any person who distributes, sells or offers for sale the manufacturer's containers made with bisphenol A in this state of the prohibition of section 1 (2) of this 2010 Act at least 90 days before the operative date specified in section 6 of this 2010 Act.
  - <u>SECTION 3.</u> A person who manufactures any child's beverage container made with bisphenol A for distribution, sale or offer for sale in this state shall recall any child's beverage container made with bisphenol A and adequately reimburse the retailer or consumer for the cost of the container and the cost to comply with the recall.
    - **SECTION 4.** ORS 646.608 is amended to read:
- 21 646.608. (1) A person engages in an unlawful practice when in the course of the person's busi-

(a) Passes off real estate, goods or services as those of another.

- (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, approval, or certification of real estate, goods or services.
- (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or association with, or certification by, another.
- (d) Uses deceptive representations or designations of geographic origin in connection with real estate, goods or services.
- (e) Represents that real estate, goods or services have sponsorship, approval, characteristics, ingredients, uses, benefits, quantities or qualities that they do not have or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the person does not have.
- (f) Represents that real estate or goods are original or new if they are deteriorated, altered, reconditioned, reclaimed, used or secondhand.
- (g) Represents that real estate, goods or services are of a particular standard, quality, or grade, or that real estate or goods are of a particular style or model, if they are of another.
- (h) Disparages the real estate, goods, services, property or business of a customer or another by false or misleading representations of fact.
- (i) Advertises real estate, goods or services with intent not to provide them as advertised, or with intent not to supply reasonably expectable public demand, unless the advertisement discloses a limitation of quantity.
- (j) Makes false or misleading representations of fact concerning the reasons for, existence of, or amounts of price reductions.
- (k) Makes false or misleading representations concerning credit availability or the nature of the transaction or obligation incurred.
- (L) Makes false or misleading representations relating to commissions or other compensation to be paid in exchange for permitting real estate, goods or services to be used for model or demonstration purposes or in exchange for submitting names of potential customers.
- (m) Performs service on or dismantles any goods or real estate when not authorized by the owner or apparent owner thereof.
- (n) Solicits potential customers by telephone or door to door as a seller unless the person provides the information required under ORS 646.611.
- (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate, discount or other value is contingent upon occurrence of an event subsequent to the time the customer enters into the transaction.
- (p) Makes any false or misleading statement about a prize, contest or promotion used to publicize a product, business or service.
- (q) Promises to deliver real estate, goods or services within a certain period of time with intent not to deliver them as promised.
  - (r) Organizes or induces or attempts to induce membership in a pyramid club.
- (s) Makes false or misleading representations of fact concerning the offering price of, or the person's cost for real estate, goods or services.
- (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any known material defect or material nonconformity.

- 1 (u) Engages in any other unfair or deceptive conduct in trade or commerce.
  - (v) Violates any of the provisions relating to auction sales, auctioneers or auction marts under ORS 698.640, whether in a commercial or noncommercial situation.
- (w) Manufactures mercury fever thermometers.

- 5 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal 6 law, or is:
  - (A) Prescribed by a person licensed under ORS chapter 677; and
- 8 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and 9 on the proper cleanup of mercury should breakage occur.
  - (y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to inform the purchaser that mercury is present in the thermostat and that the thermostat may not be disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the mercury does not become part of the solid waste stream or wastewater. For purposes of this paragraph, "thermostat" means a device commonly used to sense and, through electrical communication with heating, cooling or ventilation equipment, control room temperature.
- 16 (z) Sells or offers for sale a motor vehicle manufactured after January 1, 2006, that contains 17 mercury light switches.
  - (aa) Violates the provisions of ORS 803.375, 803.385 or 815.410 to 815.430.
- 19 (bb) Violates ORS 646A.070 (1).
- 20 (cc) Violates any requirement of ORS 646A.030 to 646A.040.
- 21 (dd) Violates the provisions of ORS 128.801 to 128.898.
- 22 (ee) Violates ORS 646.883 or 646.885.
- 23 (ff) Violates ORS 646.569.
- 24 (gg) Violates the provisions of ORS 646A.142.

- 13 (LLL) Violates the consumer protection provisions of the Servicemembers Civil Relief Act, 50 14 U.S.C. App. 501 et seq., as in effect on January 1, 2010.
- 15 (mmm) Violates a provision of ORS 646A.480 to 646A.495.
- 16 (nnn) Violates ORS 646A.082.
- 17 (000) Violates ORS 646.647.
- 18 (ppp) Violates ORS 646A.115.
- 19 (qqq) Violates a provision of ORS 646A.405.
  - (rrr) Violates section 1 of this 2010 Act.
  - (2) A representation under subsection (1) of this section or ORS 646.607 may be any manifestation of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact.
  - (3) In order to prevail in an action or suit under ORS 646.605 to 646.652, a prosecuting attorney need not prove competition between the parties or actual confusion or misunderstanding.
  - (4) An action or suit may not be brought under subsection (1)(u) of this section unless the Attorney General has first established a rule in accordance with the provisions of ORS chapter 183 declaring the conduct to be unfair or deceptive in trade or commerce.
  - (5) Notwithstanding any other provision of ORS 646.605 to 646.652, if an action or suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attorney, relief is limited to an injunction and the prevailing party may be awarded reasonable attorney fees.
  - SECTION 5. Sections 1 to 3 of this 2010 Act and the amendments to ORS 646.608 by section 4 of this 2010 Act apply to a person that operates as a manufacturer, distributor or retailer of any child's beverage container described in section 1 of this 2010 Act on or after the effective date of this 2010 Act.
  - SECTION 6. Sections 1 and 3 of this 2010 Act and the amendments to ORS 646.608 by section 4 of this 2010 Act become operative on July 1, 2011.
