**STATUTORY QUALIFICATIONS:** ORS 678.800

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Nine members concerned with the care and treatment of the chronically ill or infirm elderly; appointed after consultation with the appropriate associations and societies
  - Three licensed nursing home administrators (BURNHAM, FUSON, MCNAMARA)
  - One licensed medical doctor actively engaged in practice and conversant with the care and treatment of the long-term patient (KRULEWITCH)
  - One licensed professional nurse actively engaged in caring for chronically ill and infirm patients (ELIAS)
  - Three representative the public, at least one of whom is at least 62 years of age (GARDNER, HOWE, WEATHERBY)
  - A licensed pharmacist (DEERING)
- Except for the licensed administrators, no direct financial interest in a nursing home
- No more than two officials or full-time employees of state or local governments
- No public members may hold any pecuniary interest in, or have any employment contract with, a long-term care facility
- Citizens of the United States or declared intent to become citizens of the United States
- Residents of Oregon, no more than two consecutive terms, serve at the pleasure of the Governor

**DUTIES AND AUTHORITY:** ORS 678.810 – ORS 678.825

- Elect chair and vice chair; adopt rules
- Develop standards for licensing nursing home administrators
- Develop examinations and investigations for determining qualification for licensure as administrators
- Issue, revoke and suspend administrator licenses
- Enforce standards; conduct continuing study of nursing homes and nursing home administrators
- Approve courses and programs to meet requirements
- Maintain register of licensed administrators and trainees
