White: Three-year term: March 1, 2012 – February 28, 2015

STATUTORY QUALIFICATIONS: ORS 677.235 and 677.240

- Twelve members appointed by the Governor; residents for at least seven years
 - Seven Medical Doctors; at least one member from each federal congressional district
 - Congressional District 1 (GIRARD, KOVAL)
 - Congressional District 2 (MASTRANGELO)
 - Congressional District 3 (WILLIAMSON)
 - Congressional District 4 (MCKIMMY)
 - Congressional District 5 (SUKUMAR, WHITE)
 - Two Doctors of Osteopathy (NEACE, YATES)
 - One Doctor of Podiatric Medicine (MAH)
 - Two public members representing health consumers (KOPETSKI, TURNER)
- Physicians in active practice at least five years immediately preceding their appointment
- Neither a public member nor a member of the public member's immediate family employed as a health professional or in any health related industry
- No more than two consecutive terms
- Members take and subscribe an oath to support the Constitution and laws of the State of Oregon and the United States

DUTIES AND AUTHORITY: ORS 677.240 – ORS 677.492

- Adopt rules for administration and enforcement of ORS Ch 677
- Elect officers annually; keep record of all proceedings
- May appoint executive director, hearings officers and other personnel and fix compensation subject to applicable provisions of the State Personnel Relations Law
- License physicians who practice medicine, podiatrists, acupuncturists, and physician assistants.
- Accredite colleges and institutions
- Investigate complaints, and discipline licensees, including suspending and revoking licenses.
- Administer oaths; issue subpoenas
- Adopt fees and charges, subject to Department of Administrative Services' prior approval
