- Serve at the pleasure of the Governor
- Eligible for reappointment

DUTIES AND AUTHORITY: ORS 418.243

- Provides advice to the Department of Human Services on licensing outdoor youth programs as child-caring agencies in the following areas:
 - Policies adopted by the department regarding outdoor youth programs
 - Requirements for treatment programs provided by outdoor youth programs
 - Requirements for behavior management by outdoor youth programs
 - Requirements for health and safety
 - Any other requirements the department imposes on outdoor youth programs
- The department consults with the board on the licensure of outdoor youth programs as child-caring agencies prior to the adoption of rules
