**APPOINTMENT/CONFIRMATION AUTHORITY:** ORS 687.115

**TERM:** Rothenberger: Four-year term: October 1, 2012 – September 30, 2016

**ECONOMIC INTEREST FILING (ORS 244.050):** Not required.

**STATUTORY QUALIFICATIONS:** ORS 687.115

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- The board has 7 members appointed by the governor for 4 year terms
  - Must have 4 licensed massage therapists (BENNOURI, CALISE, FREDRICKSON, MORIN, **ROTHENBERGER**)
  - Must have 3 public members (CHAPMAN, MCMILLIN)
    - One public member from a health related field (CHAPMAN)
- Public members may not be: massage therapists, spouse, domestic partner, child, parent or sibling of a massage therapist
- A board member shall be removed immediately if the member is not a resident of the state, has been absent from three consecutive board meetings, without at least one excused absence, and not licensed and good standing at time of retirement

**DUTIES AND AUTHORITY:** ORS 687.115, ORS 687.121 – ORS 687.123

- The Board may hire, define the duties and fix the salary of the administrator
- The Board may adopt rules:
  - Establishing reasonable standard concerning sanitary hygienic and healthy conditions of premises and facilities
  - Relating to methods and procedures used in the practice of massage
  - Governing exams and investigation of applicants for licensure
  - Standards for certifying classes, fixing educational, training, and experience requirements for licensing
  - Any matter the board reasonably considers necessary and proper
- The Board may investigate complaints, take evidence, compel appearance of witnesses, and take depositions
- The Board or authorized representative may inspect premises for compliance with standards
