HCR 18

Declares June 18, 2011, as HUGS Day in Oregon.

HB 2852 A

Provides that agent or guardian of donor of body or body part may amend or revoke anatomical gift only under certain circumstances.

HB 2908 A

Prohibits person from knowingly performing pelvic examination on anesthetized or unconscious woman unless woman, or person authorized to make health care decisions for woman, has given informed consent to examination, court orders performance of examination for collection of evidence or examination is necessary for diagnostic purposes.

HB 2047

Designates private residential boarding school that provides academic education and therapeutic care as "child-caring agency" subject to licensure requirements of Department of Human Services.

HB 2054 A

Authorizes Department of Human Services to delay annual renewal of long term care facility license until compliance is certified following on-site inspection.

HB 2145

Permits dentist to provide removable nonorthodontic dental appliance to be worn in human mouth.

HB 2107

Allows physician or provider to disregard declaration for mental health treatment if principal is committed to state hospital or facility in certain circumstances.
