HB 2859 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM 4/19/2011 AGENDA: Establishes Task Force on State Historical Resources to develop plans for coordination among agencies and institutions dedicated to preserving Oregon history.

HB 3000  
CARRIED OVER FROM 4/19/2011 AGENDA: Requires proposal for public contract for services to include personnel deployment disclosure.

HB 3038  
CARRIED OVER FROM 4/19/2011 AGENDA; FOR THE PURPOSE OF REFERRING THIS MEASURES TO HOUSE COMMITTEE ON RULES ONLY: Prohibits assessment of system development charge or standby charge for water meter of higher capacity installed to accommodate fire sprinkler system in one or two family dwelling.

HB 3317  
CARRIED OVER FROM 4/19/2011 AGENDA: Modifies provisions regulating communities governed by declarations.

HB 3415 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM 4/19/2011 AGENDA: Requires contracting agency to pay fee to Secretary of State in amount of one-tenth of one percent of contract price for public improvement contract.

HB 2003  
CARRIED OVER FROM 4/19/2011 AGENDA: Requires state agency that owns real property or operates facilities to establish dedicated account to pay expenses of maintaining, repairing and replacing state agency's real property or facilities.

HB 2466  
CARRIED OVER FROM 4/19/2011 AGENDA: Prohibits sending of unsolicited facsimiles to public bodies.

HB 3111 CARRIED OVER FROM 4/19/2011 AGENDA: Provides process for veterinary facility or boarding kennel to remove domestic animal from facility or kennel if keeper of animal does not retake possession of animal.

HB 3180 \*\* CARRIED OVER FROM 4/19/2011 AGENDA: Re-creates Oregon Board of Accountancy as semi-independent state agency. \*\*Subsequent Referral(s) to Ways and Means

HB 3195 CARRIED OVER FROM 4/19/2011 AGENDA: Provides that if governmental agency conducts transaction by electronic means or in electronic form in ordinary course of business and under authority of law, agreement of person that conducts transaction with agency to conduct transaction by electronic means is presumed.

HB 3411 CARRIED OVER FROM 4/19/2011 AGENDA; Prohibits issuance or sale of portable electronics insurance coverage without licensure by Department of Consumer and Business Services.

HB 3461 CARRIED OVER FROM 4/19/2011 AGENDA: Requires surcharges imposed under Klamath River dam agreement to be applied equally to all customer classes.

HB 3574 CARRIED OVER FROM 4/19/2011 AGENDA: Requires contracting agency to use alternative contracting method to award energy savings performance contract.

HB 3575 \*\* CARRIED OVER FROM 4/19/2011 AGENDA: Directs Oregon Department of Administrative Services and Governor to submit continuous improvement level state budget based on performance management and performance measurement techniques. \*\*Subsequent Referral(s) to Ways and Means

HJR 6 \*\* CARRIED OVER FROM 4/19/2011 AGENDA: Proposes amendment to Oregon Constitution to allow Legislative Assembly to provide for consolidation of metropolitan service district with county, and replacement of existing metropolitan service district charter with new charter for consolidated county and metropolitan service district. \*\*Subsequent Referral(s) to Revenue

**Public Hearing and Possible Work Session**

HB 2780 CARRIED OVER FROM 4/19/2011 AGENDA: Directs Governor and Legislative Assembly to use process identifying priorities of government to develop biennial state budget.

HB 2631 CARRIED OVER FROM 4/19/2011 AGENDA: Prohibits contracting agency from considering monetary donation or in-kind contribution in evaluating responsiveness of bid or proposal or responsibility of bidder or proposer.

HB 2945 CARRIED OVER FROM 4/19/2011 AGENDA: Prohibits city or district from requiring consent by landowner to eventual annexation in exchange for providing extraterritorial service when city or district is providing service on behalf of another local government pursuant to intergovernmental agreement.

HB 2957 CARRIED OVER FROM 4/19/2011 AGENDA; FIRST PUBLIC HEARING - Prohibits owner of foreclosed residential real property from neglecting real property during periods of vacancy.
