WHAT THE MEASURE DOES: Establishes new congressional districts. Specifies composition (by county, census block and tract) of new congressional districts (see attached data and maps). Declares emergency, effective upon passage.



EFFECT OF COMMITTEE AMENDMENT: No amendment.


BACKGROUND: According to the 2010 U.S. Census, the population of Oregon is 3,831, 074. This is about a 12 percent increase from the 2000 Census. Every ten years, the legislature must redraw legislative and congressional district lines based on new U.S. Census data. ORS 188.010 establishes criteria to guide the legislature when redrawing district boundaries. According to this statute, each district, as nearly practicable, should: be contiguous, be of equal population, utilize existing geographic or political boundaries, not divide communities of common interest, and be connected by transportation links.

The criteria further state that: 1) no district shall be drawn for the purpose of favoring any political party, incumbent legislator, or other person; 2) no district shall be drawn for the purpose of diluting the voting strength of any language or ethnic minority group; and, 3) two state House of Representative districts shall be wholly included within a single state senatorial district.




