

A-Engrossed House Bill 2013

Ordered by the Senate May 25
Including Senate Amendments dated May 25

Sponsored by COMMITTEE ON HEALTH CARE

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Abolishes Advisory Council for Electrologists and Permanent Color Technicians and Tattoo Artists and transfers duties of council to Oregon Health Licensing Agency.

Creates Board of Body Art Practitioners within agency to advise agency on regulation of persons performing tattooing, electrolysis, body piercing, dermal implanting and scarification.

Modifies provisions relating to regulation of persons who perform tattooing, electrolysis and body piercing.

Provides that person may not perform dermal implanting or scarification without license issued by agency.

Declares emergency, effective on passage.

A BILL FOR AN ACT

Relating to body art practitioners; creating new provisions; amending ORS 676.606, 676.610, 676.612, 676.613, 676.617, 676.622, 676.625, 676.992, 679.500, 690.350, 690.360, 690.365, 690.370, 690.380, 690.385, 690.390, 690.405, 690.407, 690.410, 690.415 and 690.992; repealing ORS 690.355, 690.425, 690.430, 690.500, 690.507, 690.510, 690.515, 690.520, 690.530, 690.550 and 690.570; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

ABOLISH AND TRANSFER

SECTION 1. (1) The Advisory Council for Electrologists and Permanent Color Technicians and Tattoo Artists is abolished. On the operative date of this section, the tenure of office of the members of the council ceases.

(2) All the duties, functions and powers of the council are imposed upon, transferred to and vested in the Oregon Health Licensing Agency.

RECORDS AND PROPERTY

SECTION 2. (1) The Advisory Council for Electrologists and Permanent Color Technicians and Tattoo Artists shall deliver to the Oregon Health Licensing Agency all records and property within the jurisdiction of the council.

(2) The agency shall take possession of the records and property.

UNEXPENDED REVENUES

1 **SECTION 3.** The unexpended balances of amounts authorized to be expended by the Ad-
 2 visory Council for Electrologists and Permanent Color Technicians and Tattoo Artists and
 3 the body piercing registration and licensing programs established under ORS 690.510 and
 4 690.520 for the biennium beginning July 1, 2009, from revenues dedicated, continuously ap-
 5 propriated, appropriated or otherwise made available for the purpose of administering and
 6 enforcing the duties, functions and powers transferred by section 1 of this 2011 Act are
 7 transferred to and are available for expenditure by the Oregon Health Licensing Agency for
 8 the biennium beginning July 1, 2009, as authorized by ORS 676.625.

 10 **ACTION, PROCEEDING, PROSECUTION**

11
 12 **SECTION 4.** The transfer of duties, functions and powers to the Oregon Health Licensing
 13 Agency by section 1 of this 2011 Act does not affect any action, proceeding or prosecution
 14 involving or with respect to such duties, functions and powers begun before and pending at
 15 the time of the transfer, except that the agency is substituted for the Advisory Council for
 16 Electrologists and Permanent Color Technicians and Tattoo Artists in the action, proceeding
 17 or prosecution.

 19 **LIABILITY, DUTY, OBLIGATION**

20
 21 **SECTION 5.** Nothing in sections 1 to 7, 10 and 22 of this 2011 Act, the amendments to
 22 ORS 676.606, 676.610, 676.612, 676.613, 676.617, 676.622, 676.625, 676.992, 679.500, 690.350, 690.360,
 23 690.365, 690.370, 690.380, 690.385, 690.390, 690.405, 690.407, 690.410, 690.415 and 690.992 by
 24 sections 8, 11 to 21 and 24 to 32 of this 2011 Act or the repeal of ORS 690.355, 690.425, 690.430,
 25 690.500, 690.507, 690.510, 690.515, 690.520, 690.530, 690.550 and 690.570 by section 33 of this 2011
 26 Act relieves a person of a liability, duty or obligation accruing under or with respect to the
 27 duties, functions and powers transferred by section 1 of this 2011 Act. The Oregon Health
 28 Licensing Agency may undertake the collection or enforcement of any such liability, duty
 29 or obligation.

 33 **SECTION 6.** (1) Notwithstanding the transfer of duties, functions and powers by section
 34 1 of this 2011 Act, the rules of the Advisory Council for Electrologists and Permanent Color
 35 Technicians and Tattoo Artists in effect on the operative date of section 1 of this 2011 Act
 36 continue in effect until superseded or repealed by rules of the Oregon Health Licensing
 37 Agency. References in rules of the council to the council or an officer or employee of the
 38 council are considered to be references to the agency or an officer or employee of the
 39 agency.

40 (2) Notwithstanding the repeal of ORS 690.500, 690.507, 690.510, 690.515, 690.520, 690.530,
 41 690.550 and 690.570 by section 33 of this 2011 Act, the rules of the agency relating to body
 42 piercing in effect on the operative date of the repeal of ORS 690.500, 690.507, 690.510, 690.515,
 43 690.520, 690.530, 690.550 and 690.570 by section 33 of this 2011 Act continue in effect until su-
 44 perseded or repealed by rules of the agency.

45 **SECTION 7.** Whenever, in any uncodified law or resolution of the Legislative Assembly

1 or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-
2 erence is made to the Advisory Council for Electrologists and Permanent Color Technicians
3 and Tattoo Artists or an officer or employee of the council, the reference is considered to
4 be a reference to the Oregon Health Licensing Agency or an officer or employee of the
5 agency.

7 **BODY ART PRACTITIONERS**

8
9 **SECTION 8.** ORS 690.350 is amended to read:

10 690.350. As used in ORS 690.350 to 690.430, unless the context requires otherwise:

11 [(1) "*Council*" means the Advisory Council for Electrologists and Permanent Color Technicians and
12 Tattoo Artists, created in the Oregon Health Licensing Agency.]

13 [(2) "*Electrologist*" means a person who practices electrolysis pursuant to the provisions of ORS
14 690.350 to 690.430.]

15 [(3) "*Electrology facility*" means any room or space or any part thereof where electrolysis is prac-
16 ticed or where the business of electrology is conducted.]

17 (1) "**Body piercing**" means the puncturing of a part of the body of a live human being to
18 create a permanent hole for ornamentation or decoration.

19 (2) "**Dermal implanting**" means the insertion of an object under the skin of a live human
20 being for ornamentation or decoration.

21 [(4)] (3) "*Electrolysis*" means the process by which hair, with a series of treatments, is perma-
22 nently removed from the skin by inserting a needle-conductor into the hair follicle and directing
23 electrical energy toward the hair cell. The word "electrolysis" is used in generic form in ORS
24 690.350 to 690.430 and refers to modalities of galvanic electrolysis, thermolysis and combinations
25 thereof.

26 [(5) "*Licensed electrologist*" means a person licensed under the provisions of ORS 690.350 to
27 690.430 to practice electrolysis.]

28 [(6) "*Licensed permanent color technician and tattoo artist*" means a person licensed under the
29 provisions of ORS 690.350 to 690.430 to practice tattooing.]

30 [(7) "*Permanent color technician and tattoo artist*" means a person who practices tattooing pursu-
31 ant to the provisions of ORS 690.350 to 690.430.]

32 [(8) "*Physician*" means a person licensed to practice the healing arts by this state pursuant to ORS
33 chapter 677, 684 or 685.]

34 [(9) "*Schools of electrolysis*" means career schools licensed by the Department of Education under
35 ORS 345.010 to 345.450 where electrolysis and related subjects are taught.]

36 [(10) "*Schools of permanent coloring or tattooing*" means career schools licensed by the Department
37 of Education under ORS 345.010 to 345.450 in which permanent coloring or tattooing and related
38 subjects are taught.]

39 [(11) "*Tattoo*" means the indelible mark, figure or decorative design introduced by insertion of
40 nontoxic dyes or pigments into or under the dermal portion of the skin upon the body of a live human
41 being.]

42 (4) "**Facility**" means a fixed or mobile place of business operated on a regular or irregular
43 basis for the purpose of providing services in one or more fields of practice.

44 (5) "**Field of practice**" means:

45 (a) **Tattooing;**

- 1 (b) Body piercing;
- 2 (c) Electrolysis;
- 3 (d) Dermal implanting; or
- 4 (e) Scarification.

5 (6) "License" means a written authorization issued under ORS 690.365 authorizing the
6 holder to:

- 7 (a) Perform services in one or more fields of practice; or
- 8 (b) Operate a facility.

9 (7) "Scarification" means injury of the skin to produce a scar on a live human being for
10 permanent ornamentation or decoration.

11 [(12)] (8) "Tattooing" means the process by which [*the skin*] a live human being is marked or
12 colored by insertion of nontoxic dyes or pigments [*into or under the dermal portion of the skin so*
13 *as*] to form indelible marks for [*cosmetic, medical or figurative purposes*] ornamentation or deco-
14 ration.

15 [(13)] "*Tattoo facility*" means any room or space or any part thereof where tattooing is practiced
16 or where the business of tattooing is conducted.]

17 [(14)] "*Teacher*" means a person who is registered by the Department of Education to teach in a
18 school of electrolysis or school of permanent coloring or tattooing pursuant to the provisions of ORS
19 345.010 to 345.450 and 690.350 to 690.430.]

20 (9) "Temporary license" means a written authorization issued under ORS 690.365 tempo-
21 rarily authorizing the holder to:

- 22 (a) Perform services in a field of practice; or
- 23 (b) Operate a facility.

24 **SECTION 9.** Section 10 of this 2011 Act is added to and made a part of ORS 690.350 to
25 690.430.

26 **SECTION 10.** (1) There is established within the Oregon Health Licensing Agency the
27 Board of Body Art Practitioners, to advise the agency with regard to the regulation of fields
28 of practice. The board consists of seven members appointed by the Governor.

29 (2) Members of the board must be residents of this state. Of the members of the board:

30 (a) Two members must be licensed under ORS 690.365 to perform body piercing, dermal
31 implanting or scarification;

32 (b) One member must be licensed under ORS 690.365 to practice electrolysis;

33 (c) Two members must be licensed under ORS 690.365 to perform tattooing;

34 (d) One member must be licensed under ORS chapter 677, 678 or 685; and

35 (e) One member must be a member of the public who does not possess the professional
36 qualifications of the other members.

37 (3) The term of office of each member of the board is four years, but a member serves
38 at the pleasure of the Governor. The Governor shall fill vacancies by appointment for the
39 unexpired term. A member shall hold the member's office until the appointment and quali-
40 fication of a successor. A member is eligible for reappointment. If a person serves two con-
41 secutive full terms, a period of at least four years must elapse before the person is eligible
42 for appointment to serve on the board.

43 (4) The board shall meet at least once per year.

44 (5) Members of the board are entitled to compensation and reimbursement of expenses
45 as provided in ORS 292.495.

1 **SECTION 11.** ORS 690.360 is amended to read:

2 690.360. *[No person shall:]*

3 *[(1) Sell, barter or offer to sell or barter a license;]*

4 *[(2) Purchase or procure by barter a license with intent to use it as evidence of the person's qual-*
5 *ification to practice electrolysis or tattooing;]*

6 *[(3) Alter materially a license with fraudulent intent;]*

7 *[(4) Use or attempt to use as a valid license a license which has been purchased, fraudulently ob-*
8 *tained, counterfeited or materially altered;]*

9 *[(5) Willfully make a false, material statement in an application for licensure or for renewal of a*
10 *license; or]*

11 *[(6) Operate an electrology facility or tattoo facility without obtaining an electrology facility license*
12 *or tattoo facility license.]*

13 **(1) A person may not:**

14 **(a) Perform or attempt to perform services in a field of practice without a license to**
15 **perform services in that field of practice;**

16 **(b) Perform or attempt to perform services in a field of practice outside of a licensed**
17 **facility;**

18 **(c) Display a sign or in any way advertise or purport to offer services in a field of prac-**
19 **tice without a license to perform services in that field of practice;**

20 **(d) Operate a facility, display a sign or in any way advertise or purport to offer services**
21 **in a field of practice in a facility without a license to operate a facility or a temporary license**
22 **to operate a facility;**

23 **(e) Knowingly make a false statement on an application to obtain or renew a license;**

24 **(f) Allow an individual in the employ or under the supervision or control of the person**
25 **to perform services in a field of practice without a license to perform services in that field**
26 **of practice;**

27 **(g) Sell, barter or offer to sell or barter a document evidencing a license;**

28 **(h) Purchase or procure by barter a document evidencing a license with intent to use the**
29 **document as evidence of the person's qualification to provide services in a field of practice;**

30 **(i) Materially alter with fraudulent intent a license or temporary license;**

31 **(j) Use or attempt to use as valid a fraudulently obtained, counterfeited or materially**
32 **altered license or temporary license; or**

33 **(k) Use or attempt to use as valid a fraudulently obtained, counterfeited or materially**
34 **altered license or temporary license.**

35 **(2) ORS 690.350 to 690.430 do not limit, preclude or otherwise interfere with the practice**
36 **of other persons or health care providers licensed in this state.**

37 **(3) Subsection (1)(a), (b) or (d) of this section does not apply to:**

38 **(a) A student while engaged in training at the direction of and under the direct super-**
39 **vision of the faculty of a school licensed under ORS 345.010 to 345.450 to teach a field of**
40 **practice; or**

41 **(b) An individual self-administering body piercing.**

42 **SECTION 12.** ORS 690.365 is amended to read:

43 690.365. (1)(a) *[An applicant for licensure shall pay a fee established by the Oregon Health Li-*
44 *censing Agency under ORS 690.350 to 690.430 and shall show]* **The Oregon Health Licensing**
45 **Agency shall issue a license to perform services in a field of practice to an applicant who:**

1 **(A) Shows** to the satisfaction of the agency that the applicant:

2 [(a) *Has complied with the provisions of ORS 690.350 to 690.430 and the applicable rules of the*
3 *agency;*]

4 [(b) (i) Is *[not less than]* **at least** 18 years of age;

5 [(c) (ii) Has a high school diploma or equivalent education; **and**

6 [(d) (iii) Has submitted evidence of completion of education and training prescribed and ap-
7 proved by the agency *[under ORS 690.410; and];*

8 [(e) (B) Has passed an examination approved, administered or recognized by the agency[.]; **and**

9 **(C) Pays fees established by the agency.**

10 [(2) *Subject to the provisions of ORS 676.612, the agency shall issue a license to each applicant*
11 *who provides evidence satisfactory to the agency of completion of all requirements for licensure. An*
12 *initial license shall be issued for one year unless otherwise specified by rule, and expires unless re-*
13 *newed on or before the expiration date by payment of required fees and demonstration of completion*
14 *of continuing education requirements specified by rule.*]

15 [(3) (b) *[Notwithstanding ORS 690.355 and subsections (1) and (2) of this section,]* The agency
16 may issue *[demonstration and]* a temporary *[permits]* **license to perform [tattooing] services in a field**
17 **of practice** as prescribed by agency rule.

18 **(2)(a) The Oregon Health Licensing Agency shall issue a license to operate a facility to**
19 **a person who:**

20 **(A) Files an application in the form and manner prescribed by the agency;**

21 **(B) Pays fees established by the agency; and**

23 **(b) The agency shall conduct periodic inspections of facilities to determine compliance**
24 **with safety, infection control and sterilization requirements.**

33 [(2)] The **Oregon Health Licensing Agency shall offer an examination for applicants for li-**
34 **censes to perform services in each field of practice** at least twice a year. [*The*] **An applicant**
35 **who fails any part of the examination may [apply to] retake the failed section [or sections twice**
36 **without being required to obtain additional training] in accordance with rules adopted by the**

39 690.380. (1) A person who holds a license under ORS 690.350 to 690.430 shall notify the Oregon
40 Health Licensing Agency in writing of the regular address of the place or places where the person
41 performs or intends to perform [*electrolysis or tattooing*] **services in a field of practice** and shall
42 keep the license conspicuously posted in the place of business at all times.

43 (2) The agency shall keep a record of the place or places of business of each person who holds
44 a license.

45 (3) Any notice required to be given by the agency to a person who holds a license may be given

1 by mailing the notice to the address of the last place of business of which the person has notified
2 the agency.

3 [(4) *The agency shall issue to each qualified applicant a license to operate an electrology facility
4 and to advertise electrolysis services for which the facility is licensed.*]

5 [(5) *The agency shall issue to each qualified applicant a license to operate a tattoo facility and to
6 advertise permanent coloring or tattooing services for which the facility is licensed.*]

7 [(6) *The agency may issue a single facility license to an applicant pursuant to ORS 676.617.*]

8 **SECTION 15.** ORS 690.385 is amended to read:

9 690.385. (1) Except as provided in [subsection (2)] **subsections (2) and (4)** of this section, a li-
10 cense issued under ORS 690.365 expires one year from the date of issuance. [*The licensee is respon-
11 sible for filing a license renewal application form.*] **To renew the license,** the licensee must submit
12 to the Oregon Health Licensing Agency:

13 (a) A completed renewal application[,];

14 (b) **The** required renewal fee; and

15 (c) Satisfactory evidence of having completed any required continuing education credits on or
16 before the expiration date of the license as specified by agency rule.

17 (2) The agency may vary the date of license renewal by giving the applicant written notice of
18 the renewal date being assigned and by making prorated adjustments to the renewal fee.

19 (3) The agency shall adopt by rule requirements for late renewal of a license, reactivation of

27 690.390. [*Licensed practicing electrologists and permanent color technicians and tattoo artists shall
28 meet the following standards and any others the Oregon Health Licensing Agency may adopt by rule*]
29 **The Oregon Health Licensing Agency shall establish standards for practitioners in a field of
30 practice. The standards must require:**

31 (1) [*Electrolysis and tattooing instruments shall*] **That instruments used in a field of practice**
32 be sterilized in accordance with methods approved by the rules of the agency;

33 (2) [*Practicing electrologists and permanent color technicians and tattoo artists shall*] **A practi-
34 tioner working in a field of practice to** be equipped with appropriate sterilizing equipment, [*with
35 availability of*] hot and cold running water and a covered waste receptacle; and

36 (3) **A practitioner working in a field of practice to keep** case history cards [*shall be kept*] for
37 each client.

15 [(12) *To issue an electrology facility license or a temporary electrology facility permit to qualified*
16 *applicants upon compliance with ORS 690.350 to 690.430;*]

17 [(13) *Notwithstanding ORS 690.355, to issue demonstration and temporary permits to perform ser-*
18 *vices as prescribed by agency rule; and*]

45 *ticing electrolysis or permanent coloring or tattooing*] **performing services in a field of practice for**

1 any of the grounds listed in ORS 676.612, and for any violation of the provisions of ORS 690.350 to
2 690.430, or the rules adopted thereunder.

4 690.410. (1) The Oregon Health Licensing Agency, in accordance with ORS chapter 183 and in

19 *electrolysis or a school of permanent coloring or tattooing under ORS 345.010 to 345.450 may employ*
20 *an individual licensed under ORS 690.350 to 690.430 and registered as a teacher by the Department*
21 *of Education to perform electrolysis, permanent coloring or tattooing for instructional purposes.*]
