

HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2020

1 On page 1 of the printed A-engrossed bill, delete lines 4 through 23.

2 Delete page 2 and insert:

3 **“SECTION 1. (1) The Oregon Department of Administrative Services shall develop a plan**
4 **for agencies of state government that employ more than 100 employees to attain a ratio of**
5 **11 to 1 of public employees to supervisory employees and managerial employees acting in a**
6 **supervisory capacity. The plan shall be used to develop the legislatively adopted budget and**
7 **may provide for a transition to the ratio specified in this subsection during a period lasting**
8 **more than one biennium.**

9 **“(2)(a) As part of the development of the legislatively adopted budget, during each odd-**
10 **numbered year regular session of the Legislative Assembly, the department shall report on**
11 **the plan developed under subsection (1) of this section to the Joint Committee on Ways and**
12 **Means.**

13 **“(b) The report required under this subsection shall also include:**

14 **“(A) The ratio of public employees to supervisory employees;**

15 **“(B) The ratio of public employees to managerial employees; and**

16 **“(C) The number of positions authorized for managerial employees who do not act in a**
17 **supervisory capacity and a description of the duties assigned to those positions.**

18 **“(3) As used in this section:**

19 **“(a) ‘Legislatively adopted budget’ means the budget enacted by the Legislative Assembly**
20 **during an odd-numbered year regular session.**

21 **“(b) ‘Managerial employee’ has the meaning given that term in ORS 243.650.**

22 **“(c) ‘Public employee’ has the meaning given that term in ORS 243.650.**

23 **“(d) ‘State government’ means every state officer, board, commission, department, in-**
24 **stitution, branch or agency whose costs are paid wholly or in part from funds held in the**
25 **State Treasury.**

26 **“(e) ‘Supervisory employee’ has the meaning given that term in ORS 243.650.**

27 **“SECTION 2. Section 1 of this 2011 Act first applies to the legislatively adopted budget**
28 **for the biennium beginning July 1, 2013.**

29 **“SECTION 3. The Oregon Department of Administrative Services shall report to the**
30 **Joint Committee on Ways and Means during the 2012 regular session of the Legislative As-**
31 **sembly on the ratio of public employees to supervisory employees or managerial employees**
32 **acting in a supervisory capacity.**

33 **“SECTION 4. Section 3 of this 2011 Act is repealed on January 2, 2013.**

34 **“SECTION 5. This 2011 Act being necessary for the immediate preservation of the public**
35 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**

1 **on its passage.”**
