House Bill 2042

Sponsored by Representative BARNHART (at the request of Oregon Vehicle Dealers Association and Oregon Power Sports Association) (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Permits person to provide Department of Transportation with odometer disclosure form for vehicle 10 years old or older.

Requires department to keep odometer records in electronic form.

A BILL FOR AN ACT

2 Relating to vehicles; amending ORS 802.200 and 803.102.

3 Be It Enacted by the People of the State of Oregon:

4 **SECTION 1.** ORS 803.102 is amended to read:

5 803.102. (1) As used in this section:

6 (a) "Transferee" means any person to whom ownership of a motor vehicle is transferred by 7 purchase, gift or any other means other than by creation of a security interest and any person who, 8 as an agent, signs an odometer disclosure statement for the transferee.

9 (b) "Transferor" means any person who transfers ownership of a motor vehicle by sale, gift or 10 any means other than by creation of a security interest and any person who, as an agent, signs an 11 odometer disclosure statement for the transferor.

(2) Except as otherwise provided in this section, upon transfer of any interest in a motor vehicle, an odometer disclosure statement shall be made by the transferor to the transferee. The disclosure shall be in a form that complies with the provisions of ORS 803.120 and shall contain the information required under ORS 803.122.

(3) If a transfer requiring a disclosure statement involves a leased vehicle, the lessor shall notify the lessee that the lessee is required to provide odometer disclosure. The lessee shall furnish the lessor with a form that complies with the requirements of ORS 803.120 and shall provide the information required by ORS 803.122 except that for purposes of the required information, the lessee shall be considered the transferor, the lessor shall be considered the transferee and the date shall be the date of the disclosure statement.

(4) Where an interest in a vehicle is transferred by operation of law, the Department of Transportation shall determine by rule whether an odometer disclosure statement is required and if so,
who is required to provide it.

(5) The odometer disclosure requirements of this section do not apply upon transfer of an interest where the transfer is due solely to the creation, release or assignment of a security interest,
or upon transfer of an interest in any of the following:

- 28 (a) A vehicle with a gross vehicle weight rating of more than 16,000 pounds.
- 29 (b) A vehicle that is not self-propelled.
- 30 (c) A vehicle that is at least 10 years old.

1	(d) A vehicle that is sold directly by the manufacturer to any agency of the United States in
2	conformity with contractual specifications.
3	(e) A vehicle that is exempted from the requirement by rules of the department.
4	(6) A person may provide an odometer disclosure statement for a vehicle that is 10 years
5	old or older.
6	SECTION 2. ORS 802.200 is amended to read:
7	802.200. In addition to any other records the Department of Transportation may establish, the
8	department is subject to the following provisions concerning records:
9	(1) The department shall maintain records concerning the titling of vehicles in this state. The
10	records under this subsection shall include the following:
11	(a) For vehicles issued a title by this state, the records shall identify the vehicle and contain
12	the following:
13	(A) The name of the vehicle owner and any security interest holders in order of priority, except
14	that a security interest holder need not be identified if the debtor who granted the interest is in the
15	business of selling vehicles and the vehicles constitute inventory held for sale;
16	(B) The name of any lessor of the vehicle;
17	(C) The vehicle description; and
18	(D) Whether a certificate of title was issued for the vehicle.
19	(b) If the vehicle is an antique vehicle that is reconstructed, the records shall indicate that the
20	vehicle is reconstructed.
21	(c) If the vehicle is a replica, the records shall indicate that the vehicle is a replica.
22	(d) Any other information concerning the titling of vehicles that the department considers con-
23	venient or appropriate.
24	(e) All odometer readings for a vehicle that are reported to the department under provisions of
25	the vehicle code. The department shall keep records required under this paragraph in elec-
26	tronic form.
27	(f) If the vehicle has been reported to the department as a totaled vehicle under the provisions
28	of ORS 819.012 or 819.014, the records shall indicate that the vehicle is a totaled vehicle unless the
29	reason for the report was theft and the vehicle has been recovered.
30 31	(2) If a vehicle that has been registered or titled in another jurisdiction is registered or titled in this state, the department shall retain a record of any odometer readings shown on the title or
32	registration documents submitted to the department at the time of registration or title.
33	(3) Except as otherwise provided in ORS 826.003, the department shall maintain records con-
34	cerning the registration of vehicles required to be registered by the department. The records con-
35	cerning the registration of vehicles may be stored along with records concerning the titling of
36	vehicles. The records under this subsection shall include the following:
37	(a) For vehicles registered by the department, the records shall identify the vehicle and contain
38	the following:
39	(A) The registration plate number assigned by the department to the vehicle;
40	(B) The name of the vehicle owner;
41	(C) The vehicle description and vehicle identification number; and
42	(D) An indication that the vehicle is a totaled vehicle if it has been reported to the department
43	as a totaled vehicle under the provisions of ORS 819.012 or 819.014, unless the reason for the report

that result from operation or use of a commercial motor vehicle and all convictions of the person 1

2 for violation of motor vehicle laws except convictions for offenses requiring mandatory revocation

or suspension of driving privileges under ORS 809.409, 809.411, 809.413 and 813.400, but shall include 3

only such accidents, suspensions and convictions that occur while the person is driving a motor 4 $\mathbf{5}$ vehicle:

(A) In the course of the person's employment when the person is employed by another for the 6 $\mathbf{7}$ principal purpose of driving a motor vehicle;

(B) Carrying persons or property for compensation;

9 (C) In the course of the person's employment in the collection, transportation or delivery of mail if the vehicle is government owned or marked for the collection, transportation or delivery of mail 10 in accordance with government rules; 11

12 (D) That is an authorized emergency vehicle;

13 (E) That is a commercial motor vehicle; or

(F) In the course of the person's employment with a federal, state or local government in a 14 15 public works project involving repair or maintenance of water, sewer or road systems.

(c) The nonemployment driving record shall include the person's:

17 (A) Motor vehicle accidents that the person is required to report under ORS 811.720, other than 18 the motor vehicle accidents that are included on the person's employment driving record;

(B) Suspensions, cancellations and revocations of licenses, permits and driving privileges;

(C) Convictions for violation of the motor vehicle laws other than those included in the em-20ployment driving record including, for each violation of ORS 811.100 or 811.111, the speed at which 2122the person was convicted of traveling and the posted speed, the speed limit or the speed that con-23stitutes prima facie evidence of violation of the basic speed rule, as appropriate; and

(D) Diversion agreements entered into under ORS 813.220 within the preceding 15 years.

25(d) The department may record other entries to indicate correspondence, interviews, participation in driver improvement programs or other matters concerning the status of the driving priv-2627ileges of the person.

(e) When a person from another jurisdiction applies for a driver license or driver permit issued 28by this state, the department shall request a copy of the person's driving record from the other ju-2930 risdiction. At the time the person is issued a license in Oregon, the record from the other jurisdic-31 tion shall become part of the driver's record in this state with the same force and effect as though entered on the driver's record in this state in the original instance. The department by rule may 32specify methods for converting entries from out-of-state records for use in Oregon. 33

34 (f) When a suspension of a driver permit, driver license or other driving privilege is placed on the driving record under ORS 809.280 for failure to appear in court on a traffic crime, the depart-35 ment shall note on the record that the suspension was for failure to appear in court and shall also 36 37 note the offense charged against the person on which the person failed to appear.

38 (g) The Department of Transportation, in consultation with the Department of State Police, shall devise and implement a method of noting suspensions and revocations of driving privileges on the 39 record in such a way that police agencies can determine directly from the record what class of of-40 fense, as provided by law, is committed by a person who drives in violation of the suspension or 41 42 revocation. If the Department of Transportation and the Department of State Police devise a mutually agreeable alternative method of informing police agencies of the nature of a suspension or re-43 vocation and the consequences of its violation, the implementation of that method shall satisfy the 44 duty of the Department of Transportation under this paragraph. 45

The records required by this subsection shall include the 8 9 following: (a) A description of the vehicle sufficient to identify the vehicle. 10 11 (b) The person to whom the permit was issued. 12(c) When the permit was issued. (d) The type of permit issued. 13(e) For registration weight trip permits, the maximum allowable registration weight permitted 14 15for operation under the permit. 16(f) Any other information the department determines appropriate or convenient. 17
