

# A-Engrossed House Bill 2100

Ordered by the House April 26  
Including House Amendments dated April 26

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor John A. Kitzhaber for Oregon Health Authority)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes Pharmacy and Therapeutics Committee to perform functions of Drug Use Review Board, which is abolished. Establishes Health Evidence Review Commission to perform functions of Health Resources Commission and Health Services Commission, which are abolished. Describes dual roles of Oregon Health Authority and Department of Human Services in administering medical assistance program. Permits sharing of information between authority and Department of Human Services for specified reasons. Modifies services provided to persons with developmental disabilities. *[Removes mandate for use of pharmacy benefit manager.]* **Prohibits charging hospital for complaint investigations in excess of specified number and for related fees in excess of specified amount.** Modifies preferred drug list requirements. Extends end date for authority and department to cross-delegate. Corrects references, updates terminology, makes other technical corrections and creates enabling provisions for authority.

Declares emergency, effective on passage.

2 **Be It Enacted by the People of the State of Oregon:**

3  
4 **PHARMACY AND THERAPEUTICS COMMITTEE**

5  
6 **SECTION 1. As used in sections 1 to 12 of this 2011 Act:**

7 (1) **“Compendia” means those resources widely accepted by the medical profession in the**  
8 **efficacious use of drugs, including the following sources:**

9 (a) **The American Hospital Formulary Service drug information.**

10 (b) **The United States Pharmacopeia drug information.**

11 (c) **The American Medical Association drug evaluations.**

12 (d) **Peer-reviewed medical literature.**

13 (e) **Drug therapy information provided by manufacturers of drug products consistent**  
14 **with the federal Food and Drug Administration requirements.**

15 (2) **“Criteria” means the predetermined and explicitly accepted elements based on**  
16 **compendia that are used to measure drug use on an ongoing basis to determine if the use**  
17 **is appropriate, medically necessary and not likely to result in adverse medical outcomes.**

18 (3) **“Drug-disease contraindication” means the potential for, or the occurrence of, an**  
19 **undesirable alteration of the therapeutic effect of a given prescription because of the pres-**  
20 **ence, in the patient for whom it is prescribed, of a disease condition or the potential for, or**  
21 **the occurrence of, a clinically significant adverse effect of the drug on the patient’s disease**  
22 **condition.**

23 (4) **“Drug-drug interaction” means the pharmacological or clinical response to the ad-**  
24 **ministration of at least two drugs different from that response anticipated from the known**  
25 **effects of the two drugs when given alone, which may manifest clinically as antagonism,**  
26 **synergism or idiosyncrasy. Such interactions have the potential to have an adverse effect**  
27 **on the individual or lead to a clinically significant adverse reaction, or both, that:**

28 (a) **Is characteristic of one or any of the drugs present; or**

29 (b) **Leads to interference with the absorption, distribution, metabolism, excretion or**  
30 **therapeutic efficacy of one or any of the drugs.**

31 (5) **“Drug use review” means the programs designed to measure and assess on a retro-**  
32 **spective and a prospective basis, through an evaluation of claims data, the proper utilization,**  
33 **quantity, appropriateness as therapy and medical necessity of prescribed medication in the**  
34 **medical assistance program.**

35 (6) **“Intervention” means an action taken by the Oregon Health Authority with a**  
36 **prescriber or pharmacist to inform about or to influence prescribing or dispensing practices**  
37 **or utilization of drugs.**

38 (7) **“Overutilization” means the use of a drug in quantities or for durations that put the**  
39 **recipient at risk of an adverse medical result.**

40 (8) **“Pharmacist” means an individual who is licensed as a pharmacist under ORS chapter**  
41 **689.**

42 (9) **“Prescriber” means any person authorized by law to prescribe drugs.**

43 (10) **“Prospective program” means the prospective drug use review program described in**  
44 **section 7 of this 2011 Act.**

45 (11) **“Retrospective program” means the retrospective drug use review program described**

1 in section 8 of this 2011 Act.

2 (12) "Standards" means the acceptable prescribing and dispensing methods determined  
3 by compendia, in accordance with local standards of medical practice for health care pro-  
4 viders.

5 (13) "Therapeutic appropriateness" means drug prescribing based on scientifically based  
6 and clinically relevant drug therapy that is consistent with the criteria and standards de-  
7 veloped under sections 1 to 12 of this 2011 Act.

8 (14) "Therapeutic duplication" means the prescribing and dispensing of two or more  
9 drugs from the same therapeutic class such that the combined daily dose puts the recipient  
10 at risk of an adverse medical result or incurs additional program costs without additional  
11 therapeutic benefits.

12 (15) "Underutilization" means that a drug is used by a recipient in insufficient quantity  
13 to achieve a desired therapeutic goal.

14 **SECTION 2.** (1) There is created an 11-member Pharmacy and Therapeutics Committee  
15 responsible for advising the Oregon Health Authority on the implementation of the retro-  
16 spective and prospective programs and on the Practitioner-Managed Prescription Drug Plan.

17 (2) The Director of the Oregon Health Authority shall appoint the members of the com-  
18 mittee, who shall serve at the pleasure of the director for a term of three years. An indi-  
19 vidual appointed to the committee may be reappointed upon completion of the individual's  
20 term. The membership of the committee shall be composed of the following:

21 (a) Five persons licensed as physicians and actively engaged in the practice of medicine  
22 or osteopathic medicine in Oregon, who may be from among persons recommended by or-  
23 ganizations representing physicians;

24 (b) Four persons licensed in and actively practicing pharmacy in Oregon who may be  
25 from among persons recommended by organizations representing pharmacists whether affil-  
26 iated or unaffiliated with any association; and

27 (c) Two persons who are not physicians or pharmacists.

28 (3) If the committee determines that it lacks current clinical or treatment expertise with  
29 respect to a particular therapeutic class, or at the request of an interested outside party, the  
30 director shall appoint one or more medical experts otherwise qualified as described in sub-  
31 section (2)(a) of this section who have such expertise. The medical experts shall have full  
32 voting rights with respect to recommendations made under section 4 (3) and (4) of this 2011  
33 Act. The medical experts may participate but may not vote in any other activities of the  
34 committee.

35 (4) The director shall fill a vacancy on the committee by appointing a new member to  
36 serve the remainder of the unexpired term.

37 **SECTION 3.** Notwithstanding the term of office specified by section 2 of this 2011 Act,  
38 of the members first appointed to the Pharmacy and Therapeutics Committee:

39 (1) Three shall serve for a term ending December 31, 2012.

40 (2) Three shall serve for a term ending December 31, 2013.

41 (3) Five shall serve for a term ending December 31, 2014.

42 **SECTION 4.** (1) The Pharmacy and Therapeutics Committee shall advise the Oregon  
43 Health Authority on:

44 (a) Adoption of rules to implement sections 1 to 12 of this 2011 Act in accordance with  
45 ORS chapter 183.

1       **(b) Implementation of the medical assistance program retrospective and prospective**  
2 **programs as described in sections 1 to 12 of this 2011 Act, including the type of software**  
3 **programs to be used by the pharmacist for prospective drug use review and the provisions**  
4 **of the contractual agreement between the state and any entity involved in the retrospective**  
5 **program.**

6       **(c) Development of and application of the criteria and standards to be used in retro-**  
7 **spective and prospective drug use review in a manner that ensures that such criteria and**  
8 **standards are based on compendia, relevant guidelines obtained from professional groups**  
9 **through consensus-driven processes, the experience of practitioners with expertise in drug**  
10 **therapy, data and experience obtained from drug utilization review program operations. The**  
11 **committee shall have an open professional consensus process for establishing and revising**  
12 **criteria and standards. Criteria and standards shall be available to the public. In developing**  
13 **recommendations for criteria and standards, the committee shall establish an explicit ongo-**  
14 **ing process for soliciting and considering input from interested parties. The committee shall**  
15 **make timely revisions to the criteria and standards based upon this input in addition to re-**  
16 **visions based upon scheduled review of the criteria and standards. Further, the drug utili-**  
17 **zation review standards shall reflect the local practices of prescribers in order to monitor:**

18       **(A) Therapeutic appropriateness.**

19       **(B) Overutilization or underutilization.**

20       **(C) Therapeutic duplication.**

21       **(D) Drug-disease contraindications.**

22       **(E) Drug-drug interactions.**

23       **(F) Incorrect drug dosage or drug treatment duration.**

24       **(G) Clinical abuse or misuse.**

25       **(H) Drug allergies.**

26       **(d) Development, selection and application of and assessment for interventions that are**  
27 **educational and not punitive in nature for medical assistance program prescribers,**  
28 **dispensers and patients.**

29       **(2) In reviewing retrospective and prospective drug use, the committee may consider only**  
30 **drugs that have received final approval from the federal Food and Drug Administration.**

31       **(3) The committee shall make recommendations to the authority, subject to approval by**  
32 **the Director of the Oregon Health Authority or the director's designee, for drugs to be in-**  
33 **cluded on any preferred drug list adopted by the authority and on the Practitioner-Managed**  
34 **Prescription Drug Plan. The committee shall also recommend all utilization controls, prior**  
35 **authorization requirements or other conditions for the inclusion of a drug on a preferred**  
36 **drug list.**

37       **(4) In making recommendations under subsection (3) of this section, the committee may**  
38 **use any information the committee deems appropriate. The recommendations must be based**  
39 **upon the following factors in order of priority:**

40       **(a) Safety and efficacy of the drug.**

41       **(b) The ability of Oregonians to access effective prescription drugs that are appropriate**  
42 **for their clinical conditions.**

43       **(c) Substantial differences in the costs of drugs within the same therapeutic class.**

44       **(5) The committee shall post a recommendation to the website of the authority no later**  
45 **than 30 days after the date the committee approves the recommendation. The director shall**

1 approve, disapprove or modify any recommendation of the committee as soon as practicable,  
2 shall publish the decision on the website and shall notify persons who have requested notifi-  
3 cation of the decision. A recommendation adopted by the director, in whole or in part, with  
4 respect to the inclusion of a drug on a preferred drug list or the Practitioner-Managed Pre-  
5 scription Drug Plan may not become effective less than 60 days after the date that the  
6 director's decision is published.

7 (6) The director shall reconsider any decision to adopt or modify a recommendation of  
8 the committee with respect to the inclusion of a particular drug on a preferred drug list or  
9 the Practitioner-Managed Prescription Drug Plan, upon the request of any interested person  
10 filed no later than 30 days after the director's decision is published on the website. The de-  
11 cision on reconsideration shall be sent to the requester and posted to the website without  
12 undue delay.

13 **SECTION 5.** In addition to the duties described in section 4 of this 2011 Act, the Phar-  
14 macy and Therapeutics Committee shall do the following subject to the approval of the Di-  
15 rector of the Oregon Health Authority:

16 (1) Publish an annual report, as described in section 12 of this 2011 Act.

17 (2) Publish and disseminate educational information to prescribers and pharmacists re-  
18 garding the committee and the drug use review programs, including information on the fol-  
19 lowing:

20 (a) Identifying and reducing the frequency of patterns of fraud, abuse or inappropriate  
21 or medically unnecessary care among prescribers, pharmacists and recipients.

22 (b) Potential or actual severe or adverse reactions to drugs.

23 (c) Therapeutic appropriateness.

24 (d) Overutilization or underutilization.

25 (e) Appropriate use of generic products.

26 (f) Therapeutic duplication.

27 (g) Drug-disease contraindications.

28 (h) Drug-drug interactions.

29 (i) Drug allergy interactions.

30 (j) Clinical abuse and misuse.

31 (3) Adopt and implement procedures designed to ensure the confidentiality of any infor-  
32 mation that identifies individual prescribers, pharmacists or recipients and that is collected,  
33 stored, retrieved, assessed or analyzed by the committee, staff of the committee, the Oregon  
34 Health Authority or contractors to the committee or the authority.

35 **SECTION 6.** In appropriate instances, interventions developed under section 4 (1)(d) of  
36 this 2011 Act may include the following:

37 (1) Information disseminated to prescribers and pharmacists to ensure that they are  
38 aware of the duties and powers of the Pharmacy and Therapeutics Committee.

39 (2) Written, oral or electronic reminders of recipient-specific or drug-specific information  
40 that are designed to ensure recipient, prescriber and pharmacist confidentiality, and sug-  
41 gested changes in the prescribing or dispensing practices designed to improve the quality of  
42 care.

43 (3) Face-to-face discussions between experts in drug therapy and the prescriber or  
44 pharmacist who has been targeted for educational intervention.

45 (4) Intensified reviews or monitoring of selected prescribers or pharmacists.

1 (5) Educational outreach through the retrospective program focusing on improvement  
2 of prescribing and dispensing practices.

3 (6) The timely evaluation of interventions to determine if the interventions have im-  
4 proved the quality of care.

5 (7) The review of case profiles before the conducting of an intervention.

6 **SECTION 7.** The prospective drug use review program must use guidelines established  
7 by the Oregon Health Authority that are based on the recommendations of the Pharmacy  
8 and Therapeutics Committee. The program must ensure that prior to the prescription being  
9 filled or delivered a review will be conducted by the pharmacist at the point of sale to screen  
10 for potential drug therapy problems resulting from the following:

11 (1) Therapeutic duplication.

12 (2) Drug-drug interactions, including serious interactions with nonprescription or over-  
13 the-counter drugs.

14 (3) Incorrect dosage and duration of treatment.

15 (4) Drug-allergy interactions.

16 (5) Clinical abuse and misuse.

17 (6) Drug-disease contraindications.

18 **SECTION 8.** The retrospective drug use review program must use:

19 (1) Guidelines established by the Oregon Health Authority that are based on the recom-  
20 mendations of the Pharmacy and Therapeutics Committee; and

21 (2) The mechanized drug claims processing and information retrieval system to analyze  
22 claims data on drug use against explicit predetermined standards that are based on  
23 compendia and other sources to monitor the following:

24 (a) Therapeutic appropriateness.

25 (b) Overutilization or underutilization.

26 (c) Fraud and abuse.

27 (d) Therapeutic duplication.

28 (e) Drug-disease contraindications.

29 (f) Drug-drug interactions.

30 (g) Incorrect drug dosage or duration of drug treatment.

31 (h) Clinical abuse and misuse.

32 **SECTION 9.** (1) Information collected under sections 1 to 12 of this 2011 Act that identi-  
33 fies an individual is confidential and may not be disclosed by the Pharmacy and Therapeutics  
34 Committee, the retrospective program or the Oregon Health Authority to any person other  
35 than a health care provider appearing on a recipient's medication profile.

36 (2) The staff of the committee may have access to identifying information for purposes  
37 of carrying out intervention activities. The identifying information may not be released to  
38 anyone other than a staff member of the committee, the retrospective program, the au-  
39 thority or a health care provider appearing on a recipient's medication profile or, for pur-  
40 poses of investigating potential fraud in programs administered by the authority, the  
41 Department of Justice.

42 (3) The committee may release cumulative, nonidentifying information for the purposes  
43 of legitimate research and for educational purposes.

44 **SECTION 10.** (1) Notwithstanding ORS 192.610 to 192.690, the Pharmacy and Therapeutics  
45 Committee shall meet in an executive session for purposes of:

1 (a) Reviewing the prescribing or dispensing practices of individual physicians or  
2 pharmacists;

3 (b) Discussing drug use review data pertaining to individual physicians or pharmacists;

4 (c) Reviewing profiles of individual patients; or

5 (d) Reviewing confidential drug pricing information, including substantial cost differences  
6 between drugs within the same therapeutic class, that is necessary for the committee to  
7 make final recommendations under section 4 of this 2011 Act or to comply with section 9 of  
8 this 2011 Act.

9 (2) A meeting held in executive session is subject to the requirements of ORS 192.650 (2).

10 **SECTION 11.** (1) Except as provided in section 10 of this 2011 Act, the Pharmacy and  
11 Therapeutics Committee shall operate in accordance with ORS chapter 192. The committee  
12 shall annually elect a chairperson from the members of the committee.

13 (2) A committee member is not entitled to compensation but is entitled to reimbursement  
14 for actual and necessary travel expenses incurred in connection with the member's duties,  
15 pursuant to ORS 292.495.

16 (3) A quorum consists of six members of the committee.

17 (4) The committee may establish advisory committees to assist in carrying out the  
18 committee's duties under sections 1 to 12 of this 2011 Act, with the approval of the Director  
19 of the Oregon Health Authority.

20 (5) The Oregon Health Authority shall provide staff and support services to the commit-  
21 tee.

22 (6) The committee shall meet no less than four times each year at a place, day and hour  
23 determined by the director. The committee also shall meet at other times and places speci-  
24 fied by the call of the director or a majority of the members of the committee. No less than  
25 30 days prior to a meeting the committee shall post to the authority website:

26 (a) The agenda for the meeting;

27 (b) A list of the drug classes to be considered at the meeting; and

28 (c) Background materials and supporting documentation provided to committee members  
29 with respect to drugs and drug classes that are before the committee for review.

30 (7) The committee shall provide appropriate opportunity for public testimony at each  
31 regularly scheduled committee meeting. Immediately prior to deliberating on any recom-  
32 mendations regarding a drug or a class of drugs, the committee shall accept testimony, in  
33 writing or in person, that is offered by a manufacturer of those drugs or another interested  
34 party.

35 (8) The committee may consider more than 20 classes of drugs at a meeting only if:

36 (a) There is no new clinical evidence for the additional class of drugs; and

37 (b) The committee is considering only substantial cost differences between drugs within  
38 the same therapeutic class.

39 **SECTION 12.** (1) The annual report required under section 5 (1) of this 2011 Act is subject  
40 to public comment prior to its submission to the Director of the Oregon Health Authority  
41 and must include the following:

42 (a) An overview of the activities of the Pharmacy and Therapeutics Committee and the  
43 prospective and retrospective programs;

44 (b) A summary of interventions made, including the number of cases brought before the  
45 committee and the number of interventions made;

1 (c) An assessment of the impact of the interventions, criteria and standards used, in-  
2 cluding an overall assessment of the impact of the educational programs and interventions  
3 on prescribing and dispensing patterns;

4 (d) An assessment of the impact of the criteria, standards and educational interventions  
5 on quality of care; and

6 (e) An estimate of the cost savings generated as a result of the prospective and retro-  
7 spective programs, including an overview of the fiscal impact of the programs to other areas  
8 of the medical assistance program such as hospitalization or long term care costs. This  
9 analysis should include a cost-benefit analysis of both the prospective and retrospective  
10 programs and should take into account the administrative costs of the drug utilization re-  
11 view program.

12 (2) Copies of the annual report shall be submitted to the President of the Senate, the  
13 Speaker of the House of Representatives and other persons who request copies of the report.

14  
15 **DRUG USE REVIEW BOARD ABOLISHED**

16  
17 **SECTION 13.** (1) The Drug Use Review Board is abolished. On the operative date of this  
18 section, the tenure of office of the members of the Drug Use Review Board ceases.

19 (2) All the duties, functions and powers of the Drug Use Review Board are imposed upon,  
20 transferred to and vested in the Pharmacy and Therapeutics Committee.

21 **SECTION 14.** (1) The Director of the Oregon Health Authority shall:

22 (a) Deliver to the Pharmacy and Therapeutics Committee all records and property within  
23 the jurisdiction of the Drug Use Review Board that relate to the duties, functions and powers  
24 transferred by section 13 of this 2011 Act; and

25 (b) Transfer to the committee those employees engaged primarily in the exercise of the  
26 duties, functions and powers transferred by section 13 of this 2011 Act.

27 (2) The committee shall take possession of the records and property and shall take  
28 charge of the employees and employ them, in the exercise of the duties, functions and powers  
29 transferred by section 13 of this 2011 Act, without reduction of compensation but subject to  
30 change or termination of employment or compensation as provided by law.

31 (3) The director shall resolve any dispute between the Drug Use Review Board and the  
32 Pharmacy and Therapeutics Committee relating to transfers of records, property and em-  
33 ployees under this section, and the director's decision is final.

34 **SECTION 15.** (1) The unexpended balances of amounts authorized to be expended by the  
35 Drug Use Review Board for the biennium beginning July 1, 2011, from revenues dedicated,  
36 continuously appropriated, appropriated or otherwise made available for the purpose of ad-  
37 ministering and enforcing the duties, functions and powers transferred by section 13 of this  
38 2011 Act are transferred to and are available for expenditure by the Pharmacy and  
39 Therapeutics Committee for the remainder of the biennium beginning July 1, 2011, for the  
40 purpose of administering and enforcing the duties, functions and powers transferred by sec-  
41 tion 13 of this 2011 Act.

42 (2) The expenditure classifications, if any, established by Acts authorizing or limiting  
43 expenditures by the board remain applicable to expenditures by the committee under this  
44 section.

45 **SECTION 16.** The transfer of duties, functions and powers to the Pharmacy and



1 Therapeutics Committee by section 13 of this 2011 Act does not affect any action, proceeding  
2 or prosecution involving or with respect to such duties, functions and powers begun before  
3 and pending at the time of the transfer, except that the committee is substituted for the  
4 Drug Use Review Board in the action, proceeding or prosecution.

5 **SECTION 17.** (1) Nothing in sections 1 to 16 of this 2011 Act or the repeal of ORS 414.350,  
6 414.355, 414.360, 414.365, 414.370, 414.375, 414.380, 414.385, 414.390, 414.395, 414.400, 414.410 or  
7 414.415 by section 228 of this 2011 Act relieves a person of a liability, duty or obligation ac-  
8 cruing under or with respect to the duties, functions and powers transferred by section 13  
9 of this 2011 Act. The Pharmacy and Therapeutics Committee may undertake the collection  
10 or enforcement of any such liability, duty or obligation.

11 (2) The rights and obligations of the Drug Use Review Board legally incurred under con-  
12 tracts, leases and business transactions executed, entered into or begun before the operative  
13 date of section 13 of this 2011 Act are transferred to the Pharmacy and Therapeutics Com-  
14 mittee. For the purpose of succession to these rights and obligations, the Pharmacy and  
15 Therapeutics Committee is a continuation of the Drug Use Review Board and is not a new  
16 authority.

17 **SECTION 18.** Whenever, in any uncodified law or resolution of the Legislative Assembly  
18 or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-  
19 erence is made to the Drug Use Review Board or an officer or employee of the Drug Use  
20 Review Board, the reference is considered to be a reference to the Pharmacy and  
21 Therapeutics Committee or an officer or employee of the Pharmacy and Therapeutics Com-  
22 mittee.

23 **SECTION 19.** For the purpose of harmonizing and clarifying statutory law, the Legislative  
24 Counsel may substitute for words designating the “Drug Use Review Board” or its officers,  
25 wherever they occur in statutory law, words designating the “Pharmacy and Therapeutics  
26 Committee” or its officers.

27 **SECTION 20.** The Director of the Oregon Health Authority may take any action before  
28 the operative date specified in section 21 of this 2011 Act that is necessary to enable the  
29 Pharmacy and Therapeutics Committee to exercise, on and after the operative date of sec-  
30 tion 13 of this 2011 Act, the duties, functions and powers of the committee pursuant to sec-  
31 tion 13 of this 2011 Act.

32 **SECTION 21.** Except as otherwise specifically provided in section 20 of this 2011 Act,  
33 sections 1 to 16 of this 2011 Act become operative 31 calendar days after the effective date  
34 of this 2011 Act.

35  
36 **HEALTH EVIDENCE REVIEW COMMISSION**

37  
38 **SECTION 22.** (1) As used in this section:

39 (a) “Practice of pharmacy” has the meaning given that term in ORS 689.005.

40 (b) “Retail drug outlet” has the meaning given that term in ORS 689.005.

41 (2) The Health Evidence Review Commission is established in the Oregon Health Au-  
42 thority, consisting of 13 members appointed by the Governor in consultation with profes-  
43 sional and other interested organizations, and confirmed by the Senate, as follows:

44 (a) Five members must be physicians licensed to practice medicine in this state who have  
45 clinical expertise in the areas of family medicine, internal medicine, obstetrics, perinatal

1 health, pediatrics, disabilities, geriatrics or general surgery. One of the physicians must be  
2 a doctor of osteopathy, and one must be a hospital representative or a physician whose  
3 practice is significantly hospital-based.

4 (b) One member must be a dentist licensed under ORS chapter 679 who has clinical ex-  
5 pertise in general, pediatric or public health dentistry.

6 (c) One member must be a public health nurse.

7 (d) One member must be a behavioral health representative who may be a social services  
8 worker, alcohol and drug treatment provider, psychologist or psychiatrist.

9 (e) Two members must be consumers of health care who are patient advocates or rep-  
10 resent the areas of indigent services, labor, business, education or corrections.

11 (f) One member must be a complementary or alternative medicine provider who is a  
12 chiropractic physician licensed under ORS chapter 684, a naturopathic physician licensed  
13 under ORS chapter 685 or an acupuncturist licensed under ORS chapter 677.

14 (g) One member must be an insurance industry representative who may be a medical  
15 director or other administrator.

16 (h) One member must be a pharmacy representative who engages in the practice of  
17 pharmacy at a retail drug outlet.

18 (3) No more than six members of the commission may be physicians either in active  
19 practice or retired from practice.

20 (4) Members of the commission serve for a term of four years at the pleasure of the  
21 Governor. A member is eligible for reappointment.

22 (5) Members are not entitled to compensation, but may be reimbursed for actual and  
23 necessary travel and other expenses incurred by them in the performance of their official  
24 duties in the manner and amounts provided for in ORS 292.495. Claims for expenses shall be  
25 paid out of funds available to the Oregon Health Authority for purposes of the commission.

26 **SECTION 23.** (1) The Health Evidence Review Commission shall select one of its members  
27 as chairperson and another as vice chairperson, for terms and with duties and powers the  
28 commission determines necessary for the performance of the functions of the offices.

29 (2) A majority of the members of the commission constitutes a quorum for the trans-  
30 action of business.

31 (3) The commission shall meet at least four times per year at a place, day and hour de-  
32 termined by the chairperson. The commission also shall meet at other times and places  
33 specified by the call of the chairperson or of a majority of the members of the commission.

34 (4) The commission may use advisory committees or subcommittees whose members are  
35 appointed by the chairperson of the commission subject to approval by a majority of the  
36 members of the commission. The advisory committees or subcommittees may contain ex-  
37 perts appointed by the chairperson and a majority of the members of the commission. The  
38 conditions of service of the experts will be determined by the chairperson and a majority of  
39 the members of the commission.

40 (5) The Office for Oregon Health Policy and Research shall provide staff and support  
41 services to the commission.

42 **SECTION 24.** (1) The Health Evidence Review Commission shall regularly solicit testi-  
43 mony and information from stakeholders representing consumers, advocates, providers,  
44 carriers and employers in conducting the work of the commission.

45 (2) The commission shall actively solicit public involvement through a public meeting

1 process to guide health resource allocation decisions.

2 (3) The commission shall develop and maintain a list of health services ranked by prior-  
3 ity, from the most important to the least important, representing the comparative benefits  
4 of each service to the population to be served. The list must be submitted by the commission  
5 pursuant to subsection (5) of this section and is not subject to alteration by any other state  
6 agency.

7 (4) In order to encourage effective and efficient medical evaluation and treatment, the  
8 commission:

9 (a) May include clinical practice guidelines in its prioritized list of services. The com-  
10 mission shall actively solicit testimony and information from the medical community and the  
11 public to build a consensus on clinical practice guidelines developed by the commission.

12 (b) May include statements of intent in its prioritized list of services. Statements of in-  
13 tent should give direction on coverage decisions where medical codes and clinical practice  
14 guidelines cannot convey the intent of the commission.

15 (c) Shall consider both the clinical effectiveness and cost-effectiveness of health services,  
16 including drug therapies, in determining their relative importance using peer-reviewed med-  
17 ical literature as defined in ORS 743A.060.

18 (5) The commission shall report the prioritized list of services to the Oregon Health Au-  
19 thority for budget determinations by July 1 of each even-numbered year.

20 (6) The commission shall make its report during each regular session of the Legislative  
21 Assembly and shall submit a copy of its report to the Governor, the Speaker of the House  
22 of Representatives and the President of the Senate.

23 (7) The commission may alter the list during the interim only as follows:

24 (a) To make technical changes to correct errors and omissions;

25 (b) To accommodate changes due to advancements in medical technology or new data  
26 regarding health outcomes;

27 (c) To accommodate changes to clinical practice guidelines; and

28 (d) To add statements of intent that clarify the prioritized list.

29 (8) If a service is deleted or added during an interim and no new funding is required, the  
30 commission shall report to the Speaker of the House of Representatives and the President  
31 of the Senate. However, if a service to be added requires increased funding to avoid discon-  
32 tinuing another service, the commission shall report to the Emergency Board to request the  
33 funding.

34 (9) The prioritized list of services remains in effect for a two-year period beginning no  
35 earlier than October 1 of each odd-numbered year.

36 **SECTION 25.** (1) As used in this section and section 26 of this 2011 Act:

37 (a) "Medical technology" means medical equipment and devices, medical or surgical pro-  
38 cedures and techniques used by health care providers in delivering medical care to individ-  
39 uals, and the organizational or supportive systems within which medical care is delivered.

40 (b) "Medical technology assessment" means evaluation of the use, clinical effectiveness  
41 and cost of a technology in comparison with its alternatives.

42 (2) The Health Evidence Review Commission shall develop a medical technology assess-  
43 ment process. The Oregon Health Authority shall direct the commission with regard to  
44 medical technologies to be assessed and the timing of the assessments.

45 (3) The commission shall appoint and work with an advisory committee whose members

1 have the appropriate expertise to conduct a medical technology assessment.

2 (4) The commission shall present its preliminary findings at a public hearing and shall  
3 solicit testimony and information from health care consumers. The commission shall give  
4 strong consideration to the recommendations of the advisory committee and public testi-  
5 mony in developing its assessment.

6 (5) To ensure that confidentiality is maintained, identification of a patient or a person  
7 licensed to provide health services may not be included with the data submitted under this  
8 section, and the commission shall release such data only in aggregate statistical form. All  
9 findings and conclusions, interviews, reports, studies, communications and statements pro-  
10 cured by or furnished to the commission in connection with obtaining the data necessary to  
11 perform its functions is confidential pursuant to ORS 192.501 to 192.505.

12 **SECTION 26.** (1) The Health Evidence Review Commission shall conduct comparative ef-  
13 fectiveness research of medical technologies selected in accordance with section 25 of this  
14 2011 Act. The commission may conduct the research by comprehensive review of the com-  
15 parative effectiveness research undertaken by recognized state, national or international  
16 entities. The commission may consider evidence relating to prescription drugs that is rele-  
17 vant to a medical technology assessment but may not conduct a drug class evidence review  
18 or medical technology assessment solely of a prescription drug. The commission shall dis-  
19 seminate the research findings to health care consumers, providers and third-party payers  
20 and to other interested stakeholders.

21 (2) The commission shall develop or identify and shall disseminate evidence-based health  
22 care guidelines for use by providers, consumers and purchasers of health care in Oregon.

23 (3) The Oregon Health Authority shall vigorously pursue health care purchasing strate-  
24 gies that adopt the research findings described in subsection (1) of this section and the  
25 evidence-based health care guidelines described in subsection (2) of this section.

26 **SECTION 26a.** The Health Evidence Review Commission, in ranking health services or  
27 developing guidelines under section 24 of this 2011 Act or in assessing medical technologies  
28 under section 26 of this 2011 Act, and the Pharmacy and Therapeutics Committee, in con-  
29 sidering a recommendation for a drug to be included on any preferred drug list or on the  
30 Practitioner-Managed Prescription Drug Plan, may not rely solely on the results of compar-  
31 ative effectiveness research.

32  
33 **HEALTH RESOURCES COMMISSION AND**  
34 **HEALTH SERVICES COMMISSION ABOLISHED**  
35

36 **SECTION 27.** (1) The Health Resources Commission and the Health Services Commission  
37 are abolished. On the operative date of this section, the tenure of office of the members of  
38 the Health Resources Commission and the Health Services Commission ceases.

39 (2) All the duties, functions and powers of the Health Resources Commission and the  
40 Health Services Commission are imposed upon, transferred to and vested in the Health Evi-  
41 dence Review Commission.

42 **SECTION 28.** (1) The Director of the Oregon Health Authority shall:

43 (a) Deliver to the Health Evidence Review Commission all records and property within  
44 the jurisdiction of the director that relate to the duties, functions and powers transferred  
45 by section 27 of this 2011 Act; and

1 (b) Transfer to the commission those employees engaged primarily in the exercise of the  
2 duties, functions and powers transferred by section 27 of this 2011 Act.

3 (2) The commission shall take possession of the records and property and shall take  
4 charge of the employees and employ them, in the exercise of the duties, functions and powers  
5 transferred by section 27 of this 2011 Act, without reduction of compensation but subject to  
6 change or termination of employment or compensation as provided by law.

7 (3) The director shall resolve any dispute between the Health Resources Commission and  
8 the Health Services Commission and the Health Evidence Review Commission relating to  
9 transfers of records, property and employees under this section, and the director's decision  
10 is final.

11 **SECTION 29.** (1) The unexpended balances of amounts authorized to be expended by the  
12 Health Resources Commission and the Health Services Commission for the biennium begin-  
13 ning July 1, 2011, from revenues dedicated, continuously appropriated, appropriated or oth-  
14 erwise made available for the purpose of administering and enforcing the duties, functions  
15 and powers transferred by section 27 of this 2011 Act are transferred to and are available for  
16 expenditure by the Health Evidence Review Commission for the remainder of the biennium  
17 beginning July 1, 2011, for the purpose of administering and enforcing the duties, functions  
18 and powers transferred by section 27 of this 2011 Act.

19 (2) The expenditure classifications, if any, established by Acts authorizing or limiting  
20 expenditures by the Health Resources Commission and the Health Services Commission re-  
21 main applicable to expenditures by the Health Evidence Review Commission under this sec-  
22 tion.

23 **SECTION 30.** The transfer of duties, functions and powers to the Health Evidence Review  
24 Commission by section 27 of this 2011 Act does not affect any action, proceeding or prose-  
25 cution involving or with respect to such duties, functions and powers begun before and  
26 pending at the time of the transfer, except that the Health Evidence Review Commission is  
27 substituted for the Health Resources Commission or the Health Services Commission in the  
28 action, proceeding or prosecution.

29 **SECTION 31.** (1) Nothing in sections 22 to 30 of this 2011 Act or the repeal of ORS 414.715,  
30 414.720, 414.741, 442.575, 442.580, 442.581, 442.583, 442.584, 442.588 and 442.589 by section 228 of  
31 this 2011 Act relieves a person of a liability, duty or obligation accruing under or with respect  
32 to the duties, functions and powers transferred by section 27 of this 2011 Act. The Health  
33 Evidence Review Commission may undertake the collection or enforcement of any such li-  
34 ability, duty or obligation.

35 (2) The rights and obligations of the Health Resources Commission and the Health Ser-  
36 vices Commission legally incurred under contracts, leases and business transactions exe-  
37 cuted, entered into or begun before the operative date of section 27 of this 2011 Act are  
38 transferred to the Health Evidence Review Commission. For the purpose of succession to  
39 these rights and obligations, the Health Evidence Review Commission is a continuation of the  
40 Health Resources Commission and the Health Services Commission and is not a new au-  
41 thority.

42 **SECTION 32.** The Director of the Oregon Health Authority may take any action before  
43 the operative date of section 27 of this 2011 Act that is necessary to enable the Health Evi-  
44 dence Review Commission to exercise, on and after the operative date of section 27 of this  
45 2011 Act, the duties, functions and powers of the commission pursuant to section 27 of this

1 2011 Act.

2 **SECTION 33.** Whenever, in any uncodified law or resolution of the Legislative Assembly  
3 or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-  
4 erence is made to the Health Resources Commission or the Health Services Commission or  
5 an officer or employee of the Health Resources Commission or the Health Services Com-  
6 mission, the reference is considered to be a reference to the Health Evidence Review Com-  
7 mission or an officer or employee of the Health Evidence Review Commission.

8 **SECTION 34.** For the purpose of harmonizing and clarifying statutory law, the Legislative  
9 Counsel may substitute for words designating the “Health Resources Commission” or the  
10 “Health Services Commission” or the officers of the Health Resources Commission or the  
11 Health Services Commission, wherever they occur in statutory law, words designating the  
12 “Health Evidence Review Commission” or its officers.

13 **SECTION 35.** Except as otherwise specifically provided in section 32 of this 2011 Act,  
14 sections 22 to 30 of this 2011 Act become operative on January 1, 2012.

15  
16 **OREGON HEALTH AUTHORITY FINANCIAL ADMINISTRATION**

17  
18 **SECTION 36.** Notwithstanding any other provision of law, federal laws shall govern the  
19 administration of federally granted funds. The Director of the Oregon Health Authority may  
20 request a waiver of any federal law in order to fully implement provisions of state law using  
21 federally granted funds.

22 **SECTION 37.** (1) There is established an Oregon Health Authority Special Checking Ac-  
23 count in the State Treasury. Upon the written request of the Director of the Oregon Health  
24 Authority, the Oregon Department of Administrative Services shall draw payments in favor  
25 of the authority to be charged against appropriations and other moneys available to the au-  
26 thority in the same manner as other claims against the state, as provided in ORS chapter  
27 293. All such payments shall be deposited in the special checking account and may be dis-  
28 bursed by check or other means acceptable to the State Treasurer.

29 (2) The special checking account may be used for the purpose of paying the administra-  
30 tive expenses of programs and services as assigned to the authority by law, including the  
31 payment of expenses to be reimbursed by the federal government.

32 (3) In addition to funds authorized under ORS 293.180, the authority may establish petty  
33 cash funds out of the special checking account or any account established in the State  
34 Treasury for the authority. The authority may pay expenses using small cash disbursements  
35 from a petty cash fund. Periodically, the authority shall request reimbursement for dis-  
36 bursements made from a petty cash fund. Upon receipt of a reimbursement payment from  
37 an appropriate account, the authority shall use the payment to reimburse the petty cash  
38 fund.

39 **SECTION 38.** Notwithstanding any other law, the Oregon Health Authority may, with the  
40 approval of the Oregon Department of Administrative Services and the State Treasurer,  
41 combine or eliminate any accounts that are established in statute and appropriated to the  
42 authority if economy and efficiency in operations can be obtained and the combination or  
43 elimination of accounts does not substantially alter the intent of the authorizing statutes.  
44 When accounts are combined, the Oregon Health Authority retains the authority granted  
45 by the statutes establishing the accounts.



1 of the Oregon Health Authority.

2 (2) Notwithstanding any other provision of law, the authority shall disclose to the general  
3 public the name and the dates of birth and death of a person whose cremated remains are  
4 in the possession of the authority for the purpose of:

5 (a) Giving a family member of the person an opportunity to claim the cremated remains;  
6 or

7 (b) Creating a memorial for those persons whose cremated remains are not claimed.

8 (3) If an individual contacts the authority to determine whether the authority is in pos-  
9 session of the cremated remains of a family member of the individual and the authority de-  
10 termines that the authority is in possession of the cremated remains, the authority shall  
11 disclose to the individual that the authority is in possession of the cremated remains and  
12 offer the individual the opportunity to claim the remains.

13 SECTION 43. Liquidated and delinquent debts owed to the Oregon Health Authority may  
14 be set off against amounts owed by the authority to the debtors.

15 SECTION 44. (1) Notwithstanding ORS 8.690, 9.160, 9.320 or 203.145 or ORS chapter 180  
16 or other law, in any contested case proceeding before the Oregon Health Authority, a cor-  
17 poration may be represented by an attorney or by any officer or authorized agent or em-  
18 ployee of the corporation.

19 (2) As used in this section, "corporation" includes a public or private corporation,  
20 whether or not organized for profit.

21 SECTION 45. (1) The Oregon Health Authority may accept funds, money or other valu-  
22 able things from relatives, corporations or interested persons or organizations for the care  
23 and support of needy persons and may expend the same for the care and support of the in-  
24 dividual or individuals for whom the moneys were paid.

25 (2) The authority may accept from individuals, corporations and organizations contribu-  
26 tions or gifts in cash or otherwise that shall be disbursed in the same manner as moneys  
27 appropriated for public assistance purposes, unless the donor of a gift stipulates a different  
28 manner in which a gift must be expended. Moneys received under this section shall be de-  
29 posited with the State Treasurer in an account separate and distinct from the General Fund.  
30 Interest earned by the account shall be credited to the account. Moneys in the account are  
31 continuously appropriated to the department for the purposes specified in this section.

32 SECTION 46. All sums of money recovered by or paid to the Oregon Health Authority  
33 as reimbursement for funds expended for medical assistance shall be paid into the Oregon  
34 Health Authority Fund established by ORS 413.031 and may be used for the provision and  
35 administration of medical assistance. However, the United States Government is entitled to  
36 a share of any amount received as its interest may appear, which shall be promptly paid to  
37 the United States Government.

38 SECTION 47. In addition to its other powers, the Oregon Health Authority may:

39 (1) Enter into agreements with, join with or accept grants from the federal government  
40 for cooperative research and demonstration projects for health and health care purposes,  
41 including, but not limited to, any project that:

42 (a) Improves the lifelong health of Oregonians.

43 (b) Aids in effecting coordination of planning between private and public health and  
44 health care agencies of the state.

45 (c) Improves the administration and effectiveness of programs carried on or assisted by



1 the authority.

2 (2) With the cooperation and the financial assistance of the federal government, train  
3 personnel employed or preparing for employment by the authority. The training may be  
4 carried out in any manner, including but not limited to:

5 (a) Directly by the authority.

6 (b) Indirectly through grants to public or other nonprofit institutions of learning or  
7 through grants of fellowships.

8 (c) Any other manner for which federal aid in support of the training is available.

9 (3) Subject to the allotment system provided for in ORS 291.234 to 291.260, expend the  
10 sums required to be expended for the programs and projects described in subsections (1) and  
11 (2) of this section.

12 **SECTION 48.** (1) The Oregon Health Authority shall adopt and enforce rules governing  
13 the custody, use and preservation of the records, papers, files and communications of the  
14 authority in accordance with applicable privacy laws. The use of the records, papers, files  
15 and communications is limited to the purposes for which they are furnished and by the pro-  
16 visions of law under which they may be furnished.

17 (2) The records, papers, files and communications of the authority may be maintained in  
18 a single or combined data system accessible to the authority and to the Department of Hu-  
19 man Services for the administration of programs and the coordination of functions shared  
20 by the authority and the department.

21 **SECTION 49.** (1) For the protection of applicants for and recipients of public assistance,  
22 except as otherwise provided in this section, the Oregon Health Authority may not disclose  
23 or use the contents of any public assistance records, files, papers or communications for  
24 purposes other than those directly connected with the administration of the public assistance  
25 programs or necessary to assist public assistance applicants and recipients in accessing and  
26 receiving other governmental or private nonprofit services, and these records, files, papers  
27 and communications are considered confidential subject to the rules of the authority. In any  
28 judicial or administrative proceeding, except proceedings directly connected with the admin-  
29 istration of public assistance or child support enforcement, their contents are considered  
30 privileged communications.

31 (2) Nothing in this section prohibits the disclosure or use of contents of records, files,  
32 papers or communications for purposes directly connected with the establishment and  
33 enforcement of support obligations pursuant to the Title IV-D of the Social Security Act.

34 (3) Nothing in this section prohibits the disclosure of the address, Social Security number  
35 and photograph of any applicant or recipient to a law enforcement officer at the request of  
36 the officer. To receive information pursuant to this section, the officer must furnish the  
37 agency the name of the applicant or recipient and advise that the applicant or recipient:

38 (a) Is fleeing to avoid prosecution, custody or confinement after conviction for a felony;

39 (b) Is violating a condition of probation or parole; or

40 (c) Has information that is necessary for the officer to conduct the official duties of the  
41 officer and the location or apprehension of the applicant or recipient is within such official  
42 duties.

43 (4) Nothing in this section prohibits disclosure of information between the authority and  
44 the Department of Human Services for the purpose of administering public assistance pro-  
45 grams that the authority and the department are responsible for administering.

1       **SECTION 50.** (1) The Oregon Health Authority may serve a notice described in ORS  
2 183.415 by regular mail or, if requested by the recipient of the notice, by electronic mail. The  
3 legal presumption described in ORS 40.135 (1)(q) does not apply to a notice that is served by  
4 regular mail under this section.

5       (2) Except as provided in subsection (3) of this section, a contested case notice served in  
6 accordance with subsection (1) of this section that complies with ORS 183.415 but for service  
7 by regular or electronic mail becomes a final order against a party and is not subject to ORS  
8 183.470 (2), upon the earlier of the following:

9       (a) If the party fails to request a hearing, the day after the date prescribed in the notice  
10 as the deadline for requesting a hearing.

11       (b) The date the authority or the Office of Administrative Hearings mails an order dis-  
12 missing a hearing request because:

13       (A) The party withdraws the request for hearing; or

14       (B) Neither the party nor the party's representative appears on the date and at the time  
15 set for hearing.

16       (3) The authority shall prescribe by rule a period of not less than 60 days after a notice  
17 becomes a final order under subsection (2) of this section within which a party may request  
18 a hearing under this subsection. If a party requests a hearing within the period prescribed  
19 under this subsection, the authority shall do one of the following:

20       (a) If the authority finds that the party did not receive the written notice and did not  
21 have actual knowledge of the notice, refer the request for hearing to the Office of Adminis-  
22 trative Hearings for a contested case proceeding on the merits of the authority's intended  
23 action described in the notice.

24       (b) Refer the request for hearing to the Office of Administrative Hearings for a contested  
25 case proceeding to determine whether the party received the written notice or had actual  
26 knowledge of the notice. The authority must show that the party had actual knowledge of  
27 the notice or that the authority mailed the notice to the party's correct address or sent an  
28 electronic notice to the party's correct electronic mail address.

29       (4) If a party informs the authority that the party did not receive a notice served by  
30 regular or electronic mail in accordance with subsection (1) of this section, the authority  
31 shall advise the party of the right to request a hearing under subsection (3) of this section.

45           (2) If the assets of the trust estate are insufficient to pay in full all expenses or claims of any

1 one class specified in subsection (1) of this section, each expense or claim of that class shall be paid  
2 only in proportion to the amount thereof.

3 **SECTION 65.** ORS 179.505 is amended to read:

4 179.505. (1) As used in this section:

5 (a) "Disclosure" means the release of, transfer of, provision of access to or divulgence in any  
6 other manner of information outside the health care services provider holding the information.

7 (b) "Health care services provider" means:

8 (A) Medical personnel or other staff employed by or under contract with a public provider to  
9 provide health care or maintain written accounts of health care provided to individuals; or

10 (B) Units, programs or services designated, operated or maintained by a public provider to pro-

12 (c) "Individually identifiable health information" means any health information that is:

27 (e) "Psychotherapy notes" means notes recorded in any medium:

28 (A) By a mental health professional, in the performance of the official duties of the mental

31 (C) That are maintained separately from the rest of the individual's record.

32 (f) "Psychotherapy notes" does not mean notes documenting:

33 (A) Medication prescription and monitoring;

35 (C) Modalities and frequencies of treatment furnished;

36 (D) Results of clinical tests; or

37 (E) Any summary of the following items:

38 (i) Diagnosis;

39 (ii) Functional status;

40 (iii) Treatment plan;

42 (v) Prognosis; or

43 (vi) Progress to date.

44 (g) "Public provider" means:

45 (A) The Blue Mountain Recovery Center, the Eastern Oregon Training Center and the Oregon

1 State Hospital campuses;

2 (B) Department of Corrections institutions as defined in ORS 421.005;

3 (C) A contractor of the Department of Corrections, the Department of Human Services or the  
4 Oregon Health Authority that provides health care to individuals residing in a state institution op-  
5 erated by the agencies;

6 (D) A community mental health program or community developmental disabilities program as  
7 described in ORS 430.610 to 430.695 and the public and private entities with which it contracts to  
8 provide mental health or developmental disabilities programs or services;

9 (E) A program or service provided under ORS 431.250, 431.375 to 431.385 or 431.416;

10 (F) A program or service established or maintained under ORS 430.630 **or section 174 of this**  
11 **2011 Act;**

12 (G) A program or facility providing an organized full-day or part-day program of treatment that  
13 is licensed, approved, established, maintained or operated by or contracted with the Oregon Health  
14 Authority for alcoholism, drug addiction or mental or emotional disturbance;

15 (H) A program or service providing treatment by appointment that is licensed, approved, estab-

19 (h) "Written account" means records containing only individually identifiable health information.

20 (2) Except as provided in subsections (3), (4), (6), (7), (8), (9), (11), (12), (14), (15), (16) and (17) of  
21 this section or unless otherwise permitted or required by state or federal law or by order of the  
22 court, written accounts of the individuals served by any health care services provider maintained  
23 in or by the health care services provider by the officers or employees thereof who are authorized  
24 to maintain written accounts within the official scope of their duties are not subject to access and  
25 may not be disclosed. This subsection applies to written accounts maintained in or by facilities of  
26 the Department of Corrections only to the extent that the written accounts concern the medical,

(a) By the sheriff of a county with a population of fewer than 75,000 inhabitants, according to the latest federal decennial census;

(e) By the Oregon State Police for work in a county with a population of fewer than 75,000 inhabitants, according to the latest federal decennial census; *[or]*

(f) As a deputy director or assistant director of the Department of Human Services, if the Governor approves the exemption for the person from the limitations on employment imposed in subsections (2) and (3) of this section[.]; **or**

**(g) As a deputy director or assistant director of the Oregon Health Authority, if the Governor approves the exemption for the person from the limitations on employment imposed in subsections (2) and (3) of this section.**

(6) Except as provided in subsection (9) of this section, the limitations on employment imposed by subsections (2) and (3) of this section do not apply to a retired member who is employed to temporarily replace an employee who serves in the National Guard or in a reserve component of the Armed Forces of the United States and who is called to federal active duty.

(7) Except as provided in subsection (9) of this section, the limitations on employment imposed by subsections (2) and (3) of this section do not apply to a retired member who is employed by a road assessment district organized under ORS 371.405 to 371.535.

2 subsidiaries that apply for coverage under the arrangement and that meet the requirements for  
3 membership in the arrangement. For purposes of this subsection, the requirements for membership  
4 in an arrangement shall not include any requirements that relate to the actual or expected health  
5 status of the prospective enrollee.

6 (7) A small employer carrier shall, pursuant to subsections (4) and (5) of this section, offer cov-  
7 erage to or accept applications from a group covered under an existing small employer health ben-  
8 efit plan whether or not a prospective enrollee is excluded from coverage under the existing plan  
9 because of late enrollment. When a small employer carrier accepts an application for such a group,  
10 the carrier may continue to exclude the prospective enrollee excluded from coverage by the replaced  
11 plan until the prospective enrollee would have become eligible for coverage under that replaced  
12 plan.

13 (8) No small employer carrier shall be required to offer coverage or accept applications pursuant  
14 to subsections (4) and (5) of this section if the director finds that acceptance of an application or  
15 applications would endanger the carrier's ability to fulfill its contractual obligations or result in fi-  
16 nancial impairment of the carrier.

17 (9) Every small employer carrier shall market fairly all small employer health benefit plans of-  
18 fered by the carrier to small employers in the geographical areas in which the carrier makes cov-  
19 erage available or provides benefits.

20 (10)(a) No small employer carrier shall be required to offer coverage or accept applications  
21 pursuant to subsections (4) and (5) of this section in the case of any of the following:

22 (A) To a small employer if the small employer is not physically located in the carrier's approved  
23 service area;

24 (B) To an employee if the employee does not work or reside within the carrier's approved ser-  
25 vice areas; or

26 (C) Within an area where the carrier reasonably anticipates, and demonstrates to the satisfac-  
27 tion of the director, that it will not have the capacity in its network of providers to deliver services  
28 adequately to the enrollees of those groups because of its obligations to existing group contract  
29 holders and enrollees.

30 (b) A carrier that does not offer coverage pursuant to paragraph (a)(C) of this subsection shall  
31 not offer coverage in the applicable service area to new employer groups other than small employers  
32 until the carrier resumes enrolling groups of new small employers in the applicable area.

33 (11) For purposes of ORS 743.733 to 743.737, except as provided in this subsection, carriers that  
34 are affiliated carriers or that are eligible to file a consolidated tax return pursuant to ORS 317.715  
35 shall be treated as one carrier and any restrictions or limitations imposed by ORS 743.733 to 743.737  
36 apply as if all health benefit plans delivered or issued for delivery to small employers in this state  
37 by the affiliated carriers were issued by one carrier. However, any insurance company or health  
38 maintenance organization that is an affiliate of a health care service contractor located in this state,  
39 or any health maintenance organization located in this state that is an affiliate of an insurance  
40 company or health care service contractor, may treat the health maintenance organization as a  
41 separate carrier and each health maintenance organization that operates only one health mainte-  
42 nance organization in a service area in this state may be considered a separate carrier.

43 (12) A small employer carrier that, after September 29, 1991, elects to discontinue offering all  
44 of its small employer health benefit plans under ORS 743.737 (5)(e), elects to discontinue renewing  
45 all such plans or elects to discontinue offering and renewing all such plans is prohibited from of-

1 offering health benefit plans in the small employer market in this state for a period of five years from  
2 one of the following dates:

3 (a) The date of notice to the director pursuant to ORS 743.737 (5)(e); or

4 (b) If notice is not provided under paragraph (a) of this subsection, from the date on which the  
5 director provides notice to the carrier that the director has determined that the carrier has effec-  
6 tively discontinued offering small employer health benefit plans in this state.

7 **SECTION 221.** ORS 743A.010 is amended to read:

8 743A.010. No policy of health insurance shall exclude from payment or reimbursement losses  
9 incurred by an insured for any covered service because the service was rendered at any hospital  
10 owned or operated by the State of Oregon or any state approved community mental health *[and]*

20 (a) In publications that the commission **or the committee** determines to be equivalent to:

21 (A) The American Hospital Formulary *[Services]* **Service** drug information;

22 (B) "Drug Facts and Comparisons" (Lippincott-Raven Publishers);

24 (D) Other publications that have been identified by the United States Secretary of Health and  
25 Human Services as authoritative;

26 (b) In the majority of relevant peer-reviewed medical literature; or

27 (c) By the United States Secretary of Health and Human Services.

28 (2) Required coverage of a prescription drug under this section shall include coverage for med-  
29 ically necessary services associated with the administration of that drug.

30 (3) Nothing in this section requires coverage for any prescription drug if the United States Food  
31 and Drug Administration has determined use of the drug to be contraindicated.

32 (4) Nothing in this section requires coverage for experimental drugs not approved for any indi-  
33 cation by the United States Food and Drug Administration.

34 (5) This section is exempt from ORS 743A.001.

25 **SECTION 226.** **The Mental Health Services Fund is established in the State Treasury,**  
26 **separate and distinct from the General Fund. The Mental Health Services Fund comprises**

28 **Services and the Department of Corrections under ORS 179.640, 426.241 and 430.165. The**

38 (4) **Programs operating under ORS 430.265, 430.306 to 430.375, 430.405, 430.415, 430.850 to**  
39 **430.880, 813.500 and 813.510.**

40 **SECTION 227.** **Notwithstanding any other provision of law, ORS 411.459 shall not be con-**  
41 **sidered to have been added to or made a part of ORS chapter 411 for the purpose of statutory**  
42 **compilation or for the application of definitions, penalties or administrative provisions ap-**  
43 **plicable to statute sections in that chapter.**
