SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes Pharmacy and Therapeutics Committee to perform functions of Drug Use Review Board, which is abolished. Establishes Health Evidence Review Commission to perform functions of Health Resources Commission and Health Services Commission, which are abolished. Describes dual roles of Oregon Health Authority and Department of Human Services in administering medical assistance program. Permits sharing of information between authority and Department of Human Services for specified reasons. Modifies services provided to persons with developmental disabilities. Prohibits charging hospital for complaint investigations in excess of specified number and for related fees in excess of specified amount. Modifies preferred drug list requirements. Extends end date for authority and department to cross-delegate. Corrects references, updates terminology, makes other technical corrections and creates enabling provisions for authority.

Declares emergency, effective on passage.

5 **Be It Enacted by the People of the State of Oregon:**

7 **PHARMACY AND THERAPEUTICS COMMITTEE**

8
9 **SECTION 1. As used in sections 1 to 12 of this 2011 Act:**

10 (1) **“Compendia” means those resources widely accepted by the medical profession in the**
11 **efficacious use of drugs, including the following sources:**

12 (a) **The American Hospital Formulary Service drug information.**

13 (b) **The United States Pharmacopeia drug information.**

14 (c) **The American Medical Association drug evaluations.**

15 (d) **Peer-reviewed medical literature.**

16 (e) **Drug therapy information provided by manufacturers of drug products consistent**
17 **with the federal Food and Drug Administration requirements.**

18 (2) **“Criteria” means the predetermined and explicitly accepted elements based on**
19 **compendia that are used to measure drug use on an ongoing basis to determine if the use**
20 **is appropriate, medically necessary and not likely to result in adverse medical outcomes.**

21 (3) **“Drug-disease contraindication” means the potential for, or the occurrence of, an**
22 **undesirable alteration of the therapeutic effect of a given prescription because of the pres-**
23 **ence, in the patient for whom it is prescribed, of a disease condition or the potential for, or**
24 **the occurrence of, a clinically significant adverse effect of the drug on the patient’s disease**
25 **condition.**

26 (4) **“Drug-drug interaction” means the pharmacological or clinical response to the ad-**
27 **ministration of at least two drugs different from that response anticipated from the known**
28 **effects of the two drugs when given alone, which may manifest clinically as antagonism,**
29 **synergism or idiosyncrasy. Such interactions have the potential to have an adverse effect**
30 **on the individual or lead to a clinically significant adverse reaction, or both, that:**

31 (a) **Is characteristic of one or any of the drugs present; or**

32 (b) **Leads to interference with the absorption, distribution, metabolism, excretion or**
33 **therapeutic efficacy of one or any of the drugs.**

34 (5) **“Drug use review” means the programs designed to measure and assess on a retro-**
35 **spective and a prospective basis, through an evaluation of claims data, the proper utilization,**
36 **quantity, appropriateness as therapy and medical necessity of prescribed medication in the**
37 **medical assistance program.**

38 (6) **“Intervention” means an action taken by the Oregon Health Authority with a**
39 **prescriber or pharmacist to inform about or to influence prescribing or dispensing practices**
40 **or utilization of drugs.**

41 (7) **“Overutilization” means the use of a drug in quantities or for durations that put the**
42 **recipient at risk of an adverse medical result.**

43 (8) **“Pharmacist” means an individual who is licensed as a pharmacist under ORS chapter**
44 **689.**

45 (9) **“Prescriber” means any person authorized by law to prescribe drugs.**

1 (10) "Prospective program" means the prospective drug use review program described in
2 section 7 of this 2011 Act.

3 (11) "Retrospective program" means the retrospective drug use review program described
4 in section 8 of this 2011 Act.

5 (12) "Standards" means the acceptable prescribing and dispensing methods determined
6 by compendia, in accordance with local standards of medical practice for health care pro-
7 viders.

8 (13) "Therapeutic appropriateness" means drug prescribing based on scientifically based
9 and clinically relevant drug therapy that is consistent with the criteria and standards de-
10 veloped under sections 1 to 12 of this 2011 Act.

11 (14) "Therapeutic duplication" means the prescribing and dispensing of two or more
12 drugs from the same therapeutic class such that the combined daily dose puts the recipient
13 at risk of an adverse medical result or incurs additional program costs without additional
14 therapeutic benefits.

15 (15) "Underutilization" means that a drug is used by a recipient in insufficient quantity
16 to achieve a desired therapeutic goal.

17 **SECTION 2.** (1) There is created an 11-member Pharmacy and Therapeutics Committee
18 responsible for advising the Oregon Health Authority on the implementation of the retro-
19 spective and prospective programs and on the Practitioner-Managed Prescription Drug Plan.

20 (2) The Director of the Oregon Health Authority shall appoint the members of the com-
21 mittee, who shall serve at the pleasure of the director for a term of three years. An indi-
22 vidual appointed to the committee may be reappointed upon completion of the individual's
23 term. The membership of the committee shall be composed of the following:

24 (a) Five persons licensed as physicians and actively engaged in the practice of medicine
25 or osteopathic medicine in Oregon, who may be from among persons recommended by or-
26 ganizations representing physicians;

27 (b) Four persons licensed in and actively practicing pharmacy in Oregon who may be
28 from among persons recommended by organizations representing pharmacists whether affil-
29 iated or unaffiliated with any association; and

30 (c) Two persons who are not physicians or pharmacists.

31 (3) If the committee determines that it lacks current clinical or treatment expertise with
32 respect to a particular therapeutic class, or at the request of an interested outside party, the
33 director shall appoint one or more medical experts otherwise qualified as described in sub-
34 section (2)(a) of this section who have such expertise. The medical experts shall have full
35 voting rights with respect to recommendations made under section 4 (3) and (4) of this 2011
36 Act. The medical experts may participate but may not vote in any other activities of the
37 committee.

38 (4) The director shall fill a vacancy on the committee by appointing a new member to
39 serve the remainder of the unexpired term.

40 **SECTION 3.** Notwithstanding the term of office specified by section 2 of this 2011 Act,
41 of the members first appointed to the Pharmacy and Therapeutics Committee:

42 (1) Three shall serve for a term ending December 31, 2012.

43 (2) Three shall serve for a term ending December 31, 2013.

44 (3) Five shall serve for a term ending December 31, 2014.

45 **SECTION 4.** (1) The Pharmacy and Therapeutics Committee shall advise the Oregon

1 **Health Authority on:**

2 (a) **Adoption of rules to implement sections 1 to 12 of this 2011 Act in accordance with**
3 **ORS chapter 183.**

4 (b) **Implementation of the medical assistance program retrospective and prospective**
5 **programs as described in sections 1 to 12 of this 2011 Act, including the type of software**
6 **programs to be used by the pharmacist for prospective drug use review and the provisions**
7 **of the contractual agreement between the state and any entity involved in the retrospective**
8 **program.**

9 (c) **Development of and application of the criteria and standards to be used in retro-**
10 **spective and prospective drug use review in a manner that ensures that such criteria and**
11 **standards are based on compendia, relevant guidelines obtained from professional groups**
12 **through consensus-driven processes, the experience of practitioners with expertise in drug**
13 **therapy, data and experience obtained from drug utilization review program operations. The**
14 **committee shall have an open professional consensus process for establishing and revising**
15 **criteria and standards. Criteria and standards shall be available to the public. In developing**
16 **recommendations for criteria and standards, the committee shall establish an explicit ongo-**
17 **ing process for soliciting and considering input from interested parties. The committee shall**
18 **make timely revisions to the criteria and standards based upon this input in addition to re-**
19 **visions based upon scheduled review of the criteria and standards. Further, the drug utili-**
20 **zation review standards shall reflect the local practices of prescribers in order to monitor:**

21 (A) **Therapeutic appropriateness.**

22 (B) **Overutilization or underutilization.**

23 (C) **Therapeutic duplication.**

24 (D) **Drug-disease contraindications.**

25 (E) **Drug-drug interactions.**

26 (F) **Incorrect drug dosage or drug treatment duration.**

27 (G) **Clinical abuse or misuse.**

28 (H) **Drug allergies.**

29 (d) **Development, selection and application of and assessment for interventions that are**
30 **educational and not punitive in nature for medical assistance program prescribers,**
31 **dispensers and patients.**

32 (2) **In reviewing retrospective and prospective drug use, the committee may consider only**
33 **drugs that have received final approval from the federal Food and Drug Administration.**

34 (3) **The committee shall make recommendations to the authority, subject to approval by**
35 **the Director of the Oregon Health Authority or the director's designee, for drugs to be in-**
36 **cluded on any preferred drug list adopted by the authority and on the Practitioner-Managed**
37 **Prescription Drug Plan. The committee shall also recommend all utilization controls, prior**
38 **authorization requirements or other conditions for the inclusion of a drug on a preferred**
39 **drug list.**

40 (4) **In making recommendations under subsection (3) of this section, the committee may**
41 **use any information the committee deems appropriate. The recommendations must be based**
42 **upon the following factors in order of priority:**

43 (a) **Safety and efficacy of the drug.**

44 (b) **The ability of Oregonians to access effective prescription drugs that are appropriate**
45 **for their clinical conditions.**

1 (c) Substantial differences in the costs of drugs within the same therapeutic class.

2 (5) The committee shall post a recommendation to the website of the authority no later
3 than 30 days after the date the committee approves the recommendation. The director shall
4 approve, disapprove or modify any recommendation of the committee as soon as practicable,
5 shall publish the decision on the website and shall notify persons who have requested notifi-
6 cation of the decision. A recommendation adopted by the director, in whole or in part, with
7 respect to the inclusion of a drug on a preferred drug list or the Practitioner-Managed Pre-
8 scription Drug Plan may not become effective less than 60 days after the date that the
9 director's decision is published.

10 (6) The director shall reconsider any decision to adopt or modify a recommendation of
11 the committee with respect to the inclusion of a particular drug on a preferred drug list or
12 the Practitioner-Managed Prescription Drug Plan, upon the request of any interested person
13 filed no later than 30 days after the director's decision is published on the website. The de-
14 cision on reconsideration shall be sent to the requester and posted to the website without
15 undue delay.

16 **SECTION 5.** In addition to the duties described in section 4 of this 2011 Act, the Phar-
17 macy and Therapeutics Committee shall do the following subject to the approval of the Di-
18 rector of the Oregon Health Authority:

19 (1) Publish an annual report, as described in section 12 of this 2011 Act.

20 (2) Publish and disseminate educational information to prescribers and pharmacists re-
21 garding the committee and the drug use review programs, including information on the fol-
22 lowing:

23 (a) Identifying and reducing the frequency of patterns of fraud, abuse or inappropriate
24 or medically unnecessary care among prescribers, pharmacists and recipients.

25 (b) Potential or actual severe or adverse reactions to drugs.

26 (c) Therapeutic appropriateness.

27 (d) Overutilization or underutilization.

28 (e) Appropriate use of generic products.

29 (f) Therapeutic duplication.

30 (g) Drug-disease contraindications.

31 (h) Drug-drug interactions.

32 (i) Drug allergy interactions.

33 (j) Clinical abuse and misuse.

34 (3) Adopt and implement procedures designed to ensure the confidentiality of any infor-
35 mation that identifies individual prescribers, pharmacists or recipients and that is collected,
36 stored, retrieved, assessed or analyzed by the committee, staff of the committee, the Oregon
37 Health Authority or contractors to the committee or the authority.

38 **SECTION 6.** In appropriate instances, interventions developed under section 4 (1)(d) of
39 this 2011 Act may include the following:

40 (1) Information disseminated to prescribers and pharmacists to ensure that they are
41 aware of the duties and powers of the Pharmacy and Therapeutics Committee.

42 (2) Written, oral or electronic reminders of recipient-specific or drug-specific information
43 that are designed to ensure recipient, prescriber and pharmacist confidentiality, and sug-
44 gested changes in the prescribing or dispensing practices designed to improve the quality of
45 care.

1 (3) Face-to-face discussions between experts in drug therapy and the prescriber or
2 pharmacist who has been targeted for educational intervention.

3 (4) Intensified reviews or monitoring of selected prescribers or pharmacists.

4 (5) Educational outreach through the retrospective program focusing on improvement
5 of prescribing and dispensing practices.

6 (6) The timely evaluation of interventions to determine if the interventions have im-
7 proved the quality of care.

8 (7) The review of case profiles before the conducting of an intervention.

9 **SECTION 7.** The prospective drug use review program must use guidelines established
10 by the Oregon Health Authority that are based on the recommendations of the Pharmacy
11 and Therapeutics Committee. The program must ensure that prior to the prescription being
12 filled or delivered a review will be conducted by the pharmacist at the point of sale to screen
13 for potential drug therapy problems resulting from the following:

14 (1) Therapeutic duplication.

15 (2) Drug-drug interactions, including serious interactions with nonprescription or over-
16 the-counter drugs.

17 (3) Incorrect dosage and duration of treatment.

18 (4) Drug-allergy interactions.

19 (5) Clinical abuse and misuse.

20 (6) Drug-disease contraindications.

21 **SECTION 8.** The retrospective drug use review program must use:

22 (1) Guidelines established by the Oregon Health Authority that are based on the recom-
23 mendations of the Pharmacy and Therapeutics Committee; and

24 (2) The mechanized drug claims processing and information retrieval system to analyze
25 claims data on drug use against explicit predetermined standards that are based on
26 compendia and other sources to monitor the following:

27 (a) Therapeutic appropriateness.

28 (b) Overutilization or underutilization.

29 (c) Fraud and abuse.

30 (d) Therapeutic duplication.

31 (e) Drug-disease contraindications.

32 (f) Drug-drug interactions.

33 (g) Incorrect drug dosage or duration of drug treatment.

34 (h) Clinical abuse and misuse.

35 **SECTION 9.** (1) Information collected under sections 1 to 12 of this 2011 Act that identi-
36 fies an individual is confidential and may not be disclosed by the Pharmacy and Therapeutics
37 Committee, the retrospective program or the Oregon Health Authority to any person other
38 than a health care provider appearing on a recipient's medication profile.

39 (2) The staff of the committee may have access to identifying information for purposes
40 of carrying out intervention activities. The identifying information may not be released to
41 anyone other than a staff member of the committee, the retrospective program, the au-
42 thority or a health care provider appearing on a recipient's medication profile or, for pur-
43 poses of investigating potential fraud in programs administered by the authority, the
44 Department of Justice.

45 (3) The committee may release cumulative, nonidentifying information for the purposes

1 of legitimate research and for educational purposes.

2 **SECTION 10.** (1) Notwithstanding ORS 192.610 to 192.690, the Pharmacy and Therapeutics
3 Committee shall meet in an executive session for purposes of:

4 (a) Reviewing the prescribing or dispensing practices of individual physicians or
5 pharmacists;

6 (b) Discussing drug use review data pertaining to individual physicians or pharmacists;

7 (c) Reviewing profiles of individual patients; or

8 (d) Reviewing confidential drug pricing information, including substantial cost differences
9 between drugs within the same therapeutic class, that is necessary for the committee to
10 make final recommendations under section 4 of this 2011 Act or to comply with section 9 of
11 this 2011 Act.

12 (2) A meeting held in executive session is subject to the requirements of ORS 192.650 (2).

13 **SECTION 11.** (1) Except as provided in section 10 of this 2011 Act, the Pharmacy and
14 Therapeutics Committee shall operate in accordance with ORS chapter 192. The committee
15 shall annually elect a chairperson from the members of the committee.

16 (2) A committee member is not entitled to compensation but is entitled to reimbursement
17 for actual and necessary travel expenses incurred in connection with the member's duties,
18 pursuant to ORS 292.495.

19 (3) A quorum consists of six members of the committee.

20 (4) The committee may establish advisory committees to assist in carrying out the
21 committee's duties under sections 1 to 12 of this 2011 Act, with the approval of the Director
22 of the Oregon Health Authority.

23 (5) The Oregon Health Authority shall provide staff and support services to the commit-
24 tee.

25 (6) The committee shall meet no less than four times each year at a place, day and hour
26 determined by the director. The committee also shall meet at other times and places speci-
27 fied by the call of the director or a majority of the members of the committee. No less than
28 30 days prior to a meeting the committee shall post to the authority website:

29 (a) The agenda for the meeting;

30 (b) A list of the drug classes to be considered at the meeting; and

31 (c) Background materials and supporting documentation provided to committee members
32 with respect to drugs and drug classes that are before the committee for review.

33 (7) The committee shall provide appropriate opportunity for public testimony at each
34 regularly scheduled committee meeting. Immediately prior to deliberating on any recom-
35 mendations regarding a drug or a class of drugs, the committee shall accept testimony, in
36 writing or in person, that is offered by a manufacturer of those drugs or another interested
37 party.

38 (8) The committee may consider more than 20 classes of drugs at a meeting only if:

39 (a) There is no new clinical evidence for the additional class of drugs; and

40 (b) The committee is considering only substantial cost differences between drugs within
41 the same therapeutic class.

42 **SECTION 12.** (1) The annual report required under section 5 (1) of this 2011 Act is subject
43 to public comment prior to its submission to the Director of the Oregon Health Authority
44 and must include the following:

45 (a) An overview of the activities of the Pharmacy and Therapeutics Committee and the

1 prospective and retrospective programs;

2 (b) A summary of interventions made, including the number of cases brought before the
3 committee and the number of interventions made;

4 (c) An assessment of the impact of the interventions, criteria and standards used, in-
5 cluding an overall assessment of the impact of the educational programs and interventions
6 on prescribing and dispensing patterns;

7 (d) An assessment of the impact of the criteria, standards and educational interventions
8 on quality of care; and

9 (e) An estimate of the cost savings generated as a result of the prospective and retro-
10 spective programs, including an overview of the fiscal impact of the programs to other areas
11 of the medical assistance program such as hospitalization or long term care costs. This
12 analysis should include a cost-benefit analysis of both the prospective and retrospective
13 programs and should take into account the administrative costs of the drug utilization re-
14 view program.

15 (2) Copies of the annual report shall be submitted to the President of the Senate, the
16 Speaker of the House of Representatives and other persons who request copies of the report.

17
18 **DRUG USE REVIEW BOARD ABOLISHED**

19
20 **SECTION 13.** (1) The Drug Use Review Board is abolished. On the operative date of this
21 section, the tenure of office of the members of the Drug Use Review Board ceases.

22 (2) All the duties, functions and powers of the Drug Use Review Board are imposed upon,
23 transferred to and vested in the Pharmacy and Therapeutics Committee.

24 **SECTION 14.** (1) The Director of the Oregon Health Authority shall:

25 (a) Deliver to the Pharmacy and Therapeutics Committee all records and property within
26 the jurisdiction of the Drug Use Review Board that relate to the duties, functions and powers
27 transferred by section 13 of this 2011 Act; and

28 (b) Transfer to the committee those employees engaged primarily in the exercise of the
29 duties, functions and powers transferred by section 13 of this 2011 Act.

30 (2) The committee shall take possession of the records and property and shall take
31 charge of the employees and employ them, in the exercise of the duties, functions and powers
32 transferred by section 13 of this 2011 Act, without reduction of compensation but subject to
33 change or termination of employment or compensation as provided by law.

34 (3) The director shall resolve any dispute between the Drug Use Review Board and the
35 Pharmacy and Therapeutics Committee relating to transfers of records, property and em-
36 ployees under this section, and the director's decision is final.

37 **SECTION 15.** (1) The unexpended balances of amounts authorized to be expended by the
38 Drug Use Review Board for the biennium beginning July 1, 2011, from revenues dedicated,
39 continuously appropriated, appropriated or otherwise made available for the purpose of ad-
40 ministering and enforcing the duties, functions and powers transferred by section 13 of this
41 2011 Act are transferred to and are available for expenditure by the Pharmacy and
42 Therapeutics Committee for the remainder of the biennium beginning July 1, 2011, for the
43 purpose of administering and enforcing the duties, functions and powers transferred by sec-
44 tion 13 of this 2011 Act.

45 (2) The expenditure classifications, if any, established by Acts authorizing or limiting

1 expenditures by the board remain applicable to expenditures by the committee under this
2 section.

3 **SECTION 16.** The transfer of duties, functions and powers to the Pharmacy and
4 Therapeutics Committee by section 13 of this 2011 Act does not affect any action, proceeding
5 or prosecution involving or with respect to such duties, functions and powers begun before
6 and pending at the time of the transfer, except that the committee is substituted for the
7 Drug Use Review Board in the action, proceeding or prosecution.

8 **SECTION 17.** (1) Nothing in sections 1 to 16 of this 2011 Act or the repeal of ORS 414.350,
9 414.355, 414.360, 414.365, 414.370, 414.375, 414.380, 414.385, 414.390, 414.395, 414.400, 414.410 or
10 414.415 by section 228 of this 2011 Act relieves a person of a liability, duty or obligation ac-
11 cruing under or with respect to the duties, functions and powers transferred by section 13
12 of this 2011 Act. The Pharmacy and Therapeutics Committee may undertake the collection
13 or enforcement of any such liability, duty or obligation.

14 (2) The rights and obligations of the Drug Use Review Board legally incurred under con-
15 tracts, leases and business transactions executed, entered into or begun before the operative
16 date of section 13 of this 2011 Act are transferred to the Pharmacy and Therapeutics Com-
17 mittee. For the purpose of succession to these rights and obligations, the Pharmacy and
18 Therapeutics Committee is a continuation of the Drug Use Review Board and is not a new
19 authority.

20 **SECTION 18.** Whenever, in any uncodified law or resolution of the Legislative Assembly
21 or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-
22 erence is made to the Drug Use Review Board or an officer or employee of the Drug Use
23 Review Board, the reference is considered to be a reference to the Pharmacy and
24 Therapeutics Committee or an officer or employee of the Pharmacy and Therapeutics Com-
25 mittee.

26 **SECTION 19.** For the purpose of harmonizing and clarifying statutory law, the Legislative
27 Counsel may substitute for words designating the “Drug Use Review Board” or its officers,
28 wherever they occur in statutory law, words designating the “Pharmacy and Therapeutics
29 Committee” or its officers.

30 **SECTION 20.** The Director of the Oregon Health Authority may take any action before
31 the operative date specified in section 21 of this 2011 Act that is necessary to enable the
32 Pharmacy and Therapeutics Committee to exercise, on and after the operative date of sec-
33 tion 13 of this 2011 Act, the duties, functions and powers of the committee pursuant to sec-
34 tion 13 of this 2011 Act.

35 **SECTION 21.** Except as otherwise specifically provided in section 20 of this 2011 Act,
36 sections 1 to 16 of this 2011 Act become operative 31 calendar days after the effective date
37 of this 2011 Act.

38
39 **HEALTH EVIDENCE REVIEW COMMISSION**
40

41 **SECTION 22.** (1) As used in this section:

42 (a) “Practice of pharmacy” has the meaning given that term in ORS 689.005.

43 (b) “Retail drug outlet” has the meaning given that term in ORS 689.005.

44 (2) The Health Evidence Review Commission is established in the Oregon Health Au-
45 thority, consisting of 13 members appointed by the Governor in consultation with profes-

1 sional and other interested organizations, and confirmed by the Senate, as follows:

2 (a) Five members must be physicians licensed to practice medicine in this state who have
3 clinical expertise in the areas of family medicine, internal medicine, obstetrics, perinatal
4 health, pediatrics, disabilities, geriatrics or general surgery. One of the physicians must be
5 a doctor of osteopathy, and one must be a hospital representative or a physician whose
6 practice is significantly hospital-based.

7 (b) One member must be a dentist licensed under ORS chapter 679 who has clinical ex-
8 pertise in general, pediatric or public health dentistry.

9 (c) One member must be a public health nurse.

10 (d) One member must be a behavioral health representative who may be a social services
11 worker, alcohol and drug treatment provider, psychologist or psychiatrist.

12 (e) Two members must be consumers of health care who are patient advocates or rep-
13 resent the areas of indigent services, labor, business, education or corrections.

14 (f) One member must be a complementary or alternative medicine provider who is a
15 chiropractic physician licensed under ORS chapter 684, a naturopathic physician licensed
16 under ORS chapter 685 or an acupuncturist licensed under ORS chapter 677.

17 (g) One member must be an insurance industry representative who may be a medical
18 director or other administrator.

19 (h) One member must be a pharmacy representative who engages in the practice of
20 pharmacy at a retail drug outlet.

21 (3) No more than six members of the commission may be physicians either in active
22 practice or retired from practice.

23 (4) Members of the commission serve for a term of four years at the pleasure of the
24 Governor. A member is eligible for reappointment.

25 (5) Members are not entitled to compensation, but may be reimbursed for actual and
26 necessary travel and other expenses incurred by them in the performance of their official
27 duties in the manner and amounts provided for in ORS 292.495. Claims for expenses shall be
28 paid out of funds available to the Oregon Health Authority for purposes of the commission.

29 **SECTION 23.** (1) The Health Evidence Review Commission shall select one of its members
30 as chairperson and another as vice chairperson, for terms and with duties and powers the
31 commission determines necessary for the performance of the functions of the offices.

32 (2) A majority of the members of the commission constitutes a quorum for the trans-
33 action of business.

34 (3) The commission shall meet at least four times per year at a place, day and hour de-
35 termined by the chairperson. The commission also shall meet at other times and places
36 specified by the call of the chairperson or of a majority of the members of the commission.

37 (4) The commission may use advisory committees or subcommittees whose members are
38 appointed by the chairperson of the commission subject to approval by a majority of the
39 members of the commission. The advisory committees or subcommittees may contain ex-
40 perts appointed by the chairperson and a majority of the members of the commission. The
41 conditions of service of the experts will be determined by the chairperson and a majority of
42 the members of the commission.

43 (5) The Office for Oregon Health Policy and Research shall provide staff and support
44 services to the commission.

45 **SECTION 24.** (1) The Health Evidence Review Commission shall regularly solicit testi-

1 mony and information from stakeholders representing consumers, advocates, providers,
2 carriers and employers in conducting the work of the commission.

3 (2) The commission shall actively solicit public involvement through a public meeting
4 process to guide health resource allocation decisions.

5 (3) The commission shall develop and maintain a list of health services ranked by prior-
6 ity, from the most important to the least important, representing the comparative benefits
7 of each service to the population to be served. The list must be submitted by the commission
8 pursuant to subsection (5) of this section and is not subject to alteration by any other state
9 agency.

10 (4) In order to encourage effective and efficient medical evaluation and treatment, the
11 commission:

12 (a) May include clinical practice guidelines in its prioritized list of services. The com-
13 mission shall actively solicit testimony and information from the medical community and the
14 public to build a consensus on clinical practice guidelines developed by the commission.

15 (b) May include statements of intent in its prioritized list of services. Statements of in-
16 tent should give direction on coverage decisions where medical codes and clinical practice
17 guidelines cannot convey the intent of the commission.

18 (c) Shall consider both the clinical effectiveness and cost-effectiveness of health services,
19 including drug therapies, in determining their relative importance using peer-reviewed med-
20 ical literature as defined in ORS 743A.060.

21 (5) The commission shall report the prioritized list of services to the Oregon Health Au-
22 thority for budget determinations by July 1 of each even-numbered year.

23 (6) The commission shall make its report during each regular session of the Legislative
24 Assembly and shall submit a copy of its report to the Governor, the Speaker of the House
25 of Representatives and the President of the Senate.

26 (7) The commission may alter the list during the interim only as follows:

27 (a) To make technical changes to correct errors and omissions;

28 (b) To accommodate changes due to advancements in medical technology or new data
29 regarding health outcomes;

30 (c) To accommodate changes to clinical practice guidelines; and

31 (d) To add statements of intent that clarify the prioritized list.

32 (8) If a service is deleted or added during an interim and no new funding is required, the
33 commission shall report to the Speaker of the House of Representatives and the President
34 of the Senate. However, if a service to be added requires increased funding to avoid discon-
35 tinuing another service, the commission shall report to the Emergency Board to request the
36 funding.

37 (9) The prioritized list of services remains in effect for a two-year period beginning no
38 earlier than October 1 of each odd-numbered year.

39 **SECTION 25.** (1) As used in this section and section 26 of this 2011 Act:

40 (a) "Medical technology" means medical equipment and devices, medical or surgical pro-
41 cedures and techniques used by health care providers in delivering medical care to individ-
42 uals, and the organizational or supportive systems within which medical care is delivered.

43 (b) "Medical technology assessment" means evaluation of the use, clinical effectiveness
44 and cost of a technology in comparison with its alternatives.

45 (2) The Health Evidence Review Commission shall develop a medical technology assess-

1 ment process. The Oregon Health Authority shall direct the commission with regard to
2 medical technologies to be assessed and the timing of the assessments.

3 (3) The commission shall appoint and work with an advisory committee whose members
4 have the appropriate expertise to conduct a medical technology assessment.

5 (4) The commission shall present its preliminary findings at a public hearing and shall
6 solicit testimony and information from health care consumers. The commission shall give
7 strong consideration to the recommendations of the advisory committee and public testi-
8 mony in developing its assessment.

9 (5) To ensure that confidentiality is maintained, identification of a patient or a person
10 licensed to provide health services may not be included with the data submitted under this
11 section, and the commission shall release such data only in aggregate statistical form. All
12 findings and conclusions, interviews, reports, studies, communications and statements pro-
13 cured by or furnished to the commission in connection with obtaining the data necessary to
14 perform its functions is confidential pursuant to ORS 192.501 to 192.505.

15 **SECTION 26.** (1) The Health Evidence Review Commission shall conduct comparative ef-
16 fectiveness research of medical technologies selected in accordance with section 25 of this
17 2011 Act. The commission may conduct the research by comprehensive review of the com-
18 parative effectiveness research undertaken by recognized state, national or international
19 entities. The commission may consider evidence relating to prescription drugs that is rele-
20 vant to a medical technology assessment but may not conduct a drug class evidence review
21 or medical technology assessment solely of a prescription drug. The commission shall dis-
22 seminate the research findings to health care consumers, providers and third-party payers
23 and to other interested stakeholders.

24 (2) The commission shall develop or identify and shall disseminate evidence-based health
25 care guidelines for use by providers, consumers and purchasers of health care in Oregon.

26 (3) The Oregon Health Authority shall vigorously pursue health care purchasing strate-
27 gies that adopt the research findings described in subsection (1) of this section and the
28 evidence-based health care guidelines described in subsection (2) of this section.

29 **SECTION 26a.** The Health Evidence Review Commission, in ranking health services or
30 developing guidelines under section 24 of this 2011 Act or in assessing medical technologies
31 under section 26 of this 2011 Act, and the Pharmacy and Therapeutics Committee, in con-
32 sidering a recommendation for a drug to be included on any preferred drug list or on the
33 Practitioner-Managed Prescription Drug Plan, may not rely solely on the results of compar-
34 ative effectiveness research.

35
36 **HEALTH RESOURCES COMMISSION AND**
37 **HEALTH SERVICES COMMISSION ABOLISHED**
38

39 **SECTION 27.** (1) The Health Resources Commission and the Health Services Commission
40 are abolished. On the operative date of this section, the tenure of office of the members of
41 the Health Resources Commission and the Health Services Commission ceases.

42 (2) All the duties, functions and powers of the Health Resources Commission and the
43 Health Services Commission are imposed upon, transferred to and vested in the Health Evi-
44 dence Review Commission.

45 **SECTION 28.** (1) The Director of the Oregon Health Authority shall:

1 (a) Deliver to the Health Evidence Review Commission all records and property within
2 the jurisdiction of the director that relate to the duties, functions and powers transferred
3 by section 27 of this 2011 Act; and

4 (b) Transfer to the commission those employees engaged primarily in the exercise of the
5 duties, functions and powers transferred by section 27 of this 2011 Act.

6 (2) The commission shall take possession of the records and property and shall take
7 charge of the employees and employ them, in the exercise of the duties, functions and powers
8 transferred by section 27 of this 2011 Act, without reduction of compensation but subject to
9 change or termination of employment or compensation as provided by law.

10 (3) The director shall resolve any dispute between the Health Resources Commission and
11 the Health Services Commission and the Health Evidence Review Commission relating to
12 transfers of records, property and employees under this section, and the director's decision
13 is final.

14 **SECTION 29.** (1) The unexpended balances of amounts authorized to be expended by the
15 Health Resources Commission and the Health Services Commission for the biennium begin-
16 ning July 1, 2011, from revenues dedicated, continuously appropriated, appropriated or oth-
17 erwise made available for the purpose of administering and enforcing the duties, functions
18 and powers transferred by section 27 of this 2011 Act are transferred to and are available for
19 expenditure by the Health Evidence Review Commission for the remainder of the biennium
20 beginning July 1, 2011, for the purpose of administering and enforcing the duties, functions
21 and powers transferred by section 27 of this 2011 Act.

22 (2) The expenditure classifications, if any, established by Acts authorizing or limiting
23 expenditures by the Health Resources Commission and the Health Services Commission re-
24 main applicable to expenditures by the Health Evidence Review Commission under this sec-
25 tion.

26 **SECTION 30.** The transfer of duties, functions and powers to the Health Evidence Review
27 Commission by section 27 of this 2011 Act does not affect any action, proceeding or prose-
28 cution involving or with respect to such duties, functions and powers begun before and
29 pending at the time of the transfer, except that the Health Evidence Review Commission is
30 substituted for the Health Resources Commission or the Health Services Commission in the
31 action, proceeding or prosecution.

32 **SECTION 31.** (1) Nothing in sections 22 to 30 of this 2011 Act or the repeal of ORS 414.715,
33 414.720, 414.741, 442.575, 442.580, 442.581, 442.583, 442.584, 442.588 and 442.589 by section 228 of
34 this 2011 Act relieves a person of a liability, duty or obligation accruing under or with respect
35 to the duties, functions and powers transferred by section 27 of this 2011 Act. The Health
36 Evidence Review Commission may undertake the collection or enforcement of any such li-
37 ability, duty or obligation.

38 (2) The rights and obligations of the Health Resources Commission and the Health Ser-
39 vices Commission legally incurred under contracts, leases and business transactions exe-
40 cuted, entered into or begun before the operative date of section 27 of this 2011 Act are
41 transferred to the Health Evidence Review Commission. For the purpose of succession to
42 these rights and obligations, the Health Evidence Review Commission is a continuation of the
43 Health Resources Commission and the Health Services Commission and is not a new au-
44 thority.

45 **SECTION 32.** The Director of the Oregon Health Authority may take any action before

1 the operative date of section 27 of this 2011 Act that is necessary to enable the Health Evi-
2 dence Review Commission to exercise, on and after the operative date of section 27 of this
3 2011 Act, the duties, functions and powers of the commission pursuant to section 27 of this
4 2011 Act.

5 **SECTION 33.** Whenever, in any uncodified law or resolution of the Legislative Assembly
6 or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-
7 erence is made to the Health Resources Commission or the Health Services Commission or
8 an officer or employee of the Health Resources Commission or the Health Services Com-
9 mission, the reference is considered to be a reference to the Health Evidence Review Com-
10 mission or an officer or employee of the Health Evidence Review Commission.

11 **SECTION 34.** For the purpose of harmonizing and clarifying statutory law, the Legislative
12 Counsel may substitute for words designating the “Health Resources Commission” or the
13 “Health Services Commission” or the officers of the Health Resources Commission or the
14 Health Services Commission, wherever they occur in statutory law, words designating the
15 “Health Evidence Review Commission” or its officers.

16 **SECTION 35.** Except as otherwise specifically provided in section 32 of this 2011 Act,
17 sections 22 to 30 of this 2011 Act become operative on January 1, 2012.

18
19 **OREGON HEALTH AUTHORITY FINANCIAL ADMINISTRATION**
20

21 **SECTION 36.** Notwithstanding any other provision of law, federal laws shall govern the
22 administration of federally granted funds. The Director of the Oregon Health Authority may
23 request a waiver of any federal law in order to fully implement provisions of state law using
24 federally granted funds.

25 **SECTION 37.** (1) There is established an Oregon Health Authority Special Checking Ac-
26 count in the State Treasury. Upon the written request of the Director of the Oregon Health
27 Authority, the Oregon Department of Administrative Services shall draw payments in favor
28 of the authority to be charged against appropriations and other moneys available to the au-
29 thority in the same manner as other claims against the state, as provided in ORS chapter
30 293. All such payments shall be deposited in the special checking account and may be dis-
31 bursed by check or other means acceptable to the State Treasurer.

32 (2) The special checking account may be used for the purpose of paying the administra-
33 tive expenses of programs and services as assigned to the authority by law, including the
34 payment of expenses to be reimbursed by the federal government.

35 (3) In addition to funds authorized under ORS 293.180, the authority may establish petty
36 cash funds out of the special checking account or any account established in the State
37 Treasury for the authority. The authority may pay expenses using small cash disbursements
38 from a petty cash fund. Periodically, the authority shall request reimbursement for dis-
39 bursements made from a petty cash fund. Upon receipt of a reimbursement payment from
40 an appropriate account, the authority shall use the payment to reimburse the petty cash
41 fund.

42 **SECTION 38.** Notwithstanding any other law, the Oregon Health Authority may, with the
43 approval of the Oregon Department of Administrative Services and the State Treasurer,
44 combine or eliminate any accounts that are established in statute and appropriated to the
45 authority if economy and efficiency in operations can be obtained and the combination or

1 elimination of accounts does not substantially alter the intent of the authorizing statutes.
2 When accounts are combined, the Oregon Health Authority retains the authority granted
3 by the statutes establishing the accounts.

4 **SECTION 39.** The Oregon Department of Administrative Services shall draw warrants in
5 favor of the Oregon Health Authority for the aggregate amounts of the authority's expenses.
6 The authority shall deposit the warrants in the State Treasury in a checking account in re-
7 imbursement of those expenses. The authority may draw its checks on the State Treasury
8 in favor of the persons, firms, corporations, associations or counties entitled to payment
9 under rules of the authority so as to include in single combined payments for specified peri-
10 ods all moneys allotted to particular payees from various sources for the period.

11 **SECTION 40.** (1) On written request of the Oregon Health Authority, the Oregon De-
12 partment of Administrative Services shall draw warrants on amounts appropriated to the
13 authority for operating expenses for use by the authority as a revolving fund. The revolving
14 fund may not exceed the aggregate sum of \$100,000 including unreimbursed advances. The
15 revolving fund shall be deposited with the State Treasurer to be held in a special account
16 against which the authority may draw checks.

17 (2) The revolving fund may be used by the authority:

18 (a) To pay for or advance travel expenses for employees of the authority and for any
19 consultants or advisers for whom payment of travel expenses is authorized by law;

20 (b) For purchases required from time to time; or

21 (c) For receipt or disbursement of federal funds available under federal law.

22 (3) All claims for reimbursement of amounts paid from the revolving fund must be ap-
23 proved by the authority and by the department. When such claims are approved, the de-
24 partment shall draw a warrant covering them against the appropriate fund or account in
25 favor of the authority. The authority shall use the moneys to reimburse the revolving fund.

26
27 **ADMINISTRATION OF HUMAN SERVICES**
28

29 **SECTION 41.** (1) As used in this section:

30 (a) "Adult foster home" has the meaning given that term in ORS 443.705.

31 (b) "Health care facility" has the meaning given that term in ORS 442.015.

32 (c) "Residential facility" has the meaning given that term in ORS 443.400.

33 (2) Every adult foster home, health care facility and residential facility licensed or reg-
34 istered by the Oregon Health Authority shall:

35 (a) Adopt a plan to provide for the safety of persons who are receiving care at or are
36 residents of the home or facility in the event of an emergency that requires immediate action
37 by the staff of the home or facility due to conditions of imminent danger that pose a threat
38 to the life, health or safety of persons who are receiving care at or are residents of the home
39 or facility; and

40 (b) Provide training to all employees of the home or facility about the responsibilities of
41 the employees to implement the plan required by this section.

42 (3) The authority shall adopt by rule the requirements for the plan and training required
43 by this section. The rules adopted shall include, but are not limited to, procedures for the
44 evacuation of the persons who are receiving care at or are residents of the adult foster
45 home, health care facility or residential facility to a place of safety when the conditions of

1 imminent danger require relocation of those persons.

2 **SECTION 42.** (1) As used in this section, “family member” means any individual related
3 by blood, marriage or adoption to a person whose cremated remains are in the possession
4 of the Oregon Health Authority.

5 (2) Notwithstanding any other provision of law, the authority shall disclose to the general
6 public the name and the dates of birth and death of a person whose cremated remains are
7 in the possession of the authority for the purpose of:

8 (a) Giving a family member of the person an opportunity to claim the cremated remains;
9 or

10 (b) Creating a memorial for those persons whose cremated remains are not claimed.

11 (3) If an individual contacts the authority to determine whether the authority is in pos-
12 session of the cremated remains of a family member of the individual and the authority de-
13 termines that the authority is in possession of the cremated remains, the authority shall
14 disclose to the individual that the authority is in possession of the cremated remains and
15 offer the individual the opportunity to claim the remains.

16 **SECTION 43.** Liquidated and delinquent debts owed to the Oregon Health Authority may
17 be set off against amounts owed by the authority to the debtors.

18 **SECTION 44.** (1) Notwithstanding ORS 8.690, 9.160, 9.320 or 203.145 or ORS chapter 180
19 or other law, in any contested case proceeding before the Oregon Health Authority, a cor-
20 poration may be represented by an attorney or by any officer or authorized agent or em-
21 ployee of the corporation.

22 (2) As used in this section, “corporation” includes a public or private corporation,
23 whether or not organized for profit.

24 **SECTION 45.** (1) The Oregon Health Authority may accept funds, money or other valu-
25 able things from relatives, corporations or interested persons or organizations for the care
26 and support of needy persons and may expend the same for the care and support of the in-
27 dividual or individuals for whom the moneys were paid.

28 (2) The authority may accept from individuals, corporations and organizations contribu-
29 tions or gifts in cash or otherwise that shall be disbursed in the same manner as moneys
30 appropriated for public assistance purposes, unless the donor of a gift stipulates a different
31 manner in which a gift must be expended. Moneys received under this section shall be de-
32 posited with the State Treasurer in an account separate and distinct from the General Fund.
33 Interest earned by the account shall be credited to the account. Moneys in the account are
34 continuously appropriated to the department for the purposes specified in this section.

35 **SECTION 46.** All sums of money recovered by or paid to the Oregon Health Authority
36 as reimbursement for funds expended for medical assistance shall be paid into the Oregon
37 Health Authority Fund established by ORS 413.031 and may be used for the provision and
38 administration of medical assistance. However, the United States Government is entitled to
39 a share of any amount received as its interest may appear, which shall be promptly paid to
40 the United States Government.

41 **SECTION 47.** In addition to its other powers, the Oregon Health Authority may:

42 (1) Enter into agreements with, join with or accept grants from the federal government
43 for cooperative research and demonstration projects for health and health care purposes,
44 including, but not limited to, any project that:

45 (a) Improves the lifelong health of Oregonians.

1 **(b) Aids in effecting coordination of planning between private and public health and**
2 **health care agencies of the state.**

3 **(c) Improves the administration and effectiveness of programs carried on or assisted by**
4 **the authority.**

5 **(2) With the cooperation and the financial assistance of the federal government, train**
6 **personnel employed or preparing for employment by the authority. The training may be**
7 **carried out in any manner, including but not limited to:**

8 **(a) Directly by the authority.**

9 **(b) Indirectly through grants to public or other nonprofit institutions of learning or**
10 **through grants of fellowships.**

11 **(c) Any other manner for which federal aid in support of the training is available.**

12 **(3) Subject to the allotment system provided for in ORS 291.234 to 291.260, expend the**
13 **sums required to be expended for the programs and projects described in subsections (1) and**
14 **(2) of this section.**

15 **SECTION 48.** **(1) The Oregon Health Authority shall adopt and enforce rules governing**
16 **the custody, use and preservation of the records, papers, files and communications of the**
17 **authority in accordance with applicable privacy laws. The use of the records, papers, files**
18 **and communications is limited to the purposes for which they are furnished and by the pro-**
19 **visions of law under which they may be furnished.**

20 **(2) The records, papers, files and communications of the authority may be maintained in**
21 **a single or combined data system accessible to the authority and to the Department of Hu-**
22 **man Services for the administration of programs and the coordination of functions shared**
23 **by the authority and the department.**

24 **SECTION 49.** **(1) For the protection of applicants for and recipients of public assistance,**
25 **except as otherwise provided in this section, the Oregon Health Authority may not disclose**
26 **or use the contents of any public assistance records, files, papers or communications for**
27 **purposes other than those directly connected with the administration of the public assistance**
28 **programs or necessary to assist public assistance applicants and recipients in accessing and**
29 **receiving other governmental or private nonprofit services, and these records, files, papers**
30 **and communications are considered confidential subject to the rules of the authority. In any**
31 **judicial or administrative proceeding, except proceedings directly connected with the admin-**
32 **istration of public assistance or child support enforcement, their contents are considered**
33 **privileged communications.**

34 **(2) Nothing in this section prohibits the disclosure or use of contents of records, files,**
35 **papers or communications for purposes directly connected with the establishment and**
36 **enforcement of support obligations pursuant to the Title IV-D of the Social Security Act.**

37 **(3) Nothing in this section prohibits the disclosure of the address, Social Security number**
38 **and photograph of any applicant or recipient to a law enforcement officer at the request of**
39 **the officer. To receive information pursuant to this section, the officer must furnish the**
40 **agency the name of the applicant or recipient and advise that the applicant or recipient:**

41 **(a) Is fleeing to avoid prosecution, custody or confinement after conviction for a felony;**

42 **(b) Is violating a condition of probation or parole; or**

43 **(c) Has information that is necessary for the officer to conduct the official duties of the**
44 **officer and the location or apprehension of the applicant or recipient is within such official**
45 **duties.**

1 (4) Nothing in this section prohibits disclosure of information between the authority and

17 (B) Identifiable to an individual, including demographic information that identifies the individual,
18 or for which there is a reasonable basis to believe the information can be used to identify an indi-
19 vidual, and that relates to:

20 (i) The past, present or future physical or mental health or condition of an individual;

21 (ii) The provision of health care to an individual; or

22 (iii) The past, present or future payment for the provision of health care to an individual.

23 (d) "Personal representative" includes but is not limited to:

24 (A) A person appointed as a guardian under ORS 125.305, 419B.370, 419C.481 or 419C.555 with
25 authority to make medical and health care decisions;

26 (B) A person appointed as a health care representative under ORS 127.505 to 127.660 or a rep-
27 resentative under ORS 127.700 to 127.737 to make health care decisions or mental health treatment
28 decisions; and

29 (C) A person appointed as a personal representative under ORS chapter 113.

30 (e) "Psychotherapy notes" means notes recorded in any medium:

31 (A) By a mental health professional, in the performance of the official duties of the mental
32 health professional;

33 (B) Documenting or analyzing the contents of conversation during a counseling session; and

34 (C) That are maintained separately from the rest of the individual's record.

35 (f) "Psychotherapy notes" does not mean notes documenting:

36 (A) Medication prescription and monitoring;

37 (B) Counseling session start and stop times;

38 (C) Modalities and frequencies of treatment furnished;

39 (D) Results of clinical tests; or

40 (E) Any summary of the following items:

41 (i) Diagnosis;

42 (ii) Functional status;

43 (iii) Treatment plan;

44 (iv) Symptoms;

45 (v) Prognosis; or

- 1 (vi) Progress to date.
- 2 (g) "Public provider" means:
 - 3 (A) The Blue Mountain Recovery Center, the Eastern Oregon Training Center and the Oregon
 - 4 State Hospital campuses;
 - 5 (B) Department of Corrections institutions as defined in ORS 421.005;
 - 6 (C) A contractor of the Department of Corrections, the Department of Human Services or the
 - 7 Oregon Health Authority that provides health care to individuals residing in a state institution op-
 - 8 erated by the agencies;
 - 9 (D) A community mental health program or community developmental disabilities program as
 - 10 described in ORS 430.610 to 430.695 and the public and private entities with which it contracts to
 - 11 provide mental health or developmental disabilities programs or services;
 - 12 (E) A program or service provided under ORS 431.250, 431.375 to 431.385 or 431.416;
 - 13 (F) A program or service established or maintained under ORS 430.630 **or section 174 of this**
 - 14 **2011 Act**;
 - 15 (G) A program or facility providing an organized full-day or part-day program of treatment that
 - 16 is licensed, approved, established, maintained or operated by or contracted with the Oregon Health
 - 17 Authority for alcoholism, drug addiction or mental or emotional disturbance;
 - 18 (H) A program or service providing treatment by appointment that is licensed, approved, estab-
 - 19 lished, maintained or operated by or contracted with the authority for alcoholism, drug addiction
 - 20 or mental or emotional disturbance; or
 - 21 (I) The impaired health professional program established under ORS 676.190.
- 22 (h) "Written account" means records containing only individually identifiable health information.
- 23 (2) Except as provided in subsections (3), (4), (6), (7), (8), (9), (11), (12), (14), (15), (16) and (17) of
- 24 this section or unless otherwise permitted or required by state or federal law or by order of the
- 25 court, written accounts of the individuals served by any health care services provider maintained
- 26 in or by the health care services provider by the officers or employees thereof who are authorized
- 27 to maintain written accounts within the official scope of their duties are not subject to access and
- 28 may not be disclosed. This subsection applies to written accounts maintained in or by facilities of
- 29 the Department of Corrections only to the extent that the written accounts concern the medical,
- 30 dental or psychiatric treatment as patients of those under the jurisdiction of the Department of
- 31 Corrections.
- 32 (3) If the individual or a personal representative of the individual provides an authorization, the
- 33 content of any written account referred to in subsection (2) of this section must be disclosed ac-
- 34 cordingly, if the authorization is in writing and is signed and dated by the individual or the personal
- 35 representative of the individual and sets forth with specificity the following:
 - 36 (a) Name of the health care services provider authorized to make the disclosure, except when
 - 37 the authorization is provided by recipients of or applicants for public assistance to a governmental
 - 38 entity for purposes of determining eligibility for benefits or investigating for fraud;
 - 39 (b) Name or title of the persons or organizations to which the information is to be disclosed or
 - 40 that information may be disclosed to the public;
 - 41 (c) Name of the individual;
 - 42 (d) Extent or nature of the information to be disclosed; and
 - 43 (e) Statement that the authorization is subject to revocation at any time except to the extent
 - 44 that action has been taken in reliance thereon, and a specification of the date, event or condition
 - 45 upon which it expires without express revocation. However, a revocation of an authorization is not

1 valid with respect to inspection or records necessary to validate expenditures by or on behalf of
2 governmental entities.

3 (4) The content of any written account referred to in subsection (2) of this section may be dis-
4 closed without an authorization:

5 (a) To any person to the extent necessary to meet a medical emergency.

6 (b) At the discretion of the responsible officer of the health care services provider, which in the
7 case of any Oregon Health Authority facility or community mental health program is the Director
8 of the Oregon Health Authority, to persons engaged in scientific research, program evaluation, peer
9 review and fiscal audits. However, individual identities may not be disclosed to such persons, except
10 when the disclosure is essential to the research, evaluation, review or audit and is consistent with
11 state and federal law.

12 (c) To governmental agencies when necessary to secure compensation for services rendered in
13 the treatment of the individual.

14 (5) When an individual's identity is disclosed under subsection (4) of this section, a health care
15 services provider shall prepare, and include in the permanent records of the health care services
16 provider, a written statement indicating the reasons for the disclosure, the written accounts dis-
17 closed and the recipients of the disclosure.

18 (6) The content of any written account referred to in subsection (2) of this section and held by
19 a health care services provider currently engaged in the treatment of an individual may be disclosed
20 to officers or employees of that provider, its agents or cooperating health care services providers
21 who are currently acting within the official scope of their duties to evaluate treatment programs,
22 to diagnose or treat or to assist in diagnosing or treating an individual when the written account
23 is to be used in the course of diagnosing or treating the individual. Nothing in this subsection

26 Oregon Health Authority or a local correctional facility when the transfer is necessary or beneficial

29 or 34.310 to 34.730 and involves a claim of constitutionally inadequate medical care, diagnosis or
30 treatment, or is brought under ORS 30.260 to 30.300 and involves the Department of Corrections or
31 an institution operated by the department, nothing in this section prohibits the disclosure of any
32 written account referred to in subsection (2) of this section to the Department of Justice, Oregon
33 Department of Administrative Services, or their agents, upon request, or the subsequent disclosure
34 to a court, administrative hearings officer, arbitrator or other administrative decision maker.

35 (8)(a) When an action, suit, claim, arbitration or proceeding involves the Department of Human
36 Services, the Oregon Health Authority or an institution operated by the department or authority,
37 nothing in this section prohibits the disclosure of any written account referred to in subsection (2)
38 of this section to the Department of Justice, Oregon Department of Administrative Services, or their
39 agents.

40 (b) Disclosure of information in an action, suit, claim, nonlabor arbitration or proceeding is

42 and ORS chapter 183. Only written accounts of a plaintiff, claimant or petitioner shall be disclosed
43 under this paragraph.

44 (c) Disclosure of information as part of a labor arbitration or proceeding to support a personnel
45 action taken against staff is limited to written accounts directly relating to alleged action or in-

1 action by staff for which the personnel action was imposed.

2 (9)(a) The copy of any written account referred to in subsection (2) of this section, upon written
3 request of the individual or a personal representative of the individual, shall be disclosed to the
4 individual or the personal representative of the individual within a reasonable time not to exceed
5 five working days. The individual or the personal representative of the individual shall have the
6 right to timely access to any written accounts.

7 (b) If the disclosure of psychiatric or psychological information contained in the written account
8 would constitute an immediate and grave detriment to the treatment of the individual, disclosure
9 may be denied, if medically contraindicated by the treating physician or a licensed health care

20 personal representative of the individual may not be denied access to written accounts concerning
21 the individual because of inability to pay.

22 (11) A written account referred to in subsection (2) of this section may not be used to initiate

24 federal, state or local authorities against the individual or to conduct any investigations of the in-

35 (13) The prohibitions of this section apply to written accounts concerning any individual who

38 (14) Persons other than the individual or the personal representative of the individual who are
39 granted access under this section to the contents of a written account referred to in subsection (2)
40 of this section may not disclose the contents of the written account to any other person except in
41 accordance with the provisions of this section.

42 (15) Nothing in this section prevents the Department of Human Services or the Oregon Health
43 Authority from disclosing the contents of written accounts in its possession to individuals or agen-
44 cies with whom children in its custody are placed.

45 (16) The system described in ORS 192.517 (1) shall have access to records, as defined in ORS

1 192.515, as provided in ORS 192.517.

2 (17)(a) Except as provided in paragraph (b) of this subsection, a health care services provider
3 must obtain an authorization from an individual or a personal representative of the individual to
4 disclose psychotherapy notes.

5 (b) A health care services provider may use or disclose psychotherapy notes without obtaining
6 an authorization from the individual or a personal representative of the individual to carry out the
7 following treatment, payment and health care operations:

8 (A) Use by the originator of the psychotherapy notes for treatment;

9 (B) Disclosure by the health care services provider for its own training program in which stu-
10 dents, trainees or practitioners in mental health learn under supervision to practice or improve their
11 skills in group, joint, family or individual counseling; or

12 (C) Disclosure by the health care services provider to defend itself in a legal action or other
13 proceeding brought by the individual or a personal representative of the individual.

14 (c) An authorization for the disclosure of psychotherapy notes may not be combined with an
15 authorization for a disclosure of any other individually identifiable health information, but may be
16 combined with another authorization for a disclosure of psychotherapy notes.

17 **SECTION 66.** ORS 179.560 is amended to read:

18 179.560. (1) There is established in the [*Department of Human Services*] **Oregon Health Au-**
19 **thority** the Oregon State Hospital Advisory Board, consisting of 16 members. Two nonvoting mem-
20 bers shall be from the Legislative Assembly, one appointed by the President of the Senate and one
21 appointed by the Speaker of the House of Representatives. Fourteen members shall be appointed by

35 (A) One individual to represent board-certified physicians;

38 (2) Members appointed by the Governor shall serve four-year terms, but a member serves at the
39 pleasure of the Governor. Before the expiration of the term of a member appointed by the Governor,

17 (2) May make recommendations directly to the superintendent of the Oregon State Hospital, the
18 Director of *[Human Services]* **the Oregon Health Authority**, the Legislative Assembly or interim

20 (a) Federal and state laws concerning, and administrative rules, policies, procedures and proto-
21 cols of the hospital related to, the safety, security and care of patients;

25 (d) Potential legislative proposals or budget packages related to the hospital; and

24 (b) For outpatient commitments under ORS 426.127, the community mental health program di-
25 irector, or designee of the director, of the county in which the person on outpatient commitment
26 lives.

27 (c) For trial visits under ORS 426.273, the community mental health program director, or
28 designee of the director, of the county in which the person on trial visit is to receive outpatient
29 treatment.

30 (2) On its own motion, the court with jurisdiction of a mentally ill person on such placement
31 may cause the person to be brought before it for a hearing to determine whether the person is or
32 is not adhering to the terms and conditions of the placement. The person shall have the same rights
33 with respect to notice, detention stay, hearing and counsel as for a hearing held under ORS 426.095.
34 The court shall hold the hearing within five judicial days of the date the mentally ill person receives
35 notice under this section. The court may allow postponement and detention during postponement as
36 provided under ORS 426.095.

37 (3) Pursuant to the determination of the court upon hearing under this section, a person on
38 placement shall either continue the placement on the same or modified conditions or shall be re-
39 turned to the Oregon Health Authority for involuntary care and treatment on an inpatient basis

4 [(4)] (5) “Developmental period” means the period of time between birth and the 18th birthday.

5 [(5)] (6) “Director of the facility” means the superintendent of a state training center, or the
6 person in charge of care, treatment and training programs at other facilities.

7 [(6)] (7) “Facility” means a state training center, community hospital, group home, activity cen-
8 ter, intermediate care facility, community mental health clinic, or such other facility or program as
9 the Department of Human Services approves to provide necessary services to persons with mental
10 retardation.

11 [(7)] (8) “Incapacitated” means a person is unable, without assistance, to properly manage or
12 take care of personal affairs or is incapable, without assistance, of self-care.

13 [(8)] (9) “Independence” means the extent to which persons with mental retardation or devel-

41 [(12)] (14) “Minor” means an unmarried person under 18 years of age.

42 [(13)] (15) “Physician” means a person licensed by the Oregon Medical Board to practice medi-
43 cine and surgery.

44 [(14)] (16) “Productivity” means engagement in income-producing work by a person with mental
45 retardation or a developmental disability which is measured through improvements in income level,

1 employment status or job advancement or engagement by a person with mental retardation or a
2 developmental disability in work contributing to a household or community.

3 [(15)] (17) "Resident" means a person admitted to a state training center either voluntarily or
4 after commitment to the department.

5 [(16)] (18) "Significantly subaverage" means a score on a test of intellectual functioning that is
6 two or more standard deviations below the mean for the test.

7 [(17) "State training center" means Eastern Oregon Training Center and any other facility operated
8 by the department for the care, treatment and training of persons with mental retardation.]

15 **Sec. 20.** On or before January 2, [2012] **2014**, the Department of Human Services and the Oregon
16 Health Authority may delegate to each other any duties, functions or powers transferred by section
17 **19, chapter 595, Oregon Laws 2009**, [*of this 2009 Act*] that the department or the authority [*deem*]
18 **deems** necessary for the efficient and effective operation of their respective functions.

19 **SECTION 225.** Section 29, chapter 856, Oregon Laws 2009, is amended to read:

20 **Sec. 29.** Notwithstanding any other law appropriating moneys or limiting expenditures, in car-
21 rying out sections 1 to 3 [*of this 2009 Act the Department of Human Services*], **chapter 856, Oregon**
22 **Laws 2009, the Oregon Health Authority** may use only funds provided by the United States Bu-
23 reau of Justice Assistance through the American Recovery and Reinvestment Act of 2009 Edward
24 Byrne Memorial Justice Assistance Grant Program.

26 **MISCELLANEOUS PROVISIONS**
27

28 **SECTION 226.** **The Mental Health Services Fund is established in the State Treasury,**
29 **separate and distinct from the General Fund. The Mental Health Services Fund comprises**
30 **moneys collected or received by the Oregon Health Authority, the Department of Human**
31 **Services and the Department of Corrections under ORS 179.640, 426.241 and 430.165. The**
32 **moneys in the fund are continuously appropriated to the Oregon Health Authority, the De-**
33 **partment of Human Services and the Department of Corrections for the purposes of paying**
34 **the costs of:**

35 (1) **Services provided to a person in a state institution, as defined in ORS 179.610;**

36 (2) **Emergency psychiatric care, custody and treatment paid for by a county under ORS**
37 **426.241;**

38 (3) **Emergency care, custody or treatment provided to a person admitted to or detained**
39 **in a state mental hospital under ORS 426.070, 426.140, 426.180 to 426.210, 426.228, 426.232 or**
40 **426.233; and**

41 (4) **Programs operating under ORS 430.265, 430.306 to 430.375, 430.405, 430.415, 430.850 to**
42 **430.880, 813.500 and 813.510.**

43 **SECTION 227.** **Notwithstanding any other provision of law, ORS 411.459 shall not be con-**
44 **sidered to have been added to or made a part of ORS chapter 411 for the purpose of statutory**
45 **compilation or for the application of definitions, penalties or administrative provisions ap-**

1 **plicable to statute sections in that chapter.**

2 **SECTION 228. ORS 409.310, 409.330, 410.110, 414.338, 414.350, 414.355, 414.360, 414.365,**
3 **414.370, 414.375, 414.380, 414.385, 414.390, 414.395, 414.400, 414.410, 414.415, 414.715, 414.720,**
4 **414.741, 430.170, 431.190, 442.575, 442.580, 442.581, 442.583, 442.584, 442.588, 442.589 and 735.711**
5 **are repealed.**

6 **SECTION 229. The unit captions used in this 2011 Act are provided only for the conven-**
7 **ience of the reader and do not become part of the statutory law of this state or express any**
8 **legislative intent in the enactment of this 2011 Act.**

17 343.961. (1) As used in this section:

18 (a) "Eligible residential treatment program" means a residential treatment program with which
19 the Oregon Health Authority, **the Department of Human Services** or the Oregon Youth Authority
20 contracts for long-term care or treatment. "Eligible residential treatment program" does not include
21 psychiatric day treatment programs or programs that provide care or treatment to juveniles who
22 are in detention facilities.

23 (b) "Residential treatment program" means a public or private residential program that provides
24 treatment of children with a mental illness, an emotional disturbance or another mental health issue.

25 (c) "Student" means a child who is placed in an eligible residential treatment program by a
26 public or private entity or by the child's parent.

27 (2) The Department of Education shall be responsible for payment of the costs of education of
28 students in eligible residential treatment programs by contracting with the school district in which
29 the eligible [*resident*] **residential** treatment program is located. The costs of education do not in-
30 clude transportation, care, treatment or medical expenses.

31 (3)(a) The school district in which an eligible residential treatment program is located is re-
32 sponsible for providing the education of a student, including the identification, location and evalu-
33 ation of the student for the purpose of determining the student's eligibility to receive special
34 education and related services under ORS 343.035.

35 (b) A school district that is responsible for providing an education under this subsection may
36 provide the education:

37 (A) Directly or through another school district or an education service district; and

38 (B) In the facilities of an eligible residential treatment program, a school district or an educa-
39 tion service district.

40 (c) When a student is no longer in an eligible residential treatment program, the responsibilities
41 imposed by this subsection terminate and become the responsibilities of the school district where the
42 student is a resident, as determined under ORS 339.133 and 339.134.

43 (4) A school district may request the Department of Education to combine several eligible resi-
44 dential treatment programs into one contract with another school district or an education service
45 district.

1 (5) The Oregon Health Authority, **the Department of Human Services** or the Oregon Youth
2 Authority shall give the school district providing the education at an eligible residential treatment
3 program 14 days' notice, **to the extent practicable**, before a student is dismissed from the program.

4 (6) The Department of Education may make advances to school districts responsible for provid-
5 ing an education to students under this section from funds appropriated for that purpose based on
6 the estimated agreed cost of educating the students per school year. Advances equal to 25 percent
7 of the estimated cost may be made on September 1, December 1 and March 1 of the current year.
8 The balance may be paid whenever the full determination of cost is made.

9 (7) School districts that provide the education described in this section on a year-round plan
10 may apply for 25 percent of the funds appropriated for that purpose on July 1, October 1, January
11 1, and 15 percent on April 1. The balance may be paid whenever the full determination of cost is
12 made.

13 (8) In addition to the payment methods described in this section, the Department of Education
14 may:

15 (a) Negotiate interagency agreements to pay for the cost of education in residential treatment
16 programs operated under the auspices of the State Board of Higher Education; and

17 (b) Negotiate intergovernmental agreements to pay for the cost of education in residential
18 treatment programs operated under the auspices of the Oregon Health and Science University Board
19 of Directors.

29 (1) "Adaptive behavior" means the effectiveness or degree with which an individual meets the
30 standards of personal independence and social responsibility expected for age and cultural group.

31 (2) "Care" means:

32 (a) Supportive services, including, but not limited to, provision of room and board;

33 (b) Supervision;

34 (c) Protection; and

35 (d) Assistance in bathing, dressing, grooming, eating, management of money, transportation or
36 recreation.

37 (3) "Community developmental disabilities program director" means the director of an entity
38 that provides services described in section 174 of this 2011 Act to persons with **intellectual dis-**
39 **abilities or other** developmental disabilities.

40 (4) "Developmental disability" means an intellectual disability, autism, cerebral palsy, epilepsy
41 or other neurological condition diagnosed by a qualified professional that:

42 (a) Originates before an individual is 22 years of age, or 18 years of age for an intellectual dis-
43 ability;

44 (b) Originates in and directly affects the brain and is expected to continue indefinitely;

45 (c) Results in a significant impairment in adaptive behavior as measured by a qualified profes-

1 sional;

2 (d) Is not attributed primarily to other conditions including, but not limited to, a mental or
3 emotional disorder, sensory impairment, substance abuse, personality disorder, learning disability
4 or attention deficit hyperactivity disorder; and

5 (e) Requires training and support similar to that required by an individual with an intellectual
6 disability.

7 [(5) *“Developmental period” means the period of time between birth and the 18th birthday.*]

8 [(6) (5) “Director of the facility” means the superintendent of a state training center, or the
9 person in charge of care, treatment and training programs at other facilities.

10 [(7) (6) “Facility” means a state training center, community hospital, group home, activity cen-
11 ter, intermediate care facility, community mental health clinic, or such other facility or program as
12 the Department of Human Services approves to provide necessary services to persons with [*mental*
13 *retardation*] **intellectual disabilities or other developmental disabilities.**

14 [(8) (7) “Incapacitated” means a person is unable, without assistance, to properly manage or
15 take care of personal affairs or is incapable, without assistance, of self-care.

16 [(9) (8) “Independence” means the extent to which persons with [*mental retardation or*] **intel-**
17 **lectual disabilities or other** developmental disabilities exert control and choice over their own
18 lives.

19 [(10) (9) “Integration” means:

20 (a) Use by persons with [*mental retardation or*] **intellectual disabilities or other** developmental
21 disabilities of the same community resources that are used by and available to other persons;

22 (b) Participation by persons with [*mental retardation or*] **intellectual disabilities or other de-**
23 **velopmental disabilities** in the same community activities in which persons without disabilities par-
24 ticipate, together with regular contact with persons without disabilities; and

25 (c) Residence by persons with **intellectual disabilities or other** developmental disabilities in
26 homes or in home-like settings that are in proximity to community resources, together with regular
27 contact with persons without disabilities in their community.

28 [(11) (10)(a) “Intellectual disability” means significantly subaverage general intellectual func-
29 tioning, defined as intelligence quotients under 70 as measured by a qualified professional and ex-
30 isting concurrently with significant impairment in adaptive behavior, that is manifested before the
31 individual is 18 years of age.

32 (b) An individual with intelligence quotients of 70 through 75 may be considered to have an
33 intellectual disability if there is also significant impairment in adaptive behavior, as diagnosed and
34 measured by a qualified professional.

35 (c) The impairment in adaptive behavior must be directly related to the intellectual disability.

36 (d) Intellectual disability is synonymous with mental retardation.

37 [(12) (11) “Intellectual functioning” means functioning as assessed by one or more of the indi-
38 vidually administered general intelligence tests developed for the purpose.

39 [(13) *“Mental retardation” is synonymous with intellectual disability.*]

40 [(14) (12) “Minor” means an unmarried person under 18 years of age.

41 [(15) (13) “Physician” means a person licensed by the Oregon Medical Board to practice medi-
42 cine and surgery.

43 [(16) (14) “Productivity” means engagement in income-producing work by a person with [*mental*
44 *retardation*] **an intellectual disability** or [*a*] **another** developmental disability which is measured
45 through improvements in income level, employment status or job advancement or engagement by a

1 person with *[mental retardation]* **an intellectual disability** or *[a]* **another** developmental disability
2 in work contributing to a household or community.

3 [(17)] **(15)** “Resident” means a person admitted to a state training center either voluntarily or
4 after commitment to the department.

5 [(18)] **(16)** “Significantly subaverage” means a score on a test of intellectual functioning that is
6 two or more standard deviations below the mean for the test.

7 [(19)] **(17)** “State training center” means any facility that is an intermediate care facility for the
8 mentally retarded as defined in 42 U.S.C. 1396d(d).

9 [(20)] **(18)** “Training” means:

10 (a) The systematic, planned maintenance, development or enhancement of self-care, social or
11 independent living skills; or

12 (b) The planned sequence of systematic interactions, activities, structured learning situations
13 or education designed to meet each resident’s specified needs in the areas of physical, emotional,
14 intellectual and social growth.

15 [(21)] **(19)** “Treatment” means the provision of specific physical, mental, social interventions and
16 therapies which halt, control or reverse processes that cause, aggravate or complicate malfunctions
17 or dysfunctions.

18 **SECTION 235. The amendments to ORS 427.005 by section 234 of this 2011 Act become**
19 **operative January 1, 2012.**

27 **SECTION 238. This 2011 Act being necessary for the immediate preservation of the public**
28 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**
29 **on its passage.**
