

House Bill 2243

Sponsored by Representative MATTHEWS; Representatives BARKER, BUCKLEY, GELSER, READ (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Allows Attorney General or Commissioner of the Bureau of Labor and Industries to file civil action in relation to discrimination against person for service in uniformed service.

2 Relating to discrimination against person for service in uniformed service; creating new provisions;
3 and amending ORS 659A.885.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 659A.885, as amended by section 3, chapter 102, Oregon Laws 2010, is
6 amended to read:

7 659A.885. (1) Any person claiming to be aggrieved by an unlawful practice specified in sub-
8 section (2) of this section may file a civil action in circuit court. In any action under this subsection,
9 the court may order injunctive relief and any other equitable relief that may be appropriate, in-
10 cluding but not limited to reinstatement or the hiring of employees with or without back pay. A
11 court may order back pay in an action under this subsection only for the two-year period imme-
12 diately preceding the filing of a complaint under ORS 659A.820 with the Commissioner of the Bureau
13 of Labor and Industries, or if a complaint was not filed before the action was commenced, the two-
14 year period immediately preceding the filing of the action. In any action under this subsection, the
15 court may allow the prevailing party costs and reasonable attorney fees at trial and on appeal. Ex-
16 cept as provided in subsection (3) of this section:

17 (a) The judge shall determine the facts in an action under this subsection; and

18 (b) Upon any appeal of a judgment in an action under this subsection, the appellate court shall
19 review the judgment pursuant to the standard established by ORS 19.415 (3).

20 (2) An action may be brought under subsection (1) of this section alleging a violation of ORS
21 25.337, 25.424, 171.120, 408.230, 476.574, 652.355, 653.060, 659A.030, 659A.040, 659A.043, 659A.046,
22 659A.063, 659A.069, 659A.082, 659A.088, 659A.103 to 659A.145, 659A.150 to 659A.186, 659A.194,
23 659A.199, 659A.203, 659A.218, 659A.230, 659A.233, 659A.236, 659A.250 to 659A.262, 659A.277,
24 659A.290, 659A.300, 659A.306, 659A.309, 659A.315, 659A.318 or 659A.421 or section 2, chapter 102,
25 Oregon Laws 2010.

26 (3) In any action under subsection (1) of this section alleging a violation of ORS 25.337, 25.424,
27 659A.030, 659A.040, 659A.043, 659A.046, 659A.069, 659A.082, 659A.103 to 659A.145, 659A.199,
28 659A.230, 659A.250 to 659A.262, 659A.290, 659A.318 or 659A.421:

29 (a) The court may award, in addition to the relief authorized under subsection (1) of this section,
30 compensatory damages or \$200, whichever is greater, and punitive damages;

31 (b) At the request of any party, the action shall be tried to a jury;

1 (c) Upon appeal of any judgment finding a violation, the appellate court shall review the judg-
 2 ment pursuant to the standard established by ORS 19.415 (1); and

3 (d) Any attorney fee agreement shall be subject to approval by the court.

4 (4) In any action under subsection (1) of this section alleging a violation of ORS 652.355 or
 5 653.060, the court may award, in addition to the relief authorized under subsection (1) of this section,
 6 compensatory damages or \$200, whichever is greater.

7 (5) In any action under subsection (1) of this section alleging a violation of ORS 171.120, 476.574,
 8 659A.203 or 659A.218, the court may award, in addition to the relief authorized under subsection (1)
 9 of this section, compensatory damages or \$250, whichever is greater.

10 (6) Any individual against whom any distinction, discrimination or restriction on account of
 11 race, color, religion, sex, sexual orientation, national origin, marital status or age, if the individual
 12 is 18 years of age or older, has been made by any place of public accommodation, as defined in ORS
 13 659A.400, by any employee or person acting on behalf of the place or by any person aiding or
 14 abetting the place or person in violation of ORS 659A.406 may bring an action against the operator
 15 or manager of the place, the employee or person acting on behalf of the place or the aider or abettor
 16 of the place or person. Notwithstanding subsection (1) of this section, in an action under this sub-
 17 section:

18 (a) The court may award, in addition to the relief authorized under subsection (1) of this section,
 19 compensatory and punitive damages;

20 (b) The operator or manager of the place of public accommodation, the employee or person
 21 acting on behalf of the place, and any aider or abettor shall be jointly and severally liable for all
 22 damages awarded in the action;

23 (c) At the request of any party, the action shall be tried to a jury;

24 (d) The court shall award reasonable attorney fees to a prevailing plaintiff;

25 (e) The court may award reasonable attorney fees and expert witness fees incurred by a de-
 26 fendant who prevails only if the court determines that the plaintiff had no objectively reasonable
 27 basis for asserting a claim or no reasonable basis for appealing an adverse decision of a trial court;
 28 and

29 (f) Upon any appeal of a judgment under this subsection, the appellate court shall review the
 30 judgment pursuant to the standard established by ORS 19.415 (1).

31 **(7)(a) When the commissioner or the Attorney General has reasonable cause to believe**
 32 **that an employer is engaged in resistance to the rights protected by ORS 659A.082, the**
 33 **commissioner or the Attorney General may file a civil action on behalf of a person in the**
 34 **same manner as a person may file a civil action under this section. The civil action may be**
 35 **filed in the Circuit Court for Marion County or the circuit court of the county in which the**
 36 **unlawful employment practice occurred.**

37 **(b) In a civil action filed under this subsection, the court may assess against the re-**
 38 **spondent, in addition to the relief authorized under subsections (1) and (3) of this section:**

39 **(A) A civil penalty in an amount not exceeding:**

40 **(i) \$50,000 for a first violation; and**

41 **(ii) \$100,000 for any subsequent violation; and**

42 **(B) The reasonable attorney fees of the commissioner or Attorney General if the com-**
 43 **missioner or Attorney General prevails in the action.**

44 ~~[(7)]~~ **(8) When the commissioner or the Attorney General has reasonable cause to believe that**
 45 **a person or group of persons is engaged in a pattern or practice of resistance to the rights protected**

1 by ORS 659A.145 or 659A.421 or federal housing law, or that a group of persons has been denied
 2 any of the rights protected by ORS 659A.145 or 659A.421 or federal housing law, the commissioner
 3 or the Attorney General may file a civil action on behalf of the aggrieved persons in the same
 4 manner as a person or group of persons may file a civil action under this section. In a civil action
 5 filed under this subsection, the court may assess against the respondent, in addition to the relief
 6 authorized under subsections (1) and (3) of this section, a civil penalty:

7 (a) In an amount not exceeding \$50,000 for a first violation; and

8 (b) In an amount not exceeding \$100,000 for any subsequent violation.

9 [(8)] (9) In any action under subsection (1) of this section alleging a violation of ORS 659A.145
 10 or 659A.421 or alleging discrimination under federal housing law, when the commissioner is pursuing
 11 the action on behalf of an aggrieved complainant, the court shall award reasonable attorney fees to
 12 the commissioner if the commissioner prevails in the action. The court may award reasonable at-
 13 torney fees and expert witness fees incurred by a defendant that prevails in the action if the court
 14 determines that the commissioner had no objectively reasonable basis for asserting the claim or for
 15 appealing an adverse decision of the trial court.

16 [(9)] (10) In an action under subsection (1) or [(7)] (8) of this section alleging a violation of ORS
 17 659A.145 or 659A.421 or discrimination under federal housing law:

18 (a) "Aggrieved person" includes a person who believes that the person:

19 (A) Has been injured by an unlawful practice or discriminatory housing practice; or

20 (B) Will be injured by an unlawful practice or discriminatory housing practice that is about to
 21 occur.

22 (b) An aggrieved person in regard to issues to be determined in an action may intervene as of
 23 right in the action. The Attorney General may intervene in the action if the Attorney General cer-
 24 tifies that the case is of general public importance. The court may allow an intervenor prevailing
 25 party costs and reasonable attorney fees at trial and on appeal.

26 **SECTION 2. The amendments to ORS 659A.885 by section 1 of this 2011 Act apply to un-**
 27 **lawful practices occurring on or after the effective date of this 2011 Act.**
