**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Alters definitions of Class I, II and III all-terrain vehicles.

Creates definition of Class IV all-terrain vehicle.

Exempts Class IV all-terrain vehicles from laws relating to vehicle registration, titling and accident reporting.

**Directs State Parks and Recreation Department to adopt rules to provide for Class IV all-terrain vehicle safety education courses and to issue operator permit to person who takes course.**

Adds Class IV all-terrain vehicle to various offenses relating to all-terrain vehicles.

Creates offense of operation of Class IV all-terrain vehicle without driving privileges. Punishes by maximum fine of \$180.

**Creates offense of endangering a Class IV all-terrain vehicle operator. Punishes by maximum fine of \$180.**

Adds two members to All-Terrain Vehicle Advisory Committee.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 801.190 is amended to read:

8 801.190. "Class I all-terrain vehicle" means a motorized, off-highway recreational vehicle **that:**

9 (1) **Is** 50 inches or less in width [*with*];

10 (2) **Has** a dry weight of [*800*] **1,200** pounds or less [*that*];

11 (3) Travels on three or more [*low pressure*] **pneumatic** tires **that are six inches or more in**  
12 **width and that are designed for use on wheels with a rim diameter of 14 inches or less**, [*has*  
13 *a saddle or seat for the operator and*];

14 (4) **Uses handlebars for steering;**

15 (5) **Has a seat designed to be straddled for the operator; and**

16 (6) Is designed for or capable of cross-country travel on or immediately over land, water, sand,  
17 snow, ice, marsh, swampland or other natural terrain.

18 **SECTION 2.** ORS 801.193 is amended to read:

19 801.193. "Class II all-terrain vehicle" means any motor vehicle that:

20 (1) Weighs more than **or is wider than** a Class I all-terrain vehicle;

21 (2) Is designed for or capable of cross-country travel on or immediately over land, water, sand,

1 snow, ice, marsh, swampland or other natural terrain; *[and]*

2 (3) Is actually being operated off a highway or is being operated on a highway for agricultural  
3 purposes under ORS 821.191; **and**

4 **(4) Is not a Class IV all-terrain vehicle.**

5 **SECTION 3.** ORS 801.194 is amended to read:

6 801.194. "Class III all-terrain vehicle" means *[an off-highway]* a motorcycle *[with a dry weight*  
7 *of 600 pounds or less]* that travels on two tires **and that is actually being operated off highway.**

8 **SECTION 4.** Sections 5 and 6 of this 2011 Act are added to and made a part of the Oregon  
9 Vehicle Code.

10 **SECTION 5.** "Class IV all-terrain vehicle" means any motorized vehicle that:

11 (1) Travels on four or more pneumatic tires that are six inches or more in width and that  
12 are designed for use on wheels with a rim diameter of 14 inches or less;

13 (2) Is designed for or capable of cross-country travel on or immediately over land, water,  
14 sand, snow, ice, marsh, swampland or other natural terrain;

15 (3) Has nonstraddle seating;

16 (4) Has a steering wheel for steering control;

17 (5) Has a dry weight of 1,800 pounds or less; and

18 (6) Is 65 inches wide or less at its widest point.

19 **SECTION 6.** (1) A person commits the offense of operation of a Class IV all-terrain ve-  
20 hicle without driving privileges if the person operates a Class IV all-terrain vehicle on public  
21 lands and the person does not hold a valid driver license issued under ORS 807.040.

22 (2) This section does not apply to a child under the age of 16 if:

23 (a) The child's age complies with the manufacturer's minimum age recommendation as  
24 evidenced by the manufacturer's warning label affixed to the vehicle;

25 (b) The child is accompanied by a person who is at least 18 years of age, who holds a valid  
26 all-terrain vehicle operator permit issued under ORS 390.570 or 390.575 or section 6b of this  
27 2011 Act and who is able to provide immediate assistance and direction to the child; and

28 (c) The child holds a Class IV all-terrain vehicle operator permit issued under section 6b  
29 of this 2011 Act.

30 (3) This section does not apply if:

31 (a) The vehicle is used exclusively in farming, agricultural or forestry operations or used  
32 by persons licensed under ORS chapter 571 exclusively for nursery or Christmas tree growing  
33 operations; or

34 (b) The vehicle is being used on land owned or leased by the owner of the vehicle.

35 (4) The offense described in this section, operation of a Class IV all-terrain vehicle  
36 without driving privileges, is a Class C traffic violation.

37 **SECTION 6a.** Section 6b of this 2011 Act is added to and made a part of ORS 390.550 to  
38 390.590.

39 **SECTION 6b.** (1) The State Parks and Recreation Department shall issue or provide for  
40 issuance of a Class IV all-terrain vehicle operator permit to any person who has taken a  
41 Class IV all-terrain vehicle safety education course established under this section and has  
42 been found qualified to operate a Class IV all-terrain vehicle.

43 (2) The department shall adopt rules to provide for Class IV all-terrain vehicle safety  
44 education courses, equivalency examinations and the issuance of Class IV all-terrain vehicle  
45 operator permits consistent with this section. The rules adopted by the department shall be

1 consistent with the following:

2 (a) The courses must be given by instructors designated by the department as qualified  
3 to conduct the courses and issue the permits.

4 (b) The instructors may be provided and permits issued through public or private local  
5 and state organizations meeting qualifications established by the department.

6 (c) The department may collect a fee of not more than \$5 from each participant in a  
7 course established under this section.

8 **SECTION 6c.** (1) Sections 6a and 6b of this 2011 Act become operative on July 1, 2012.

9 (2) The State Parks and Recreation Department may take any action before the operative  
10 date specified in subsection (1) of this section that is necessary to enable the department to  
11 exercise, on and after the operative date specified in subsection (1) of this section, all the  
12 duties, functions and powers conferred on the department by section 6b of this 2011 Act.

13 **SECTION 7.** ORS 390.550 is amended to read:

14 390.550. As used in this chapter:

15 (1) "Class I all-terrain vehicle" has the meaning given that term in ORS 801.190.

16 (2) "Class II all-terrain vehicle" has the meaning given that term in ORS 801.193.

17 (3) "Class III all-terrain vehicle" has the meaning given that term in ORS 801.194.

18 (4) "Class IV all-terrain vehicle" has the meaning given that term in section 5 of this 2011  
19 Act.

20 **SECTION 7a.** ORS 390.555 is amended to read:

21 390.555. The All-Terrain Vehicle Account is established as a separate account in the State Parks  
22 and Recreation Department Fund, to be accounted for separately. Interest earned by the All-Terrain  
23 Vehicle Account shall be credited to the account. After deduction of expenses of collection, transfer  
24 and administration, including the expenses of establishment and operation of Class I, **Class III and**  
25 **Class IV** all-terrain vehicle safety education courses and examinations under ORS 390.570 and  
26 [*Class III all-terrain vehicle safety education courses and examinations under ORS*] 390.575 **and sec-**  
27 **tion 6b of this 2011 Act**, the following moneys shall be transferred to the account:

28 (1) Fees collected by the State Parks and Recreation Department for issuance of operating per-  
29 mits for all-terrain vehicles under ORS 390.580 and 390.590.

30 (2) Fees collected by the department from participants in the Class I, [*and*] **Class III and Class**  
31 **IV** all-terrain vehicle safety education courses under ORS 390.570 and 390.575 **and section 6b of**  
32 **this 2011 Act**.

33 (3) The moneys transferred from the Department of Transportation under ORS 802.125 that  
34 represent unrefunded fuel tax.

35 **SECTION 8.** ORS 390.560 is amended to read:

36 390.560. Moneys in the All-Terrain Vehicle Account established under ORS 390.555 shall be used  
37 for the following purposes only:

38 (1) In each 12-month period, no less than 10 percent of the moneys described in ORS 390.555 that  
39 are attributable to Class I all-terrain vehicles shall be transferred to the Department of Transpor-  
40 tation for the development and maintenance of snowmobile facilities as provided in ORS 802.110;

41 (2) Planning, promoting and implementing a statewide all-terrain vehicle program, including the  
42 acquisition, development and maintenance of all-terrain vehicle recreation areas;

43 (3) Education and safety training for all-terrain vehicle operators;

44 (4) Provision of first aid and police services related to all-terrain vehicle recreation;

45 (5) Paying the costs of instigating, developing or promoting new programs for all-terrain vehicle

1 users and of advising people of possible usage areas for all-terrain vehicles;

2 (6) Paying the costs of coordinating between all-terrain vehicle user groups and the managers  
3 of public lands;

4 (7) Paying the costs of providing consultation and guidance to all-terrain vehicle user programs;

5 (8) Paying the costs of administration of the all-terrain vehicle programs, including staff support  
6 provided under ORS 390.565 as requested by the All-Terrain Vehicle Advisory Committee;

7 (9) Paying the costs of law enforcement activities related to the operation of [*Class I and Class*  
8 *III*] all-terrain vehicles. The State Parks and Recreation Department shall determine the amount  
9 required for law enforcement activities and the intervals at which the moneys shall be distributed.  
10 The funds available shall be apportioned according to the terms of an intergovernmental agreement  
11 entered into between the State Parks and Recreation Department and a city, the Department of  
12 State Police or the sheriff of a county; and

13 (10) Control and eradication of invasive species related to all-terrain vehicle recreation.

14 **SECTION 9.** ORS 390.565 is amended to read:

15 390.565. (1) The All-Terrain Vehicle Advisory Committee is established. The committee shall  
16 consist of [*eleven*] **thirteen** voting members and one nonvoting member appointed by the State Parks  
17 and Recreation Commission for a term of four years. Members are eligible for reappointment [*for a*  
18 *second term*] and vacancies may be filled by the commission. A majority of members constitutes a  
19 quorum for the transaction of business. [*Recommendations under subsection (4)(a) of this section on*  
20 *allocation of moneys in the All-Terrain Vehicle Account must receive an affirmative vote from at least*  
21 *six of the voting members of the committee.*]

22 (2) Of the voting members of the committee:

23 (a) One shall be a representative of a Class I all-terrain vehicle user organization.

24 (b) One shall be a representative of a Class II all-terrain vehicle user organization.

25 **(c) One shall be a representative of a Class III all-terrain vehicle user organization.**

26 **(d) One shall be a representative of a Class IV all-terrain vehicle user organization.**

27 [*(c)*] **(e)** One shall be an all-terrain vehicle dealer.

28 [*(d)*] **(f)** One shall be an at-large all-terrain vehicle user.

29 [*(e)*] *One shall be a representative of a Class III all-terrain vehicle user organization.*

30 [*(f)*] **(g)** One shall be a representative of the United States Forest Service **who is knowledgeable**  
31 **about all-terrain vehicle recreation areas on federal lands.**

32 [*(g)*] **(h)** One shall be a representative of the Bureau of Land Management **who is knowledge-**  
33 **able about all-terrain vehicle recreation areas on federal lands.**

34 [*(h)*] **(i)** One shall be a representative of the Department of Transportation who is knowledgeable  
35 about transportation safety.

36 [*(i)*] **(j)** One shall be a representative of the State Forestry Department who is knowledgeable  
37 about all-terrain vehicle recreation areas on state lands.

38 [*(j)*] **(k)** One shall be a representative of the Department of Human Services who is knowledge-  
39 able about public health and safety.

40 [*(k)*] **(L)** One shall be a representative of a law enforcement agency **who is knowledgeable**  
41 **about and active in enforcement of all-terrain vehicle laws.**

42 **(m) One shall be a representative of the State Department of Fish and Wildlife who is**  
43 **knowledgeable about all-terrain vehicle activities and the use of all-terrain vehicles in hunt-**  
44 **ing and fishing.**

45 (3) One representative from the State Parks and Recreation Department shall be a nonvoting

1 member of the committee.

2 (4) The committee shall:

3 [(a) *Advise the State Parks and Recreation Department on the allocation of moneys in the All-*  
4 *Terrain Vehicle Account established by ORS 390.555.*]

5 [(b)] (a) Review accidents and fatalities resulting from all-terrain vehicle recreation and make  
6 recommendations to the State Parks and Recreation Commission.

7 [(c)] (b) Review changes to statutory vehicle classifications as necessary for safety consider-  
8 ations and make recommendations to the commission.

9 [(d)] (c) Review safety features of all classes of off-highway vehicles and make recommendations  
10 to the commission.

11 [(e)] (d) Recommend appropriate safety requirements to protect child operators and riders of  
12 off-highway vehicles to the commission.

13 (5)(a) A subcommittee **of the All-Terrain Vehicle Advisory Committee, titled the All-Terrain**  
14 **Vehicle Grant Subcommittee**, shall be established consisting of the following [voting] members:

15 (A) The representative of a Class I all-terrain vehicle user organization.

16 (B) The representative of a Class II all-terrain vehicle user organization.

17 (C) The representative of a Class III all-terrain vehicle user organization.

18 **(D) The representative of a Class IV all-terrain vehicle user organization.**

19 [(D)] (E) The at-large all-terrain vehicle user.

20 [(E)] (F) The representative of a law enforcement agency.

21 (b) The [subcommittee] **All-Terrain Vehicle Grant Subcommittee** shall:

22 **(A) Advise the State Parks and Recreation Department on the allocation of moneys in**  
23 **the All-Terrain Vehicle Account established by ORS 390.555; and**

24 **(B) Review grant proposals and make recommendations to the commission as to which projects**  
25 **should receive grant funding.**

26 (c) Recommendations under this subsection on grant proposals must receive an affirmative vote  
27 from at least [three] **four** of the members of the subcommittee.

28 (6) The State Parks and Recreation Department shall provide staff support for the committee  
29 and shall provide for expansion of programs for all-terrain vehicle users.

30 **SECTION 10.** ORS 390.580 is amended to read:

31 390.580. (1)(a) An all-terrain vehicle off-road operating permit issued under this section is a decal  
32 that authorizes use of the all-terrain vehicle for which it is issued on trails and in areas designated  
33 for such use by the appropriate authority.

34 (b) An all-terrain vehicle decal issued under this section must be permanently affixed to the  
35 vehicle and displayed in a clearly visible manner. The State Parks and Recreation Department shall  
36 prescribe by rule the manner in which the decal shall be displayed.

37 (2) The department shall issue an all-terrain vehicle off-road operating permit to any person who  
38 completes the application described in subsection (4) of this section and pays the fee specified in  
39 subsection (5) of this section.

40 (3) The department shall specify by rule the form of the permit and the information to be con-  
41 tained on the permit.

42 (4) Application for an all-terrain vehicle off-road operating permit for a Class I, Class II, [or]  
43 Class III **or Class IV** all-terrain vehicle shall be in a form furnished by the department. The appli-  
44 cation shall include:

45 (a) The name and address of the owner of the all-terrain vehicle; and

1 (b) The make and body style of the all-terrain vehicle for which application is made.

2 (5) The department shall establish by rule a fee for a permit issued or renewed under this sec-  
3 tion. The fee shall be designed to cover the costs to the department for issuing or renewing permits  
4 under this section but shall not exceed \$10.

5 (6) Permits issued under this section are valid for two years. A permit may be renewed upon  
6 submission of an application that contains the information specified in subsection (4) of this section  
7 and payment of the renewal fee specified in subsection (5) of this section.

8 (7) The department may appoint agents to issue permits for all-terrain vehicles. The department  
9 shall prescribe the procedure for the issuance of the permits. Agents appointed under this subsection  
10 shall issue permits in accordance with the prescribed procedure and shall charge and collect the  
11 fees prescribed in this section for the permits.

12 **SECTION 11.** ORS 646.913 is amended to read:

13 646.913. (1) Except as provided in subsection (5) of this section, a retail dealer, nonretail dealer  
14 or wholesale dealer may not sell or offer for sale gasoline unless the gasoline contains 10 percent  
15 ethanol by volume.

16 (2) Gasoline containing ethanol that is sold or offered for sale meets the requirements of this  
17 section if the gasoline, exclusive of denaturants and permitted contaminants, contains not less than  
18 9.2 percent by volume of agriculturally derived, denatured ethanol that complies with the standards  
19 for ethanol adopted by the State Department of Agriculture.

20 (3) The department shall adopt standards for ethanol blended with gasoline sold in this state.  
21 The standards adopted shall require that the gasoline blended with ethanol:

22 (a) Contains ethanol that is derived from agricultural or woody waste or residue;

23 (b) Contains ethanol denatured as specified in 27 C.F.R. parts 20 and 21;

24 (c) Complies with the volatility requirements specified in 40 C.F.R. part 80;

25 (d) Complies with or is produced from a gasoline base stock that complies with ASTM Interna-  
26 tional specification D 4814;

27 (e) Is not blended with casinghead gasoline, absorption gasoline, drip gasoline or natural gaso-  
28 line after the gasoline has been sold, transferred or otherwise removed from a refinery or terminal;  
29 and

30 (f) Contains ethanol that complies with ASTM International specification D 4806.

31 (4) The department may review specifications adopted by ASTM International, or equivalent  
32 organizations, and federal regulations and revise the standards adopted pursuant to this section as  
33 necessary.

34 (5) A retail dealer, nonretail dealer or wholesale dealer may sell or offer for sale gasoline that  
35 is not blended with ethanol if the gasoline has an octane rating, as defined in ORS 646.945, of 91  
36 or above or if the gasoline is for use in:

37 (a) An aircraft:

38 (A) With a supplemental type certificate approved by the Federal Aviation Administration that  
39 allows the aircraft to use gasoline that is intended for use in motor vehicles; or

40 (B) Issued a type certificate by an aircraft engine manufacturer that allows the aircraft to use  
41 gasoline that is intended for use in motor vehicles;

42 (b) An aircraft that has been issued an experimental certificate, described in 14 C.F.R. 21.191,  
43 by the Federal Aviation Administration and that is required by the manufacturer's specifications to  
44 use gasoline that is intended for use in motor vehicles;

45 (c) A light-sport aircraft, as defined in 14 C.F.R. 1.1, that is required by the manufacturer's

1 specifications to use gasoline that is intended for use in motor vehicles;

2 (d) A vintage aircraft, as defined by the Oregon Department of Aviation by rule, that is required  
3 by the manufacturer's specifications to use gasoline that is intended for use in motor vehicles;

4 (e) An antique vehicle, as defined in ORS 801.125;

5 (f) A Class I all-terrain vehicle, as defined in ORS 801.190;

6 (g) A Class III all-terrain vehicle, as defined in ORS 801.194;

7 **(h) A Class IV all-terrain vehicle, as defined in section 5 of this 2011 Act;**

8 [(h)] (i) A racing activity vehicle, as defined in ORS 801.404;

9 [(i)] (j) A snowmobile, as defined in ORS 801.490;

10 [(j)] (k) Tools, including but not limited to lawn mowers, leaf blowers and chain saws; or

11 [(k)] (L) A watercraft.

12 **SECTION 12.** ORS 802.125 is amended to read:

13 802.125. The Department of Transportation shall transfer to the State Parks and Recreation  
14 Department that portion of the amount paid to the Department of Transportation as motor vehicle  
15 fuel tax under ORS 319.020 and 319.530 that is determined by the department to be tax on fuel used  
16 by Class I, Class II, [and] Class III **and Class IV** all-terrain vehicles in off-highway operation and  
17 that is not refunded. The Department of Transportation shall determine the amount of moneys to  
18 be transferred under this section at quarterly intervals.

19 **SECTION 13.** ORS 803.030 is amended to read:

20 803.030. This section establishes exemptions from the requirements under ORS 803.025 to obtain  
21 title issued by this state. The exemptions are subject to ORS 803.040. The exemptions are in addition  
22 to any exemptions under ORS 801.026. Vehicles exempted by this section from the requirements to  
23 be titled by this state are not prohibited from being titled by this state if titling is permitted under  
24 ORS 803.035. The exemptions are partial or complete as provided in the following:

25 (1) Title from this state is not required for a vehicle unless the vehicle is operated on a highway  
26 in this state.

27 (2) Title from this state is not required unless a vehicle is operated under a registration number  
28 of this state.

29 (3) Snowmobiles[,] **and** Class I, [*all-terrain vehicles and*] Class III **and Class IV** all-terrain vehi-  
30 cles are not subject to the requirements under ORS 803.025. The requirements and procedures for  
31 titling snowmobiles are as provided under ORS 821.060 and 821.070.

32 (4) Road rollers, farm tractors and traction engines are exempt from the requirements for title.

33 (5) Trolleys are exempt from the requirements for title.

34 (6) Bicycles are exempt from the requirements for title.

35 (7) United States Government owned and operated motor vehicles and trailers are exempt from  
36 the requirements for title.

37 (8) Implements of husbandry, well drilling machinery, emergency fire apparatus providing public  
38 fire protection and wheelchairs are exempt from the requirements for title.

39 (9) Except as provided in subsection (23) of this section, fixed load vehicles are exempt from the  
40 requirements for title while operated within the immediate construction project, as described in the  
41 governmental agency contract, in the construction or reconstruction of state or county roads,  
42 highways or city streets.

43 (10) Motor vehicles designed to operate at a loaded weight over 8,000 pounds, trailers and  
44 equipment are exempt from requirements for title while:

45 (a) Owned, leased, contracted or requisitioned by the State Forester, State Board of Forestry,

1 their contractors under ORS chapter 477, or the federal government; and

2 (b) Being used for the purposes of forest protection and fire suppression under ORS chapter 477  
3 or a similar federal statute, including movement of the vehicles to and from the work area.

4 (11) Farm trailers are exempt from requirements for title when the operation or movement of  
5 the vehicle upon the highways is incidental to its use in an agricultural operation.

6 (12) Golf carts operated under an ordinance adopted under ORS 810.070 are exempt from re-  
7 quirements for title.

8 (13) Golf carts or similar vehicles are exempt from requirements for title when:

9 (a) They have not less than three wheels in contact with the ground;

10 (b) They have an unloaded weight of less than 1,300 pounds;

11 (c) They are designed to be and are operated at not more than 15 miles per hour; and

12 (d) They are operated by persons with disabilities.

13 (14) The nonresident owners of vehicles currently registered and titled in any other country,  
14 state or territory may operate such vehicles over the highways of this state without complying with  
15 the titling requirements under ORS 803.025. All of the following apply to this subsection:

16 (a) This subsection only provides an exemption so long as the owner satisfactorily shows that  
17 the owner is not a resident of this state or has been a resident of this state for less than 30 days.  
18 For the purpose of this paragraph, a person is a resident of this state if the person meets the resi-  
19 dency requirements described in ORS 803.200.

20 (b) The exemption under this subsection applies to vehicles granted exemptions under ORS  
21 802.500, 802.520 or 826.005, unless otherwise provided under paragraph (c) of this subsection.

22 (c) Except as otherwise provided in this paragraph, a vehicle operated over the highways of this  
23 state for compensation or profit must comply with the titling requirements under ORS 803.025 in the  
24 same manner as required of nontitled vehicles. The following vehicles are not subject to this para-  
25 graph:

26 (A) Vehicles operated under reciprocal registration exemptions established under ORS 802.500  
27 or 826.005.

28 (B) Vehicles operated under an exemption established under ORS 802.520.

29 (C) Vehicles that are proportionally registered under an agreement established under ORS  
30 826.007, and according to the procedures established under ORS 826.009 or 826.011.

31 (D) Any vehicle if duly registered and titled under the laws of the state or country of which the  
32 owner is a bona fide resident to the extent that in the foreign country, state, territory or federal  
33 district where the owner resides like exemptions and privileges are granted vehicles duly registered  
34 and titled under the laws of this state and owned by residents of this state.

35 (d) If no exemptions from titling requirements are in effect under ORS 802.500, 802.520, 826.005  
36 or 826.007 with respect to another jurisdiction, any vehicle properly registered and titled in such  
37 other jurisdiction and for which evidence of compliance is supplied shall receive, when operated in  
38 this state, the same exemptions, benefits and privileges granted by such other jurisdictions to vehi-  
39 cles properly registered and titled in this state. Reciprocity extended under this paragraph shall  
40 apply to commercial vehicles only when engaged exclusively in interstate commerce.

41 (e) Any vehicle operated under dealer registration plates issued by another state, country,  
42 province, territory or the District of Columbia is subject to this subsection.

43 (15) Vehicle dealers issued certificates under ORS 822.020 may use and operate untitled vehicles  
44 as provided under ORS 822.040.

45 (16) Towing businesses issued certificates under ORS 822.205 may tow untitled vehicles as pro-



1 vided under ORS 822.210.

2 (17) Vehicle transporters issued certificates under ORS 822.310 may transport untitled vehicles  
3 as provided in ORS 822.310.

4 (18) Untitled vehicles may be operated under trip permits described under ORS 803.600 or under  
5 permits described under ORS 803.610 to 803.625.

6 (19) Vehicles that are registered by the United States Department of State and that are owned  
7 or operated by foreign nationals with diplomatic immunity are exempt from the requirements for  
8 title.

9 (20)(a) Vehicles that are registered under the proportional registration provisions of ORS chap-  
10 ter 826 and are titled in a jurisdiction other than Oregon are exempt from the requirements for title.

11 (b) A trailer that is registered under the proportional registration provisions of ORS chapter 826  
12 and titled in a jurisdiction other than Oregon shall remain exempt from the requirements for title  
13 in Oregon if the trailer is registered when the other jurisdiction removes its exception to propor-  
14 tional registration requirements for the trailer.

15 (21) Converter dollies and tow dollies are exempt from the requirements for title.

16 (22) Electric personal assistive mobility devices are exempt from the requirements for title.

17 (23) Road machinery that is operated at the direction of a road authority is exempt from the  
18 requirements for title. The exemption under this subsection also applies when the operation of road  
19 machinery upon a highway or an alley is incidental to its use in a highway maintenance operation.

20 **SECTION 14.** ORS 803.305 is amended to read:

21 803.305. This section establishes exemptions from the requirements under ORS 803.300. The ex-  
22 emptions under this section are in addition to any exemptions under ORS 801.026. Vehicles exempted  
23 by this section from the requirements to be registered by this state are not prohibited from being  
24 registered by this state if registration is permitted under ORS 803.310. The following are exempt,  
25 either partially or completely as described, from the registration requirements under ORS 803.300:

26 (1) Road rollers, farm tractors, trolleys and traction engines are exempt from registration.

27 (2) Bicycles are exempt from registration.

35 for hire, travel trailer or camper is not exempt by this subsection.

36 (6) Vehicles owned and operated by the United States Government are exempt from registration.

37 (7) Snowmobiles are subject to the requirements for registration provided under ORS 821.080 to  
38 821.110.

39 (8) Implements of husbandry, well drilling machinery, emergency fire apparatus providing public  
40 fire protection and wheelchairs are exempt from registration.

41 (9) Road graders, farm tractors and farm trailers on highways are exempt from registration when  
42 the operation of the vehicle upon the highway is incidental to its use in an agricultural operation.

43 (10) Except as provided in subsection (26) of this section, fixed load vehicles are exempt from  
44 registration while the vehicles are operated:

45 (a) In the construction or reconstruction of state or county roads, highways or city streets; and

1 (b) Within the immediate construction projects, as described in the governmental agency con-  
2 tract under which the work is being performed.

3 (11) Motor vehicles designed to operate at a loaded weight over 8,000 pounds, trailers and  
4 equipment are exempt from registration while being used for the purposes of forest protection and  
5 fire suppression under ORS chapter 477 or a similar federal statute. The exemption under this sub-  
6 section applies to the vehicles or equipment described while being moved to or from the work area.  
7 The exemption under this subsection only applies to vehicles or equipment owned, leased, contracted  
8 for or requisitioned by the State Forester or State Board of Forestry, a contractor of the State  
9 Forester or State Board of Forestry under ORS chapter 477 or the United States Government.

10 (12) Vehicles being used for the purposes of forest protection and fire suppression are exempt  
11 if the vehicles are necessary in order to comply with ORS 477.615 or 477.650 or a similar federal  
12 statute. The exemption under this subsection also applies to the vehicles described being moved to  
13 or from the work area.

14 (13) Golf cart exemptions from registration are as provided in ORS 820.210.

15 (14) Vehicles currently registered and titled in any other country, state or territory are not re-  
16 quired to be registered by this state. All of the following apply to this subsection:

17 (a) This subsection only provides an exemption as long as the owner of the vehicle satisfactorily  
18 shows that the owner is not a resident of this state or has been a resident of this state for less than  
19 30 days. For the purpose of this paragraph, a person is a resident of this state if the person meets  
20 the residency requirements described in ORS 803.200.

21 (b) The exemption under this subsection applies to vehicles granted exemptions under ORS  
22 802.500, 802.520 or 826.005 unless otherwise provided for under paragraph (c) of this subsection.

23 (c) Except as otherwise provided in this paragraph, a vehicle operated over the highways of this  
24 state for compensation or profit must comply with the registration requirements under ORS 803.300  
25 in the same manner as vehicles owned by persons in this state. The following vehicles are not sub-  
26 ject to this paragraph:

27 (A) Vehicles operated under reciprocal registration exemptions established under ORS 802.500  
28 or 826.005.

29 (B) Vehicles operated under an exemption established under ORS 802.520.

30 (C) Vehicles that are proportionally registered under an agreement established under ORS  
31 826.007 and according to the procedures established under ORS 826.009 and 826.011.

34 district where the owner resides like exemptions and privileges are granted vehicles duly registered  
35 and titled under the laws of this state and owned by residents of this state.

36 (d) If no exemption from registration requirements is in effect under ORS 802.500, 802.520,

6 803.600 or under permits described under ORS 803.610 to 803.625.

7 (19) If trailers that are part of a fleet of trailers for hire are properly registered in this state  
8 under an agreement entered into pursuant to ORS 802.500, all trailers that are identified as being  
9 a part of the same fleet and that are currently registered in any state, territory, province, country  
10 or the District of Columbia shall be permitted to operate in this state in both interstate and intra-  
11 state commerce without being registered by this state.

12 (20) Vehicles that are registered by the United States Department of State and that are owned  
13 or operated by foreign nationals with diplomatic immunity are exempt from registration.

14 (21) Tow dollies and converter dollies are exempt from registration.

15 (22) Class I, [and] Class III **and Class IV** all-terrain vehicles are exempt from registration.

16 (23) Motor assisted scooters are exempt from registration.

17 (24) Electric personal assistive mobility devices are exempt from registration.

18 (25) A racing activity vehicle that is being operated for the purposes of a test drive within a  
19 30-mile radius of the location where the vehicle is manufactured is exempt from registration.

20 (26) Road machinery that is operated at the direction of a road authority is exempt from regis-  
21 tration. The exemption under this subsection also applies when the operation of road machinery  
22 upon a highway or an alley is incidental to its use in a highway maintenance operation.

23 **SECTION 15.** ORS 806.020 is amended to read:

24 806.020. This section provides exemptions from the necessity for compliance with or proof of  
25 compliance with financial responsibility requirements in accident reports under ORS 811.725, when  
26 applying for vehicle registration under ORS 803.370 or 803.460 and for operating a vehicle under  
27 ORS 806.010. The owner or operator of a vehicle is exempt, as provided by this section, from finan-  
28 cial responsibility requirements if the vehicle involved in the accident, sought to be registered or

38 (7) Any motor vehicle not operated on any highway or premises open to the public in this state.

39 (8) A motor assisted scooter.

40 (9) An electric personal assistive mobility device.

41 **SECTION 16.** ORS 807.020 is amended to read:

42 807.020. A person who is granted a driving privilege by this section may exercise the driving  
43 privilege described without violation of the requirements under ORS 807.010. A grant of driving  
44 privileges to operate a motor vehicle under this section is subject to suspension and revocation the  
45 same as other driving privileges granted under the vehicle code. This section is in addition to any

1 exemptions from the vehicle code under ORS 801.026. The following persons are granted the de-  
2 scribed driving privileges:

3 (1) A person who is not a resident of this state or who has been a resident of this state for less  
4 than 30 days may operate a motor vehicle without an Oregon license or driver permit if the person

31 **(9) Driving privileges for Class IV all-terrain vehicles are exclusively as provided in sec-**  
32 **tion 6 of this 2011 Act.**

33 [(9)] (10) A person without a license or driver permit may operate a golf cart in accordance with  
34 an ordinance adopted under ORS 810.070.

35 [(10)] (11) The spouse of a member of the Armed Forces of the United States on active duty who  
36 is accompanying the member on assignment in this state may operate a motor vehicle if the spouse  
37 has a current out-of-state license or driver permit issued to the spouse by another state in the  
38 spouse's possession.

39 [(11)] (12) A person who is a member of the Armed Forces of the United States on active duty  
40 may operate a motor vehicle if the person has a current out-of-state license or driver permit in the  
41 person's possession that is issued to the person by the person's state of domicile or by the Armed  
42 Forces of the United States in a foreign country. Driving privileges described under this subsection

5 [(13)] (14) A person may operate a bicycle that is not an electric assisted bicycle without any

7 [(14)] (15) A person may operate an electric assisted bicycle without a driver license or driver  
8 permit if the person is 16 years of age or older.

9 [(15)] (16) A person may operate a motor assisted scooter without a driver license or driver  
10 permit if the person is 16 years of age or older.

11 [(16)] (17) A person who is not a resident of this state or who has been a resident of this state  
12 for less than 30 days may operate a motor vehicle without an Oregon license or driver permit if the  
13 person is at least 15 years of age and has in the person's possession a current out-of-state equivalent  
14 of a Class C instruction driver permit issued to the person. For the purpose of this subsection, a

16 807.062. A person operating a motor vehicle under authority of this subsection has the same privi-

19 [(17)] (18) A person may operate an electric personal assistive mobility device without any grant

31 (C) Is the parent, legal guardian or person with legal responsibility for the safety and welfare

34 harness as required by subsection (2) of this section.

35 (D) Operates a motor vehicle on the highways of this state with a passenger who is under 16  
36 years of age and the passenger is not properly secured with a child safety system, safety belt or  
37 safety harness as required by subsection (2) of this section.

38 (E) Is the parent, legal guardian or person with legal responsibility for the safety and welfare  
39 of a child who is under 16 years of age and the child, while riding on public lands in or on a Class  
40 I, [or] Class II **or Class IV** all-terrain vehicle that is not registered under ORS 803.420, is not  
41 properly secured with a safety belt or safety harness.

42 (F) Is the parent, legal guardian or person with legal responsibility for the safety and welfare  
43 of a child who is under 16 years of age and the child, while riding on public lands in or on a Class  
44 II all-terrain vehicle registered under ORS 803.420, is not properly secured with a safety belt or  
45 safety harness as required by subsection (2) of this section.

1 (G) Is a passenger in a privately owned commercial vehicle, as defined in ORS 801.210, that is  
2 designed and used for the transportation of 15 or fewer persons, including the driver, and the person  
3 is 16 years of age or older and is responsible for another passenger who is not properly secured with  
4 a child safety system as required under subsection (2)(a), (b) or (c) of this section.

5 (H) Is a passenger in a motor vehicle being operated on the highways of this state who is 16  
6 years of age or older and who is not properly secured with a safety belt or safety harness as re-  
7 quired by subsection (2) of this section.

8 (b) As used in this subsection, "public lands" includes privately owned land that is open to the  
9 general public for the use of all-terrain vehicles as the result of funding from the All-Terrain Vehicle  
10 Account under ORS 390.560.

11 (2) To comply with this section:

12 (a) A person who is under one year of age, regardless of weight, or a person who weighs 20  
13 pounds or less must be properly secured with a child safety system in a rear-facing position.

14 (b) A person who weighs 40 pounds or less must be properly secured with a child safety system  
15 that meets the minimum standards and specifications established by the Department of Transporta-  
16 tion under ORS 815.055 for child safety systems designed for children weighing 40 pounds or less.

39 (b) The reporting requirements for occupants of vehicles in accidents under ORS 811.750.

40 (2) Except as provided in subsection (4) of this section, an accident occurring on a highway or  
41 upon premises open to the public resulting in damage to the property of any person in excess of  
42 \$1,500 is subject to the following reporting requirements:

43 (a) The driver of a vehicle that has more than \$1,500 damage must report the accident in the  
44 manner specified under ORS 811.748.

45 (b) If the property damage is to property other than a vehicle involved in the accident, each

1 driver involved in the accident must report the accident in the manner specified under ORS 811.748.

2 (c) If a vehicle involved in the accident is damaged to the extent that the vehicle must be towed  
3 from the scene of the accident, each driver involved in the accident must report the accident in the  
4 manner specified under ORS 811.748.

44 power unit, an additional emblem shall be displayed on the rear of the rearmost vehicle in the

1        **SECTION 20.** ORS 815.300 is amended to read:

2        815.300. This section establishes exemptions from the requirements under ORS 815.295 to be  
3 equipped with a certified pollution control system. Exemptions established by this section are in  
4 addition to any exemptions established by ORS 801.026. The exemptions established in this section  
5 are also applicable to requirements for certification of pollution control equipment before registra-  
6 tion under ORS 803.350 and 803.465. All of the following vehicles are exempt from the requirements  
7 under ORS 815.295:

8        (1) Any vehicle that is not a motor vehicle.

9        (2) Any vehicle unless the vehicle is registered within:

10        (a) The boundaries of the metropolitan service district formed under ORS chapter 268 for the  
11 metropolitan area, as defined in ORS 268.020, which includes the City of Portland, Oregon.

12        (b) Boundaries designated by the Environmental Quality Commission under ORS 468A.390.

13        (3) Any new motor vehicle or new motor vehicle engine when the registration results from the  
14 initial retail sale thereof.

15        (4) Any motor vehicle:

16        (a) Not registered in areas designated under subsection (2)(a) of this section, including any ex-  
17 pansion of such boundary under subsection (2)(b) of this section, with a model year that predates  
18 by more than 20 years the year in which registration or renewal of registration is required; or

19        (b) Registered in areas designated under subsection (2)(a) of this section, including any expan-  
20 sion of such boundary under subsection (2)(b) of this section, with a model year of 1974 or earlier.

21        (5) Motor vehicles that are registered as farm vehicles under ORS 805.300 or apportioned farm  
22 vehicles under ORS 805.300.

23        (6) Special interest vehicles that are maintained as collectors' items and used for exhibitions,
