

HOUSE AMENDMENTS TO HOUSE BILL 2332

By COMMITTEE ON TRANSPORTATION AND ECONOMIC DEVELOPMENT

1 On page 1 of the printed bill, line 2, after “ORS” delete the rest of the line and delete lines 3
2 and 4 and insert “803.420 and 803.435.”.

3 Delete lines 6 through 29 and delete pages 2 through 16 and insert:

4 **“SECTION 1. Section 2 of this 2011 Act is added to and made a part of the Oregon Vehicle**
5 **Code.**

6 **“SECTION 2. (1) In addition to the privileges described under ORS 822.210, the holder of**
7 **a current, valid towing business certificate issued under ORS 822.205 may use a tow vehicle**
8 **to transport property for hire other than as described in ORS 822.210 if:**

9 **“(a) The tow vehicle is used primarily for the purposes described in ORS 822.210 in a**
10 **manner specified by the department by rule;**

11 **“(b) The tow vehicle has a combined weight of 26,001 pounds or more;**

12 **“(c) The holder of the towing business certificate has submitted a declaration of weight**
13 **under ORS 803.435 and has registered the tow vehicle under ORS 803.420 (10); and**

14 **“(d) The holder of the towing business certificate operates in accordance with the pro-**
15 **visions of ORS chapter 825.**

16 **“(2) A tow vehicle that is used to transport property for hire other than as described in**
17 **ORS 822.210 is subject to the weight-mile tax imposed under ORS 825.474.**

18 **“SECTION 3. ORS 803.420 is amended to read:**

19 “803.420. This section establishes registration fees for vehicles. If there is uncertainty as to the
20 classification of a vehicle for purposes of the payment of registration fees under the vehicle code,
21 the Department of Transportation may classify the vehicle to assure that registration fees for the
22 vehicle are the same as for vehicles the department determines to be comparable. The registration
23 fees for the vehicle shall be those based on the classification determined by the department. Except
24 as otherwise provided in this section, or unless the vehicle is registered quarterly, the fees described
25 in this section are for an entire registration period for the vehicle as described under ORS 803.415.
26 The department shall apportion any fee under this section to reflect the number of quarters regis-
27 tered for a vehicle registered for a quarterly registration period under ORS 803.415. The fees are
28 payable when a vehicle is registered and upon renewal of registration. Except as provided in ORS
29 801.041 (3) and 801.042 (7), the fee shall be increased by any amount established by the governing
30 body of a county or by the governing body of a district, as defined in ORS 801.237, under ORS
31 801.041 or 801.042 as an additional registration fee for the vehicle. The fees for registration of ve-
32 hicles are as follows:

33 **“(1) Vehicles not otherwise provided for in this section or ORS 821.320, \$43 for each year of the**
34 **registration period.**

35 **“(2) Mopeds, \$24 for each year of the registration period.**

- 1 “(3) Motorcycles, \$24 for each year of the registration period.
- 2 “(4) Government-owned vehicles registered under ORS 805.040, \$3.50.
- 3 “(5) State-owned vehicles registered under ORS 805.045, \$3.50 on registration or renewal.
- 4 “(6) Undercover vehicles registered under ORS 805.060, \$3.50 on registration or renewal.
- 5 “(7) Antique vehicles registered under ORS 805.010, \$54.
- 6 “(8) Vehicles of special interest registered under ORS 805.020, \$81.
- 7 “(9) Electric vehicles and hybrid vehicles that use electricity and another source of motive
- 8 power, as follows:
- 9 “(a) The registration fee for an electric or hybrid vehicle not otherwise described in this sub-
- 10 section is \$43 for each year of the registration period.
- 11 “(b) The registration fee for electric or hybrid vehicles that have two or three wheels is \$43.
- 12 This paragraph does not apply to electric or hybrid mopeds. Electric or hybrid mopeds are subject
- 13 to the same registration fee as otherwise provided for mopeds under this section.
- 14 “(c) The registration fees for the following electric or hybrid vehicles are the same as for com-
- 15 parable nonelectric vehicles described in this section plus 50 percent of such fee:
- 16 “(A) Motor homes.
- 17 “(B) Commercial buses.
- 18 “(C) Vehicles registered as farm vehicles under ORS 805.300.
- 19 “(D) Vehicles required to establish registration weight under ORS 803.430 or 826.013.
- 20 “(10) Motor vehicles required to establish a registration weight under ORS 803.430 or 826.013,
- 21 **tow vehicles used to transport property for hire other than as described in ORS 822.210**, and
- 22 commercial buses, as provided in the following chart, based upon the weight submitted in the dec-
- 23 laration of weight prepared under ORS 803.435 or 826.015:

14 “(c) The owner of a vehicle described in paragraphs (a) and (b) of this subsection must certify
15 at the time of initial registration, in a manner determined by the department by rule, that the motor
16 vehicle will be used exclusively to transport manufactured structures or exclusively as described in
17 ORS 822.210, **unless the motor vehicle is registered under subsection (10) of this section, or**
18 **as described in ORS 825.015 or 825.017 (14).** Registration of a vehicle described in paragraphs (a)
19 and (b) of this subsection is invalid if the vehicle is operated in any manner other than that de-
20 scribed in the certification under this paragraph.

21 “(12) Trailers registered under permanent registration, \$10.

22 “(13) Fixed load vehicles as follows:

23 “(a) If a declaration of weight described under ORS 803.435 is submitted establishing the weight
24 of the vehicle at 3,000 pounds or less, \$54.

25 “(b) If no declaration of weight is submitted or if the weight of the vehicle is in excess of 3,000
26 pounds, \$75.

27 “(14) Trailers for hire that are equipped with pneumatic tires made of an elastic material and
28 that are not travel trailers or trailers registered under permanent registration, \$27.

29 “(15) Trailers registered as part of a fleet under an agreement reached pursuant to ORS 802.500,
30 the same as the fee for vehicles of the same type registered under other provisions of the Oregon
31 Vehicle Code.

32 “(16) Travel trailers, campers and motor homes as follows, based on length as determined under
33 ORS 803.425:

34 “(a) For travel trailers or campers that are 6 to 10 feet in length, \$81.

35 “(b) For travel trailers or campers over 10 feet in length, \$81 plus \$6.75 a foot for each foot of
36 length over the first 10 feet.

37 “(c) For motor homes that are 6 to 14 feet in length, \$54.

38 “(d) For motor homes over 14 feet in length, \$126 plus \$7.50 a foot for each foot of length over
39 the first 10 feet.

40 “(17) Special use trailers as follows, based on length as determined under ORS 803.425:

41 “(a) For lengths 6 to 10 feet, \$54.

42 “(b) For special use trailers over 10 feet in length, \$54 plus \$3 a foot for each foot of length over
43 the first 10 feet.

44 “(18) Fees for vehicles with proportional registration under ORS 826.009, or proportioned fleet
45 registration under ORS 826.011, are as provided for vehicles of the same type under this section

1 except that the fees shall be fixed on an apportioned basis as provided under the agreement estab-
2 lished under ORS 826.007.

3 “(19) For any vehicle that is registered under a quarterly registration period, a minimum of \$15
4 for each quarter registered plus an additional fee of \$1.

5 “(20) In addition to any other fees charged for registration of vehicles in fleets under ORS
6 805.120, the department may charge the following fees:

7 “(a) A \$2 service charge for each vehicle entered into a fleet.

8 “(b) A \$1 service charge for each vehicle in the fleet at the time of renewal.

9 “(21) The registration fee for vehicles with special registration for disabled veterans under ORS
10 805.100 is a fee of \$15.

11 “(22) Subject to subsection (19) of this section, the registration fee for motor vehicles registered
12 as farm vehicles under ORS 805.300 is as follows based upon the registration weight given in the
13 declaration of weight submitted under ORS 803.435:

24 “(23) The registration fee for school vehicles registered under ORS 805.050 is \$7.50.

25 “(24) The registration fee for a low-speed vehicle is \$43, for each year of the registration period.

26 “(25) A rental or leasing company, as defined in ORS 221.275, that elects to initially register a
 27 vehicle for an annual or biennial registration period shall pay a fee of \$1 in addition to the vehicle
 28 registration fee provided under this section.

29 “(26) Racing activity vehicles registered under ORS 805.035, \$81.

30 “(27) Medium-speed electric vehicles, \$43 for each year of the registration period.

31 “**SECTION 4.** ORS 803.435 is amended to read:

32 “803.435. A declaration of weight required for purposes of complying with ORS 803.440 and for
 33 purposes of determining vehicle registration fees under ORS 803.420 shall contain the following:

34 “(1) For vehicles required to establish a registration weight under ORS 803.430, the declaration
 35 shall contain the registration weight.

36 “(2) For buses, the declaration shall contain the unloaded weight of the vehicle plus the un-
 37 loaded weight of any bus trailer to be used in combination with the vehicle. The declaration shall
 38 also indicate the number of persons, including the driver, to be carried in the vehicle, plus the
 39 number of persons to be carried on any bus trailer to be used in combination with the vehicle. For
 40 purposes of determining the fee for registration of the vehicle under ORS 803.420, the Department
 41 of Transportation shall determine the weight of the vehicle by adding the unloaded weight of the
 42 vehicle, plus the unloaded weight of any bus trailer to be used in combination with the vehicle, to
 43 a weight determined by multiplying the maximum seating capacity of the vehicle plus the maximum
 44 seating capacity of any bus trailer to be used in combination with the vehicle, including the driver’s
 45 seat but excluding emergency seats, times 170 pounds, if the vehicle has a separate compartment for

1 transporting baggage or express, or 150 pounds, if the vehicle has no separate compartment for
2 transporting baggage or express. If the vehicle has a seating capacity that is not arranged for sep-
3 arate or individual seating, 18 lineal inches shall be deemed the equivalent of a passenger seat.

4 “(3) For fixed load vehicles, the declaration shall contain the weight of the vehicle including the
5 cab, chassis, frame and all appurtenances necessary for making the vehicle self-propelled including
6 front bumpers, fenders, windshield, tire carrier and spare wheel, and including the fixed or perma-
7 nent load of the vehicle but excluding the spare tire.

8 “(4) **For tow vehicles that are used to transport property for hire other than as described**
9 **in ORS 822.210, the declaration shall contain the combined weight at which the vehicle will**
10 **be used to transport property for hire.**

11 “[~~(4)~~] (5) For all vehicles not otherwise provided for by this section and for which a declaration
12 is prepared or required, the declaration shall contain the registration weight of the vehicle.”.
